Good morning City Council Members,

Thank you very much for allocating time on your meeting agenda last night to discuss the Catalina Classic Commemorative Statue. Unfortunately, some comments and/or interpretations by Council members were voiced that are not accurate and the purpose of this message is to provide clarification so only the facts are considered in future discussions regarding this project. Many of these comments were made after the public comment period so we were not able to address them although we were raising our Zoom hand hoping to have the opportunity to do so.

Below is a list of inaccurate comments and/or interpretations that need clarification so decisions can be made on clear and accurate information:

- 1. The Catalina Classic Paddleboard Race is an event run by The South Bay Boardrider's Club (SBBC): This is NOT accurate.
 - o The Manhattan Beach Chamber of Commerce and lifeguard Bob Hogan created this event in 1955. This historical event was born in Manhattan Beach and is unique to the city throughout the world.
 - oFrom 1962 to 1981 the race went on hiatus and eventually brought back by lifeguards Buddy Bohn and Gibby Gibson (RIP) in 1982.
 - oBuddy and Gibby created the Catalina Classic Race Committee which continues to run the race today, and they are not a part of SBBC.
 - oPart of SBBC's mission statement is to celebrate the rich surfing history and culture in the South Bay, and the Catalina Classic Paddleboard Race is a big piece of that history. That is why we initiated this project.

2. Why does the project need to be this significant and costly?

- oThe original design concept conceived by SBBC in 2016 was a single figure knee paddling. We intended to contain the overall cost of the project.
 - City Council members said that both a woman and man are needed so we added a 2nd figure

- Manhattan Beach Arts Committee later suggested we add a 3rd figure (which
 is known common aesthetic practice in public art) so we added the figure standing with
 the 16ft board
- SBBC suggested a set of stairs coming from The Strand to the statue area for improved access and as added safety due to the 8 foot + drop off from the Strand to the neglected sand lot that exists today. City Planning said that if stairs are added then an ADA wheelchair ramp is required so we added the ramp and improved the landscape surrounding.
- SBBC and most people who have viewed this final version, including the MB City Council in 2018, believe it is the most impressive and worthy design to be installed.
- 3. The discussion that took place at the 2018 Council meeting, when the design concept was unanimously approved by the City Council, was that SBBC would pay for the statue and the City may consider paying for the stairs, wheelchair ramp, etc.: This <u>IS</u> true.
 - o However, at an Oct. 21, 2020 meeting with City Staff it was stated the city would not be able to initiate planning for the infrastructure, if funding were approved, until late 2021 due to other projects already in queue, and therefore it was unlikely the infrastructure would be begin until 2022.
 - oThe idea was then posed to have the City pay for the statue with its available Public Art Trust Fund dollars and the infrastructure be paid by SBBC which could likely be done at a lower cost than the project going through the public gov processes and could begin as soon as plans are approved and permits issued. The City Manager and City Attorney were consulted to ask if this is possible and it was confirmed to be possible with a vote by Council members.
 - oIf the Council members prefer, we can propose a phased approach and the SBBC will pay for the statue. We can also eliminate the stairs and wheelchair ramp to reduce the overall cost of the project at this time. If the City Council is willing to allocate some Public Art Trust Fund dollars to this project we would greatly appreciate it.
- 4. There was a comment made that seemed to imply SBBC's fundraising efforts have been lackluster: A robust fundraising effort has not been initiated because we have been waiting for various decisions, such as last night's, and approval for the project to be made so we are clear on exactly what funds we will need to raise. Nevertheless, through word of mouth and very little outreach we have raised nearly \$120,000. The overwhelming majority of residents who have seen the design concept since 2018, when it was made public, are thrilled with the design and are excited about where it is being installed. The funds will come once a campaign is initiated, and since SBBC is made up of volunteers with busy lives, we are seeking an allocation of dollars from the Public Art Trust Fund to assist us and reduce the time needed for fundraising.

I hope the information above adds some clarity on how this project has evolved since 2016. If you have any questions or requests please do not hesitate to contact me or my partners with this project. Thank you again for your time and consideration.
