COVID-19 Situation Report

JULY 13, 2021

CURRENT INITIATIVES AND UPDATES

- **Still Need to Get Your COVID-19 Vaccination?** – Through Thursday at county-run vaccination sites, LA City sites, and St. John’s Well Child and Family Center sites, everyone 18 and older coming to get a vaccine will have an opportunity to win one of seven packages of concert tickets. Prizes will include tickets to see Celine Dion, Grupo Firma, Kane Brown, Luke Bryan, and Dan and Shay at Staples Center, and box seats to four classical concerts at the Hollywood Bowl. - **Los Angeles County COVID-19 Case Number Increase in One Month** – One month ago, on June 13, the 5-day average of cases were 201 and today the 5-day average is 1,095; this is an increase of more than 500% in just one month. The test positivity rate has increased nearly 700% from the 0.5% seen a month ago; today’s test positivity rate is 3.4%. Locally, the City of Manhattan Beach saw a weekly increase in cases from 7 new cases to 25 new cases. The Los Angeles County Department of Public Health is encouraging everyone unvaccinated for COVID-19 to get fully vaccinated as people are vacationing, attending events, and the start of the school year gets near. If you begin your two-dose series for the Pfizer or Moderna vaccines this week, it may allow enough time to be fully protected by the start of the school year depending on the school. For all vaccines, you are only considered fully protected two weeks after all doses are complete.
- **City Council Action on Outdoor Dining Decks** – At the July 6, 2021, meeting, City Council discussed fees for business use of the public right-of-way and extended the citywide waiver until September 7, 2021, [See City Council discussion on the City website](#). Two decks located west of Ocean Drive (The Strand House and Rock’N Fish) will be removed this weekend to allow City staff to prepare for large summer events including the [2021 Charlie Saikley 6-Man Beach Volleyball Tournament](#) on July 30, 2021.
- **L.A. County Daily Briefing Statistics on COVID-19** – Los Angeles Department of Public Health has identified 1,259,772 positive cases of COVID-19 across all areas of L.A. County and a total of 24,554 deaths. Of the 12 new deaths reported today, six people that passed away were over the age of 80, four people who passed were between the ages of 65 and 79, and one person who passed was between the ages of 50 and 64. There are 376 people with COVID-19 currently hospitalized, and 23% of these people are in the Intensive Care Unit (ICU). Testing results are available for nearly 7,126,000 individuals with 16% of people testing positive.
