I WANTED TO COMMENT BRIEFLY, I KNOW WE'RE GOING TO BE DISCUSSING ITEM 15, THE COST OF USE OF THE PUBLIC RIGHT OF WAY.

A COUPLE COMMENTS.

THE STAFF REPORT IN THE BEGINNING WHEN IT TALKS ABOUT THE OVERALL RECOMMENDATION, I'M ASSUMING THAT THE RECOMMENDATION IS ONLY FOR THE USE OF WITHIN THE EMERGENCY ORDER AND ITS NOT REFERRING TO SOMETHING THAT'S GOING TO BE PERMANENT.

THAT THE DECISION TONIGHT OR DIRECTION PROVIDED TO STAFF IS NOT ON THE CORONA BASIS BUT WHILE WE'RE WORKING THROUGH COVID.

EVERYBODY WANTS TO GET BACK TO PRE-COVID.

THAT WAS A LOT LESS PARKING SPACES AND PEOPLE ON THE SIDEWALK.

UNCLE BILLS LIKE MANY OF US, THEY UTILIZE THE FRONT OF A PUBLIC RIGHT OF WAY AND DOESN'T USE ANY PARKING.

I KNOW THE \$3.00 PER FOOT RATE, I DON'T KNOW HOW THAT'S APPLICABLE TO PEOPLE USING PARKING SPACES USING MANHATTAN BEACH BOULEVARD.

I CAN'T WALK UP BECAUSE THERE ARE TOO MANY PEOPLE WALKING UP WITH THEIR SURF BOARDS.

YOU CAN WALK AROUND THE STREET AND YOU CAN'T DO THAT WITH THE UTILIZATION WITH THE PARKLETS IN FRONT OF THE BUSINESSES.

I WALK THROUGH THE ALLEY.

THE ALLEY IS ABSOLUTELY DISGUSTING.

THERE'S GREEN OOZE COMING OUT OF THE TRASH CANS.

WHEN I THINK ABOUT WHAT WE CHARGE RESTAURANTS FOR THE UTILIZATION OF THE RIGHT OF WAYS, WE NEED TO THINK ABOUT THE OTHER COSTS THE CITY IS INCURRING.

THEY PUT A LITTLE SMOKING THING.

PEOPLE ARE SMOKING IN THE ALLEY WHICH I FIND TO BE COUNTER PRODUCTIVE. PLEASE CONSIDER STAFF COSTS THAT ARE NOT INCLUDED.

PLEASE CONSIDER UTILIZING PUBLIC WALK STREET IN FRONT OF UNCLE BILLS IS A LOT DIFFERENT THAN TAKING DIAGONAL PARKING SPOTS AND THE COST FOR SUCH -- THE CITY NEEDS IT TO RECOUP THE COSTS AND WE'RE NOT LOSING COST BECAUSE OF THE ADDITIONAL OUTDOOR DINING.

I HOPE HE IS TAKING NOTES.

I'M A RESIDENT OF EAST MANHATTAN BEACH.

I WOULD LIKE TO SAY GOOD EVENING HONORABLE MAYOR HADLEY AND COUNCIL. LAST MONTH I SENT AN E-MAIL TO ALL FIVE OF THE COUNCIL MEMBERS ASKING AN EASY QUESTION.

IS THERE A HOUSING CRISIS?

UNFORTUNATELY THERE HAS NOT BEEN MUCH MOVEMENT ON THE TOPIC.

I DECIDED TO TAKE A STEP BACK AND LOOK AT WHERE I CAN IMPROVE HOW I CAN COMMUNICATE.

I SWITCHED TO FACT FINDING MODE AND LEARN MORE ABOUT BIG PICTURE VIEWS ON SPECIFIC HOUSING ISSUES WHICH EFFECT OUR COMMUNITIES.

EVEN WITH A TWO OUT OF FIVE RESPONSE RATE IT'S BEEN AN EYE-OPENING EXPERIENCE.

I WOULD LIKE TO THANK BOTH MAYOR HADLEY AND COUNCIL MEMBER FOR SENDING ME THOUGHTFUL RESPONSES TO MY OUESTION.

THOSE TWO RESPONSES WERE THE MOST EFFORT I'VE EVER SEEN OUR COUNCIL BRING OUT ON OUR HOUSING EFFORT.

I'LL REPEAT THE QUESTION HERE.

IS THERE A HOUSING CRISIS IN THE STATE OF CALIFORNIA?

I'LL ADD THIS IS A YES OR NO QUESTION.

YOU DON'T NEED TO EXPAND ON YOUR ANSWER UNLESS YOU WANT TO.

YOU CAN DEFINE HOUSING CRISIS HOWEVER YOU WANT TO.

I'M JUST LOOKING TO DISCOVER YOUR PERSPECTIVE ON THE ISSUE.

I'LL SEND AN E-MAIL FOLLOW-UP.

I LOOK FORWARD TO ANOTHER THREE VERY THOUGHTFUL RESPONSES FROM THREE MORE OF OUR THOUGHTFUL COUNCIL MEMBERS.

>> Commissioner Hardesty: THANK YOU ZACH FOR YOUR COMMENTS.

>> HI MY NAME IS ANDY.

I LIVE IN MANHATTAN BEACH.

I'VE BEEN DINING DOWNTOWN QUITE A BIT LATELY AND TALKING TO VARIOUS FRIENDS AN RESIDENTS AND LOCAL PEOPLE.

THE PREVIOUS SPEAKER -- WE ALL THINK AND ARE VERY VOCAL AMONGST OURSELVES ABOUT KEEPING THE OUTDOOR DINING, THE STREET AND SIDEWALKS AS DINING AREAS.

WE THINK IT MAKES THE CITY MUCH FRIENDLIER.

YES, WE ARE LOSING SOME PARKING SPACES.

THAT'S TOO BAD.

MANHATTAN BEACH IS NOT PARTICULARLY LOW ON PARKING SPACES.

I WOULD LIKE TO ENCOURAGE ALL OF YOU BY PUTTING IN YOUR MIND THAT MAYBE THIS IS SOMETHING YOU SHOULD KEEP THAT MAKES THE CITY FRIENDLIER AND NICER.

I HAVE NO PROBLEM, I IMAGINE ALL THE RESTAURANTS WOULD BE WILLING TO PAY A DESCENT RATE FOR IT.

IT WOULD CERTAINLY BENEFIT THEIR BUSINESS.

WHEN IT COMES TO PARKING, AGAIN, MANHATTAN BEACH ISN'T THAT BAD.

AT THIS TIME WE RECOMMEND YOU OPEN UP PUBLIC HEARING.

>> GOOD EVENING.

I'VE MISSED ALL OF YOU.

ANY WAY.

I THINK THE STORMWATER SITUATION IS VERY IMPORTANT.

THERE'S NO OUESTION ABOUT IT.

I DON'T BELITTLE IT BY COMING HERE AND SPEAKING BUT I'VE READ SOME OF THE COSTS THAT ARE USED TO APPLY -- MANY YEARS AGO I AND SOME TAXPAYER ASSOCIATION BROUGHT LITIGATION TO THE LIGHTING AND LANDSCAPING DISTRICT.

I'VE LOOKED AT SOME OF THE STORMWATER -- I DON'T UNDERSTAND, FOR EXAMPLE, HOW WE HAVE \$17,500 FOR STORMWATER TELEPHONE.

WHAT DO WE DO?

I THINK WE SHOULD QUESTION IT BEFORE WE APPROVE IT JUST BLINDLY. THANK YOU VERY MUCH.

WELCOME BACK.

IT'S GOOD TO SEE YOU.

>> THANKS A LOT.

>> WE HAVE JIM BURTON.

>> THANK YOU VERY MUCH.

I'LL MAKE THIS QUICK.

THIS MAY BE A QUESTION FOR LATER.

THE MEASURE W WE VOTED IN WITH LA COUNTY.

THERE IS SOME MONEY THAT WE HAVE TO BE ABLE TO USE THROUGH THE MEASURE

W FUND, I DON'T KNOW IF THIS IS APPLICABLE HERE.

I'M HOPING AND MAYBE THIS ISN'T SOMETHING THAT CAN HAPPEN THIS.

THIS IS NOT A REVENUE GENERATOR FOR THE CITY WHATSOEVER.

I'VE SEEN THOSE E-MAILS.

IT'S NOT A REVENUE, IT'S AN EXPENSE THAT I'D LIKE TO GET RID OF.

AS OF TODAY AND THIS BUDGET, IT'S A SHORT FALL TO THE CITY NOT A REVENUE PRODUCER.

CITY MANAGER IS HERE.

I SEE OUR CITY ANALYST.

TAKE IT AWAY.

>> IF YOU GIVE ME ONE MOMENT, I WILL PULL UP THE POWER POINT PRESENTATION.

SORRY ABOUT THAT.

HONORABLE MAYOR, I'M READY WHEN YOU ARE.

>> Commissioner Hardesty: ARE LET'S GO AHEAD AND GET STARTED.

>> I'M SENIOR MANAGEMENT ANALYST IN THE MANAGEMENT SERVICES DEPARTMENT.

SORRY ABOUT THAT.

APOLOGIZE FOR THE TIME WASTED ON THAT.

PERIODICALLY FROM QUARTER TO QUARTER WE HAVE HOMELESSNESS UPDATES AND GOING OVER OUTREACH EFFORTS.

IT'S AN ISSUE ACROSS THE COUNTY AN WE'RE DOING OUR PART TO ADDRESS HOMELESSNESS IN A WAY THAT'S OUTREACH FOCUSED AND ALSO PUBLIC SAFETY ORIENTED FOCUSED AS WELL.

I'LL START THIS PRESENTATION BY GOING OVER OUR HOMELESS METRICS, GRANT FUNDING, AN UPDATE ON THE PROSECUTION ASS INSPECT, REGIONAL UPDATES AND SUCCESS STORIES AND COMMUNITY COLLABORATION.

THIS DOCUMENT RIGHT HERE IS ONE OF OUR MOST IMPORTANT DOCUMENTS CITY WIDE

IN ESSENCE WHAT IT DOES IS WE'RE ABLE TO TRACK HOW WE'RE DOING HOMELESS OUTREACH WISE.

ARE WE INTERACTING WITH PEOPLE ON THE STREET LEVEL?

THIS IS INDEPENDENT FOR THE CALLS FOR SERVICE THAT OUR POLICE DEPARTMENT FIELDS.

JUST TO BE CLEAR.

OUR OUTREACH TEAM OVER THE COURSE OF THE GRANT FUNDING, WE'VE HAD 1186 STREET INTERACTIONS TO DATE.

JUST IN MB THERE'S BEEN 321.

WE'VE BEEN VERY ACTIVE ON THE OUTREACH FRONT.

WE'VE BEEN ABLE TO ASSIST A LOT OF CLIENTS.

THIS METRIC IS PROBABLY THE MOST IMPORTANT FOR ME.

THIS IS HOW MUCH PLACEMENTS WE'VE BEEN ABLE TO MAKE.

INTERIM HOUSING PLACEMENT REFERRALS, THROUGHOUT THE REGION MANHATTAN BEACH -- THESE ARE INDIVIDUALS NOT PLACE INTO INTERIM FACILITIES BUT PLACED INTO APARTMENT UNITS AN THINGS THAT ALLOW THEM TO BE SELF SUFFICIENT.

WE'VE PLACED TEN INDIVIDUALS INTO STABLE HOUSING PLACEMENTS. REGIONALLY WE'VE PLACED 22.

WE'RE ALMOST AT OUR GOAL IN TERMS OF DOCUMENT READY AND ENROLLING PEOPLE INTO BENEFITS AND PROGRAMS IN TERMS OF WHAT THEY NEED TO BE PLACED INTO A HOUSING PLACEMENT.

GRANT FUNDING.

THE ONLY WAY THIS IS POSSIBLE IS THROUGH THE USE OF GRANT FUNDING FOR MEASURE H.

SO FAR THE CITY HAS USED ABOUT 230,000.

THAT WILL BE AVAILABLE TO US UNTIL THE END OF THE CALENDAR YEAR. STAFF IS LIKELY TO APPLY FOR THE NEXT ROUND OF FUNDING TO ENSURE SERVICES EXTEND BEYOND 2021.

AS OF NOW SERVICES ARE ONLY GUARANTEED UNTIL THEN.

HOUSE OF SERVICES WILL ADMINISTER THAT CALL FOR PROJECTS.

IT'S EXPECTED TO HAVE A DEADLINE I BELIEVE IN AUGUST.

IT'S EITHER GOING TO BEGIN AT THAT DATE OR DEADLINE IS AT THAT DATE. IN ALL, THAT GRANT FUNDING IS COMPETITIVELY SPLIT UP BETWEEN ALL THE

SOUTH BAY CITIES.

ONE KEY PIECE OF OUR HOMELESSNESS EFFORT IS COORDINATION BETWEEN THE OTHER BEACH CITIES.

WE HAVE A SIMILAR SET OF TRAINING MATERIALS.

TWENTY STAFF MEMBERS HAVE BEEN TRAINED.

WE HAVE A DOCUMENT THAT GOES OVER HOW WE REFER, WHAT THE PROCESS IS, PLACES TO CONTACT HOME -- PLACE IT CONTRACT INDIVIDUAL WHO ARE INTERESTED IN HOMELESS SERVICES.

AT THE LAST MEETING, THE CITY COUNCIL PERFORMED A COST BENEFIT ANALYSIS.

YOU'LL NOTICE NOT A LOT OF DETAIL ON THIS EFFORT.

THE DETAILED STAFF REPORT WILL BE COMING, WE HAVE A TENTATIVE DATE OF YOUR NEXT MEETING.

WE'RE HOPING TO PROVIDE A REPORT IN TIME THROUGH THEM.

THIS IS ALSO CONNECTED TO OUR EFFORT TO SEPARATE PROSECUTION AND GO TO POTENTIALLY CONTRACT WITH REDONDO BEACH.

THE ONLY WAY TO ADD HOMELESS COURT IS TO CONTRACT THROUGH REDONDO BEACH BECAUSE THEY HAVE A HOMELESS COURT.

IN TERMS OF REGION UPDATES, AS I SAID EARLIER HOMELESSNESS IS SOMETHING OF REGION CONCERN AND EVERYBODY IS DOING THEIR PART TO TRY TO ADDRESS IT IN SOME WAY.

REDONDO BEACH IS TAKING UP AN ITEM TONIGHT TO CONSIDER REPLACING THE EXISTING SHELTERS THEY HAVE AT THE BEACH CITIES HEALTH CENTER CAMPUS. TORRANCE APPROVED A PILOT SHELLER PROGRAM.

THIS WOULD LAST FOR ABOUT A YEAR.

IT'S ABOUT FORTY TO FIFTY UNITS IN THAT PALATE SHELTER PROGRAM. THAT WAS JUST APPROVED IN JUNE.

THAT'S ANOTHER SHELTER THAT WOULD BE GOING ON REGIONALLY.

THE CITY OF LOS ANGELES FEASIBILITY STUDY.

I UPDATED THE CITY COUNCIL ON THESE TWO OR THREE MEETINGS AGO.

IN ESSENCE, THE CITY OF LA IS TRYING TO HOUSE INDIVIDUALS IN TWO LOCATIONS THEY'VE IDENTIFIED, THE CITY IS PAYING ATTENTION TO IT, THEY'VE MET AND WE'VE ASKED THEM TO KEEP US INFORMED OF THAT EFFORT. SHE GOING TO TALK ABOUT TWO SUCCESS STORIES AND THE COLLABORATIONS THAT HAVE COME ABOUT AS A RESULT OF THOSE SUCCESS STORIES.

I MAY BE ABLE TO INTRODUCE HER LATER.

TWO SPECIFIC STORIES THAT I WANTED TO REFERENCE.

ONE WAS A FAMILY REUNIFICATION THAT OUR OUTREACH TEAM WAS VERY BENEFICIAL IN ASSISTING.

A TRANSITIONAL AGE YOUTH THAT WAS SLEEPING NEAR A GROCERY STORE. WE WERE ABLE TO ESTABLISH A CONNECTION AND BUILD RAPPORT.

WE WERE ABLE TO CONNECT THEM HOME TO VIRGINIA.

ANOTHER IMPORTANT REFERRAL WAS THROUGH OUR LA HOP.

EVERYBODY ASKS WHAT THEY CAN DO TO HELP.

I ALWAYS SAY IS FILL OUT A REQUEST FOR LA HOP.

IT GIVES THEM A GA TAG LOCATION OF WHERE TO RESPOND TO INDIVIDUALS. THEY WERE ABLE TO CONTACT THESE TWO INDIVIDUALS WHO WERE EXPERIENCING HOMELESSNESS, ALSO YOUTH, WITH THE ANSWER OF MB SAFE ON OUR COMMUNITY, THEY WERE ABLE TO PROVIDE A DONATION AND GET THEM INTO A SHARED STABLE HOUSING COMMUNITY.

THESE ARE EXAMPLES OF OUR COMMUNITY COMING TOGETHER TO ASSIST AND ALSO US HAVING THE RESOURCES AT THE CITY LEVEL IN ORDER TO MAKE THESE THINGS HAPPEN.

NOT ONLY SHOULD THE COMMUNITY BE COMMENDED BY THE CITY COUNCIL AS WELL FOR THEIR EFFORTS ON THIS.

IN CONCLUSION, THE CITY IS REMAINING DILIGENT ON HOMELESSNESS.

WE'LL HAVE A REPORT COMING TO YOU AT THE NEXT CITY COUNCIL MEETING. QUARTERLY REPORTS WILL CONTINUE TO COME TO YOU.

WE REVIEW THEM IN REDONDO BEACH AND ARE CONSTANTLY REVIEWING TRENDS, WHAT IS OUR OUTREACH TEAM OBSERVING AN POLICE DEPARTMENT OBSERVING AS WELL.

THIS IS OUR REPORT.

THE STAFF AND CITY COUNCIL RECEIVED A REPORT.

I'M HERE TO ANSWER ANY QUESTIONS.

>> Commissioner Hardesty: THANK YOU GEORGE.

EXCELLENT JOB.

COLLEAGUES.

ANY REQUESTS TO SPEAK?

ANY QUESTIONS FOR, GEORGE.

>> THEY DIDN'T HAVE ALL THIS FANCY STUFF AT THE PARKING COMMISSION. WE GET CALLS ALL THE TIME FROM RESIDENTS.

WHAT ARE THE STEPS AND WHERE ARE THEY WRITTEN SO WE KNOW WHERE TO SEND THEM TO GET THE BEST POSSIBLE OUTCOME?

THE FIRST OF COURSE IS SECURITY.

WE WANT TO MAKE SURE IT'S SAFE FOR OUR RESIDENTS AS WELL AS THE HOMELESS INDIVIDUAL.

WHAT SHOULD OUR RESIDENTS DO?

>> IT CENTERS AROUND THE QUESTION WHETHER THERE'S A PUBLIC SAFETY CONCERN IN MIND.

IF THERE IS, YOU SHOULD CALL THE POLICE DEPARTMENT.

IF PUBLIC SAFETY IS NOT AN ISSUE YOU SHOULD DIRECT THEM TO OUR HOT LINE.

OUR POLICE DEPARTMENT IS INSTRUMENTAL IN THESE EFFORTS.

THEY ARE USUALLY OUR FIRST LINE OF RESPONSE.

THEY CONSTANTLY MAKE REFERRALS TO HARBOR INTERFACE.

THE ENTIRE POLICE DEPARTMENT SHOULD BE COMMENDED.

>> IS IT LA-HOP?

>> LA-HOP DOT ORG.

IT'S TYPICALLY 24 TO 26 HOURS.

OUR HOMELESS OUTREACH TEAM GET THESE REQUESTS CONSTANTLY.

IT'S ONE TO THREE PEOPLE THAT ARE RESPONDING TO THESE TICKETS THAT ARE SUBMITTED THROUGHOUT THE REGION.

THEY TRY TO RESPOND AS OUICKLY AS POSSIBLE.

THEY ARE ALSO RESPONDING TO OTHER INDIVIDUALS WHETHER THEY ARE GETTING THEM DOCUMENT READY OR MOVING THEM INTO A HOUSING PLACEMENT. THERE'S A GOAL OF 24 HOURS.

>> WHAT IS THE TYPICAL PERCENTAGES OF HOMELESS FOLKS THAT COME HERE, STAY A LITTLE BIT AND GO ON.

IS THAT THE MAJORITY?

CAN YOU GIVE US AN IDEA SO RESIDENTS CAN GET SOME PERSPECTIVE?

>> MOST OF THE TIME INDIVIDUALS ARE PASSING THROUGH MANHATTAN BEACH.

IT DOESN'T MEAN THAT SOME DON'T TRY TO STAY.

WE HAVE OUR FAIR SHARE OF INDIVIDUALS.

WE'RE NOT BLIND TO THAT.

WE'RE FORTUNATE IN SAYING THAT WE DO NOT HAVE THAT MANY.

>> IT'S BEEN IN THE NEWS THAT SUGGESTIONS BY THE LOS ANGELES CITY COUNCIL, DO WE HAVE ANY UPDATE ON THAT?

WHAT DO YOU FEEL THE IMPACT MIGHT BE ON MANHATTAN BEACH IF THEY START MOVING THEM THERE AN SETTING THAT UP?

>> IN TERMS OF AN UPDATE, WE'RE WAITING ON SUPERVISOR JANICE HAHN. IT CAN BE ANYWHERE FROM 30 DAYS TO MAXIMUM OF 90 DAYS, THIS WAS IN MID JUNE.

THIS WOULD BE SUBSTANTIAL.

THERE'S A LOT OF PEOPLE THAT NEED TO WEIGH IN.

IT'S CERTAINLY NOT SOMETHING THAT CAN BE ACCOMPLISHED OVERNIGHT.

THAT BEING SAID, IT IS A FEASIBILITY STUDY.

STAFF WILL BE EXPLORING THAT FEASIBILITY STUDY TO DETERMINE WHAT THE IMPACTS ARE.

IT RELATES TO SECURITY, INTAKE, OUT TAKE, AND OTHER INFORMATION LIKE THAT.

>> OKAY.

GREAT.

THANKS.

>> TO THE COMMENTS, RESOURCES.

ARE YOU GOING TO POST THIS?

>> IT'S ON THE AGENDA WHICH IS ON THE WEBSITE.

WE'RE WORKING ON A MORE FRIENDLY VERSION TO POST ON THE WEBSITE.

>> THE LAST PAGE, 224, THAT ONE PAGE ITSELF IS PERFECT TO JOE'S QUESTION ABOUT WHAT NUMBER THEY CALL.

IF THEY FOLLOW THIS ONE SIMPLE PAGE RESOURCE, IT'S A PERFECT GUIDE.

IT'S AN EASY GUIDE FOR US AN THE PUBLIC TO FOLLOW.

NEW RESIDENTS, OLD RESIDENTS.

YOU TOUCHED ON IT BRIEFLY.

REDONDO BEACH, IT REQUIRES US TO GO INTO A CONTRACT.

IT COULD BE A NO.

BUT ASSUMING IT'S A, YES.

TODAY IT'S NOT A MISDEMEANOR.

THIS GIVES AN OPTION TO US.

THAT'S WHY WE'RE FOLLOWING THIS PATH.

IT'S NOT BECAUSE WE'RE NOT SYMPATHETIC TO THE HOMELESS.

IT'S THAT IF THE COUNTY IS NOT GOING TO DO IT, WE NEED A RESOURCE.

>> THE POSSIBILITY OF THE DISTRICT ATTORNEY DOING US ANY FAVORS AT THIS POINT, OUR OWN ABILITY, WE TALKED ABOUT STATE MISDEMEANORS.

CAN WE NOT MIRROR WHAT THE STATE HAS AS A LOCAL MISDEMEANOR AS WELL.

A LOCAL JURISDICTION WILL ADOPT A LAW THAT IS THE SAME AS WHAT THE STATE LAW IS AND WHY CAN'T WE DO THAT HERE.

>> IN SOME INSTANCES WE CAN, IN OTHER INSTANCES WE'RE PREEMPTED BY THE STATE.

WE HAVE TO SEE WHICH OF THESE VIOLATIONS WE CAN CONTROL ON THE LOCAL LEVEL.

- >> DETERMINE WHICH ONES WE REALLY WANT TO GO AFTER.

WE HAD A DISCUSSION WITH REDONDO AN THE POLICE DEPARTMENT AND PUT TOGETHER WHAT TYPE OF VEHICLE CODE VIOLATIONS AND OTHER MISDEMEANORS.

THERE'S PROBABLY GOING TO BE SOME ANALYSIS IN GEORGE'S REPORT.

>> IT'S ALWAYS REASSURING AND HELPFUL TO UNDERSTAND.

IN THE STAFF REPORT AND YOU ALLUDED TO IT, IN THE JOINT AGREEMENT AND THE FUNDING THAT WE HAVE IN THAT AGREEMENT WILL EXPIRE IN DECEMBER OF 2021.

WHEN YOU MAKE A REQUEST FOR FUNDING FOR THAT ADDITIONAL PROJECT, WILL THAT GO THROUGH THE COGS GRANT?

DOES IT QUALIFY UNDER THE PARAMETER OF THE ONE POINT NINE MILLION THAT THE COGS WILL BE RECEIVING?

>> THE PROCESS HAS CHANGED SLIGHTLY.

IF I'M GETTING TO.

TOO BUREAUCRATIC IN THE PROCESS, PLEASE STOP ME.

THE PROCESS THAT WE'RE CURRENTLY IN, WE APPLIED FOR A GRANT FUNDING DIRECTLY TO THE COUNTY OF LA.

NOW WHAT THE COUNTY IS DOING IS DISTRIBUTING THOSE FUNS TO THE COGS AND THE COGS WILL BE AWARDING THOSE FUNDS TO THOSE CITIES.

THE COGS ARE ACTING AS AN INTERMEDIARY.

WE'RE GOING TO APPLY FOR A GRANT WITH THE COG ALLOTMENT.

AFTER THAT WE'RE HOPING TO SEE THE CHANGES TO THE SERVICES.

- >> DO YOU THINK THERE WILL BE ANY CHANGES TO THE SERVICES?
- >> I HOPE NOT.
- >> OR ADDITIONAL SERVICES.

DECIDING THAT IF THERE'S ANYTHING THAT YOU WANT TO ASK FOR IN ADDITION.

>> THE MORE OUTREACH WORKERS AND HOUSING NAVIGATORS, THEY ARE PROBABLY ONE OF THE MORE, THEY ARE VERY BENEFICIAL TO US. IT QUICKENS OUR RESPONSE TIME.

THEY CAN ALLOW US TO HOUSE MORE PEOPLE AT QUICKER RATES BECAUSE WE DON'T HAVE ONE OUTREACH WORKER BACKED UP WITH OTHER ISH USE.

IT INCREASES OUR BAND WIDTH TO HOUSE INDIVIDUALS.

>> THERE HAD WAS SOME DISCUSSION IN OUR OUTREACH WITH THE CONTRACT FOR THESE INDIVIDUALS.

>> Commissioner Hardesty: I'M GOING TO WRAP UP.

WHAT IS THE -- IS THAT CORRECT?

>> YES.

LA-HOP -- BE DEPLOY TODAY A LA-HOP REQUEST.

>> Commissioner Hardesty: WE'RE NOT DUPLICATING OR PASSING IT OFF. IT'S BOOTS ON THE GROUND HERE.

YES, I WOULD LIKE TO SECOND POINT ABOUT THE MORE HOUSING NAVIGATORS AND MORE HOURS WE HAVE, IT'S MORE BENEFICIAL TO THE UNHOUSED.

THE QUICKER WE CAN GET THEM THE SERVICES THEY NEED.

CURRENTLY WE SHARE ONE FULL TIME WORKER WITH THREE CITIES, I BELIEVE. >> TWO ACROSS THE THREE CITIES.

ONE IS DEDICATED TO MANHATTAN BEACH.

THERE'S A LITTLE MORE OF A NEED IN REDONDO.

THERE ARE TIMES WHEN HE DOES ASSIST REDONDO BEACH.

BUT IT'S ALL MANAGED BY MANHATTAN BEACH SERVICES.

>> Commissioner Hardesty: I'M ALL FOR GETTING A FULL TIME HOUSING SERVICES MANAGER HERE.

TWO CITY COUNCIL MEMBERS REACHED OUT TO ME ASKING ABOUT OUR INTEREST IN A HOMELESS COURT.

IT'S EARLY BUT THEY ALSO EXPRESSED INTEREST IN PURSUING THE HOMELESS COURT.

WHAT I'VE HEARD FROM THE CITY OF REDONDO BEACH, JANICE IS REALLY SUPPORTIVE.

IS THAT SOMETHING YOU COULD PUT IN THE JULY REPORT.

IF REDONDO TELLS YOU NO, WE DON'T WANT TORRANCE TO JOIN.

THAT WOULD BE INTERESTING TO KNOW F. THEY ARE SAYING THERE ARE ECONOMIES TO STALE, THAT WOULD HELP GET THE COUNTIES INTEREST TO HELP DEFRAY THE COST WHICH IS \$250,000 A YEAR THAT WOULD BE CHARGED JUST TO MANHATTAN FOR JOINING.

DO AGREE THAT THE INTEREST MIGHT GET BIGGER BECAUSE OF ECONOMIES TO SCALE.

>> I DO AGREE THAT ECONOMIES OF SCALE WOULD BE BENEFICIAL TO US BECAUSE OF COST.

THAT'S SOMETHING THAT WE CAN BRING UP WITH OUR NEGOTIATION WITH THE CITY OF REDONDO BEACH.

THAT'S SOMETHING WE CAN ENTERTAIN WHEN WE'RE DOWN THAT ROAD.

I KNOW THAT JANICE JUST FUNDED OR CONTRIBUTED TO ADDING LONG BEACH AS A HOMELESS COURT RECIPIENT AS WELL.

THEY HAVE THEIR OWN PROSECUTION AND THEY HAVE THE ABILITY TO PROSECUTE MISDEMEANORS.

I KNOW SHE WAS ECSTATIC ABOUT THAT EXTENDING TO LONG BEACH.

>> Commissioner Hardesty: THAT MEANS WE HAVE A CITY PROSECUTOR OUR CURRENT DISTRICT ATTORNEY IS SIGNALING THAT HE IS UNINTERESTED OR UNWILLING TO DO THAT.

WE CAN GET MORE SERVICES FOR OUR UNHOUSED BUT PERHAPS BRING MORE PROSECUTORIAL DISCRETION TO LOCAL LAW BREAKERS AS WELL.

IT SEEMS TO BE DOUBLE DUTY THERE.

OKAY.

THROUGH, GEORGE.

I'M SORRY, MY COLLEAGUE, STEVE.

>> WHEN WE ASK STAFF FOR THEIR OPINIONS, WE PUT THEM IN AWKWARD POSITIONS.

LET'S DIAL THAT BACK A LITTLE BIT.

THE REALITY IS, WE'RE ALREADY PAYING TAXES FOR A LOT OF THESE SERVICES.

I WOULD QUESTION WHY WE NEED TO PAY MORE FOR SOMETHING LIKE HOMELESS COURT WHEN IT'S UNPROVEN OR EFFECTIVE TO GETTING THEM OFF THE STREET. YOU CAN'T ARREST YOUR WAY OUT OF HOMELESSNESS.

MY POINT TO YOU AND TO OUR STAFF IS WHAT WE NEED TO DO IS CONTINUE LOBBYING THE COUNTY, IF YOU WANT HOMELESS COURT, IF YOU THINK THAT'S SOME SILVER BULLET HERE, FREE UP THE FUNDS FOR THIS KIND OF EFFORT IN THE FUTURE TO SAY LET'S PAY FOR THIS.

WE'RE ALREADY PAYING FOR THESE SERVICES WE APPROVED.

THE COUNTY SHOULD BE PUTTING UP THE MONEY FOR IT.

IT SHOULDN'T BE A SCRAMBLE AT THE COG LEVEL.

IF REDONDO DOES GET THIS ADDITIONAL COST IT SHOULD BE A CAVEAT THAT OTHER CITIES JOIN AT NO ADDITIONAL COST.

>> Commissioner Hardesty: THANK YOU, GEORGE GREAT REPORT.

I'LL GO TO PUBLIC COMMENT.

IS THERE ANYONE QUEUED UP FOR PUBLIC COMMENT.

>> YES.

I'LL FIRST GO TO OUR ZOOM PARTICIPANT FOR PUBLIC COMMENT.

>> I'M A RESIDENT OF MANHATTAN BEACH I'M CALLING WITH BEING TIED WITH THE CITY TO ADDRESS THE HOMELESSNESS ISSUE FOR THE LAST COUPLE OF YEARS.

MY COMMENT IS ABOUT THE HOMELESS COURT.

THE ALLEGATION THAT THE HOMELESS COURT ISN'T PROVEN IS NOT ACCURATE. THERE ARE DATA AND STATISTICS THAT ARE AVAILABLE AND I CAN SHARE WITH

YOU IF YOU WANT THAT PROVE THAT HOMELESS COURT AND ESPECIALLY THE CONCEPT OF RESTORATIVE JUSTICE.

THE TRUTH OF THE MATTER IS WE DO NOT HAVE, YOU DO NOT HAVE ANY EFFECTIVE CONTROL WITH THE COUNTY CAN DO, SHOULD -- WE ONLY HAVE CONTROL WHAT WE CAN DO AS A CITY.

AS A CITY WE SHOULD CHOOSE THE RIGHT THING AND SUPPORT ACCESS TO THE HOMELESS COURT.

- >> Commissioner Hardesty: THANK YOU FOR YOUR COMMENTS.
- >> NEXT WE HAVE VICTOR.
- >> MY NAME IS WILLIAM VICTOR.

I HAVE TWO INSTANCES I THINK ARE INTERESTING THERE'S ONE REGULAR FELLOW THAT SEEMS TO BE A ROUTINE.

NO PROBLEM AT ALL AS FAR AS I'M CONCERNED.

ANOTHER FELLOW.

THERE'S A RECEPTACLE FOR THE WASTE.

HE WAS SLEEPING THERE.

IT WAS DARK.

I SUBJECTED THAT HE FIND A MORE COMFORTABLE PLACE TO SLEEP.

I WAS AWAY FROM OCTOBER TO MARCH OF THIS YEAR.

I REPRESENT CLIENTS AND SOME DIDN'T KNOW I WASN'T THERE.

WHEN I CAME BACK SOMEONE SEEMED TO KNOW HIS WAY AROUND PRETTY WELL.

I ASKED IF HE LIVED THERE AND OWNED THE PLACE.

HE SAID YES.

A FIREPLACE HAD BEEN MADE RIGHT IN THE MIDDLE OF THE CARPETING OF THE UNIT AND THE SINKS.

THE PLACE WAS RANSACKED.

HE WAS FROM THAT CHURCH.

I CALLED THE CHURCH.

I GAVE THIS INFORMATION TO OUR POLICE DEPARTMENT.

THEY CAME.

THEY DIDN'T WANT TO GO INSIDE BECAUSE OF THE PANDEMIC.

THEY ASKED A NEIGHBOR TO THE NORTH.

HE CAME IN AND BROKE IN FROM THE OCEAN DRIVE SIDE.

WHAT HAPPENED WAS, HE WENT AROUND INTRODUCING HIMSELF TO NEIGHBORS AS A NEW NEIGHBOR.

HE WAS PRETTY CORDIAL ABOUT THAT.

HE LEFT LOTS OF NOTES AND SO FORTH.

THE POLICE TRY TODAY HELP.

THEY CALLED THAT CHURCH AND ASKED TO MAKE CONTACT WITH HIM.

THEY SAID, THEY ONLY COLLECT HIS MAIL.

\$17,000 WORTH OF DAMAGE AND STILL RECOVERING THE RANSACKED AREAS. I JUST WANT TO TELL YOU -- WHAT I'M SUGGESTING IS THE POLICE WERE HELPFUL.

IT'S VERY LIMITED WHAT THEY CAN DO IN MY EXPERIENCE ANY WAY.

THIS CHURCH IN VENICE, HE HAD PLACES TO GO.

THE PLACES LEFT WERE FOR SHOWERS.

THERE WAS A SIGN UP.

IT WAS REALLY PERFECT AT MY PLACE.

THERE WAS NO HEAT BECAUSE THE THERMO STATS.

- I HAVE TO YOU HAVE WRAP UP.
- >> WHAT I'M SAYING IS I DON'T HAVE THE MAIL THERE.

THEY BREAK INTO THE MAILBOXES OF PEOPLE.

IT'S A PROBLEM.

IT MAKE IT'S LESS DESIRABLE FOR PEOPLE WHO WANT A HOUSE BY THE OCEAN.

>> Commissioner Hardesty: YES.

THANK YOU.

THANK YOU FOR CALLING THE POLICE AND HANDLING IT THROUGH LEGAL CHANNELS.

THEY DO AN EXCELLENT JOB.

THANK YOU.

NEXT CALLER.

- >> THERE'S NO FURTHER REQUEST FOR PUBLIC COMMENT AT THIS TIME.
- >> Commissioner Hardesty: I'LL GO BACK TO MY COMMENTS.
- >> GOING BACK TO OUR STAFF.

SHE SAID SHE HAS STATS AN FIGURES FOR HOMELESS COURT.

I ASKED FOR THOSE AT THE LAST MEETING.

- >> THE GOAL IS TO HAVE THAT DATA AVAILABLE WHEN STAFF RETURNS WITH THE HOMELESS COURT DISCUSSION.
- >> SO IT EXISTS NOW SOMEWHERE?
- >> YES.
- >> OKAY.
- >> Commissioner Hardesty: OKAY.

LET'S DISCUSS AND PROVIDE DIRECTION.

IF NO MORE COMMENTS OR QUESTIONS FOR GEORGE.

WE'LL MOVE ON.

THANK YOU SO MUCH.

I LOOK FORWARD TO JULY 20TH.

WE'LL MOVE ONTO ITEM NUMBER 15TH WHICH IS A CONTINUATION OF DISCUSSION OF FEES FOR THE BUSINESS USE OF THE PUBLIC RIGHT OF WAY.

WE'LL CALL ON OUR COMMUNITY DEVELOPMENT DIRECTOR KERRY WHO IS IN THE HOUSE.

YAY.

>> GOOD EVENING.

I'M SO HAPPY TO BE HERE TONIGHT ALONG WITH ALL OF YOU.

WE HAVE A STAFF PRESENTATION TONIGHT.

>> MEMBERS OF CITY COUNCIL, I'M CALLING TO YOU VIRTUALLY ABOUT FIFTY FEET AWAY FROM YOU.

A LITTLE OVER A YEAR AGO THE CITY COUNCIL ISSUED EMERGENCY ORDER TEN REGARDING OUTDOOR DINING AND PARKING SPACES IN OUR PUBLIC RIGHT OF WAYS.

STARTING IN JULY OF THAT YEAR, THE CITY AUTHORIZED THE USE, THE CURRENT RATE WAS ABOUT \$3 PER SQUARE FOOT, AT THE TIME THE CITY RETROACTIVELY WAIVED THOSE FEES AS A MANNER OF RELIEF TO THEM.

ABOUT A MONTH LATER IN SEPTEMBER, THE CITY COUNCIL WORKED OUT AN INCREASE IN THE PARKING METER FEES TO \$2 PER HOUR FOR ON-STREET METERS TO MAKE UP FOR ONSET OF LOSSES FOR THE USE OF THOSE PARKING SPACES FOR OUTDOOR DINING.

THAT WAS ABOUT A \$750 OFFSET.

OTHER RECOMMENDATIONS.

CURRENTLY THERE ARE OUTDOOR DINING AND PARKING SPACES.

IN MAY WE STARTED A DISCUSSION TO REINSTITUTE THOSE FEES FOR PARKING METER REIMBURSEMENT AND USE OF THE PUBLIC RIGHT OF WAY.

AS YOU RECALL JUST A COUPLE WEEKS AGO THE GOVERNOR'S OFFICE REMOVED THE MANDATORY RESTRICTIONS FOR OCCUPANCY LIMITS OF RESTAURANTS AND OTHER BUSINESSES EVEN THOUGH THEY CAN GO TO 100% INDOORS THE RECOMMENDED PRACTICE IS TABLES BE NO LESS THAN SIX FEET APART AND

A LOT OF RESTAURANT CUSTOMERS ARE NOT COMFORTABLE DINING INDOORS YET. FOR THE RESTAURANT IS LOOKING TO RECOVER AS WELL.

THE CONCERN AT A CERTAIN POINT IS THAT THE CITY WOULD BE IN ESSENCE BE GIVING A GIFT OF PUBLIC FUNDS WITH NO PUBLIC GAIN.

THIS HAS BEEN JUSTIFIED DUE THE PANDEMIC.

AT A CERTAIN POINT WE'RE LOOKING AT WHAT POINT DOES THAT CHANGE? THE COSTS RIGHT NOW FOR PARKING METER IS \$2.00 PER HOUR. \$36.00 PER DAY.

\$790 PER DAY.

IN ADDITION TO THAT IN WE WERE CHARGING \$3.00 PER SQUARE FOOT FOR LEASED AREAS, THAT WOULD EQUATE TO \$114,000 PER YEAR.

THE FINANCE OFFICE HAS LOOKED INTO THE GOING RATES, IF YOU WILL, THE RENTAL RATE FOR DOWNTOWN OFFICE SPACE IS ABOUT \$8 PER SQUARE FOOT. OUTDOORS THAT MAY NOT BE EQUIVALENT BECAUSE SOMETIMES YOU HAVE WEATHER CONDITIONS AND YOU MAY NOT BE ABLE TO USE THAT OUTDOOR SPACE ALL THE TIME.

THE COMMON INDUSTRY PRACTICE IS TO CHARGE 50 PERCENT OF THAT RATE. THAT WOULD BE EQUIVALENT OF \$4 PER SQUARE FOOT FOR TEMPORARY OUTDOOR USE.

SOME OTHER SOUTH BAY CITIES DO NOT CHANGE AT THIS TIME.

WE ARE LOOKING TO YOU FOR DIRECTION FOR THE LOSS OF THE PARKING METER REVENUE, PARKING CITATIONS AND STANDARD LEASE RATES.

THE CITY IS CONTRIBUTED AN EXTENSIVE AMOUNT OF EXPENSE FOR EXTRA PUBLIC SERVICES SUCH AS TRASH AND MAINTENANCE, MAINTENANCE OF THE STREETS, CHANGING OF THE SIGNS, LAW ENFORCEMENT AND ALL THE REST. AT THIS TIME STAFF IS RECOMMENDING THAT THE CITY COUNCIL PROVIDE DIRECTION ON WHEN WOULD BE THE APPROPRIATE DIRECTION TO REINSTATE THIS CITIES PRACTICE OF REQUIRING BUSINESSES TO REIMBURSE FOR PARKING METERS AND MAKE LEASE PAYMENTS FOR USE OF THE PUBLIC RIGHT OF WAY. WITH THAT, THAT CONCLUDES MY PRESENTATION.

>> Commissioner Hardesty: THANK YOU TRAFFIC ENGINEER FROM FIFTY FEET AWAY.

>> SANTA MONICA CHARGE SIMILAR FEES.

DID THEY GIVE YOU AN IDEA OF WHAT THE SIMILAR FEE WAS?

>> IT WAS IN THE \$5.00 RANGE.

DIRECTOR CAN GIVE YOU A LITTLE MORE DETAIL ON THAT.

>> I WAS ON MUTE, SORRY ABOUT THAT.

ONE TO FIVE DOLLARS DIFFERENT PLACES IN THEIR CITY.

SANTA MONICA CHARGES DIFFERENT RATES IN THEIR CITY.

THE AVERAGE IS RIGHT AROUND \$3.

>> Commissioner Hardesty: CAN YOU REPEAT THE QUESTION.

>> IN THE STAFF REPORT ON PAGE 227, STAFF WRITES THAT SANTA MONICA, AND HERMOSA CHARGE SIMILAR FEES.

MY YES WAS WHAT SIMILAR WAS.

IT'S IN THE \$5.00 RANGE.

>> Commissioner Hardesty: I'M CONFUSED.

YOU'RE SAYING THAT'S FOR RIGHT NOW FOR OUTDOOR DINING OR IS THAT A REGULAR FEE CHARGED FOR SOMETHING ELSE?

>> YOU WANT TO ASK THE QUESTION, I'M READING THE STAFF REPORT.

>> Commissioner Hardesty: THAT SEEM IT CONFLICT WITH THE REPORT FROM CHAMBER OF COMMERCE.

>> I ASK ANSWER THAT QUESTION.

CERTAIN CITIES CHARGE FOR THE USE OF OUTDOOR DINING.

WE HAVE NOT INDIVIDUALLY VERIFIED THAT INFORMATION.

I CAN'T SPEAK TO EXACTLY WHAT IS ON THAT CHART.

THERE ARE DEFINITELY NOT JUST COASTAL CITIES, OTHER CITIES HAVE A RANGE OF CHARGES.

IT DEPENDS ON THE POPULARITY OF THE AREA.

>> A QUESTION ALONG THOSE SAME LINES.

THOSE WERE THE FEES CHARGED BEFORE COVID FOR AREAS THAT WERE USED. HAVE WE BEEN CHARGING FOR UNCLE BILLS OR NICKS OR ANY OF THE PLACES DURING COVID?

>> YES.

FOR THE EXISTING ARRANGEMENTS.

>> HOW IS THAT FAIR?

EVERYONE ELSE GETS OUTDOOR DINING BUT IT'S A PANDEMIC.

WE'RE DOING THIS FOR ECONOMIC REASONS.

WE'RE CHARGING THESE OTHER FOLKS.

>> THAT'S A GOOD QUESTION.

THERE ARE DIFFERENT UNDERLYING ALLOWANCES FOR EXISTING AREAS.

THE FUSION SUSHI, UNCLE BILLS, THOSE ARE ALL PREEXISTING LAND USE ENTITLEMENTS.

>> SURE.

WEREN'T THEY HIT ECONOMICALLY AS WELL?

>> PERHAPS.

UNCLE BILLS.

THE CITY CONTINUED TO CHARGE ON THE WALK STREET PORTION.

>> THAT'S CONSISTENTLY INCONSISTENT AND EQUALLY UNEQUAL.

- >> EVERYONE ELSE IS ASKING STAFF FOR THEIR OPINION TONIGHT.
- >> MY ANSWER IS GOING TO BE, IT IS WHAT IT IS.

ANYTHING THAT WAS ADDITIONAL BUSINESS.

>> THIS ISSUE OF FAIRNESS AND EQUALNESS.

THAT IS THROWN OUT THE WINDOW.

- >> Commissioner Hardesty: ANY OTHER QUESTIONS.
- >> AS IT PERTAIN IT GIFT OF PUBLIC FUNDS, THIS IS DIRECTLY TO CITY ATTORNEY, CAN YOU GIVE US AN UPDATE ON THAT.

WE DID RECEIVE A LIST THAT THESE OTHER CITIES ARE NOT CHARGING, WORRIED ABOUT COVID AND POST COVID RIGHT OF WAY SPACES.

IS THERE ANY SORT OF DETERMINATION ON THIS AND IS THERE AN AMOUNT THAT WE CAN CHARGE THAT JUST GETS US OUT OF THAT CONUNDRUM?

>> I DON'T SEE A CONUNDRUM AT THIS TIME.

IT'S JUST A MATTER OF TIMING.

OTHER CITIES HAVE FOUND THAT IT BRINGS SERVICE TO THE CITY.

RIGHT BEFORE WE DISCUSSED THIS IT WAS JUNE 15TH.

WE WERE WAITING FOR THE GOVERNOR TO MAKE THE ANNOUNCEMENT THAT EVERYTHING WAS BACK TO NORMAL.

IMPLICIT IN BOTH OF THOSE ANNOUNCEMENTS IS THAT WE HAVEN'T REACHED THAT POINT YET, THE BUSINESSES STILL NEED SOME HELP.

THE GOVERNOR TALKED ABOUT THE PROGRAM, HE DIDN'T SAY PROVIDE IT FOR FREE.

IT'S QUOTED IN THE STAFF REPORT, THEY NEED TO RECOUP -- TAKE A QUICK LOOK AT THAT --

- >> TO CONTINUE TO BENEFIT FROM THEIR INVESTMENTS.

THE TEMPORARY CAPITAL IMPROVEMENTS TO BUILD THE DECKS ET CETERA.

YES, OUR OPINION IS AT SOME POINT IT WILL BE A GIFT OF PUBLIC FUNDS.

- I DON'T THINK WE'VE REACHED THAT POINT NOW.
- >> THANK YOU.

ERIC, I WANTED TO ASK YOU A REQUEST ABOUT A COUPLE OF THE NUMBERS YOU HAD.

IF YOU'RE STILL FIFTY FEET AWAY OR WHEREVER YOU ARE.

- >> Commissioner Hardesty: ARE YOU STILL ON THE LINE?
- >> YOU IDENTIFIED THAT THE COST PER PARKING SPACE PER MONTH IS \$750 A MONTH.
- IS THAT JUST THE TWO HOURS A MONTH THAT SPACE IS BEING USED?
- >> CORRECT.

THE AVERAGE IS ONE YEAR DIVIDED BY 12 MONTHS.

- >> IT DOESN'T INCLUDE THE \$100,000 A MONTH IN LOSS REVENUE.
- >> THAT WOULD BE ADDED ONTO THE REVENUE THAT THE CITY WOULD GET.
- >> OKAY.

THANK YOU.

WITH RESPECT TO THE \$3 PER SQUARE FOOT FOR USE OF THE OUTDOOR SPACE, DO YOU HAVE AN AVERAGE OF THE PLACES USING THE SPACE WHAT IT WOULD BE FOR THEM PER MONTH.

>> BASICALLY THE LEAST AMOUNT IS ABOUT \$150 PER MONTH AND THE GREATEST

WOULD BE 250 A MONTH.

DEPENDING ON HOW MUCH LAND THEY ARE USING.

>> OKAY.

THANK YOU FOR THAT.

IS THERE A NUMBER THAT EACH OF THE --

>> I KNOW THERE'S 78 SPOTS OPEN.

HOW MANY RESTAURANTS ARE USING PUBLIC SPOTS OR RIGHT OF WAYS?

>> 80% OF THE RESTAURANTS ARE USING PARKING SPACES.

ABOUT 50% OF THE RESTAURANTS ARE USING LEASABLE SPACE.

>> DO WE KNOW THE NUMBER OF RESTAURANTS THAT ARE DOING THAT.

>> DOING BOTH?

>> HOW MANY RESTAURANTS CURRENTLY ARE USING PARKING SPOTS FOR DINING DECKS, DO WE KNOW THAT NUMBER?

>> TWENTY-FOUR RESTAURANTS ARE USING PARKING SPACES.

FIFTEEN OR SO ARE USING LEASABLE AREAS.

>> HAVE THEY EVER BEEN TOLD MONTHLY HOW MUCH IT WOULD BE FOR LEASING,

DO THEY KNOW WHAT THAT NUMBER IS?

>> NOT DIRECTLY.

AT THE BEGINNING, THEY WERE GO TO GO GET A BILL.

>> JUST ONE MORE OUESTION BECAUSE I FOUND SOME OF THE NOTES.

WE RAISED THE RATES TO \$2, IT WILL RAISE \$750,000 PER YEAR TO MAKE UP FOR IT.

ON THE VERY FIRST PARAGRAPH THE FISCAL APPLICATIONS, WE'RE CURRENTLY LOSING REVENUE OF \$734,000.

IS IT SAFE TO SAY IT'S KIND OF A PUSH, BALANCES OUT DUE TO THE EMERGENCY.

>> NO IT WOULD NOT BE.

THAT IS STRICTLY FOR THE PARKING METER REVENUE.

YOU WOULD WANT TO ADD ON THE PARKING CITATION REVENUE OF \$100,000 OR MORE.

THE POLICED AREAS, THAT WAS ALSO ANOTHER \$114,000 IF YOU WERE USING A \$3.00 RATE.

THAT'S ANOTHER \$200,000 THAT THE CITY IS NOT GETTING IN REVENUE PER YEAR.

>> OKAY.

ALL RIGHT.

THANK YOU.

>> Commissioner Hardesty: OKAY.

I SEE NO OTHER COMMENTS OR REQUESTS FROM MY COLLEAGUES.

WE'LL TURN TO PUBLIC COMMENT.

>> WE HAVE ANDREW.

IF YOU CAN STATE YOUR NAME AND RESIDENCY FOR THE RECORD AND YOU IS HAVE TWO MINUTES FOR PUBLIC COMMENT.

>> I'M ALSO THE LANDLORD OF COFFEE BEAN AND TEA LEAF WHICH HAS VACATED

THE PROPERTY.

THEY DECIDED IN THE MIDDLE OF THE NIGHT WITH NO NOTICE TO VACATE BECAUSE THEY WERE NOT MAKING ENOUGH MONEY TO CONTINUE.

THEY STILL PAY MONTHLY RENT.

- >> THERE'S NO FURTHER QUESTION FOR PUBLIC COMMENT AT THIS I'M.
- >> Commissioner Hardesty: WE'LL CLOSE PUBLIC COMMENT AND RETURN TO COUNCIL DISCUSSION.
- >> I'LL START US OFF, YOUR HONOR.
- I'M CURIOUS WHEN LANDLORDS HAVE DECREASED THE RENTS DURING
- COVID -- CONTINUE TO DECREASE THE RENTS TO HELP THEIR TENANTS OUT DURING THIS PERIOD, VERY FEW HAVE DONE IT.
- WHEN I HEAR PEOPLE TELL ANYWAY THE CITY HASN'T DONE ANYTHING EXCEPT RESTAURANTS OR RETAIL IN THE CITY.

NOR DID HE ASK TO WAIVE ANY FEES.

OUR QUESTION IS SIMPLE.

JUST WAITING FOR SOMEONE TO PRESS THE BUTTON.

I'M GOING TO HOP IN HERE.

I'M SENSITIVE TO WHAT MY COLLEAGUE RICHARD SAID ABOUT TIMING.

I THINK THAT'S PERFECTLY LEGITIMATE.

IT'S A LITTLE BIT OF A STRONG-ARM ARGUMENT.

NOBODY SAID WE'RE WAIVING FEES FOREVER.

IF YOU WANT TO DISCUSS FEES TONIGHT, THAT'S FINE.

THIS IS A DISCUSS AND DIRECT ITEM.

I JUST WANT TO BE CLEAR FOR THE PEOPLE WATCHING AT HOME, WE GOT AN EXTRAORDINARILY INTERESTING PACKET FROM THE CHAMBER OF COMMERCE, IT'S IN CHART FORM, WHICH I LOVE.

IT'S NEVER A GREAT IDEA TO REINVENT THE WHEEL UNLESS YOU'RE ELON MUSK AND GOING TO MARS.

IT'S ALWAYS A GOOD IDEA TO SEE WHAT OTHER GOVERNMENTS ARE DOING. TAKING POLLS AN BEST PRACTICES.

KNOW WHAT YOUR COMPETITORS, NEIGHBORS ARE DOING.

LED ME JUST READ OFF, I THINK THIS IS EXCELLENT WORK DONE BY THE PRIVATE SECTOR.

LET ME READ OFF THE SET OF PRIVATE CITIES THAT WERE POLLED.

LAGUNA BEACH, NEWPORT, SANTA BARBARA, SANTA MONICA, LONG BEACH, VENICE.

THAT'S A REALLY GOOD DATA SET.

IT'S NOT FREMONT AND TEMECULA.

THESE ARE LIKE MINED CITIES.

DURING THE PANDEMIC, IT'S WATER OVER THE DAMN AND MAYBE IT WAS AN OKAY DECISION, WE ARE THE ONLY CITY ON THIS CHART THAT CHARGED PERMIT FEES TO OUR SMALL BUSINESSES.

THE ONLY CITY OUT OF 15 CITIES.

OUR STAFF DID AN AMAZING JOB.

EVERYONE HERE HAS CONTINUAL PRAISED STAFF, EVERYONE PIVOTED AND SCRAMBLED.

EVERYONE HELPED START OUTDOOR DECKS AN DINING.

OUT OF 15 CITIES WE'RE THE ONLY ONES WHO CHARGED PERMIT FEES.

THAT'S SOMETIMES THOUSANDS AND THOUSANDS OF DOLLARS.

I THINK FIVE FIGURES AND HIGHER IF SOMEONE WANT IT QUESTION THAT, WE CAN GET ERIC HERE TO QUANTIFY THE MAXIMUM.

OBVIOUSLY ON A SLOPED STREET IT CAN BE PRICEY TO BUILD.

A BUNCH OF CITIES HAVE DATES OF WHEN THEY'RE GOING TO START CHARGING,

SEVEN OF THE 15 WILL NOT CHARGE UNTIL DECEMBER OF 202021, IT'S JULY NOW.

OTHERS WILL CHARGE MAYBE SEPTEMBER OTHERS NOT UNTIL 2022 AND BEYOND. I WANT TO PUT THAT OUT THERE FOR PUBLIC RECORD.

THE LAST IMPORTANT THING ON THIS CHARGE.

OUT OF 15 COMPARABLE CITIES NO ONE IS CHARGING RIGHT NOW FOR DINING DECKS IN THE PUBLIC RIGHT OF WAY.

I THINK THAT MATTERS.

I DON'T WANT TO BE THE SCROUGE OF SOUTH BAY CITIES.

THEY CAN PUT SIDEWALK TABLES, RACKS.

WE'RE NOT GIVING UP REVENUE WITH THE SIDEWALK TABLES.

I WOULD BEG MY COLLEAGUES, TO WE REALLY WANT TO BE NOT ONLY THE ONLY CITY TO CHARGE IN THE TEETH OF COVID TO BUILD THESE DECKS.

I DIDN'T NOTICE THAT EITHER, MY BAD, WE WERE SCRAMBLING AND DOING THE BEST WE COULD.

DO WE NOW WANT TO BE THE ONLY CITY TO CHARGE ANY AMOUNT OF MONEY FOR THE PUBLIC RIGHT OF WAY UNTIL SEPTEMBER WHEN WE'RE PERMITTING UNTIL SEPTEMBER 7TH OR LABOR DAY?

LASTLY, SOME OF THESE CITIES HAVE SAID THEY WILL NOT CHARGE UNTIL -- WHAT'S THE LATEST DATE?
JANUARY 2022.

ONE IS MARCH 2022.

IF YOU WANT TO TALK ABOUT DATES, I WOULD LOVE TO TALK ABOUT SOMETHING AS LATE AS DECEMBER.

THE LOGICAL DATE IS NOT CHARGING AS LONG AS THE DECKS ARE UP, WE WOULD NOT CHARGE.

I WOULD SUBMIT THAT I DON'T THINK WE WANT TO BE THE FIRST MOVER. WE'VE GOTTEN THE ADVICE FROM THE CITY ATTORNEY THAT THERE'S NO GIFT OF PUBLIC FUNDS.

WE'RE IN LINE WITH THE REST OF THE COUNTY NOT CHARGING FOR PUBLIC RIGHT OF WAY.

OUR BUSINESSES ARE THE FABRIC OF OUR COMMUNITY.

LANDLORDS ARE SMALL BUSINESSES TOO.

A LANDLORD IS A SMALL BUSINESS.

THEY HAVE THE RIGHT TO CHARGE FOR THEIR PRODUCT.

THEIR PRODUCT JUST HAPPENS TO BE A BUILDING.

WE HAVE A LANDLORD HERE IN CHAMBERS, HE HAS THE RIGHT TO CHARGE RENT FOR HIS UNIT AND NOT HAVE A SQUATTER THERE.

TO SAY THAT THE LAND -- I DON'T THINK IT'S FAIR TO SAY THAT LANDLORDS HAVE NOT GIVEN DISCOUNTS AND DEAL IT THEIR BUSINESSES.

IN FACT, I WOULD SUBMIT AND I HAVE NO DATA ON THIS, I WOULD SUBMIT THAT ALL OF THEM PROBABLY HAVE GIVEN DISCOUNTS OR WAIVERS OF RENT DURING COVID OTHERWISE WE WOULD HAVE HAD MORE BUSINESSES FAIL.

I AGREE WITH A LOT OF WHAT YOU SAID.

FILLING A HOLE.

THEY CALL IT FILLING A HOLE WHEN A BUSINESS OR RESTAURANT GOES OUT OF BUSINESS.

THAT TAKES A LONG TIME.

WE ARE SEEING THAT RIGHT NOW.

HOW LONG HAS IT TAKEN THE PAPYRUS SPOT TO ATTRACT A TENANT IN VERY DIFFICULT TIMES TO HAVE THAT TENANT DO THE BUILD-OUT DURING VERY DIFFICULT TIMES WHEN THOSE MATERIALS ARE COSTING MORE.

AND THEN ULTIMATELY OPEN.

IT TAKES A LONG TIME.

THAT'S ZERO SALES TAX REVENUE TO THE CITY.

SALES TAX REVENUE IS THE SECOND LARGEST PRODUCER OF REVENUE FOR THE CITY AFTER PROPERTY TAXES.

IT'S NOT ONLY HELPING THE BUSINESSES AND RESTAURANTS BUT HELPING THE CITY TO THRIVE AND SURVIVE.

WE ARE SO BLESSED WE HAVE GREAT FINANCIAL MINDS, YOU KNOW, THAT TEAM THAT KEEPS THE CITY FINANCIALLY HEALTHY AND TO PREPARE FOR EMERGENCIES.

THIS IS THAT TIME.

IT'S STILL AN EMERGENCY.

THE DEBTS THE RESTAURANTS ARE CARRYING ARE VERY REAL.

WE HAVE HEARD HEART WRENCHING STORIES HOW THEY MAKE UP THOSE NEGATIVE BALANCES.

SO I'M IN FAVOR OF NOT CHARGING THEM UNTIL IT BECOMES, YOU KNOW, AS LONG AS ITS FEASIBLE UNTIL THE END OF THE YEAR.

WHAT ALSO DOES IT SAY ABOUT ATTRACTING NEW BUSINESS TO MANHATTAN BEACH WHEN THEY SEE THAT WE ARE A TRUE PARTNER WITH THEM, A PROSPECTIVE BUSINESS COMING IN AND SAY THEY WENT TO BAT FOR THE BUSINESSES, THEY CARE ABOUT OUR BUSINESSES?

WE WANT TO MAKE THIS HOME.

YOU KNOW, IT'S LIKE MR. GOLDSTEIN SAID, TO MAKE AN INVESTMENT IN MANHATTAN BEACH, IT ISN'T JUST COLD NUMBERS.

THEY ARE MAKING AN INVESTMENT.

THAT'S WHAT YOU WANT.

THAT'S THE HEART AND SOUL OF THE RESTAURANTS AND STORES THAT WENT IN HERE.

I WENT INTO A COUPLE OF RETAILERS YESTERDAY TO TALK ABOUT THE IMPACT AND EVERYTHING.

I SAID IS ALL THAT HUBBUB BOTHERING YOU? SHE SAID IT'S JUST NOISE. THE CITY NEEDS TO BE THAT TEAM PLAYER AS WELL.

THE RESTAURANTS ALSO NEED THAT OUTDOOR RIGHT OF WAY, THEY AREN'T PAYING FOR IT NOW.

I THINK IT WAS DESCRIBED AS A LOSS.

IT'S NOT REALLY A LOSS THERE.

BUT THEY NEED THOSE OUTDOOR SPACES.

PUBLIC HEALTH IS TELLING US.

PEOPLE ARE STILL CONCERNED ABOUT THAT.

THEY WANT TO FEEL COMFORTABLE BY EATING OUTDOORS.

IT'S MADE UP BETWEEN A COMBINATION OF THE INSIDE AND KEEPING SOME DISTANCING THERE BETWEEN TABLES AND HAVING PEOPLE SIT OUTSIDE.

SO THAT'S STILL GOING TO GO ON.

EVERYBODY HAS A MASK ON THE PLANE.

SOME WOULD PROBABLY PREFER NOT TO BUT STILL A LOT OF PEOPLE DO PREFER.

THEY NEED THAT EXTRA MONEY TO MAKE UP FOR A VERY BIG DEFICIT.

AND WE WANT THEM TO SUCCEED BECAUSE WE DON'T WANT THEM LEAVING.

WE WANT TO MAKE SURE THAT THEY CAN PAY THE LANDLORDS.

I'VE HEARD -- RESTAURANTS ARE HAVING, YOU KNOW, A COUPLE GOOD MONTHS HERE, LET'S HELP THEM CONTINUE TO HAVE SOME MORE.

NOT CHARGING IF THE PUBLIC FUNDS IS NOT AN ISSUE, LET'S NOT CHARGE THEM.

HERMOSA DID CHARGE FEES FOR THE PERMITS THOUGH.

I HAVE NO PROBLEM WITH THE PERMIT FEES WE CHARGE BECAUSE THAT'S STAFF TIME.

STAFF TIME.

SOMEONE HAS TO PAY.

IT'S TO ENSURE SAFETY AND THE FACT WE HAVE THEY ARE THE SAFEST AND BEST AROUND, THERE'S A REASON FOR THAT.

AND THE PERMITTING IS PART OF THAT.

IT COSTS.

AND THAT'S THE COST OF DOING BUSINESS AND EVERYBODY DID IT.

WE HAVE BEEN GETTING COMPLAINTS ABOUT THAT.

WE GOT COMPLAINTS ABOUT HOW MUCH AND HOW QUICKLY IT TOOK BUT YOU KNOW, THEY ALSO UNDERSTOOD THAT PLANS CHANGED ALONG THE WAY.

IT WASN'T NECESSARILY STAFF THAT CHANGED THOSE PLANS.

SO AS FAR AS BEST PRACTICES GO.

THERE ISN'T ANY DECLARED BEST PRACTICES HERE.

THERE'S A BUNCH OF CITIES.

SINCE WE AGREE WITH WHAT THEY ARE DOING, WE WILL SAY IT'S A GOOD THING BUT THERE'S PLENTY OF INSTANCES CITIES DO THINGS WE DON'T DO.

WE THEY SAY WE AREN'T GOING TO FOLLOW THEM.

THERE'S REALLY NO SET LINE OR PRECEDENT TO FOLLOW.

THIS IS WHAT IS HAPPENING NOW.

WE GET IT, WE WANT TO BE FAVORABLE TO BUSINESS.

I'VE GOT NO PROBLEM WITH THAT.

BUT THE THINGS I DO HAVE MORE OF AN ISSUE WITH IS WE SAY WE AREN'T BEING CHARGED AND PART OF THE DEAL.

SO WHAT ON THE DOWNTOWN BUSINESS ASSOCIATION THAT LUNCH WOULD BE SERVED.

THESE RESTAURANTS WOULD TAKE ON LUNCH.

I HAVE HEARD ABOUT THE STAFFING SHORTAGES.

WE ARE ALSO SEEING STAFFING SHORTAGES BUT THEY NEED THE OUTDOOR SPACE. YET SOME OF THE OUTDOOR SPACE ISN'T BEING USED DURING THE WEEK. WHEN WE TALK ABOUT BEING OUTDOORS WE ARE TALKING WITH A LOT OF ANECDOTES TONIGHT.

I WAS THERE WATCHING BOTH SIDES WEST OF THE STREET, WEST OF OCEAN BEING UNUSED, UNOCCUPIED, PACKAGED UP AND I LOOK AT THE RESTAURANTS THAT HAVE THOSE DECKS AND THEY ARE PACKED INSIDE.

AND SOME OF THOSE PLACES HAVE DOORS THAT OPEN WIDE OPEN.

WHAT'S INDOOR AND WHAT'S OUTDOOR ANYMORE.

IT'S SEEING THOSE KINDS OF THINGS.

YES, OKAY, WE ARE IN THIS TOGETHER AS WE HAVE BEEN.

DON'T TELL ME WE HAVEN'T DONE ANYTHING FOR BUSINESS HERE.

I'M NOT LOOKING FOR APPLAUSE BUT I'M NOT LOOKING TO BE TOLD WE HAVEN'T DONE ANYTHING EITHER BECAUSE THAT'S SIMPLY NOT TRUE.

WHEN WE ARE TALKING ABOUT HOW TO MAINTAIN BALANCE AND HOW TO WORK TOGETHER, IT ALSO MEANS WE HAVE EXTRA EXPENSES TOO.

THE DIRECTOR OF THE DOWNTOWN BUSINESS ASSOCIATION, ON MAY  $25 \, \text{th}$  AT 6:15 AFTER THE MEETING ALREADY STARTED EMAILED COUNCIL WITH A LIST OF 7-8 BUDGET ITEMS THEY WANT CONSIDERED.

THEY WOULD HAVE BEEN, IN A LOT OF INSTANCES ADDITIONAL FUNDS THAT WOULD HAVE BEEN REQUIRED.

THOSE FUNDS NEED TO COME FROM SOMEWHERE.

NOT GOING TO TAKE FROM THE STORMWATER SO WE HAVE TO MAKE UP FOR IT SOMEWHERE ELSE.

IF WE ARE TALKING ABOUT SHARED BURDEN, I UNDERSTAND THERE'S ARE BURDENS.

WE HAVE HEARD A LONG WAY, AND SOME BUSINESSES STAYED OPEN DURING THE PANDEMIC AND STILL OPEN.

I DON'T KNOW A BUSINESS THAT'S GONE OUT IN MANHATTAN BEACH BECAUSE OF THE PANDEMIC.

THIS IS VERY MUCH, I KNOW IT'S BECAUSE THE DOLLARS THAT WOULD BE PAID BY THE RESTAURANTS THAT ARE DOWNTOWN.

BUT WHEN WE TALK ABOUT HELP AND HOW WE HAVE TO MAKE SURE THEIR BUSINESSES, BUSINESSES WE ALL WANT TO DO AND ALL SAID THAT ALONG THE WAY WE HAVE TO ALSO CONSIDER WHAT OTHERS ARE DOING.

THAT'S WHY I BROUGHT UP THE FAIRNESS ISSUE OF RESTAURANTS THAT HAVE THAT OUTDOOR SEATING ELEMENT THAT HAD TO PAY FOR IT DURING THE PANDEMIC, STELE HAD ECONOMIC ISSUES, SAME AS OTHER RESTAURANTS. RESTAURANTS THAT DON'T HAVE THE SAME ADVANTAGE OF HAVING AN OUTDOOR DECK OR OCEAN VIEW ON MANHATTAN BEACH BOULEVARD, SEPULVEDA OR

ELSEWHERE IN THE CITY.

THEY DON'T GET ANY OF THIS AND THEY ARE SURVIVING.

WE SHOULD BE THERE FOR THEM JUST AS MUCH AS ANYWHERE ELSE.

SPACE ACROSS INDOOR, OUTDOOR, THE SIX-FOOT SEPARATION, IS ANYONE CHECKING UP ON THAT? IT'S A RECOMMENDATION, THEY DON'T HAVE TO DO THAT.

THEY DON'T HAVE TO DO THAT.

I WOULD BE SURPRISED IF ANYONE REALLY IS.

BUT ASIDE FROM THAT, YOU KNOW, I'M FINE WITH THE SIX-FOOT.

WHEN WE REACH THAT SEPTEMBER POINT WE KNOW WE WILL TALK ABOUT THIS AGAIN.

SOMEONE WILL TALK ABOUT HOW WE NEED TO TALK ABOUT MAKING A PERMIT. SO YOU KNOW, WE SET UP EXPECTATIONS WITH THE COMMUNITY RIGHT NOW OVER CERTAIN DECISIONS THAT HAVE BEEN MADE.

SO WHEN THIS COMES UP AGAIN, YOU KNOW, WE TALK ABOUT WHAT IT TAKES TO MAKE EVERYONE WHOLE, YOU CAN'T HAVE IT BOTH WAYS.

YOU CAN'T TRY TO MAKE THESE PERMANENT AND SAY WE AREN'T GOING TO PAY WHAT YOU ARE SUPPOSED TO PAY OR PUBLIC PROPERTY AND THE MONEY WE ARE LOSING IS THE PARKING.

WE AREN'T GOING TO GET BACK TO CITATIONS, THAT'S FINE, WE NEED THAT EXTRA MONEY AND WE CAN COME BACK TO THAT.

IT'S NOT A SHARED BURDEN, IT'S ALL BEING PUT ON THE CITY.

THAT'S FINE, WE WILL TAKE IT FOR NOW BUT CAN'T FOREVER.

THERE ARE OTHER NEEDS IN THE CITY.

WE CAN'T GUARANTY EVERY OUTCOME, AS I HAVE HEARD SO MANY TIMES WE AREN'T PICKING WINNERS AND LOSERS, BUT WE ARE. THANK YOU.

>> MAYOR PRO TEM HASN'T SPOKEN YET.

>> THANK YOU.

YEAH, SO, I'M HEARING A LOT OF SIMILAR CONCERNS AND SIMILAR SUPPORT FOR OUR RESTAURANTS.

IT'S BEEN AN INTERESTING YEAR AND A HALF.

WE ALWAYS REALLY APPRECIATED OUR BUSINESSES BUT IT'S NEVER BEEN THIS CONVERSATION WE HAVE HAD IN THE LAST YEAR AND A HALF ABOUT JUST HOW IMPORTANT OUR RESTAURANTS ARE TO THE BROADER BUSINESS DISTRICT.

WE HAVE HEARD THAT AND REALLY SEEN THE EVIDENCE OF THAT.

WE HAVE SEEN THE EVIDENCE FROM EVEN OUR NON-RESIDENTS AND RETAIL BUSINESSES THEY KEEP ASKING US TO HELP THE RESTAURANTS BECAUSE IT HELPS THEM AS WELL.

SO WE RESPONDED TO THAT AND HAD THOSE DISCUSSIONS OVER AND OVER AGAIN. AND I THINK THAT WE'VE ALL REALLY COME TO THAT UNDERSTANDING AND WE HAVE REALLY RESPONDED TO IT IN A WAY THAT WAS VERY SUPPORTIVE OF THE RESTAURANTS AND BECAUSE WE WANT TO SUPPORT THE GREATER BUSINESSES. BUT I DO, YOU KNOW, I AGREE, THIS IS A TEMPORARY MEASURE.

THIS IS THE MEASURE TO CONTINUE TO GET OVER THE COVID HUMP, TO GET OVER THE IMPACTS OF COVID.

THAT WHEN WE GET TO THE POINT WE REALLY REVISIT WHETHER WE ARE GOING TO CONTINUE OUTDOOR DINING IN SOME PERMANENT WAY THAT IS A MORE COMPREHENSIVE WAY, THAT'S A WHOLE DIFFERENT DISCUSSION THAN WHETHER WE ARE GOING TO TRY TO DO THIS FOR THIS TEMPORARY REASON OF ASSISTING THE RESTAURANTS TO CONTINUE TO MAKE UP FOR THE NEGATIVE IMPACTS THEY HAVE HAD BECAUSE OF COVID AND WE KNOW THAT THEY HAVE.

ONE OF THE THINGS I WAS A LITTLE SURPRISED BY AND THE REASON I ASKED ERIC THE QUESTION, DO WE KNOW WHAT THE COSTS WILL BE.

DO WE WANT TO JUST BLANKETLY WAIVE THE FEES, IF THAT'S OUR DETERMINATION? OR DO WE WANT TO LET THE RESTAURANTS KNOW WHAT THEIR ACTUAL MONTHLY FEE WOULD BE, SO THEY CAN ALSO BE, AS WE HAVE STATED OVER AND OVER, A PARTNER IN THIS DECISION.

SO THEY CAN LOOK AT WHAT THOSE FEES ARE AND SEE IF POTENTIALLY THERE IS SOME CONTRIBUTION THEY DO WANT TO MAKE TO THE FEES, IF THEY KNEW WHAT THE FEES WERE.

WE JUST HEARD THAT ONE OF THE, THE AVERAGE RANGE FOR THE USE OF THE PUBLIC SPACES, NOT THE PARKLETS COULD BE 150 A MONTH.

WELL, YOU KNOW, WE ARE ALL WORKING IN THIS TOGETHER.

THESE ARE THE COSTS POTENTIALLY BEING WAIVED, IS THERE ANYTHING YOU WOULD LIKE TO CONTRIBUTE TO THE CITY SO WE ARE ALL CONTRIBUTING IN THIS WAY TO SUPPORT BOTH THE CITY AND SUPPORT THE BUSINESSES.

RIGHT NOW WE HAVE THIS SEPTEMBER 7th DATE, IT SEEMS TO ME WE WOULD TIE THE WAIVER, TO WAIVE TO THAT DATE.

THERE >> WE HAVE 40 MILLION.

THAT'S NOT COMPARABLE.

HAS TO BE SOUTH BAY CITIES SIMILAR IN SIZE.

IF THAT'S NOT COMPARABLE OUT.

HOW MANY KNOW WE HAVE 12 NEW RESTAURANTS AT OUR MALL? ANYBODY? GUESS WHAT, THEY HAVE NO CONCESSIONS.

THEY HAVE NO PARKLETS, THEY HAVE NO METERS.

NO ONE IS GIVING THEM A HAND.

NONE HAVE CLOSED EITHER.

MANY OF THEM OPENED IN COVID AND THEY ARE STRUGGLING LIKE EVERYBODY ELSE.

BUT YES, THEY GET NO HELP FROM THE CITY.

THE HANGER INN, HAVE THEY GOT ANYTHING FROM THE CITY? NO.

WE'RE NOT TALKING ABOUT JUST DOWNTOWN, LAST TIME I CHECKED.

IT IS DOWNTOWN, NORTH END, EAST SIDE, WEST SIDE, EVERYBODY ELSE. IT'S CITYWIDE.

CITY COUNCIL'S GOAL IS EVERYONE.

BEFORE WE WAVE THE MAGIC WAND AND SAY HERE IT IS, WHY DON'T WE TELL THEM WHAT THEY MIGHT BE RESPONSIBLE FOR.

I LIKE THAT.

I KNOW I TALKED TO ONE RESTAURANT OWNER AND SAID, LOOK, WOULD I RATHER PAY FOR IT? NO.

BUT IF I HAD TO, WOULD I DO IT? YES.

HE BELIEVES IN A FAIR SHARE APPROACH.

SOME PEOPLE WANT TO PAY WHAT THEY CAN FOR IT AND OTHERS DO NOT, OR WILL NOT OR CANNOT, WHATEVER THAT CHOICE MAY BE.

I LIKE THE IDEA.

AND THE SEPTEMBER IDEA OF RECONCILIATION, IF WE ARE TELLING THEM DECKS ARE GONE BY SEPTEMBER 2nd OR WHATEVER THAT DATE MIGHT BE WE CAN'T COME AROUND AND WAVE THE MAGIC WAND.

IT'S A COMMONSENSE APPROACH.

I WOULD SUPPORT THE SEPTEMBER 7th DATE.

BUT I WOULDN'T GO FARTHER THAN THAT.

THAT'S IT.

>> THANK YOU, RICHARD.

I WILL WRAP UP HERE.

I AM FINE WITH TYING, AND I THINK I SAID IN MY COMMENTS I DON'T KNOW WHY WE WOULD EXTEND THE FEES PAST SEPTEMBER 7th SINCE THE DECKS ARE COMING OUT SEPTEMBER 7th.

I THINK THAT'S NEWS OF THE TOPOLOGICAL AS WALL STREET CALLS IT. IF THAT ALLAYS CONCERNS CREEPING THESE FORWARD, BUT WE WOULDN'T BE CHARGING FOR DECKS THAT DON'T EXIST IN SEPTEMBER AND OCTOBER.

I WOULD BE FINE TYING THOSE DATES TOGETHER.

I WANT TO THANK THE CHAMBER AND DBPA FOR DOING THE WORK.

I AGREE WITH RICHARD TWO OF THE CITIES AREN'T COMPARABLE, BUT EL SEGUNDO, BEVERLY HILLS, REDONDO BEACH AND TORRANCE ARE PRETTY DARN COMPARABLE.

I ALSO WANT TO SAY THE RETAILERS AND MAYOR PRO TEM STERN AND COUNCILMEMBER FRANKLIN SAID THAT AS WELL.

THE RETAILERS WANT THE RESTAURANTS TO SURVIVE AS WELL.

AND THE CHAMBER AND DOWNTOWN BUSINESS GROUPS HAVE RELENTLESSLY POLLED AND TALKED TO NOT JUST THE RESTAURANTS BUT IT IS AN ORGANIC LIFT THAT HELPS ALL BOATS.

THE MORE IT HELPS THEM ALL AND HELPS THE HOTELS.

WE DO TALK ABOUT THE DOWNTOWN AS THE JEWEL OF THE SOUTH BAY FOR A REASON AND THE HEALTHIER THEY ARE AND FEWER BOARDED UP STORE FRONTS, AS JOE SAID, THE BETTER.

AND THEN I WOULD SAY THAT SOME OF THE BUSINESSES OUTSIDE OF THE DOWNTOWN DO HAVE THE BENEFIT OF PARKING LOTS LIKE MANHATTAN BEACH HOUSE AND HANGER INN.

AND PARKING LOTS ARE PERMITTED TO HAVE STRUCTURES ON THEM UNLIKE THE DOWNTOWN.

SO THE DOWNTOWN IS UNIQUELY CROWDED AND CRAMPED.

I ALSO WANT TO SAY TO RESIDENTS DOWNTOWN, I'VE BEEN CONSISTENT. ANYONE WHO HAS EMAILED, BUTTONHOLED ME, CALLED ME, SEEN ME AT THE LIBRARY, I HAVE HAD TWO TRACKS ON THESE DINING DECKS.

ONE IS TEMPORARY AS MAYOR PRO TEM STERN SAID TO GET US THROUGH COVID. AND THE OTHER IS PERMANENT.

TO GET US THROUGH.

THERE IS NO AGENDA, AT LEAST ON MY PART TO YOU KNOW, CREEP THESE TEMPORARY ONES INTO PERMANENT.

I HAVE BEEN CLEAR ABOUT THIS IN EVERY SINGLE MEETING.

I THINK ANY BUSINESS WHO HAS EVER TALKED TO ME ABOUT IT AND EVERY DOWNTOWN RESIDENT I HAVE SAID TWO ENTIRELY DIFFERENT DECISIONS.

THIS, AS MAYOR PRO TEM STERN LAID IT OUT WELL, THIS SUMMER, IT'S ABOUT THE TEMPORARY DECKS THAT ARE SET TO EXPIRE IN SEPTEMBER.

THIS IS NOT ABOUT THE PERMANENT DECKS.

AND OF COURSE, IF THEY ARE PAYING FOR THESE PERMANENT DECKS AND HUGE ARCHITECTURAL FEES AND THEY HAVE TO BE CONTIGUOUS TO THE RESTAURANT AND OF COURSE THAT WILL INVOLVE PAYING FOR THE USE OF THE RIGHT OF WAY THAT'S A CONDITION.

BUT AS HILDY SAID THIS IS ALL TEMPORARY RIGHT NOW.

LASTLY, NO ONE IS TALKING ABOUT.

THIS IS NOT THE CAMEL'S NOSE UNDER THE TENT MAKING THE PUBLIC RIGHT OF WAY FREE FOREVER.

I STRONGLY PUSH BACK ON THAT.

I DON'T THINK WE HAVE EVER DISCUSSED THAT.

THERE'S NO HIDDEN AGENDA HERE AT LEAST ON MY PART AND I JUST WANT TO PUT THAT TO BED.

BUT I DO THINK OUR DOWNTOWN IS SPECIAL.

THE BEACH IS SPECIAL.

THE BEACH IS DOWNTOWN.

THE BEACH HELPS BRING PEOPLE.

THEY MIGHT HAVE BEACH DOWNTOWN AND GO TO THE MALL TO EAT.

RICHARD, ANY BUSINESS THAT OPENED DURING OR AFTER COVID HAD THE OPTION TO WAIT UNTIL DURING OR AFTER COVID.

THESE WERE BUSINESSES DOWNTOWN THAT WERE IN EXISTENCE BEFORE COVID AND THIS UNIQUE SITUATION HIT THEM HARD.

I AGREE.

I THINK HILDY LAID IT OUT THE BEST.

THIS IS TEMPORARY, THIS IS FOR NOW.

LET'S TIE IT IN WITH SEPTEMBER, I WOULD COMPLETELY AGREE WITH THAT, THE PUBLIC DECKS WOULD COME OUT AND A WHOLE DIFFERENT DISCUSSION. I HAVE SAID THAT FOR EVERY DOWNTOWN RESIDENT, EVERY EAST SIDE, EVERY MALL BUSINESS, CHAMBER DIRECTOR AS WELL.

SO WITH THAT, RICHARD MIGHT WANT TO MAKE A MOTION.

THERE'S A LOT OF RESTAURANTS OPENED PRIOR TO COVID THAT SUFFERED THROUGH.

NOT JUST DURING COVID, POST COVID, NOT OFFICIALLY OUT OF COVID YET. BUT WITH THAT I WILL MAKE THE MOTION THAT WE EXTEND THE LACK OF BETTER WORD, WAIVER, UNTIL SEPTEMBER 7, 2021.

THAT'S CITYWIDE.

LET'S BE CLEAR.

CITYWIDE.

TO GO FORWARD.

- >> CAN WE INCLUDE IN THE MOTION WE SEND A LETTER TO THE RESTAURANTS THAT INDICATES THE AMOUNT OF THEIR WAIVER.
- >> I WOULD ACCEPT THAT AS A FRIENDLY AMENDMENT.

>> Mayor Hadley: THEY WERE PAYING THAT BEFORE COVID.

I AGREE THEY SHOULD ALSO BE WAIVED.

HOW MANY MONTHS?

3-4 MONTHS THEY COULDN'T SEAT ANYBODY OUTDOORS.

THEY COULD ONLY DO TAKE-OUT.

AND THE METER WAS STILL RUNNING.

- >> S. Napolitano: BUT THEY WERE STILL PAYING.
- >> Mayor Hadley: THAT'S A GOOD POINT.

OCEAN VIEW CAFE HAS NO INDOOR DINING, I BELIEVE.

IT'S ALL ON THE PUBLIC -

- >> S. Napolitano: NO PARKLET EITHER.
- >> R. Montgomery: WOULD YOU LIKE ME TO RESTATE THE MOTION TO MAKE IT EASIER?
- >> Mayor Hadley: YEAH.
- >> R. Montgomery: MY MOTION IS WE CONTINUE TO WAIVE ALL RIGHT OF WAY METER FEES CITYWIDE FOR THOSE RESTAURANTS THAT CURRENTLY HAVE THOSE PROPERTIES.

AND THEN TIE IT TO SEPTEMBER 7th AND SECOND MOTION IS THAT THOSE RESTAURANTS THAT HAD OUTDOOR DINING PRIOR TO COVID, THAT WE WAIVE THEIRS AS WELL UNTIL SEPTEMBER 7th.

MEANING, THOSE THAT HAD PAID THE CITY FOR OUTSIDE DINING PRIOR TO COVID.

>> MAYOR AND MEMBERS OF THE CITY COUNCIL, IF I COULD ASK A QUESTION FOR CLARIFICATION.

THERE ARE SEVERAL RESTAURANTS THAT DO HAVE OUTDOOR SEATING.

BUT IT'S A SLIGHT DIFFERENCE BETWEEN -- IT'S NOT IN A PARKING SPACE AND IT'S NOT IN- STREET DINING.

IT'S A LITTLE BIT DIFFERENT FROM THE OUTDOOR DINING THAT WAS AUTHORIZED AS A MATTER OF COURSE DURING THE EMERGENCY.

THERE IS A NUANCE THERE.

WHILE IT WAS LONG-STANDING IT WAS NOT IN A PARKING SPACE AND NOT IN THE STREET RIGHT OF WAY.

THERE'S A BIT OF A DIFFERENCE THERE.

AGAIN, IT'S A DECISION THAT IS OBVIOUSLY ABLE TO BE DISCUSSED AND DECIDED UPON BY THE COUNCIL.

BUT I DO WANT TO POINT OUT THERE'S A SLIGHT DIFFERENCE.

>> THERE'S A PERMIT FEE FOR THE SIDEWALK BUT NOT A PER SQUARE FOOT LEASABLE FEE.

NUANCE.

PICKING UP WITH ITEM K-16, ENTERPRISE PROJECT IMPLEMENTATION QUARTERLY UPDATE.

TERRY HACKELMAN.

>> HELLO MAYOR AND MEMBERS OF THE COUNCIL.

I WANT TO BRIEFLY [INDISCERNIBLE] [OFF MIC] MY NAME IS TERRY HACKELMAN.

I'M THE CITY'S IT DIRECTOR, PROVIDING THE ENTERPRISE PROJECT IMPLEMENTATION QUARTERLY UPDATE.

WHEN THE COUNCIL APPROVED THE ENTIRE LAND MANAGEMENT SOLUTIONS BACK IN JULY 2019 THEY REQUESTED A QUARTERLY UPDATE AND WE ARE DOING THAT AT THIS POINT IN TIME.

I WILL KEEP MY PRESENTATION PRETTY BRIEF TONIGHT BECAUSE I WANT TO TURN IT OVER TO STEVE, DIRECTOR CHARELIAN AND THE FINANCE DEPARTMENT TO UPDATE YOU ON SOME OF THE NEW THINGS WE ARE DOING WITH THE FINANCIAL SYSTEM THIS PAST JANUARY.

THE PURPOSE OF THE ENTERPRISE PROJECT IMPLEMENTATION TAKING YOU BACK WAS TO REPLACE SEVERAL OF THE CITY'S LEGACY OUT OF DATE SYSTEMS. THE FIRST IS THE E.R.P.

SYSTEM, WE ARE IMPLEMENTING THE SYSTEM TO REPLACE THE LONG-STANDING

FINANCE SYSTEM.

THE NAV UNI SYSTEM WILL SUPPORT FINANCE, PAYROLL, H.R., UTILITY BILLING, LICENSING AND ASSET MANAGEMENT.

IT'S A COMPREHENSIVE SOLUTION WE ARE PUTTING IN.

THE LAND MANAGEMENT SYSTEM, SOMETIMES REFERRED TO AS THE PERMITTING AND PLANNING SYSTEM REPLACED THE BUS SYSTEM FOR A SIGNIFICANT TIME AND THAT WAS REPLACED WITH THE ENTERPRISE SYSTEM.

SUPPORTING PLANNING, PERMITTING, INSPECTION AND CODE ENFORCEMENT FUNCTIONS THAT CITY PERFORMS.

IN ADDITION TO THESE TWO CORE SYSTEMS WE HAVE BEEN IMPLEMENTING SHARED TECHNOLOGIES AND INFRASTRUCTURE.

THINGS THAT SUPPORT THE ELECTRONIC PAPERLESS WORKFLOW PROCESSES ONLINE DOCUMENT MANAGEMENT, PORTALS, PAYMENT, REPORTING AND A NUMBER OF OTHER KEY SHARED SYSTEMS THAT BOTH THESE SYSTEMS ARE INTEGRATED TO MAXIMIZE THE AUTOMATION AND TAKE STEPS TO STREAMLINE SOME OF OUR PROCESSES.

OVERALL, THE SYSTEMS WERE IMPLEMENTED TO ACHIEVE EFFICIENT PROCESSES.

THEY WERE ALSO TO IMPROVE INFORMATION SHARING AND ALSO PROVIDE AND IMPROVE THE OVERALL CUSTOMER SERVICES.

IN THE PAST YOU HEARD BENEFITS FROM THE SYSTEM IMPLEMENTED AND IN A FEW MINUTES YOU WILL HEAR ABOUT BENEFITS FROM THE UNI SYSTEM WE RECENTLY IMPLEMENTED.

I WANT TO GO BACK REAL QUICK TO KIND OF BRING YOU UP TO SPEED ON THE ENTERPRISE SYSTEM.

ORIGINALLY IMPLEMENTED IN JANUARY 2020, PRIMARILY TO SUPPORT THE PERMITTING AND PLANNING ACTIVITIES AND IMPLEMENTATION FOCUSED ON BUILDING SAFETY PERMITS CUSTOMER SELF SERVICE PORTAL, THE ABILITY TO TAKE ONLINE PAYMENTS TO BE MORE CONVENIENT FOR THE CITIZENS. SINCE THAT INITIAL IMPLEMENTATION STAFF HAS CONTINUED TO IMPLEMENT MUCH MORE OF THE SYSTEM ITSELF.

JUST RECENTLY WE WENT THROUGH AN UPGRADE TO A NEW RELEASE TO TAKE ADVANTAGE OF NEW FEATURES AND FUNCTIONALITY THAT EXISTED IN THE NEWEST RELEASE AND TECHNOLOGY STANDARDS ISSUES WITH THE PRODUCT. IT'S IMPORTANT TO REMIND YOU THAT THE RELEASE IMPLEMENTATIONS ARE ACTUALLY PART OF OUR STANDARD AGREEMENT.

THE CITY HAS THE ABILITY AT OUR CHOICE TO UPGRADE TO ANY NEW RELEASES OF THE SOFTWARE AT NO ADDITIONAL COST.

MOVING ONTO THE MUNIS SYSTEM, WE IMPLEMENTED THE FINANCIAL MODULES WHICH HAS CERTAINLY IMPACTED THE FINANCE DEPARTMENT BUT QUITE FRANKLY IT IMPACTS ALL OF THE CITY STAFF THAT ARE INVOLVED IN OUR FINANCIAL PROCESSES.

THAT IMPLEMENTATION SCOPE INCLUDED THE GENERAL LEDGER, THE BUDGET, ACCOUNTS RECEIVABLE, ACCOUNTS PAYABLE, GENERAL BILLING, PROJECT ACCOUNTING, CONTRACT S PURCHASING AND CAPITAL ASSETS AND PROBABLY A FEW THINGS THAT STEVE AND LIBBY MIGHT EXPAND BEYOND THOSE.

CURRENTLY WE ARE IN THE PROCESS OF THE PHASE OF SECOND PART OF MUNIS,

THE HUMAN CAPITAL MANAGEMENT, PAYROLL AND HUMAN RESOURCES.
THESE MODULES ARE SCHEDULED TO GO LIVE ON THE FIRST PAYROLL IN
SEPTEMBER AND THE PROJECT IS MOVING ALONG ACCORDING TO PLAN AND ON

WHAT'S IMPORTANT IS HOW DO WE GET RID OF PAPER AND MAKE THE PROCESS MORE EFFICIENT SO STAFF CAN BE MORE EFFICIENT AND THAT'S BEEN A BASIC TENET WE HAVE BEEN FOCUSED ON.

IN SEPTEMBER WHEN WE COMPLETE THE IMPLEMENTATION OF THE UNI CAPITAL MANAGEMENT MODULES WE WILL MOVE ON TO THE BUSINESS LICENSE MODULES GO LIVE JUNE 2022.

ENTERPRISE ASSET MANAGEMENT AND THE TRANSPARENCY MODULE FOR DECEMBER 2022

AND ULTIMATELY WE WILL WRAP UP WITH THE UTILITY BILLING MODULES GOING LIVE IN JUNE 2023.

SO A VERY DELIBERATE SCHEDULE, A VERY ATTAINABLE SCHEDULE WE ARE PLANNING AND RESOURCING ACCORDINGLY.

I'M HAPPY TO TELL YOU BOTH OF THESE PROJECTS, ALL OF THE PROJECTS AND ACTIVITIES WE ARE DOING ARE PROGRESSING ON TYPE ACCORDING TO OUR AMENDED COVID SCHEDULE.

IN ADDITION, THEY ARE ON OR UNDER BUDGET AT THIS TIME AND WE ONLY INTEND TO KEEP TO THAT BUDGET.

WITH KIND OF A CONTINUOUS MIND SET IMPROVEMENT MINDSET AS WE IMPLEMENT THESE, WE WILL CONTINUE TO LOOK AT NEW RELEASES THAT ARE COMING OUT FOR THE SOFTWARE SOLUTIONS THAT WE HAVE IMPLEMENTED AND WHENEVER POSSIBLE WE WILL CERTAINLY TRY TO IMPLEMENT THOSE RELEASES TO TAKE ADVANTAGE OF NEW FEATURES AND FUNCTIONS AND CERTAIN AUTOMATED PROCESSES IMPROVE HOW WE DO BUSINESS TODAY.

AGAIN, WHEN WE DO THOSE NEW RELEASES THEY CERTAINLY TAKE STAFF TIME AND EFFORT TO DO IT BUT THERE'S NOT AN INCREDIBLE COST, THE RIGHTS TO THOSE RELEASES ARE COVERED UNDER THE TYLER MAINTENANCE AGREEMENT WE HAVE IN PLACE FOR ALL.

IN ADDITION WHAT WE ARE LOOKING AT FOR RELEASE MANAGEMENT ON THE MODULES.

THE I.T. TEAM IS LOOKING FOR WAYS TO MANAGE THE COMPLEX SYSTEMS WE HAVE IN PLACE TODAY WITH SPECIAL EYE PROTECTING THE SYSTEMS.

WE ARE CONTINUING TO LOOK AT LEVERAGING SOLUTIONS WHEN APPROPRIATE, SOMETHING SIMILAR WE BROUGHT TO COUNCIL WITH THE TYLER DISASTER RECOVERY.

AND CERTAINLY AS OPPORTUNITIES ARISE TO IMPROVE OUR TECHNOLOGY INFRASTRUCTURE, WE WILL CONTINUE TO REMAIN OPEN TO THE CLOUD, PARTICULARLY ONE THAT COULD BE MORE COST EFFECTIVE TO THE CITY. I'M EXTREMELY PROUD TO PROVIDE YOU AN UPDATE WITH OUR NEW FINANCIAL

SYSTEM, MUNIS, AS TERRY MENTIONED WENT LIVE IN JANUARY.

WE HAVE BEEN LIVE NOW FOR ABOUT SIX MONTHS THROUGH THE BUDGET PROCESS. VERY PROUD TO REPORT THAT.

THIS PROJECT WAS A MULTI-YEAR IMPLEMENTATION WITH UPGRADING OUR FINANCIAL SYSTEM FROM THE LATE 1990'S WHICH WAS ABOUT 20 YEARS OLD AND THAT REACHED ITS END OF LIFE.

IT'S BEEN A TREMENDOUS EFFORT TO MAKE IT TO THIS POINT AND I WANT TO REITERATE OUR THANKS TO THE FINANCE AND I.T.

DEPARTMENT FOR THEIR SUPPORT AND [OFF MIC] IT'S ALSO IMPORTANT TO RECOGNIZE THE END USERS AND OTHER DEPARTMENTS THEY WORKED INSIDE OUT.

EVERYONE REALLY STEPPED UP TO THE NEW SYSTEM, THE TRAINING SESSIONS ONLINE AND NOW AFTER SIX MONTHS REALLY REAPING THE BENEFITS.

WE REMAPPED EVERYTHING WHICH SOUNDS OVERWHELMING BUT WITH THE USE OF THE CAPABILITY AND SEARCH FUNCTIONALITY IT WAS A FAIRLY EASY TRANSITION

THROUGH THAT WE WERE TESTING OUR ROLES AND PROVISIONS WITH CONFIDENTIAL DATA HELD IN THE SYSTEM.

AS TERRY MENTIONED IT'S IMPORTANT TO OUR FINANCE AND AUDITORS THOSE STAY UP-TO-DATE TO MAKE SURE THE DATA SECURITY IS BEING CHANGED.

SO AFTER THE SET-UP IN DATA ENTRY, TRANSITIONED AND DEVELOPED INTERNAL REVENUES, PROCEDURE GUIDES, 30 HOURS OF TRAINING

OPPORTUNITIES AND LAB TIME WHERE END USERS COULD RECEIVE ONE-ON-ONE AND SMALL ROOM TRAINING.

THE WAY THE STAFF EMBRACED THE NEW SYSTEM, THE DIRECT RESULTS KEY EFFICIENCIES WE NOW SEE AND WE WERE KIND OF DREAMING ABOUT THEM FOR YEARS SO IT'S GREAT TO SEE THEM IN EFFECT.

THESE ARE ALL TRULY GAME CHANGERS FOR THE WAY WE OPERATE.

IT'S BEEN WONDERFUL THE WAY STAFF HAS WORKED TOGETHER.

I WANT TO HIGHLIGHT A FEW ON THE SCREEN.

ONE OF THE BIGGEST CHANGES INTERGOV SYSTEM.

BEFORE MUNIS ALL PERMITS AND FEES WERE ENTERED INTO INTERGOV AND THE CUSTOMER WERE WALK OVER TO FINANCE.

THIS SHOT IS AN EXAMPLE FROM OUR ENGINEERING SYSTEM.

I WANT TO SHOW THAT NOW INSTEAD OF STAFF HAVING TO REENTER THAT DATA INTO THE CASHIERING SYSTEM WE CAN SEARCH FOR THE NAME OR INVOICE NUMBER AND IT PULLS UP THE FEE CODES AUTOMATICALLY WHICH OBVIOUSLY EXPEDITES THE PROCESS FOR THE CUSTOMER BUT ALSO ELIMINATES THE CHANCE OF ANY DATA ENTRY ERRORS.

THESE BATCHES CARRY OVER FOR APPROVAL AND POSTING.

SO WITHIN MUNIS, WE CALL IT THE HUB, AND THESE PAGES SERVE AS OUR DASHBOARD WHERE EVERYTHING IS SEARCHABLE AND IN A USER-FRIENDLY FORMAT.

INDIVIDUAL USERS CAN CUSTOMIZE THEIR OWN FAVORITES FROM THE HOMEPAGE. CLICKING ON THIS TAKES ME TO APPROVALS.

THIS ARROW WILL TAKE ME TO THE INVOICE ENTRY SCREEN.

AND FROM THERE ONE OF MY FAVORITE PARTS I CAN EASILY GET TO A PDF WITH THE ACTUAL VENDOR INVOICE ALL RIGHT HERE, CLICKING A FEW BUTTONS. THESE CHANGES ARE HUGE FOR US, TO HAVE ALL THESE WORKFLOWS AND ATTACHMENTS ELECTRONIC AND NOT PAPER.

IT'S IMPORTANT WHEN YOU ARE TRYING TO RESEARCH SOMETHING.

I WAS TRYING TO FIGURE OUT A WAY TO EXPLAIN THAT TO SOMEONE WHO MAY NOT HAVE WORKED WITH A SYSTEM LIKE THIS.

THE BEST I COULD COME UP WITH, THE PICTURE OF BASKETBALL COACH DRAWING OUT A PLAY FOR A GAME AND IT'S GOT ALL THESE CRAZY ARROWS AND LINES FROM THE BALL BEING PASSED AWAY.

SOMETIMES RESEARCHING SOMETHING CAN FEEL LIKE THAT, ARE YOU BOUNCING AROUND DIFFERENT MODULES, PAPER FILES AND BACK.

YOU MIGHT NOT ALWAYS GET TO WHERE YOU WANT TODAY GO EASILY.

BUT WITH MUNIS THAT PROCESS SEEMS SO MUCH MORE LINEAR AND REALLY DUE TO THESE DRILLED DOWN FEATURES AND ALL OF THESE BLUE TESTS, ACTUALLY HYPERLINKS THAT TAKE YOU TO THE SCREENS AND CONNECTS THE DIFFERENT MODULES.

HERE I SWITCHED TO A VENDOR FIRST, YOU CAN SEE THE INVOICES PAID, CHECKS THAT WERE ISSUED, THE PURCHASE ORDERS, CONTRACTS.

AND OF COURSE, IT'S NOT JUST HAVING THOSE DATA FIELDS BUT IT'S ALSO HAVING THAT ACCESS TO THE SCANNED BACK UP DOCUMENTATION THAT IS JUST SO HELPFUL.

SO GOING WITH THESE WORKFLOWS, ALSO THE THOUSANDS OF PAGES THAT ARE NO LONGER BEING PRINTED AND AS STEVE MENTIONED MINIMIZING THE FILING CABINETS WE HAVE HAD AROUND, OVER THE LONG TERM THIS WILL REDUCE, MAYBE SOME DAY ELIMINATE THE COST OF STORING THE PAPER FILES SINCE WE HAVE TO KEEP THEM FOR SO MANY YEARS DUE TO OUR RETENTION SCHEDULE. LAST BUT NOT LEAST THERE'S BETTER REPORTING FUNCTIONALITY.

THIS IS AVAILABLE TO ALL END USERS, NOT JUST FINANCE.
