AT THE TIME.
NOW THE APPEAL DID NOT COMPLETE WHEN IT CLOSED MAY 4TH.
BRING BACK A DRAFT RESOLUTION FOR CONSIDERATION IN A PUBLIC HEARING.
INSTEAD THE CITY HAS PLACED THE DRAFT RESOLUTION ON THE CONSENT
CALENDAR WITHOUT CONSIDERATION BY THE CITY COUNCIL LACKING

I NOTED THAT THE AGENDA INDICATED THAT THE PUBLIC WAS NOT ALLOWED. THE PUBLIC CAN ONLY PARTICIPATE BY ZOOM.

I'M ASSUMING THAT'S TRUE.

THE GOVERNOR'S SUSPENSION OF THE BROWN ACT ALLOWED -- AND ALLOWS VIRTUAL MEETINGS BUT IT DOESN'T ALLOW A QUORUM OF THE CITY COUNCIL TO CONVENE IN CHAMBERS WHILE EXCLUDING THE PUBLIC.

IF IT'S THE INTENTION OF THE MAJORITY OF THE COUNCIL TO CONTINUE CONVENING IN CHAMBERS, I STRONGLY SUGGEST THAT YOU OPEN THE CHAMBERS TO THE PUBLIC WEARING MASKS.

SECOND, I WOULD LIKE TO URGE YOUR APPROVAL OF THE HISTORY ADVISORY COMMITTEE'S REPORT ON BRUCE'S BEACH WHICH IS LATER ON YOUR AGENDA TONIGHT.

I'M NOT GOING TO REPEAT EVERYTHING IN MY EMAIL TO ALL OF YOU FROM LAST NIGHT.

YOU RELIED ON THE BRUCE'S BEACH TASK FORCE REPORT IN APRIL WHEN YOU CONDEMNED THE RACIST AND UNLAWFUL EMINENT DOMAIN PROCEEDINGS IN THE 1920'S THAT DISPLACED THE BRUCE'S BEACH AREA.

THIS REPORT IS APPROVED AND BETTER DOCUMENTED AND HAS BEEN VETTED BY PROFESSIONAL HISTORIANS.

THIS REPORT DESERVES YOUR ACCEPTANCE AND YOUR APPROVAL.

I WOULD HOPE THAT YOU DO THAT LATER THIS EVENING.

THE CITY COUNCIL WOULD PUT GREAT RESTRICTIONS ON IT SO IT WOULD NOT DISTURB NEIGHBORS.

AS YOU DID ON FIFTH AND HIGH LAND THAT LIMITS HOW LATE THEY CAN GO.

THAT WILL GIVE ME TIME TO RECOUP SOME OF THE EXPENSES THAT IT TOOK TO PUT IN THESE DECKS.

IF YOU NEED A MEETING WITH A SPECIFIC MEMBER, YOU CAN DO THAT ONLINE AS WELL.

THERE'S NOTHING ABOUT THE OUTCOMES.
I DIDN'T SEE HOW MANY PEOPLE HAVE BEEN SERVED FROM THE CITY OF MANHATTAN BEACH.
I DIDN'T SEE A LOT OF BACKGROUND AS TO WHAT IS GOING ON THERE AND WHAT WE'RE GETTING FOR OUR MONEY.
AND ANY OTHER INSTANCE ANY OTHER CONTRACT, I WOULD EXPECT SOME BACKGROUND AS TO THIS IS HOW MUCH WE SPENT, AND THIS IS HOW MANY WERE SERVED AND THESE ARE THE OUTCOMES.
THAT SORT OF THING.
HOW MANY HOURS WERE PUT IN WITH REGARDS TO HOW MANY WERE SERVED.
I GUESS, I'D LIKE MORE INFORMATION BEFORE APPROVAL OF THIS.
>> Mayor Hadley: YOUR WISH HAS BEEN GRANTED.

WE HAVE BEACH CITIES HEALTH DISTRICT T 'ED UP TO SPEAK ON THIS ITEM.
WE CAN INVITE THEM INTO THIS MEETING TO SPEAK ON THIS ITEM.
IS THAT OKAY WITH YOU?

ONE OF MY CONCERNS IS THAT IT'S A VERBAL REPORT WHEN IT SHOULD BE

SINCE WE BEGAN OUR PARTNERSHIP ABOUT A YEAR AND A HALF AGO.

WE HAVE BEEN ABLE TO EXPAND THE PROGRAM.

WE'RE ACCEPTING REFERRALS IN THE ONLY FROM MANHATTAN BEACH POLICE
DEPARTMENT BUT THE THREE BEACH CITY SCHOOL DISTRICTS.

THAT REALLY WAS THE FOUNDATION LAID BY MANHATTAN BEACH AND A STRONG
RELATIONSHIP WITH THE SCHOOL DISTRICT TO HAVE THOSE REFERRALS COMING
FROM SCHOOL OFFICERS AS WELL AS LOCAL POLICE DEPARTMENTS.

ABOUT A YEAR AGO WE WERE ABLE TO CONVENE A MEETING WITH THE POLICE
CHIEFS THROUGH THE DEPARTMENT OF HEALTH SERVICES, YOUTH DIVERSION
AND DEVELOPMENT.

THAT'S WHAT WE'VE BEEN WORKING TOWARD OVER THE PAST YEAR AND A HALF
IS CREATE SOME SUSTAINABILITY AND OPPORTUNITY FOR EXPANSION OF THIS
PROGRAM.

A LOT OF THE DATA THAT WAS REFERENCED, THAT'S A KEY COMPONENT OF THE

COUNTY PROGRAM THAT WE BE FORMALIZED IN THAT SYSTEM OF REPORTING ACROSS A LOT OF DIFFERENT DEMOGRAPHIC QUALITIES.
I CAN SHARE SOME PRELIMINARY DATA WITH YOU.
SINCE JULY WHEN WE RENEWED OUR CONTRACT LAST YEAR, NEARLY SEVENTY CASES HAVE BEEN DEFERRED FOR DIVERSION.
IT COULD BE CODE ENFORCEMENT VIOLATION, DEMEANOR, VIOLATION OF SCHOOL RULES.
THOSE ARE SENT OVER TO THE DIRECTOR AND CONTINUES TO BE AS WAS STARTED IN MANHATTAN BEACH.
WE CONTINUE TO SEE ESPECIALLY DURING COVID, IT WAS A TIME OF ISOLATION AND UNCERTAINTY FOR EVERYONE.
ESPECIALLY OUR YOUNG PEOPLE.
THAT MANIFESTED IN THOSE CASES I HAD REFERENCED.
SOME ARE ONGOING BUT WOULD BE HAPPY TO PROVIDE ADDITIONAL DATA THAT WASN'T INCLUDED IN THE INITIAL REPORT AS A FOLLOW-UP TO THIS PRESENTATION.
WE DO HAVE ALL THAT DATA IN TERMS OF CITATIONS, OUTCOMES, HOW THEY WERE REFERRED.
LOOKING AT RESTORATIVE JUSTICE IT TRULY IS INNOVATIVE AND WHAT THE COUNTY IS TRYING TO GET IN COMPLIANCE WITH YOUTH INVESTMENT.
IN ALLIANCE WITH THAT PROGRAM WE'RE WELL ON OUR WELL.
THIS TRULY PERSONALIZED APPROACH TO RESTORATIVE JUSTICE REPAIRING HARM DONE TAKING PERSONAL RESPONSIBILITY AND EMPHASIS ON COMMUNITY SERVICE.
REFERRALS FOR TREATMENT, WHETHER THAT'S MENTAL HEALTH OR SUBSTANCE ABUSE TREATMENT.
PROVIDE THESE EXPANDED SERVICES IN THE BEACH CITIES AND THIS WOULD BE IN COLLABORATION WITH OUR LOCAL POLICE DEPARTMENTS.
THAT WOULD PROVIDE AN OPPORTUNITY TO CONTINUE TO PROVIDE DIVERSION REGARDLESS OF WHERE SOMEONE LIVES IF THEY WERE IN VIOLATION OF ANY CODE OR CIVIL ORDINANCE, THEY WOULD BE DIVERTED.
WE'VE SEEN IN THE YEARLY 500 CASES IN THE JUVENILE PROGRAM, VERY FEW CASES OF RECIDIVISM.
WE KNOW THIS WORK CAN BE TRULY TRANSFORMATIVE AND LIFE CHANGING AND GIVE A YOUNG PERSON AN OPPORTUNITY TO GET BACK ON TRACK AND CREATE A PURPOSEFUL PATH FOR THEMSELVES.
WITH THAT WE CAN ANSWER ANY OTHER QUESTIONS YOU MIGHT HAVE.

YOU SAID YOU TOOK IT OVER FROM MANHATTAN BEACH.
CAN YOU GIVE ME THE NAME OF THE PROGRAM THAT WE HAD?
WAS IT FOCUSED ON STUDENTS AND OTHER PLACES.

>> THIS WAS A PROGRAM THAT YOU HAD WITHIN YOUR CITY PROSECUTOR'S
OFFICE.

IT WAS SOMETHING THAT MANHATTAN BEACH WAS DOING, LEADING THE WAY WITH
THIS.

WE WORKED OUT A PARTNERSHIP ABOUT A YEAR AGO WHERE WE SHARE WITH THE
COSTS.

THE 50,000 YOU ARE PUTTING IN, WE ALSO PUT IN AND THE 50,000 AT THE
HEALTH DISTRICT.

YOU'RE GETTING APPROXIMATELY THE SAME AMOUNT OF SERVICE YOU WERE
GETTING FOR ROUGHLY HALF THE COST BECAUSE WE'RE BUILDING ON THIS MODEL

WE GET A LITTLE CONTRIBUTION FROM TWO OF THE SCHOOL DISTRICTS AND

RESTORATIVE JUSTICE.

>> Mayor Hadley: PLEASE EXPLAIN -- OR WHY ITEM 36 IS RELEVANT.

>> WE TALKED ABOUT IT, IF I RECALL, DURING THE PREVIOUS COUNCIL MEETING WHERE THIS CAME UP.

I DON'T THINK WE LEFT IT THIS CLEAR.

I WANTED TO HAVE A DISCUSSION ABOUT IT.

THE PARKING FEE, I'VE STAYED AT BUSINESS HOTELS.

PEOPLE TRAVELING ON BUSINESS AREN'T REALLY CONCERNED WITH THE PARKING FEE.

I DON'T KNOW WHAT IT'S PLANNED TO BE HERE.

I IMAGINE IT WOULD NOT BE ONEROUS.

OR AT LEAST TO CAUSE A PROBLEM.

THERE ARE SOLUTIONS THAT WERE OUTLINED BY THE DEVELOPERS LETTER INFORMING THE GUESTS THEY CAN'T PARK OUT ON THE STREET.

YOU SEE AROUND BARNABY'S YOU SEE SIGNS THAT SAY NO HOTEL PARKING. FROM WHAT I UNDERSTAND THOSE DO NOT HAVE -- THEY ARE NOT RULED BY ORDINANCES BUT THEY DO A FAIRLY GOOD JOB OF KEEPING THE UNWANTED PARKING AWAY.

LINKS AND CITATIONS TO PRIMARY SOURCES FOR INFORMATION AS PRESENTED. WE MET WITH MEMBERS OF THE PUBLIC AS WELL AS SOLICITED.

THESE HISTORIANS PROVIDED REVIEW OF THEIR COMMENTS AND ARE ATTACHED IN THE REPORT AND PROVIDED AS AN ATTACHMENT TO THE REPORT.

THERE ARE TWO ATTACHMENTS.

THE FIRST ONE IS THE ACTUAL HISTORY REPORT WHICH HAS BEEN REVISED. THE SECOND ATTACHMENT WAS PROVIDED BY THE HISTORY ADVISORY BOARD SUMMARIZING WHICH HISTORIANS PROVIDED INPUT AS WELL AS WHAT THOSE COMMENTS WERE.

THOSE ARE ALL LISTED IN THE COMMENTS FOR YOU.

THE EXPERTISE WAS PROVIDED FREE OF CHARGE TO THE CITY.

THE STAFF RECOMMENDS THE REPORT BE SUBMITTED BY THE COUNCIL TO CONTINUE OUR WORK ON THE PLAQUE LANGUAGE TO BE BROUGHT BACK TO YOU IN THE COMING MONTHS.

IT'S A LOT OF WORK.
IT'S NO EASY TASK.
NO MATTER WHAT, SOMEONE IS GOING TO BE UPSET WITH YOU.
IT'S GOOD TRAINING FOR CITY COUNCIL.
I ALSO WANT TO THANK GARY AND JEN FOR THEIR LIMITLESS ENERGY IN DOCK
MING THE CITY'S HISTORY AND RESERVING IT AND MAKING THEMSELVES
AVAILABLE THROUGHOUT THE YEARS TO THE CITY OF MANHATTAN BEACH.

>> Joe Franklin: ASK FOR THEIR EXPERTISE. WHEN I WAS AT FACILITIES PLANNING, WE WERE LOOKING AT BUILDINGS AND I'M NOT A STRUCTURAL ENGINEER. OTHER PLACES, WE NEED THAT KIND OF EXPERTISE AND I DON'T SEE THE HARM IN HAVING THAT APPLIED IN THIS PARTICULAR SITUATION. I THINK IT WOULD BENEFIT EVERYBODY. I THINK IT WOULD BENEFIT ALL THE RESIDENTS OF MANHATTAN BEACH TO HAVE THAT LOOKED AT. THEY MAY VERY WELL COME BACK WITH THE SAME CONCLUSIONS, IN WHICH CASE THAT'S GREAT, BUT ALSO LOOK AT THE HISTORY REPORT ITSELF. ALL RIGHT, BRING THAT UP. IN THE PROCESS SECTION ON PAGE FOUR, SECOND PARAGRAPH. WE COMPARE THE MASTER'S THESIS OF ROBERT BRIGHAM AND DOCTORIAL DISSERTATION OF DOCTOR ALISON ROSE JEFFERSON AS WELL AS DOCTOR JEFFERSON'S BOOK WITH OTHER REPORTS FROM THAT TIME. YOU'RE COMPARING IT, PRESUMABLY DEFINED WHAT'S MISSING OR WHAT IS THERE. WHERE EVEN WE HAVE ACKNOWLEDGED THAT THERE WAS MISTAKES MADE IN ROBERT BRIGHAM'S DISSERTATION. AND THAT WAS 65 YEARS AGO AND I KNOW WE WANT TO HAVE AN ACCURATE REPRESENTATION. AND ALSO THE NEXT PARAGRAPH IS DUE TO COVID 19 RESTRICTIONS AND A FLOOD OF THE LOS ANGELES HOME RECORDS WE HAVE NOT BEEN ABLE TO OBTAIN ALL THE DOCUMENTATION WE NEED TO CERTIFY SOME CLAIMS. SO REGARDLESS OF THE OFFER TO CONTINUE THE WORK, PERHAPS WE CAN BRING IN THIS HISTORY EXPERT TO CONTINUE THAT WORK AND TO GO BACK AND CHECK THE WORK THAT'S BEEN DONE. I DON'T SEE THE HARM IN THAT. WE'VE GOT THE LETTER FROM DR. *GROSS BUT WE ALSO GOT A LETTER FROM NICHOLAS ROSENTHAL WHO IS AN ASSOCIATE PROFESSOR OF HISTORY AT LOYOLA MARYMOUNT UNIVERSITY. SO I WENT THROUGH AND I COMPARED THEM AND THIS IS WHAT DR. *GROSS SAYS IN THE PROFESSIONAL REVIEW FEEDBACK. SHE SAYS IN A PARAGRAPH, SHE SAID MORE HISTORICAL CONTEXT WOULD BE USEFUL AND PREFER YOU NOT DETRIMENT THE END. IDEALLY YOU CAN INTEGRATE MORE CONTEXT INTO THE TIMELINE ITSELF. THIS IS AFTER ALL FAR MORE THAN A TIMELINE. THIS IS YOUR TELLING OF THE STORY. THIS IS ESPECIALLY IMPORTANT BECAUSE THE GIST OF THE CRITICISM FROM THE ASSUMED CONSERVATIVE CRITICS IS HAVE YOU TAKEN THIS HISTORY OUT OF CONTEXT? AND THE SPECIFIC CONTEXT IS THAT MB MIGHT HAVE BEEN BAD, BUT OTHER CITIES OR WORSE. AND THEN SHE GOES ON TO SAY PROBABLY THE TWO MOST USEFUL BOOKS FOR YOU WOULD BE RICHARD ROTHSTEIN THE COLOR OF LAW AND JOSH SIDES, IT'S S-I-D-E-S I THINK SIDES, L.A. CITY LIMITS. SO IT'S INTERESTING BECAUSE I WENT BACK TO THE LETTER FROM NICHOLAS ROSENTHAL DATED JUNE 15TH AND HE GOES THROUGH SAYING THAT YOU WOULD BENEFIT FROM A HISTORY PROFESSIONAL TAKING A LOOK AT THIS. AND THEN GUESS WHAT? HE RECOMMENDS THE SAME PERSON, JOSH SIDES. BECAUSE HE SAID IT'S A -- SORRY, I JUST CAN'T FIGURE THAT OUT. EXCUSE ME, I'M WORKING FROM NOT MY NORMAL COMPUTER SO PLEASE FORGIVE ME, I GOT IT HERE SOMEWHERE. I'M SO SORRY, IT'S TAKING LONGER THAN I THOUGHT. YEAH, SO HE SAYS ONE OPTION WOULD BE TO CONTACT A HISTORIAN WITH A SPECIALTY IN CALIFORNIA HISTORY WHO HAS EXPERIENCE AS A HISTORICAL CONSULTANT AND WOULD EITHER TAKE ON THE PROJECT THEMSELVES OR PUT TOGETHER A TEAM TO DO SO. TWO PEOPLE COME TO MIND. THE FIRST IS JOSH SIDES, WHITSETT PROFESSOR OF CALIFORNIA HISTORY AT CSU NORTHRIDGE

AND DIRECTOR OF THE CENTER OF SOUTHERN CALIFORNIA AT THE CSU NORTHRIDGE. HIS FIRST BOOK L.A. CITY LIMITS: AFRICAN AMERICAN LOS ANGELES FROM GREAT DEPRESSION TO THE PRESENT IS A FOUNDATIONAL WORK IN THE FIELD. AND I BELIEVE HE ALSO HAS EXPERIENCE AS A HISTORICAL CONSULTANT. SO HERE'S TWO PEOPLE AGREE THAT THIS PERSON, AS EVERYBODY SAID, WELL WHERE ARE YOU GOING TO FIND AN UNBIASED PERSON? HOW ARE YOU GOING TO FIND -- HERE ARE TWO PEOPLE RESPECTED BY ALL. PEOPLE ON THE HISTORICAL COMMITTEE AND FROM LOYOLA MARYMOUNT UNIVERSITY PROFESSOR OF HISTORY RECOMMENDING THE SAME PERSON. THERE IS THAT PERSON. NOW I HAVEN'T CONTACTED THAT PERSON BUT I THINK IT'S WELL WORTH THE EFFORT TO GET THIS OPINION FROM A PROFESSIONAL. IT'S BECAUSE WE WANT IT CORRECT. THE PEOPLE, THE RESIDENTS, THE TAXPAYERS OF MANHATTAN BEACH DESERVE THAT BECAUSE IT'S WHAT WE ARE, IT'S WHO WE ARE. THESE THINGS HAPPEN. WE CRAFTED THE ACKNOWLEDGMENT, WE DON'T WANT IT TO HAPPEN AGAIN, WE WANT THE HISTORY TAUGHT. WHO WOULDN'T WANT THE MOST ACCURATE HISTORY AVAILABLE? AND AGAIN I'M NOT SAYING THE TASK FORCE MADE MISTAKES. THAT THERE ARE THINGS THAT WERE NOT AVAILABLE TO THEM, THERE'S RESOURCES THAT A HISTORIAN WOULDN'T HAVE, I IMAGINE THAT WE DON'T HAVE. SO I FOR ONE WOULD -- IF THERE'S AN INTERIM STEP WE CAN DO AS FAR AS ACCEPTING THE WORK THAT'S BEEN DONE BUT TO ALSO EXAMINE THE HISTORY FURTHER. WE OWE THAT TO OUR CITY, WE OWE IT TO THE PEOPLE WHO WERE NOT INVOLVED 100 YEARS AGO, IF AND HOW YOU CAN DETERMINE THAT, AND WE OWE IT TO THE GENERATIONS MOVING FORWARD. THANK YOU.

>> Suzanne Hadley: THANK YOU JOE. I WILL WRAP UP HERE. I TOO WANT TO ECHO THE COMMENTS OF MY COLLEAGUES, I'M VERY GRATEFUL FOR THE ORIGINAL BRUCE'S BEACH TASK FORCE AS WELL AS THE HISTORY ADVISORY BOARD OF LINDSEY FOX, ISLA GARRAWAY, KRISTEN LONG DREW AND TYLER ST. BERNARD. I ALSO AGAIN WANT TO REITERATE MY THANKS TO ALI LATRAGNA OUR SENIOR ANALYST IN MEDICAL SCIENCES STAFFER FOR MANHATTAN CITY BEACH WHO DID AN EXCELLENT JOB SPEARHEADING THIS PROCESS AND BEING A CONDUIT AMONG COUNCIL, THE COMMUNITY, AND THE TASK FORCE AS WELL AS THE HISTORY ADVISORY BOARD. SO KUDOS TO ALL OF YOU. I AM COMING TO COUNCIL TONIGHT THE SAME TIME IN HISTORY THAT YOU ALL ARE AT A TIME WHERE WE CAN NOT EVEN AGREE ON "THE SCIENCE". SCIENCE IS NOW CONSIDERED BIASED IN THESE HIGHLY, HIGHLY POLARIZED TIMES. AND I WOULD SUBMIT THAT THERE WILL NEVER BE AGREEMENT ON A DEFINITIVE HISTORY ABOUT WHAT HAPPENED LAST WEEK SADLY, LET ALONE WHAT HAPPENED 100 YEARS AGO. AND IN THE INTERIM WITH BOB BRIGHAM'S MASTER'S THESIS 65 YEARS AGO, THERE'S DISAGREEMENT NOW VERSUS WHAT WAS IN THAT THEN. SO WE ARE IN HIGHLY POLARIZED TIMES, WE ARE IN DIVIDED TIMES AND HISTORY HAS ALWAYS BEEN BIASED. THERE ARE MANY NOW WHO TALK ABOUT BEING BIASED TO BENEFIT THE VICTORS. THAT'S KIND OF A COMMON JOKE AMONG HISTORIANS THAT HISTORY IS WRITTEN BY THE WINNERS AND LARGELY I AGREE WITH THAT. THERE'S MUCH WONDERFUL SCHOLARSHIP ON ALL SIDES OF EVERY ISSUE. I WORK AT THE LIBRARY, I LOVE HISTORY, I MARRIED A HISTORIAN, MY HUSBAND HAS A BA IN HISTORY. I TAKE HISTORY VERY, VERY

SERIOUSLY. MY KIDS ARE GOOD, AMATEUR, YOUNG HISTORIANS. IT'S VERY, VERY IMPORTANT BUT LET THERE BE NO MISTAKE, THERE IS NO AGREEMENT ON HISTORY. THERE ARE LOTS AND LOTS AND LOTS OF OPINIONS AND LOTS AND LOTS AND LOTS OF SCHOLARSHIP. AND I WOULD SAY IT'S CLOSER TO MEDICINE THAN IT IS TO SCIENCE. I WOULD JUST SUBMIT THAT OUR COMMUNITY HAS BEEN IN SEARCH OF A MEDICAL PROCEDURE. AND WE HAVE SOUGHT SOME EXPERT ADVICE LOCALLY AND YOU CAN ENDLESSLY SEEK SECOND, THIRD, FOURTH, FIFTH, TENTH OPINIONS. YOUR BROTHER-IN-LAW HAS AN OPINION, YOUR MOM HAS AN OPINION, YOUR LOCAL DOCTOR HAS AN OPINION, THE WEBSITE HAS A DIFFERENT OPINION. THERE IS NO CONSENSUS ON A MEDICAL PROCEDURE FOR YOU. YOU HAVE TO MAKE THE DECISION TAKING EVERYTHING INTO ACCOUNT THAT YOU HAVE THE TIME AND ENERGY TO INVESTIGATE. AND I WOULD SAY THAT THIS, BRUCE'S SPEECH, HISTORY ADVISOR BOARD REPORT IS MORE SIMILAR TO THAT. THERE IS NO KING SOLOMON TO WRITE THIS DEFINITIVE HISTORY SO I REALLY JUST DISPUTE THIS NOTION THAT MORE TIME, MORE MONEY, MORE EXPERTS, AND KICKING THE CAN DOWN THE ROAD WILL YIELD A BETTER RESULT. IT WILL YIELD A DIFFERENT RESULT ABSOLUTELY AND IT MAY YIELD A RESULT THAT ONE OF YOU LISTENING LIKES BETTER THAN WHAT WE HAVE TODAY AND I ACCEPT THAT. I ACCEPT THAT SOME PEOPLE DON'T WANT THIS REPORT AND SOME PEOPLE WANT ANOTHER VERSION OF THE REPORT. THAT'S WHAT MAKES THIS A GREAT COUNTRY. EVERYONE IS WILLING AND ABLE TO SPEAK THEIR MIND AND PUBLISH, FRANKLY, ANYTHING THAT YOU WANT TO SEE OUT IN THE PUBLIC SQUARE INSTEAD. BUT THIS COUNCIL REALLY IS TASKED WITH THIS TASK FORCE AND COMPLETING THE WORK OF THIS TASK FORCE AND I DO TAKE THAT SERIOUSLY. I DO AGREE WITH MY COLLEAGUES THAT THE TASK FORCE WAS STOOD UP FOR THREE TASKS AND I TOOK THAT SERIOUSLY. JOE DID NOT VOTE FOR ANY OF THESE THINGS, HE WAS NOT ON COUNCIL AS HE SAID BUT THE THREE ITEMS IF I CAN REMIND EVERYONE WAS AN ACCURATE, FACTUAL HISTORY OF WHAT HAPPENED IN THE 1910'S AND 1920'S IN MANHATTAN BEACH IN THE AREA NOW KNOWN AS BRUCE'S BEACH. SECOND WAS AN ART PIECE WHICH IS IN PROGRESS AND THIRD IS A NEW PLAQUE LANGUAGE. SO THIS HISTORY REPORT WAS REALLY THERE FROM THE VERY BEGINNING. THE OTHER THINGS THAT WE DECIDED AS A COMMUNITY, NOW WE COULD CHANGE OUR MIND, AGAIN WITH A MEDICAL PROCEDURE YOU CAN START OUT GOING IN ONE DIRECTION AND YOU CAN COMPLETELY CHANGE AND GO TO ANOTHER, BUT THE DECISION WAS TO SPEND NO MONEY ON OUTSIDE EXPERTS AND THE DECISION WAS TO POPULATE THE TASK FORCE AND WRITE THE HISTORY WITH LOCAL RESIDENTS AND THAT'S WHAT WE'VE DONE. I UNDERSTAND THAT MANY OF YOU DON'T LIKE TO READ THE HISTORY, I DO HOPE EVERYONE WHO'S EMAILED HAS ACTUALLY READ THE ENTIRE DOCUMENT. I DON'T ASK YOU WHEN YOU EMAIL ME, BUT I DO HOPE THAT YOU'VE READ THE ENTIRE DOCUMENT. I HAVE. I AM QUITE CONFIDENT ALL MY COLLEAGUES HAVE. IT IS NOT PERFECT, IT IS NOT PROFESSIONAL, IT IS NOT LENGTHY, IT IS NOT WRITTEN BY PEOPLE WHO GET PAID TO DO HISTORY. I STIPULATE ALL OF THAT. HOWEVER IT IS FACTUAL, IT IS DOCUMENTED AND IT IS SUBSTANTIATED AND THESE ARE PUBLIC SOURCES. I DID SPEAK WITH SOME OF THE TASK FORCE MEMBERS AND I WOULD LIKE TO REMIND EVERYONE THAT THE HISTORY ADVISORY BOARD USED FREE RESOURCES

AVAILABLE TO ALL SO THAT EVERYTHING IN THIS DOCUMENT, LIKE GOOD SCIENCE, CAN BE VERIFIED AND FOLLOWED UP ON AND DOUBLE CHECKED ON BY YOU. IF YOU DON'T LIKE WHAT YOU SEE, I MEAN LET'S BE SCIENTISTS AND LET'S INVESTIGATE IT OURSELVES AND GO TO THAT SOURCE AND READ IT OURSELVES AND SEE WHAT WE MIGHT DISAGREE WITH. BUT THIS NOTION THAT WE'RE GOING TO JUST PASS THIS OFF TO SOME MYTHICAL, IMPECCABLE, UNIMPEACHABLE HISTORIAN FOR A PERFECT REPORT IS REALLY JUST THAT. IT IS A MYTH

AND I DON'T BUY INTO THAT.

ALL HUMANS ARE FALLIBLE.

ALL HUMANS HAVE BIASES AND HISTORIANS HAVE ABOUT THE MOST BIASES BECAUSE IT'S ALL WORDS AND A LOT OF IT IS POINT OF VIEW AND UNLESS YOU STICK TO THE SOURCES, CONTEMPORARY SOURCES, THAT PRINTED THINGS IN REAL-TIME BACK THEN, THEN YOU ARE GOING TO BE LED ASTRAY.

EMBROIDERING OR NARRATING OR TELLING THE STORY OR ADDING YOUR INPUT. BUT IF YOU REPORT LIKE A FACTUAL RECITATION OF FACTS AND WHERE THEY'RE FROM AND THEIR DATA AND THEIR PICTURES AND QUOTATIONS, THEN I THINK WE'RE ON PRETTY FIRM GROUND. SO I KNOW THE HISTORY IS NOT PRETTY, I KNOW THAT I DON'T LIKE TO READ IT.

I KNOW IT'S NOT WHAT I WOULD LIKE TO THINK OF MY HOMETOWN 100 YEARS AGO. BUT I DO READ THE CONTEXT. I DO KNOW THAT THIS HISTORY IS NOT UNUSUAL.

PLESSY VS FERGUSON WAS 1896 AND THEN IN THE 1920S, THE SUPREME COURT, AGAIN THIS IS IN THE HISTORY REPORT, BUT THERE WAS A SUPREME COURT DECISION THAT UPHELD RACIAL COVENANTS IN THE 1920S, I THINK THAT COURT CASE WAS 1926 OR SOMETHING.

SO, THOSE WERE THE WATERS THESE FEW HUNDRED MANHATTAN BEACH RESIDENTS WERE SWIMMING IN AND THEY'RE NOT PRETTY WATERS. I DON'T LIKE TO THINK ABOUT THAT TIME. THERE MANY HAVE WRITTEN TO ME ABOUT HOW SPECIAL MANHATTAN BEACH WAS FOR SELLING LAND TO THE BRUCES, AND I THINK THAT THAT'S GREAT BUT MANHATTAN BEACH WAS NOT ALONE IN SELLING LAND TO BLACK LANDOWNERS. I VERIFIED THAT WITH THE HISTORY ADVISORY BOARD, THAT THERE WERE OTHER BLACK LANDOWNERS IN THE 1910'S AND 1920'S THROUGHOUT THE SOUTH BAY, SO WAS IT GREAT THAT GEORGE PECK SOLD TO THE BRUCES? ABSOLUTELY, BUT THAT WAS NOT UNIQUE.

SO WE HAVE SOME MYTHS OF OUR OWN THAT WE ENJOY AND THAT WE FEEL GOOD ABOUT, BUT I DO THINK THAT THIS HISTORY REPORT PUTS ASIDE SOME OF THOSE STORIES AND DOCUMENTS CONTEMPORARY SOURCES ON HOW SOME OF THOSE STORIES ARE NOT TRUE.

AGAIN, I DON'T LIKE TO READ THAT, BUT I LIVE IN THE REAL WORLD AND I'M GOING TO CLING TO THAT AND WHEREVER THE FACTS LEAD IS WHAT I'M GOING TO THINK.

SO, I DON'T AGREE THAT ANOTHER HISTORIAN OR MORE TIME OR MORE MONEY WILL YIELD A BETTER RESULT.

I DO THINK THIS IS QUITE, QUITE GOOD BECAUSE IT'S FACTUAL. NOT BECAUSE OF WHAT IT'S TELLING ME, BUT BECAUSE IT'S FACTUAL AND HOW THEY WENT ABOUT IT AND THEIR DOCUMENTATION. I DO THINK IT'S INCREDIBLE, IT CAME

FROM OUR OWN COMMUNITY. I DO THINK THIS COUNCIL'S DELIVERING ON WHAT WE SAID WE WOULD DO FOR THE COMMUNITY. I AGREE WITH RICHARD THAT ADOPTING THIS HISTORY REPORT DOES NOT MEAN THAT IT'S FINAL.

I WOULD LIKE SOME DISCLAIMERS ON THE WEBSITE. I WOULD LIKE IT TO SAY, THIS IS THE WORK OF AMATEUR HISTORIANS WITHIN OUR COMMUNITY.

THIS IS NOT MEANT TO BE A DEFINITIVE WORK.

I WOULD LIKE AN INVESTIGATIVE REPORTER, A JOURNALIST, A NONFICTION WRITER, AN ERIK LARSON WHO WRITES GREAT NONFICTION BOOKS.

THIS STORY WILL BE TOLD BY MANY OTHER PEOPLE AND NEW SOURCES WILL COME, BUT I DON'T WANT MANHATTAN BEACH TO PAY FOR THAT. IT'S NOT IN OUR PURVIEW. NONE OF US IS A PROFESSIONAL HISTORIAN AND ANY OTHER PROFESSIONAL HISTORIAN WILL JUST INTRODUCE NEW BIASES.

I'D LAST LIKE TO CLOSE BY SAYING THAT MY DESIRE TO VOTE IN THE MAJORITY TO ACCEPT THIS HISTORY, TO ADOPT THIS HISTORY OF THE HISTORY ADVISORY BOARD AND PLACE IT ON OUR WEBSITE, DOES NOT MEAN I APPROVE OF STEPS THE COUNTY IS TAKING. EITHER THE STATE LEGISLATION OR THE SELECTING OF ONE PARTICULAR FAMILY FROM THAT TIME PERIOD TO BE SINGLED OUT FOR COMPENSATION.

I HAVE GONE ON THE RECORD WITH MANY OF YOU VIA EMAIL THAT I THINK IF ONE FAMILY IS PAID ALL SHOULD BE PAID.

IF ONE FAMILY IS CARVED OUT FOR SPECIAL STATEWIDE LEGISLATION, I JUST DON'T GET THAT. I THINK THAT'S TERRIBLE LAW AND TERRIBLE PRECEDENT.

ALL I KNOW IS THAT I SIT ON CITY COUNCIL, I'M THE CURRENT MAYOR OF MANHATTAN BEACH,

BAD THINGS HAPPENED 100 YEARS AGO THAT ARE SHAMEFUL AND AS GARY MCAULEY SAID, THEY'RE A STAIN ON OUR PAST.

THIS HISTORY IS BETTER THAN THE HISTORIES THAT HAVE COME BEFORE IT. IT SUBSTANTIATES AND DOCUMENTS MUCH OF WHAT HAS BEEN PRESENTED. AND THEN LASTLY, THE PEOPLE I TRUST. AND I KNOW MANY OF YOU ARE NOT GOING TO TRUST ME AND YOU'RE WELCOME TO REACH OUT TO ME AND I WILL EITHER DISCUSS THIS WITH YOU OR WE CAN AGREE TO DISAGREE, BUT PEOPLE I TRUST, LIKE KRISTIN LONG DREW, AND THE HISTORY ADVISORY BOARD, AND GARY MCAULEY, AND JAN DENNIS, THEY ALL AGREE THAT THIS IS SOLID. THAT THIS IS GOOD. THAT THIS IS DOCUMENTED. THAT THIS IS FACTUAL. AND THAT'S GOOD ENOUGH FOR ME.

YOU CAN CRITICIZE ME AND CRITICIZE THIS BOARD FOR MAKING THIS DECISION BUT NEW PEOPLE AND NEW MONEY AND NEW TIME AND NEW PROCESSES WILL NOT YIELD MORE AND BETTER.

IT WILL JUST INTRODUCE NEW AND POSSIBLY WORSE.

AND AT SOME POINT THE MEDICAL PROCEDURE HAS TO GO ON.

WE HAVE TO PUT A STOP TO THE SECOND, THIRD, FOURTH, AND HUNDREDTH OPINIONS AND WE NEED TO MOVE FORWARD.

SO WITH THAT I BELIEVE WE HAVE A SECOND FROM MY COUNCILMEMBER, COLLEAGUE NAPOLITANO. WE HAVE A MOTION BY MAYOR PRO TEM STERN, AND I WOULD LIKE TO CALL FOR A ROLL CALL VOTE.

>> Joe Franklin: MAY I ASK FOR A FRIENDLY AMENDMENT?

>> Suzanne Hadley: YES, JOE.

>> Joe Franklin: OKAY, CAN I ASK FOR A FRIENDLY AMENDMENT THAT WE HAVE THE REPORT BE CONDUCTED THROUGH SOME SORT OF PEER REVIEW BY HISTORY EXPERTS?

>> Suzanne Hadley: MAKER OF THE MOTION.

>> Hildy Stern: MY MOTION STANDS. I'M SORRY, I DON'T ACCEPT THE FRIENDLY AMENDMENT.

>> Suzanne Hadley: OKAY, RICHARD.

>> Richard Montgomery: JOE, CAN YOU RESTATE THAT? I COULDN'T HEAR YOU, WE KIND OF LOST YOU HALFWAY THROUGH THAT. CAN YOU RESTATE THE FRIENDLY AMENDMENT?

>> Suzanne Hadley: RESTATE THE FRIENDLY AMENDMENT.

>> Joe Franklin: I'M SORRY WERE YOU TALKING TO RICHARD OR TALKING TO ME?

>> Suzanne Hadley: NO. JOE, CAN YOU RESTATE YOUR FRIENDLY AMENDMENT PLEASE? WE HAD DIFFICULTY HEARING YOU.

>> Joe Franklin: IT'S TO HAVE OUR REPORT, THAT STANDS RIGHT NOW, GO THROUGH A PEER REVIEW WITH HISTORY PROFESSIONALS.

>> Suzanne Hadley: AND I TURN TO THE MAKER OF THE MOTION.

>> Hildy Stern: I AM GOING TO STAND BY THE MOTION. I THINK THAT THE REVIEW IS COMPLETE.

SO I'M GOING TO STAND BY MY MOTION AND I'M NOT GOING TO INCORPORATE THE FRIENDLY AMENDMENT.

>> Suzanne Hadley: SO THE FRIENDLY AMENDMENT HAS BEEN REJECTED. RICHARD MONTGOMERY.

>> Richard Montgomery: I'LL MAKE MY COMMENT. I THINK WHAT COUNSELOR FRANKLIN WAS TALKING ABOUT, AND I UNDERSTAND WHERE JOE IS GOING, I WOULD'VE BEEN HIS SECOND BUT HE DIDN'T READ THE WHOLE THING. THERE'S ONLY ONE LINE I'M GOING TO READ HERE FROM DR. ROSENTHAL AT LOYOLA, MY MAIN PURPOSE OF SUBMITTING THE STATEMENT WAS TO SUGGEST THAT THE REPORT COULD BE STRENGTHENED TO THE FURTHER INTERVENTION OF PROFESSIONAL HISTORIANS.

SO ANY DECISIONS MADE BY CITY MANHATTAN BEACH, BY "THE CITY" NOT THE TASK FORCE, TWO SEPARATE ISSUES, WILL HOLD UP SCRUTINY NOW AND IN THE FUTURE.

IT TAKES NOTHING AWAY FROM THE TASK FORCE.

THEIR JOB IS OVER. YOU ADOPT IT, YOU'RE DONE WITH IT.

PEOPLE ABOUT TRANSPARENCY, YOU CAN'T HAVE IT WORK ONE WAY OR THE OTHER. IF YOU'RE FULLY TRANSPARENT, WHY WOULD YOU NOT WANT SOMEONE TO LOOK AT SOMETHING? THERE'S NO DELAY IN IT.

YOU ARE ADOPTING IT TONIGHT. WELL THAT DOCUMENT MOVES TO YOUR WEBSITE, WHY NOT HAVE SOMEONE LOOK AT IT, A PEER REVIEW LOOK AT IT AND SAY, HEY, WE LOOKED THROUGH WHAT THEY DID. WE'RE A PROFESSIONAL HISTORIAN, WE LOOKED AT IT, WE THINK EVERYTHING IS GREAT. LOOKS AT IT, DUE DILIGENCE, AND TRANSPARENCY WHO WOULD POSSIBLY OBJECT TO THAT? YOU CAN'T SAY YOU'RE TRANSPARENT ON ONE END AND NOT BE ON THE OTHER. SO I'M NOT TALKING ABOUT THE ADOPTION.

THE ADOPTION I 100% AGREE WITH, WE'RE ON THE SAME PAGE.

BUT I ALSO DON'T SEE WHY ANYONE COULD OBJECT TO A THIRD PARTY. NOT SOMEONE WE TRIED TO ENGAGE IN THE PAST THAT COULDN'T WORK OUT THE WAY WE WANTED TO, NOT SOMEONE ELSE, BUT SOMEONE WE HAVE NOT ENGAGED, DOES NOT LIVE IN MANHATTAN BEACH, LET THEM LOOK AT IT. WELL WE DON'T LOSE ANY TIME, THE ADOPTIVE PROCESS MOVES TO THE WEBSITE, AND MOVE FORWARD.

SO IF JOE WANTED A SECOND TO HIS AMENDMENT, I'D BE THE SECOND TO IT. BUT IF THE MAKER OF THE MOTION DOESN'T WANT TO DO IT THEN IT STANDS WHERE IT STANDS.

>> Hildy Stern: IF I CAN JUST RESPOND TO THAT AS WELL.
IN SUPPORT OF THE MOTION --

>> Richard Montgomery: OH, I'M SORRY THERE'S A HAND UP.

>> Suzanne Hadley: WHO HAS -- OH, STEVE?

>> Steve Napolitano: I UNDERSTAND WHY THE REQUEST, BUT THE FACT IS, AND JUST A BOB BRIGHAM'S THESIS HAS BEEN LOOKED AT A MILLION TIMES OVER, ANYBODY CAN DO A REVIEW OF THIS HISTORY AND HAS BEEN WELCOME TO IT. THEY'VE BEEN TRANSPARENT, POSTING IT ALL OVER AND THE MEDIA'S BEEN PUBLIC AND IF ANYONE CAN SHOW WHERE THEY'RE WRONG OR CAN BE BETTER, THEY'RE WELCOME TO DO THAT AND ANYBODY CAN DO IT. WE'RE JUST SAYING WE'RE NOT GOING TO PAY FOR IT. IT'S OPEN. THIS IS OPEN-SOURCE HISTORY HERE. ANYBODY CAN REVIEW THIS AND TAKE A LOOK AT IT IF THEY'RE THAT INTERESTED IN DOING SO.

>> Suzanne Hadley: I AGREE WITH STEVE.

THAT IS THE NATURE OF SCHOLARSHIP THAT EVERYONE LOOKS AT EVERYONE'S WORK.

BUT YES, I DRAW THE LINE AT PAYING FOR IT OR COMMISSIONING IT.

>> Hindy Stern: YEAH, AND I WOULD JUST LIKE TO ADD THAT WE ALL RECOGNIZE THAT THERE WILL BE ADDITIONAL INFORMATION. THAT THE HISTORY ADVISORY BOARD HAS EVEN LET US KNOW THAT THEY WILL CONTINUE TO ADD TO THIS REPORT AND AS THEY'VE BEEN SO OPEN TO ALL OF THE INPUT THAT THEY'VE RECEIVED SO FAR, THEY WOULD CONTINUE, I WOULD EXPECT, TO BE OPEN TO ANYBODY WHO LOOKS AT THIS REPORT WHO WANTS TO GIVE THEM ADDITIONAL INFORMATION THAT MAKES THEIR REPORT EVEN MORE CREDIBLE. SO I DON'T ANTICIPATE THAT THAT WOULD BE A PROBLEM.

I DON'T THINK THAT WE NEED TO INCLUDE THAT IN THE MOTION.

I THINK THAT WILL COME MORE ORGANICALLY, MORE NATURALLY AS ANYBODY IS READING THIS.

>> Joe Franklin: MADAM MAYOR, MAY I COMMENT?

>> Suzanne Hadley: YES, JOE.

>> Joe Franklin: I WANT TO REITERATE WHAT RICHARD IS SAYING. I HEAR TRANSPARENCY ALL THE TIME, I DON'T KNOW WHAT WE'RE AFRAID OF. WE'RE AFRAID OF SPENDING A LITTLE BIT OF MONEY TO GET A REPORT AS ACCURATE AS POSSIBLE FROM WHAT WE WOULD ALL HOPE TO BE AN UNBIASED SOURCE?

CERTAINLY, WE'VE SEEN BIAS IN THIS WHOLE PROCESS. IF YOU'RE GOING TO SAY NO, YOU'RE NOT BEING TRUE TO YOURSELF. THERE IS A BIAS IN THIS ENTIRE PROCESS.

>> Hildy Stern: YOUR HONOR, YOU'LL HAVE TO EXCUSE ME. I THINK I AM GOING TO CALL FOR THE VOTE.

>> Suzanne Hadley: CALL FOR THE QUESTION.

>> Joe Franklin: I'LL FINISH MY COMMENTS.

SO, THERE'S NO HARM, IT'S GOING TO BE VERY TRANSPARENT, IT MAY COST SOME MONEY BUT, AGAIN, I THINK THE RESIDENTS OF MANHATTAN BEACH DESERVE IT.

>> Hildy Stern: THANK YOU.

THANK YOU, COUNCILMEMBER FRANKLIN. I HAVE CALLED FOR THE QUESTION.

>> Suzanne Hadley: SO CITY CLERK LIZA TAMURA, WE'RE READY FOR THE ROLL CALL VOTE PLEASE.

>> Liza Tamura: COUNCILMAN MONTGOMERY?

>> Richard Montgomery: YES

>> Liza Tamura: COUNCILMEMBER NAPOLITANO?

>> Steve Napolitano: YES

>> Liza Tamura: COUNCILMEMBER FRANKLIN?

>> Joe Franklin: NO

>> Liza Tamura: MAYOR PRO TEM STERN?

>> Hildy Stern: YES

>> Liza Tamura: MAYOR HADLEY?

>> Suzanne Hadley: YES

>> Liza Tamura: MOTION PASSES, 4-1. COUNCILMEMBER FRANKLIN VOTING NO.

>> Richard Montgomery: YOUR HONOR, JUST CLARIFICATION. YOU USE THE WORD ADOPTION, CORRECT?

>> Suzanne Hadley: I DID NOT MAKE THE MOTION.

>> Hildy Stern: YES.

>> Suzanne Hadley: OKAY.

>> Hildy Stern: WE DID ADOPT IT.

>> Suzanne Hadley: OKAY.

>> Quinn Barrow: ACCEPT?

>> Hildy Stern: ADOPT THE HISTORY.

>> Quinn Barrow: ADOPT, OKAY.

>> Suzanne Hadley: AND FOR THE FOLKS AT HOME, I WOULD LIKE TO REMIND EVERYONE RIGHT NOW THE UPDATED PLAQUE LANGUAGE IS PLANNING TO COME BACK TO COUNCIL ON JULY 20TH.

IF YOU WOULD LIKE TO MARK YOUR CALENDARS, THAT'S THE SECOND MEETING IN JULY FOR CITY COUNCIL.

SO AGAIN THANK YOU, HISTORY ADVISORY BOARD. THANK YOU, TASK FORCE MEMBERS. THANK YOU. I THINK OUR DEPUTY CITY CLERK SAID WE HAD 250 EMAILS AND THAT WAS AT THE TIME OF THE MEETING.

AND I RECEIVED MANY DURING THE MEETING THAT I WAS NOT ABLE TO READ BUT I DID SEE MY INBOX GOING OFF.

SO I THANK YOU FOR ALL THE COMMUNITY INPUT.

MORE INPUT IS ALWAYS BETTER. DEMOCRACY DIES IN DARKNESS SO I'M REALLY THRILLED THAT WE HAD AS MUCH COMMUNITY INPUT AS POSSIBLE.

>> Richard Montgomery: COULD YOU REPEAT THAT?

HOW MANY PEOPLE ACTUALLY EMAILED THE COUNCIL?

>> Suzanne Hadley: MARTHA SAID 250 EARLIER ON THIS AGENDA ITEM 15 AND THEN HOW MANY HAVE YOU COUNTED SINCE THE MEETING BEGAN, MARTHA? PROBABLY NONE.

>> Martha Alvarez: PROBABLY ABOUT FIVE OR SIX MORE.

>> Suzanne Hadley: OKAY.

>> Richard Montgomery: SO 244 MORE THAN RECEIVED ON THE BUDGET. ALL RIGHT, THANK YOU.

>> Suzanne Hadley: YEAH. WELL FOLKS CARE AND THEY DO WANT TO GET IT RIGHT AND I RESPECT THAT. I THINK WE WILL NEVER AGREE ON WHAT RIGHT IS IN THESE DIVIDED TIMES SADLY. SO WE WILL MOVE ON. ITEM NUMBER 16, WE WILL CONSIDER EXTENSION OF THE EXPIRATION DATE OF --

>> Joe Franklin: PARDON.

>> Hildy Stern: JOE IS TRYING TO COMMENT.

>> Suzanne Hadley: OH, YES.

>> Joe Franklin: SO, WE TRY TO HAVE PUBLIC COMMENT GIVEN THE FACT THAT THERE SEEMED TO BE SOME CONFUSION. I THINK SEVERAL OF US GOT TEXTS ABOUT THE RAISED HAND FUNCTION WASN'T WORK, BUT GIVEN THE FACT THAT WE GOT TWO HUNDRED AND FORTY SOMETHING ODD EMAILS DON'T YOU THINK THAT THERE WOULD BE PEOPLE WHO WANT TO COMMENT? AND HOW DO WE ADDRESS THAT?

>> Suzanne Hadley: CITY ATTORNEY BARROW? IT WAS THE SECOND AGENDA ITEM AFTER OUR BREAK.

WE HAD ITEM 14, AND WE HAD PUBLIC COMMENT THEN, AND THEN ITEM 15 CAME SECOND AFTER OUR BREAK.

>> Quinn Barrow: SO UNDER THE BROWN ACT, PEOPLE WERE PROVIDED AN OPPORTUNITY TO SPEAK ON THIS ITEM TWICE.

AT THE BEGINNING OF THIS COUNCIL MEETING AND THEN BEFORE THIS MEETING.

>> Suzanne Hadley: BEFORE THIS ITEM?

>> Quinn Barrow: YES. THANK YOU, BEFORE THIS ITEM. SO THE CITY HAS FULLY COMPLIED WITH THE BROWN ACT.

>> Suzanne Hadley: OKAY. THANK YOU, COUNCILMEMBER FRANKLIN. WE'VE GOTTEN THE RULING FROM CITY ATTORNEY BARROW.

WE'RE GOING TO MOVE ONTO AGENDA ITEM 16, CONSIDERING EXTENSION OF THE EXPIRATION DATE OF TEMPORARY ENCROACHMENT PERMITS FOR OUTDOOR STREET DINING ON OCEAN DRIVE AND ON MANHATTAN BEACH BOULEVARD WEST OF OCEAN AFTER JULY 5TH, 2021. COMMUNITY DEVELOPMENT DIRECTOR TAI, ARE YOU IN THE HOUSE?

>> Carrie Tai: I AM. GOOD EVENING AGAIN, HONORABLE MAYOR AND MEMBERS OF THE CITY COUNCIL. OUR CITY TRAFFIC ENGINEER ERIK ZANDVLIET HAS A BRIEF STAFF REPORT ON THIS AND SO I WOULD LIKE TO TURN IT OVER TO HIM. THANK YOU.

>> Erik Zandvliet: THANK YOU, DIRECTOR TAI. GOOD EVENING, MAYOR AND MEMBERS OF THE CITY COUNCIL. I WILL RUN YOU THROUGH A SHORT SLIDE TO SUMMARIZE THIS ITEM REGARDING A TIME EXTENSION OF THE OUTDOOR DINING WEST OF OCEAN DRIVE.

SO AS YOU CAN RECALL, BACK ON MAY 15TH THE CITY COUNCIL APPROVED

EXTENDING OUTDOOR DINING FOR MANY OF THE OTHER DINING DECKS UNTIL SEPTEMBER 6TH, LABOR DAY, AND EXTENDED THE DECKS THAT WERE WEST OF OCEAN DRIVE OR ON OCEAN DRIVE UNTIL JULY 5TH.

CURRENTLY THOSE PERMITS ARE AUTHORIZED UP TO JUNE 30TH, ON A MONTH-TO-MONTH BASIS.

THERE ARE THREE PERMIT AREAS WEST OF OR ON OCEAN DRIVE.

WE HAVE A COUPLE OF SUMMERTIME EVENTS COMING UP, JULY 30TH THROUGH AUGUST 1ST WILL BE THE INTERNATIONAL SURF FESTIVAL AND THE SIXTHMAN VOLLEYBALL TOURNAMENT. THEN ON AUGUST 19TH THROUGH THE 21ST THERE WILL BE THE MANHATTAN BEACH OPEN VOLLEYBALL TOURNAMENT.

WE EXPECT THESE EVENTS TO BE SOMEWHAT LESS ATTENDED THAN BEFORE, BUT IT IS A VERY POPULAR SUMMER AND WE ALREADY STARTED SEEING A LOT OF PEOPLE GOING TO THE BEACH THIS SUMMER.

REGULATIONS STARTED KICKING INTO EFFECT TODAY, JUNE 15TH. FROM THE STATE AND THE COUNTY, OUR TIER SYSTEM IS REMOVED NOW AT THIS POINT AND EMPLOYEES ARE STILL REQUIRED TO WEAR FACE MASKS FOR RESTAURANTS. THERE WILL BE NO TABLE SPACING RESTRICTIONS OR ANY SPECIAL INDOOR DINING RESTRICTIONS LIKE TABLE SPACING OR THAT.

THE CITY STILL REQUIRES A 100% MAXIMUM SEATING INSIDE AND OUTSIDE. YOU CAN'T GO MORE THAN YOU'RE INDOOR SEATING CAPACITY THAT YOU HAD BEFORE COVID.

OUTDOOR DINING SERVICE ENDS AT 10 PM.

YOU ARE ALLOWED TO BE ON THE DECKS UNTIL 10:30 AND THEN THERE IS A CLEANUP TIME PERIOD UNTIL 11 PM. THE STREET ENCROACHMENT AREAS WILL END ON SEPTEMBER 16TH AS I MENTIONED BEFORE, THE OTHER DINING AREAS. THE THREE ENCROACHMENT AREAS ARE THE STRAND HOUSE, THAT'S ON THE NORTH SIDE OF MANHATTAN BEACH BOULEVARD BETWEEN OCEAN DRIVE AND THE STRAND. THE SECOND ONE IS ROCK'N FISH AND THAT'S A RAISED PLATFORM ON THE SOUTHSIDE OF MANHATTAN BEACH BOULEVARD.

AND THE THOSE TWO DECKS ARE RAISED DECKS.

THEY ARE BASICALLY OUTDOOR STAGING AND BECAUSE OF THE SLOPE OF THE STREET, IT REQUIRES QUITE A BIT OF WORK TO INSTALL THEM.

THERE'S STRUCTURAL CALCULATIONS AND BUILDING PERMITS THAT ARE REQUIRED FOR THOSE.

WHEN THEY WENT IN, THEY TOOK ABOUT TWO WEEKS TO BE INSTALLED FROM THE BEGINNING TO THE TIME THAT WE HAD THEM INSPECTED. CORRECTIONS WERE MADE AND THEY WERE ABLE TO START DINING ON TOP.

IT WOULD TAKE ABOUT A WEEK FOR THEM TO BE DISASSEMBLED AND TAKEN AWAY. DURING BOTH OF THOSE TIME PERIODS, PARTS OF THE STREET DO HAVE TO BE CLOSED OFF BECAUSE OF THE CONSTRUCTION ACTIVITY THAT'S GOING ON. ALL OF THOSE WATER BARRIERS HAVE TO BE EMPTIED OR FILLED AND REMOVED WITH SEMITRUCKS.

THE THIRD ENCROACHMENT AREA IS FOR THE SHELLBACK TAVERN AND AREAS DIRECTLY ADJACENT TO THE SHELLBACK ON OCEAN DRIVE.

THIS IS A DIFFERENT DECK BECAUSE IT IS DIRECTLY ON THE PAVEMENT ITSELF. THERE IS NO DECKING OR RAISED AREAS FOR THAT AND THEY HAVE IT SURROUNDED BY WATER BARRIERS.

SO, IT WOULD BE A VERY QUICK EFFORT TO EITHER INSTALL IT OR REMOVE IT. WE WERE ABLE TO DO THAT IN ONE DAY BEFORE.

HERE'S A TENTATIVE SUMMER CALENDAR THAT SHOWS YOU THE DATES FOR SET UP AND TAKE DOWN OF THE TWO SUMMERTIME EVENTS.

THE INTERNATIONAL SURF FESTIVAL WOULD BEGIN CONSTRUCTION ON THE 26TH OF JULY AND THEN GO THROUGH THE EVENT ITSELF AND THEN THERE WILL BE A TEAR DOWN DAY ON THE 2ND OF AUGUST.

AND THEN FOR THE MANHATTAN BEACH OPEN, IT TAKES A LITTLE BIT LONGER BECAUSE THEY DO HAVE A LOT MORE SCAFFOLDING AND STAGING TO SET UP. THEY START ON THE 15TH OF AUGUST FOR SET UP, GO THROUGH THE EVENT, AND THEN THE TEAR DOWN TAKES A FEW DAYS UNTIL AUGUST 25TH.

SO, IF YOU LOOK BETWEEN THE TWO EVENTS THERE DEFINITELY WOULDN'T BE ENOUGH TIME TO SET UP AND TAKE DOWN A SET OF OUTDOOR PLATFORMS ALONG MANHATTAN BEACH BOULEVARD.

THE DINING DECK REMOVAL IF THE DECKS WERE TO BE CLOSED ON JULY 5TH, WOULD TAKE ABOUT A WEEK AND THEN BE OUT OF THERE BY ABOUT JULY 9TH OR 10TH. LABOR DAY IS SEPTEMBER 6TH, AND THAT'S THE ENDING FOR ALL OF THE OTHER DINING DECKS AS WELL.

WE DO HAVE ABOUT TWO WEEKS BEFORE THE INTERNATIONAL SURF FESTIVAL STARTS.

WE DO HAVE HEAVY BEACH ACTIVITY DURING THE SUMMERTIME AND IT IS VERY CONGESTED, BOTH FROM A PEDESTRIAN STANDPOINT AND FROM A VEHICLE STANDPOINT ON MANHATTAN BEACH BOULEVARD AND NEAR ALL THE PARKING LOTS THAT ARE BY THE PIER.

THE RESTAURANTS HAVE PROPOSED A COUPLE OF DIFFERENT THINGS. FOR THE STRAND HOUSE AND ROCK'N FISH, THEY ARE PROPOSING TO KEEP THE DECKS IN PLACE DURING THE SUMMER BUT REDUCE THE WIDTH OF ONE OF THE DECKS FOR THE STRAND HOUSE BY FOUR FEET TO BASICALLY RESTORE THE ORIGINAL STREET WIDTH MINUS THE VEHICLE PARKING AREAS DURING THE SUMMERTIME. AND THE OPTION TOO THAT MR. ZISLIS HAS PROPOSED RECENTLY IN A LETTER THAT WAS ATTACHED TO THE REPORT, OR TO THE TO CORRESPONDENCE, IS TO LEAVE THE OUTDOOR DECKS IN PLACE FOR ANOTHER TWO WEEKS AND HAVE THEM REMOVED BY JULY 25TH BEFORE THE SUMMERTIME EVENT, THE FIRST INTERNATIONAL SURF FESTIVAL/SIXTHMAN, HAS TO START SETTING UP.

THE SHELLBACK TAVERN HAS AN EXTRA WIDE AREA RIGHT NOW.

THE PROPOSAL IS TO REDUCE THAT DINING AREA TO 10 FEET WIDE.

THAT PROVIDES 20 FEET FOR TWO-WAY TRAFFIC ON OCEAN DRIVE BESIDE THE SHELLBACK OUTDOOR DINING AREA.

THIS IS BECAUSE THE STREET WIDTH IS ACTUALLY 30 FEET IN THIS AREA SO THAT COULD BE ALLOWED AND WE WOULD STILL HAVE TWO-WAY TRAFFIC IN THAT AREA.

WE COULD NOT DO THAT ON OCEAN DRIVE NORTH OF THE MANHATTAN BEACH BOULEVARD BECAUSE IT IS ONLY 25 FEET WIDE.

HERE'S A GRAPHICAL REPRESENTATION OF THE AREA AND YOU CAN SEE THE ENCROACHMENT AREAS FOR THE STRAND HOUSE ON THE NORTH SIDE OF MANHATTAN BEACH BOULEVARD AND ROCK'N FISH ON THE SOUTH SIDE OF MANHATTAN BEACH BOULEVARD.

THESE DECKS ARE ABOUT 13.5 FEET WIDE INCLUDING THE WATER BARRIERS ON BOTH SIDES AND PROVIDE ABOUT 33 FEET IN BETWEEN FOR TWO-WAY TRAFFIC.

THE BLUE AREAS ARE THE AREAS THAT ARE BEING USED FOR THE SPECIAL EVENTS.

THERE'S A COMBINATION OF THINGS THAT ARE GOING ON BOTH FROM A PUBLIC SAFETY STANDPOINT AND JUST FROM A CIRCULATION STANDPOINT THAT THOSE AREAS ARE NEEDED FOR THAT.

SO IN CLOSING, OUR RECOMMENDATION IS TO DISCUSS THIS AND PROVIDE DIRECTION TO OUR STAFF.

THE STAFF'S RECOMMENDATION BEFORE THE LETTER CAME IN FROM MR. ZISLIS WAS TO REQUIRE REMOVAL OF THE DINING AREAS ON MANHATTAN BEACH BOULEVARD, WEST OF OCEAN DRIVE AFTER JULY 5TH, THAT'S AFTER THE INDEPENDENCE DAY HOLIDAY, AND THEN REDUCE THE SHELLBACK DINING AREA TO 10 FEET WIDE TO PROVIDE 20 FEET STREET WIDTH OCEAN DRIVE, AND THEN ALL OF THE DINING DECKS WEST OF OCEAN DRIVE WOULD BE REMOVED AFTER SEPTEMBER 6TH.

WITH THAT I WOULD BE HAPPY TO ANSWER ANY QUESTIONS THAT YOU MIGHT HAVE.

>> Richard Montgomery: YOUR HONOR.

>> Suzanne Hadley: THANK YOU, ENGINEER ZANDVLIET. I'LL TURN TO MY COLLEAGUES FOR QUESTIONS. YES, RICHARD MONTGOMERY.

>> Richard Montgomery: THANK YOU. ERIK, THE DIAGRAM SHOWED RECOMMENDED JULY 5TH FOR THE TWO SPOTS, ONE BY ROCK'N FISH, ONE BY STRAND HOUSE. YOU'RE SAYING NOW WITH THE NEW LETTER THAT YOU RECEIVED FROM ZISLIS YOU'RE OKAY WITH LEAVING THEM IN PLACE FOR TWO ADDITIONAL WEEKS?

>> Erik Zandvliet: THE ADDITIONAL TWO WEEKS WOULD BE MORE OF THE TIME PERIOD WHERE WE HAVE SUMMERTIME BEACH TRAFFIC.

IF IT IS OKAY WITH THE POLICE DEPARTMENT AND FIRE DEPARTMENT TO LEAVE THOSE DECKS IN PLACE THEN WE COULD MANAGE THAT.

>> Richard Montgomery: ALL RIGHT. THANK YOU.

>> Suzanne Hadley: MAYOR PRO TEM, STEVE, JOE?

>> Hildy Stern: I DO HAVE ONE.

>> Suzanne Hadley: QUESTIONS?

>> Hildy Stern: I DO HAVE A QUESTION.

>> Suzanne Hadley: YES, MAYOR PRO TEM.

>> Hildy Stern: YEAH ERIK, CAN YOU JUST CONFIRM WE HAD RECEIVED WORD FROM THE OWNER OF SHELLBACK THAT THEY WERE ORIGINALLY PROPOSING THAT THEY COULD TEAR DOWN THEIR STRUCTURES AND PUT THEM BACK UP VERY EASILY AROUND THE SPECIAL EVENTS, BUT IT LOOKS -- AM I UNDERSTANDING IT CORRECTLY HOWEVER? THAT IF THEY JUST REDUCE THE WIDTH THAT THEY DON'T NEED TO TEAR DOWN AND PUT THEIR STRUCTURES BACK UP DURING THE SPECIAL EVENTS?

>> Erik Zandvliet: CORRECT. THAT'S THE ASSESSMENT THAT WE HAD FROM PARKS AND REC, FIRE AND POLICE. IF WE PROVIDE THE 20-FOOT-WIDE STREET WIDTH, THEY COULD KEEP THEIR OUTDOOR DINING AREA IN PLACE.

>> Hildy Stern: THANK YOU.
>> Suzanne Hadley: JOE?
>> Joe Franklin: MAYOR HADLEY.
>> Suzanne Hadley: YES.
>> Joe Franklin: MAY I ASK YOU A QUESTION PLEASE?
SO -- AND I'M SORRY, I DON'T HAVE THE SOURCE DOCUMENT IN FRONT OF ME.
CAN YOU PUT THE CALENDAR THERE WITH THE NUMBER OF DAYS THAT ARE NEEDED TO TEAR SOMETHING DOWN AND PUT SOMETHING UP?
>> Erik Zandvliet: HERE YOU GO.
>> Joe Franklin: OKAY. SO OPTION TWO FOR THE STRAND HOUSE WAS THAT IF THEY REDUCE IT BY FOUR FEET, THE WIDTH, THAT THEY COULD GO AHEAD AND STAY THERE UNTIL JULY 25TH. RIGHT?
>> Erik Zandvliet: NO, THE OPTION TWO IS TO LEAVE THEIR DECKS IN PLACE AS THEY ARE NOW, UNTIL JULY 25TH AND THEN THEY WOULD TAKE BOTH DECKS DOWN COMPLETELY FOR THE REST OF THE SUMMER.
>> Joe Franklin: OKAY, THAT'S OPTION TWO. I'M SORRY, SO WHAT'S THE REMOVE FOUR FEET?
>> Erik Zandvliet: THAT WAS THE ORIGINAL PROPOSAL BY STRAND HOUSE IN ORDER TO KEEP IT UP FOR THE ENTIRE SUMMER.
>> Joe Franklin: OH SO THAT WAS THEIR OPTION TWO.
>> Erik Zandvliet: RIGHT.
>> Joe Franklin: NOT OURS.
>> Erik Zandvliet: THEIR OPTION ONE.
>> Joe Franklin: OH THEIR OPTION ONE. OKAY, GOT IT. AND I BELIEVE THEY ALSO CONTACTED US AND SAID THAT THEY COULD DO IT RELATIVELY QUICKLY LIKE WITHIN A DAY OR SO.
>> Erik Zandvliet: WE'LL SEE IF THAT HAPPENS, BUT I'M SURE IT WILL TAKE A FEW DAYS IN ORDER FOR IT TO BE DISASSEMBLED.
>> Joe Franklin: OKAY. ALL RIGHT, THANK YOU.
>> Suzanne Hadley: STEVE, ANY QUESTIONS?
>> Steve Napolitano: WELL I GUESS, IT KIND OF WAS RAISED BY ERIK AS TO WHAT IS THE INPUT ON THE POLICE AND FIRE AT THIS POINT?
>> Suzanne Hadley: IS CHIEF ABELL ON THE LINE? CITY MANAGER MOE, ARE WE ABLE TO TAP INTO HIS EXPERTISE OR INTERIM FIRE CHIEF TIM O'BRIEN?
>> *Bruce Moe: OR CARRIE MAY KNOW THE ANSWER ALSO.
>> Suzanne Hadley: OKAY.
>> Carrie Tai: YEAH, YOUR HONOR, I UNDERSTAND. SO TRAFFIC ENGINEER ZANDVLIET PARTICIPATES IN A SPECIAL EVENTS COMMITTEE MEETING THAT'S DISCIPLINARY. IT HAS
IT HAS PARKS AND REC STAFF IN IT, POLICE AND FIRE AND THAT'S WHERE ALL OF THESE ASSESSMENTS IS CONDUCTED.
SO I CAN HAVE ERIK SUMMARIZE THE PUBLIC SAFETY POSITION, BUT I'LL JUST LEAD BY SAYING OBVIOUSLY THERE IS CONCERN ABOUT THE HEAVY BEACH TRAFFIC IN THE TWO WEEKS AFTER THE JULY 4TH HOLIDAY AND OBVIOUSLY BEFORE SIXTHMAN STARTS TO SET UP. HOWEVER I BELIEVE ERIK MENTIONED THAT WAS A TOLERABLE LEVEL, BUT ERIK, I'LL LET YOU ELABORATE ON THAT

AS WELL AS THE OTHER OPTION; WHY THE REDUCTION IN THE FOUR FEET IS NOT A VIABLE OPTION FOR THE LONG TERM THROUGHOUT THE SUMMER.

>> Erik Zandvliet: WELL, THANK YOU DIRECTOR TAI. WITH REGARD TO THE CONCERNS THAT WE RAISED IN THE SPECIAL EVENTS COMMITTEE, IT WAS VERY CLEAR FROM THE FIRE AND POLICE DEPARTMENTS THAT THOSE DECKS NEEDED TO BE OUT AND COMPLETELY GONE FOR EACH OF THE EVENTS.

THERE IS JUST TOO HIGH OF A PUBLIC SAFETY RISK THAT WE NEED TO BE ABLE TO HAVE EVACUATION AREAS WE NEED TO BE ABLE TO ACCESS IN ANY DIRECTION FOR WHATEVER INCIDENT MAY OCCUR.

SO LEAVING THE DECKS UP, EVEN WITH A REDUCED WIDTH WOULD NOT BE ACCEPTABLE FROM A PUBLIC SAFETY STANDPOINT.

NOW FOR GENERAL SUMMERTIME TRAFFIC, BEFORE THE FIRST EVENT, THAT COULD BE A TOLERABLE CONDITION.

IT WOULD LIKELY BE THAT MORE DAYS WOULD BE CLOSED TO VEHICLE TRAFFIC ON MANHATTAN BEACH BOULEVARD WEST OF MANHATTAN AVENUE, AND IT WOULD BASICALLY BECOME A PEDESTRIAN AREA.

MORE OR ALMOST ALL THOSE DAYS AFTER JULY 4TH AND BEFORE JULY 25TH. THAT WOULD BE PROBABLY THE WAY WE WOULD HANDLE THE PUBLIC ACCESS TO THAT AREA. HOPEFULLY, THAT ANSWERS YOUR QUESTION.

>> Suzanne Hadley: YEAH. THANK YOU, ERIK.

STEVE, DOES THAT ANSWER YOUR QUESTION?

>> Steve Napolitano: YES. THANK YOU, YOUR HONOR.

>> Suzanne Hadley: OKAY. THANK YOU, STEVE. MAYOR PRO TEM.

>> Hildy Stern: YEAH. I FEEL LIKE -- I JUST WANT TO MAKE SURE I UNDERSTAND HOW THE IMPLICATIONS OF TAKING SOMETHING DOWN AND PUTTING IT BACK UP AND WE DID RECEIVE PUBLIC COMMENT FROM MIKE ZISLIS THAT IT WOULD TAKE JUST A COUPLE DAYS TO TAKE DOWN THE DECKS.

AND SO I JUST WANTED TO MAKE SURE THAT WE ARE UNDERSTANDING AND I WAS LOOKING BEHIND ME TO SEE THAT, THE CALENDAR AGAIN, BUT THAT WE DO REALLY UNDERSTAND THAT IT DOES TAKE -- IS IT TWO DAYS TO TAKE DOWN A DECK? IS IT A WEEK TO TAKE DOWN A DECK? BECAUSE I CAN SEE THAT IF IT IS NOT AS BURDENSOME IN TIME THAT MAYBE THERE ARE WAYS TO CONTINUE TO SUPPORT SOME OF THE RESTAURANTS ALLOWING THEM TO HAVE THESE DECKS UP IN BETWEEN EVENTS IF THEY WANTED TO INCUR THE COST OR THE INCONVENIENCE OF TAKING DOWN AND THEN PUTTING BACK UP.

SO CAN YOU HELP ME UNDERSTAND THE TIMING OF HOW LONG IT WOULD TAKE TO TAKE THEM DOWN AND HOW LONG IT WOULD REALLY TAKE THEM TO PUT THEM BACK UP GIVEN THE COMMENTS THAT WE RECEIVED?

>> Erik Zandvliet: SURE. THANK YOU. I CAN ANSWER THAT. WITH REGARD TO TAKING DOWN THE DINING DECKS THAT ARE ON MANHATTAN BEACH BOULEVARD WEST OF OCEAN DRIVE, THOSE DECKS IN ALL PRACTICAL SENSES WOULD TAKE 3-4 DAYS TO TAKE DOWN.

THERE IS JUST SO MUCH INFRASTRUCTURE THAT'S BUILT INTO THOSE DECKS. THERE ARE FLOORS AND EXTRA WIDTH HOLDING IT ON THAT SLOPE.

TO INSTALL A DECK AGAIN AFTER IT HAS BEEN TAKEN DOWN, MIGHT BE REDUCED FROM TWO WEEKS TO MAYBE A WEEK AND A HALF.

BUT IT HAS TO BE UNDERSTOOD THAT DURING THAT TIME, THE STREET IS CLOSED

COMPLETELY BECAUSE THEY NEED THAT AREA FOR CONSTRUCTION AND SO IT'S A MAJOR DISRUPTION TO THE GENERAL PUBLIC IN THAT REGARD.

SO EVERY TIME YOU TRY TO TAKE DOWN SOMETHING OR PUT IT UP, IT'S GOING TO CLOSE OFF SIDEWALKS AND STREETS AND ALL OF THE REST. IT'S JUST GOING TO BE TOO DIFFICULT TO DO THAT DURING SUMMERTIME.
>> Carrie Tai: IF I CAN ADD ON TO ERIK'S ANSWER IN TERMS OF BREAKING DOWN AND REINSTALLING, BOTH SIDES REQUIRE THE ONGOING INSPECTION PROCESSES.

SO WHEN YOU BREAKDOWN SOMETHING, THAT'S CONSTRUCTED IN THE RIGHT OF WAY THE PUBLIC WORKS INSPECTORS NEED TO GO OUT AND INSPECT THE RIGHT OF WAY TO ENSURE THAT IT'S RETURNED TO ITS PROPER CONDITION. IF YOU THEN PUT IT BACK UP, EVEN THOUGH THERE ARE PROOF PLANS, THERE'S ANOTHER SET OF INSPECTIONS.

THE TIMELINES THAT ARE IN THE STAFF REPORT ARE FROM WHEN THE DECKS WERE INSTALLED.

WE TOOK THOSE EXACT TIMELINES.

SO THAT IS A TRIED-AND-TRUE PROVEN TIMELINE.

NOW THEY HAVEN'T BROKEN THEM DOWN YET BUT GIVEN THE AMOUNT OF MATERIAL THAT'S WHAT ERIK WAS ESTIMATING.

SO I WANTED TO TALK A LITTLE BIT JUST ABOUT THE VERTICAL BREAKDOWN AND INSTALLATION AS WELL AS THE COORDINATION WITH THE CITY INSPECTION PROCESSES.

IT'S NOT UNILATERAL IN TERMS OF RESPONSIBILITY. THERE IS A LOT OF COORDINATION THAT GOES ON THERE AS WELL. SO THANK YOU.

>> Joe Franklin: MAY I ASK A QUESTION, PLEASE?

>> Suzanne Hadley: YES, LET'S SEE. MAYOR PRO TEM, ARE YOU FINISHED?

>> Hildy Stern: YEAH, I JUST WANTED TO ALSO ASK IF -- THE SET UP TIME FOR THE TWO EVENTS THAT ARE NOTED, THE ONE STARTING ON JULY 30TH AND THE OTHER ONE STARTING ON AUGUST 19TH, THERE'S A GRACE PERIOD OF SET UP TIME OF ABOUT FIVE DAYS BEFORE THOSE TWO EVENTS START. WILL THE ROADS BE BLOCKED OFF FOR THEIR SET UP AS WELL?

>> Erik Zandvliet: SO WITH REGARD TO SET UP TIME FOR THE EVENTS THEMSELVES, FIRST START WITH NO PARKING RESTRICTIONS. THERE'S A NUMBER OF LARGE VEHICLES THAT COME IN AND START STAGING EQUIPMENT AND MATERIALS IN THE PARKING LOTS.

SO FROM A PHYSICAL STANDPOINT, THE TRAVEL LANE IS OPEN.

THEN AS YOU GET CLOSER TO THE EVENT ITSELF.

THEN THEY HAVE SPECIAL THINGS THAT GO INTO THE STREET THEMSELVES, WHETHER IT'S -- I'M TRYING TO THINK OF THE WORDS - ANCILLARY-TYPE SUPPORT, PROMOTIONAL EVENTS, AND THINGS LIKE THAT IN THAT AREA.

>> Hildy Stern: OKAY, THANK YOU.

>> Erik Zandvliet: PARTICULARLY FURTHER DOWN MANHATTAN BEACH OPEN THERE IS A LARGE AMOUNT OF SET UP AND MANY BIG RIGS COME IN TO THE AREA FOR THAT.

>> Hildy Stern: OKAY.

>> Suzanne Hadley: OKAY, JOE FRANKLIN. YOU'RE NEXT.

>> Joe Franklin: YES. THANK YOU, MAYOR. HAVE WE GOTTEN COMMITMENTS

FROM BOTH THESE ORGANIZATIONS THAT THEY ARE GOING TO BE BUILDING AS MUCH SEATING AND INFRASTRUCTURE AS THEY'VE HAD IN THE PAST?

>> Suzanne Hadley: YOU SAYING AT THE EVENTS OR OF THE --

>> Joe Franklin: YEAH, OF THE EVENTS.

>> Suzanne Hadley: OKAY.

>> Joe Franklin: ARE THEY GOING TO BE FULLY THE SAME AMOUNT OF BLEACHERS --

>> Erik Zandvliet: ALL RIGHT.

SO I CAN ANSWER THAT. SO FOR THE SIXTHMAN VOLLEYBALL AND INTERNATIONAL SURF FESTIVAL, THE SHOW WILL GO ON AND IT WILL GO ON IN BASICALLY THE SAME NATURE AS IT HAS IN THE PAST. FOR THE MANHATTAN BEACH OPEN, THE EXPECTATION OF WHAT WE'VE HEARD FROM THEIR ORGANIZERS IS THAT THEY WILL HAVE A SMALLER SPECTATOR AREA THIS YEAR WITH THE ANTICIPATION THEY WILL TRY TO RESTRICT TICKETS TO REDUCE THE NUMBER OF SPECTATORS. IT WILL NOT LIKELY BE THAT THEY HAVE A LARGE SKYDECK OR SOMETHING LIKE THAT BUT THEY'LL STILL HAVE BLEACHERS THAT THEY'LL INSTALL FOR THE EVENT ITSELF.

>> Joe Franklin: WILL THAT CUT DOWN THEIR TIME REQUIREMENT FOR SET UP?

>> Erik Zandvliet: NOT NECESSARILY BECAUSE ALL OF THAT SKYDECK IS GOING ON THE SAME TIME THAT THEY ARE INSTALLING THE SEATING FOR THE REST OF THE AREA AS WELL. AS DIRECTOR TAI SAID, ALL OF IT'S GOING TO BE INSPECTED, ALL OF IT STILL NEEDS TO BE COORDINATED WITH MULTIPLE DEPARTMENTS.

>> Joe Franklin: IS THERE AN INSPECTION REQUIREMENT FOR THE BREAKDOWN OF THE DINING DECKS?

>> Erik Zandvliet: YES, THERE IS A FINAL INSPECTION.

>> Joe Franklin: YEAH OKAY FINAL, BUT NOT DURING THE PROCESS, THEY DON'T HAVE TO WAIT. ONCE THEY TAKE OFF THE PLYWOOD OR ONCE THEY EMPTY THE WATER BARRICADES OR ANYTHING LIKE THAT, RIGHT? THEY CAN JUST GO THROUGH AND START DOING IT.

>> Erik Zandvliet: YES. ESSENTIALLY THEY CAN GO THROUGH BUT WE DO MONITOR THEM.

>> Joe Franklin: OKAY.

>> Suzanne Hadley: OKAY. JOE, ARE YOU GOOD?

>> Joe Franklin: I'M GOOD, THANK YOU.

>> Suzanne Hadley: OKAY AND STEVE I CAN'T REMEMBER, DID YOU HAVE ANOTHER QUESTION OR I GUESS YOURS WAS PUBLIC SAFETY.

>> Steve Napolitano: I DIDN'T HAVE ANY QUESTIONS.

>> Suzanne Hadley: OKAY. LET'S GO TO PUBLIC COMMENT. MARTHA ALVAREZ, ANYONE TEED UP?

>> Martha Alvarez: YES, WE HAVE SUZANNE LERNER. IF SHE CAN PLEASE STATE HER NAME FOR THE RECORD, CITY OF RESIDENCY, AND THEN SHE HAS TWO MINUTES FOR HER PUBLIC COMMENT.

>> Suzanne Lerner: GOOD EVENING EVERYBODY, MAYOR HADLEY, AND CITY COUNCILMEMBERS.

JUST WANT TO SAY I'M VERY HAPPY GOVERNOR NEWSOM OPENED UP THE STATE

AND I REALLY HOPE THAT WE CAN ALL BE BACK TOGETHER IN CITY HALL FOR THESE COUNCIL MEETINGS. I REALLY MISS BEING IN PERSON AND BEING ABLE TO DIRECTLY CONNECT WITH YOU. I KNOW WE'VE ALL BEEN ZOOMING WAY TOO MUCH.

I WANT TO TALK ABOUT THIS ISSUE, I REALLY DON'T THINK WE SHOULD EXTEND THEM.

IT'S BEEN VERY DIFFICULT TO GET AROUND DOWNTOWN AND I LIVE DOWNTOWN. ESPECIALLY DRIVING UP NORTH OCEAN DRIVE TOWARDS MANHATTAN BEACH BOULEVARD, THERE'S SUCH A STREAM OF TRAFFIC THAT I LITERALLY SIT IN GRIDLOCK THERE. AND THEN THERE'S NO CARS BEING ABLE TO PASS MOVING TO THE SOUTH AND I'M REALLY CONCERNED ABOUT EMERGENCY VEHICLES AND PEOPLE IN GENERAL TRYING TO GET AROUND AND I THINK IT'S A MATTER OF PUBLIC SAFETY.

I JUST WANT TO REMIND YOU AGAIN, EMERGENCIES. WHAT IS GOING TO HAPPEN IF THERE IS AN EMERGENCY? WE ARE GOING TO BE COMPLETELY BLOCKED. THE OTHER THING IS I THINK THIS WORK OF REDUCTION WE'RE JUST NITPICKING AT THIS POINT.

WHAT HAPPENS TO BIKES?

BIKES ARE GOING ON THE SIDEWALKS NOW BECAUSE THEY CAN'T RIDE ON THE STREETS.

SO THERE'S JUST ENOUGH ROOM FOR TWO CARS TO PASS BY, BUT WE'RE NOT THINKING ABOUT THE BIKE RIDERS. SO I REALLY THINK WE NEED THE STREETS OPEN.

AND ON MANHATTAN BEACH BOULEVARD WE REALLY NEED OUR PARKING. I WAS WALKING DOWN MANHATTAN AVENUE SATURDAY AFTER THERE WAS A HUGE PARTY ON 10TH STREET AND MANHATTAN AVENUE, IT LOOKED LIKE IT WAS PARTY TIME WITH DRINKING WINE ON THE STREETS, BUT MANHATTAN AVENUE ITSELF WAS EMPTY.

THE STORES WERE EMPTY.

THERE WAS NO PARKING.

THE SMALL RETAILERS HAVE TO BE SUFFERING, PARKING IS IMPOSSIBLE TO FIND. I HAVE FRIENDS THAT LIVE IN THE AREA, THEY CAN'T EVEN PARK THEIR CARS ANYWHERE THEY DON'T HAVE APARTMENTS WITH PARKING. PEOPLE JUST KEEP CIRCLING LOOKING FOR SPACES. SO I DO BELIEVE THERE'S RESIDENTS OF MANHATTAN BEACH THAT ARE JUST GIVING UP COMING DOWNTOWN TO SHOP. SO I REALLY WANT TO HELP AND I THINK WE ALL NEED TO HELP OUR SMALL BUSINESSES SURVIVE AND HELP OUR LOCAL RESIDENTS ENJOY AND UTILIZE DOWNTOWN AND NOT JUST FOR DINING.

SO I REALLY THINK WE ALL HAVE TO THINK ABOUT KEEPING ALL OF OUR SMALL RETAIL SHOPS IN BUSINESS. THANK YOU.

>> Suzanne Hadley: THANK YOU SO MUCH SUZANNE FOR YOUR COMMENTS.

>> Martha Alvarez: NEXT WE HAVE MICHAEL ZISLIS. IF THEY CAN STATE THEIR NAME FOR THE RECORD, CITY OF RESIDENCY, AND THEN THEY HAVE TWO MINUTES FOR THEIR PUBLIC COMMENT.

>> Michael Zislis: THIS IS MICHAEL ZISLIS, I'M A RESIDENT OF MANHATTAN BEACH, A 30 YEAR BUSINESS OWNER OF MANHATTAN BEACH.

I JUST WANT TO REITERATE THAT I'M TRYING TO BE A TEAM PLAYER HERE.

I UNDERSTAND THE NEEDS AND WANTS FROM THE POLICE AND FIRE FOR THIS EVENT COMING UP ON THE 30TH.

I DO NOT ONLY FEEL BUT I HAVE TALKED TO THOSE WHO BUILT THE DECKS AND THEY FELT THEY COULD GET THE DECKS DONE IN ONE DAY WITH MY TEAM TAKING OUT THE PLANTERS AND BARRIERS.

I DID TAKE DOWN THE DEPTHS IN FRONT THE STRAND HOUSE TWO WEEKS AGO OF REQUEST FROM CITY HALL FOR THAT FRIDAY, I WAS NOTIFIED ON A WEDNESDAY AND I HAD THE DECKS OUT IN THE TWO HOURS AND 15 MINUTES. I JUST FEEL -- I DON'T WANT TO HASH OLD THINGS. I DON'T THINK I WAS EVER TOLD TO BE TREATED DIFFERENTLY BUT HERE NOR THERE THAT'S WHERE WE'RE AT TODAY AND GOD BLESS WE'RE OPENING UP.

DON'T KNOW ALL THE RULES YET, STILL WON'T KNOW UNTIL *OSHA.

BUT THE LAST THING TALKED ABOUT MANHATTAN BEACH BOULEVARD. THIS ISN'T ABOUT MANHATTAN BEACH BOULEVARD,

THIS IS UPPER MANHATTAN BEACH, IT'S ABOUT LOWER WEST OF OCEAN. AND I ALSO JUST WANT TO REITERATE THAT ALL SUMMER LONG THERE ARE TWO BARRIERS AT THE TOP OF I THINK MANHATTAN BEACH AVENUE GOING DOWN AND ANOTHER SET OF BARRIERS OF OCEAN GOING DOWN. THEY ARE ALL BLOCKED OFF DUE TO TRAFFIC, ONLY PART OF IT. THE PERSON WITH CSA OR OSHA OPENS IT UP.

SO, I JUST DON'T THINK THAT'S AN ISSUE.

I HOPE YOU GRANT ME, UNTIL THE 25TH AND I REMOVE THE DECKS ON MONDAY AND TUESDAY AND WE ALL HAVE A GREAT SUMMER AND BUSINESS COMES BACK. THANK YOU.

>> Suzanne Hadley: THANK YOU, MICHAEL FOR YOUR PUBLIC COMMENTS.

>> Martha Alvarez: NEXT WE HAVE NEIL LEVENTHAL. IF THEY COULD STATE THEIR NAME FOR THE RECORD, CITY OF RESIDENCY, AND THEN THEY HAVE TWO MINUTES FOR THEIR PUBLIC COMMENT.

>> Neil Leventhal: YES, CAN YOU HEAR ME?

>> Martha Alvarez: YES, WE CAN HEAR YOU.

>> Neil Leventhal: NEIL LEVENTHAL, MANHATTAN BEACH, 120 13TH STREET. OBVIOUSLY, WE'RE GETTING TIRED OF REVISITING THIS ISSUE BUT COUNCIL'S DIFFICULT TASK TO TRY TO BALANCE ALL THE COMPETING INTERESTS IN PLAY. THE CITY HAS ALREADY GONE TO EXTRAORDINARY LENGTHS TO SUPPORT THE RESTAURANTS, MUCH OF IT AT THE EXPENSE OF RESIDENTS AND THE CITY BUDGET, NOT TO MENTION EXTRAORDINARY EFFORTS AND ATTENTION COMING FROM STAFF AND CITY RESOURCES.

WE CONTINUE TO SUPPORT THE DOWNTOWN BUSINESSES, WHICH OF COURSE INCLUDE RESTAURANTS BUT ALSO INCLUDE RETAILERS AND OTHER LOCAL SERVICES FROM GROCERIES TO OPTICIANS TO DRY CLEANERS. AND WE LIKE PATIO DINING AND SPACES THAT ARE DESIGNED AND APPROPRIATE FOR IT. NOT BY ENCROACHING ON OUR STREETS AND SIDE WALKS AND CERTAINLY NOT BY MAKING BAD SITUATIONS WORSE.

WITH THE TRAFFIC, PEDESTRIAN TRAFFIC, PARKING LOTS AT UPPER PIER, AND LIMITED VISIBILITY THE INTERSECTION OF MANHATTAN BEACH BOULEVARD AND OCEAN, THE WESTERN LOWER PART I'M NOT TALKING ABOUT THE UPPER PART, IS DIFFICULT AND DANGEROUS IN MIDWINTER. IT'S UNTENABLE NOW

AND IT'S HARD TO IMAGINE HOW CRAZY IT WILL BECOME JULY 4TH WITH ALL THOSE DECKS STILL IN PLACE AFTER. FRANKLY, THERE SHOULDN'T BE DECK'S EITHER SIDE OF THAT INTERSECTION DUE TO THE LACK OF VISIBILITY AT ANY TIME.

SO IT'S HARD TO IMAGINE HOW THIS CAN GO ON WITHOUT ANY SPECIAL EVENTS LET ALONE THE NEEDS OF FIRE AND PUBLIC SAFETY AND POLICE.

POLICE AND FIRE WERE CLEAR OF THEIR RECOMMENDATIONS EARLIER, THAT THEY DIDN'T THINK IT WAS A GOOD IDEA.

YOU CAN TELL IN THE TONE OF CITY STAFF THAT YES, IF YOU'RE GOING TO NEGOTIATE EVERY SQUARE FOOT AND EVERYDAY, WE CAN HAVE A DEBATE THAT GOES ON FOR LIKE -- AND BY THE WAY I WOULD LIKE TO ASK FOR AN EXTRA FEW MOMENTS SINCE MR. ZISLIS HAD THE OPPORTUNITY TO SPEAK TWO TIMES ON THIS SUBJECT.

>> TRUE.

>> Neil Leventhal: WE'VE GONE OUT OF OUR WAY. WE'VE EXTENDED BEYOND 100% RETURNING CAPACITY FOR THE RESTAURANTS AND NOW HAVE MORE CAPACITY THAN THEY HAVE IN THE MOST IDEAL OF -- PLEASE, BRING ALL ENCROACHMENTS TO A CLOSE AND ALLEVIATE THE MESS AT OCEAN AND MANHATTAN BEACH BOULEVARD AS SOON AS POSSIBLE. THANK YOU.

>> Suzanne Hadley: THANK YOU, NEIL FOR YOUR COMMENTS.

>> Martha Alvarez: THERE'S NO FURTHER REQUEST FOR PUBLIC COMMENTS AT THIS TIME.

>> Suzanne Hadley: THANK YOU.

I WILL CLOSE PUBLIC COMMENTS I WILL RETURN TO MY COUNCIL COLLEAGUES TO DISCUSS AND PROVIDE DIRECTION ABOUT THE TEMPORARY ENCROACHMENT PERMITS FOR OUTDOOR STREET DINING ON OCEAN DRIVE AND WEST OF OCEAN ON MANHATTAN BEACH BOULEVARD.

>> Richard Montgomery: YOUR HONOR, IS CARRIE STILL ON THE CALL? DIRECTOR TAI?

>> Carrie Tai: YEAH, HONORABLE -- OR COUNCILMEMBER MONTGOMERY, CORRECT?

>> Richard Montgomery: YES. CARRIE, I'M TURNING SO I CAN SEE YOU. SO WE'RE NOT CHARGING ANYONE FOR THIS --

>> THE HONORABLE --

[LAUGHTER]

>> Richard Montgomery: WE'RE NOT CHARGING ANYONE FOR THE WEST OF OCEAN AVENUE SPACE. I KNOW WE ALL KNOW IT'S TEMPORARY BUT WE DIDN'T CHARGE THEM FOR THAT USE OF THAT SPACE, CORRECT?

>> Carrie Tai: CORRECT.

>> Richard Montgomery: THAT WAS THE ONLY QUESTION. THANK YOU, CARRIE. MY ONLY COMMENT, YOUR HONOR IS THAT I THINK 25 DAYS IS A LONG TIME TO WAIT.

YOU HEARD MIKE TALK ABOUT THE FACT THAT HE THINKS HE CAN TAKE IT DOWN IN A DAY BUT YOU CAN'T GUARANTEE YOU TAKE IT DOWN IN A DAY. BUT THE IMPACT, IF YOU WALK DOWN ON THE WEEKEND, YOU'VE ALL SEEN IT, WEST OF OCEAN AVENUE, IT IS SLAMMED.

NOT THE PUBLIC SAFETY PART OF IT, THE FIRE CAN GET DOWN THERE IF IT NEEDS TO, GET DOWN TO THE BOTTOM OF THE PIER AND COME BACK UP. ARE THEY IMPACTING MOVING TRAFFIC AROUND? ABSOLUTELY. TRAFFIC IS BAD NO MATTER WHAT YOU DO DOWN THERE. DOES IT MAKE AN IMPACT? YES. IS 25 DAYS IS A LONG TIME TO GET THEM TO EXTEND IT? YES. I THINK DOWN THE MIDDLE. GIVE THEM 10 DAYS MORE AND SAY THAT'S ENOUGH. GET EVERYBODY OUT AND GET IT SET --

>> Suzanne Hadley: WAIT, WHERE DO YOU GET 25 DAYS?

>> Richard Montgomery: 20 DAYS.

>> Suzanne Hadley: IT'S FROM THE 5TH TO THE 25TH.

>> Richard Montgomery: 20 DAYS. MY SUGGESTION IS CUT IT TO 10 DAYS AND GIVE US MORE TIME TO GET THAT BACK, GET IT SET UP, CLEAR IT OUT A LITTLE BIT, RESTRIPE OVER THERE. IT NEEDS TO BE RESTRIPED, LET'S CLEAN IT, GET IT BACK TO NORMAL, NOT WAIT UNTIL THE LAST FRICKING SECOND TO GET IT DONE. AND AS SOMEONE POINTED OUT, WE ALL BEND OVER BACKWARDS TO HELP OUR BUSINESSES. NOT JUST RESTAURANTS BUT RETAIL. LET US GET OUR OWN SHIP BACK IN ORDER BEFORE THINGS START HAPPENING BECAUSE YOU KNOW WHAT IT'S LIKE AROUND HERE, WAIT THE LAST SECOND THEN PUSH BACK TWO OR THREE WEEKS. SO IF YOU WANT TO HELP THEM OUT LONGER, 10 DAYS AND THEN WE SET THINGS UP OUR OWN WAY. GET OUR STREETS DONE, REPAVED, AND WE GO ON FROM THERE. THAT'S ALL.

>> Suzanne Hadley: COLLEAGUES? THANK YOU, RICHARD.

>> Hildy Stern: OKAY. I'LL START WITH THE EASY ONE WHICH I THINK IS SHELLBACK, WHICH IS ALSO IN THIS REPORT. IT LOOKS LIKE WE DO HAVE A SOLUTION FOR SHELLBACK THAT I SUPPORT. JUST REDUCING THE WIDTH SO THAT THEY CAN STAY OPERATING ON OCEAN AND THIS IS HARD. AS WAS SAID OVER AND OVER AGAIN, WE'RE TRYING TO FIND SOLUTIONS HERE. I'M GLAD THAT WE SEEM TO BE ABLE TO FIND A SOLUTION FOR SHELLBACK. THE DECKS ON MANHATTAN BEACH BOULEVARD ARE JUST SUCH A CHALLENGE. THIS IS SUCH AN UNFORTUNATE CHALLENGE. I'M NOT SURE I UNDERSTAND THE 10 DAYS VERSUS THE 20 DAYS, I'D LIKE TO UNDERSTAND THAT A LITTLE BIT BETTER BECAUSE WHAT IT LOOKS LIKE WE DO HAVE THE OPPORTUNITY TO DO IS TO AT LEAST ALLOW THE TWO RESTAURANTS THAT ARE SET UP ON MANHATTAN BEACH BOULEVARD, IS TO EXTEND BEYOND THE JULY 5TH WHICH IS OUR CURRENT DATE. AND I WOULD LIKE TO GIVE THEM THE OPPORTUNITY TO STAY UP AS LONG AS THEY CAN. IF THE SET UP FOR THE EVENTS IS STARTING ON JULY 26TH, WHICH IS A MONDAY, THAT IF THE RESTAURANTS ARE PULLING THEIR DECKS OFF THE DAY BEFORE AND THEY STILL HAVE TO ACCOMPLISH MORE MOVING INTO THE SET UP TIME, I WONDER IF THAT CAN ACTUALLY BE ACCOMPLISHED. IF THOSE TWO THINGS CAN BE HAPPENING AT THE SAME TIME IN SOME WAY. I GUESS I CAN'T ANSWER THAT QUESTION. I THINK THAT'S A BETTER QUESTION FOR MAYBE CARRIE OR ERIK TO ANSWER.

BUT I WOULD JUST LIKE TO BE ABLE TO HELP THEM STAY OPEN AS LONG AS THEY CAN WITHIN REASON.

>> Richard Montgomery: THEY'RE NOT CLOSING. THE DECKS STAY WHERE THEY'RE AT. THEY'RE NOT CLOSING.

>> Hildy Stern: KEEPING THE DECKS ON MANHATTAN BEACH BOULEVARD.

>> Richard Montgomery: GOT IT.

>> Suzanne Hadley: OKAY THANK YOU, MAYOR PRO TEM. STEVE OR JOE?

>> Joe Franklin: YES MAYOR, IF I MAY. I'M JUST LOOKING DOWN AT THE CALENDAR JUST TO VERIFY THE DATES.

SO MR. ZISLIS DID SAY SOMETHING ABOUT JULY 4TH. TECHNICALLY I BELIEVE GOVERNMENT OFFICES AND THE LIKE IS THEY TAKE THE 5TH OFF BECAUSE JULY 4TH FALLS ON SUNDAY.

GOING ALONG WITH RICHARD'S SUGGESTION OF SPLITTING IT DOWN THE MIDDLE, THE ONLY THING I WOULD SAY IS GIVE THEM THAT. SO IF WE START FROM THE 6TH AND GO 10 DAYS THAT WOULD END ON THURSDAY THE 15TH. MAYBE JUST GIVE THEM THAT LAST WEEKEND.

I DON'T KNOW EXPONENTIALLY HOW MUCH MORE BUSINESS THEY GET ON THE WEEKEND, I WOULD IMAGINE IT'S GOT TO BE QUITE A BIT BUT GIVE THEM THROUGH UNTIL -- IF THEY CAN START DISMANTLING ON THE 19TH, MONDAY THE 19TH, THEY SHOULD HAVE IT ALL CLEARED BY THE 21ST OR 22ND.

WE CAN STOPWATCH THEM. WE CAN PUT STOPWATCH ON, BE LIKE AN INDY PIT CREW. SEE THEM DISMANTLE IT.

BUT THAT WOULD GIVE THEM I THINK I COUNTED TWELVE DAYS.

JUST IN THAT EXTRA WEEKEND.

>> Suzanne Hadley: SO RICHARD'S SAYING THE 15TH, 16TH, AND MAYOR PRO TEM STERN IS SAYING THE 25TH AND COUNCILMEMBER FRANKLIN IS SAYING MONDAY THE 19TH.

STEVE?

>> Steve Napolitano: SO I HAVE TO PICK A DIFFERENT DATE? IS THAT WHAT YOU'RE SAYING?

>> Suzanne Hadley: YOU CAN PICK A DIFFERENT DATE. YOU CAN THROW IN WITH ONE OF THIS ROGUE'S GALLERY.

>> Joe Franklin: COME ON, IT'S STILL EARLY.

>> Steve Napolitano: WELL YEAH, I THINK THAT WHAT'S REASONABLE AND WHAT MAKES SENSE AND ALLOWS FOR SOME MORE RECAPTURE OF DOLLARS BUT ALSO ADDRESSES SOME OF THE ISSUES DOWN THERE, BECAUSE I THINK THIS IS A HARD STOP ON THESE DECKS ON MANHATTAN BEACH BOULEVARD WEST OF OCEAN BECAUSE IT'S JUST GETTING TOO CRAZY DOWN THERE.

BUT I ALSO UNDERSTAND THE INVESTMENT THAT'S BEEN PUT INTO IT SO I WOULD GO WITH COUNCILMEMBER FRANKLIN'S SUGGESTION WAS A REASONABLE APPROACH HERE. THE GOLDILOCKS, GOING TOO LONG AND NOT GOING TOO SHORT.

>> Suzanne Hadley: SO, THE 23rd?

[LAUGH]

>> Steve Napolitano: NO THE 13TH.

>> Suzanne Hadley: I KNOW, I'M JOKING. OKAY, SO YOU'RE SAYING BEGIN THE TEAR DOWN ON MONDAY THE 19TH?

>> Steve Napolitano: YES, I THINK THAT'S A GOOD AMOUNT OF TIME BECAUSE

THERE WILL BE RECONSTRUCTING AND WHO KNOWS WHAT THE CONDITION WILL BE AFTER THEY'RE REMOVED AND EVERYTHING.

I THINK WE NEED THAT EXTRA TIME TO FIGURE OUT IF ANY REPAIRS NEED TO BE DONE AND SUBCONTRACTORS THAT NEED TO BE BROUGHT IN OR ANYTHING LIKE THAT.

>> Suzanne Hadley: MAYOR PRO TEM?

>> Hildy Stern: YEAH, THAT'S SMART AND THEN DOING IT DURING THE WEEK WHEN IT COULD BE LESS IMPACT. NOT HAVING IT ON A WEEKEND. THAT'S SMART.

>> Suzanne Hadley: OKAY YEAH, I AM INCLINED TO GIVE THEM A LITTLE BIT OF EXTRA TIME BUT IF MY COLLEAGUES ARE GOOD WITH THE 19TH, I THINK THAT'S GREAT. I DO THINK THE TEAR DOWN IS PRETTY QUICK, I WOULD COMPARE IT TO TAKING A VACATION. IT TAKES A LONG TIME TO PACK TO LEAVE, BUT ON YOUR WAY HOME YOU JUST THROW IT ALL IN THERE SO I THINK RIPPING THE DECKS OUT IS PROBABLY A LOT FASTER THAN INSTALLING.

BUT I DO LIKE WHAT HILDY SAID THAT THERE'S TIME DURING THE WEEK TO TAKE IT DOWN TO CLEAN, TO RESTRIPE.

SO IS THAT DIRECTION THEN, FOR DIRECTOR TAI OR DO WE NEED TO EXTEND THE DECKS PAST JULY 5TH?

>> Quinn Barrow: THAT'S ALL WE NEED. IF IT'S CLEAR THAT WE'RE GOING TO GIVE FOR THE TWO DECKS, JULY 19TH, AND FOR SHELLBACK WE'RE GOING TO

LET THEM KEEP THAT REDUCED AREA.

>> Suzanne Hadley: RIGHT AND THE TEAR DOWN BEGINS ON THE 19TH, DOESN'T HAVE TO BE COMPLETED.

>> Quinn Barrow: YES. IS THAT CLEAR?

>> Richard Montgomery: IS THE TEAR DOWN LONGER THAN ONE DAY? OR TWO HOURS?

>> *Steve Napolitano: THAT'S VERY CLEAR, THANK YOU VERY MUCH.

>> Suzanne Hadley: YEAH, ONE DAY TEAR DOWN SO IT'S REMOVED BY THE 20TH. ABSOLUTELY.

>> Richard Montgomery: THEY'RE GOING TO ASK YOU THE SAME THING.

>> Suzanne Hadley: YEAH. I THINK THAT'S A GREAT POINT. OKAY, WE HAVE GIVEN DIRECTION SO THAT'S GREAT. WE'LL MOVE ON TO LETTER L CITY COUNCIL REQUESTS AND REPORTS INCLUDING AB 1234. ANYTHING? NOBODY'S GONE ANYWHERE, PROBABLY NO REPORTS.

HAVEN'T GONE ANYWHERE YET BUT WE'RE ABOUT TO.

LETTER M, FUTURE AGENDA ITEMS. ANYBODY?

OKAY JOE AND STEVE, I CAN'T SEE YOU. SPEAK UP.

>> *Steve Napolitano: NO.

>> Suzanne Hadley: LETTER N, CITY MANAGER REPORT.
