AUGUST 13, 2021

The City of Manhattan Beach remains committed to providing the community with critical information and updates on the COVID-19 pandemic. The COVID-19 Situation Reports are published twice-a-week on Tuesdays and Thursdays and supplements the Situation Reports with coronavirus case counts (latest numbers) on Mondays, Wednesdays, and Fridays to keep the community informed.

The case numbers and deaths reported today may reflect delays in weekend and holiday reporting. *The negative count of deaths for California reported today is due in part to Santa Clara County reporting -417 deaths due to data cleaning.
