CURRENT INITIATIVES AND UPDATES

- Outdoor Dining Extension At the August 24, 2021 meeting, City Council extended the
 Executive Order permitting outdoor dining through 2021 and will be periodically evaluating the
 program. Staff will return to City Council with a formula for a nominal, but reasonable, fee for
 use of the public right-of-way for the duration of the temporary program. City Council also
 directed staff to initiate a work plan item to consider possible long-term use of the public rightof-way. To review City Council agendas and minutes, please visit www.manhattanbeach.gov.
- Back to School Vaccine Clinic Beach Cities Health District will be hosting a back to school vaccine clinic for persons aged 12 years and older, school staff, and families at the South Bay Adult School located at 3401 Inglewood Avenue, Redondo Beach, 90278. Register here for the clinic where you will receive the Pfizer vaccine.
 - o First Dose Clinic: Thursday, September 2, 3:30PM to 5:30PM
 - o Second Dose Clinic: Thursday, September 23, 3:30PM to 5:30PM

Please note that only students who are currently 12 years old or older are eligible and parent/guardian must be present for student to be vaccinated. Types of identification that are accepted as proof of age include California ID card or REAL ID card, passport, birth certificate, or any official document that includes names and date of birth. - Booster Shots Planned for Fall 2021– Federal Health Officials have developed a plan to begin offering COVID-19 vaccine booster shots this fall, pending final FDA evaluation of third doses of the Pfizer and Moderna mRNA vaccines and formal recommendations from the Center for Disease Control's (CDC) Advisory Committee on Immunization Practices (ACIP). "We have developed a plan to begin offering these booster shots this fall subject to FDA conducting an independent evaluation and determination of the safety and effectiveness of a third dose of the Pfizer and Moderna mRNA vaccines and CDC's Advisory Committee on Immunization Practices (ACIP) issuing booster dose recommendations based on a thorough review of the evidence. We are prepared to offer booster shots for all Americans beginning the week of September 20 and starting 8 months after an individual's second dose." - L.A. County Daily Briefing Statistics on COVID-19 The Los Angeles County Department of Public Health (Public Health) confirms 31 new deaths and 3,226 new cases of COVID-19. Due to the increased volume of testing in L.A. County, there have been recent delays in the processing of lab results into our data systems. Recent days have been underreported and today's counts

include backlogged data from prior days that were processed into the system yesterday. Public Health is working on increasing the processing speed and capacity and expect processing will soon keep up with the increased testing volume. Of the 31 new deaths reported today, five people who passed away were over the age of 80, seven people who died were between the ages of 65 and 79, 12 people who died were between the ages of 50 and 64, four people who died were between the ages of 30 and 49, and one person who died was between the ages of 18 and 29. Two deaths were reported by the City of Long Beach. To date, Public Health identified 1,394,488 positive cases of COVID-19 across all areas of L.A. County and a total of 25,181 deaths. There are 1,731 people with COVID-19 currently hospitalized and 27% of these people are in the ICU. Testing results are available for nearly 8,012,000 individuals with 16% of people testing positive. Today's test positivity rate is 2.7%, a decrease from last week's same-day rate of 3.7%.
