COVID-19 Situation Report

SEPTEMBER 9, 2021

CURRENT INITIATIVES AND UPDATES

- **LA County Cases Among Children (All Ages) Have Declined 30%** - While case rates increased among children in all age groups between mid-July and mid-August, cases have declined by about 30% in all age groups among children (0-4, 5-11, and 12-17 years old) over the past two weeks. The decrease is similar to the decreases we are seeing in cases among adult residents and occurred as many schools reopened with testing, masking, infection control and outbreak management protocols in place. Over the past week, children under 18 comprised, on average, 27% of all cases seen in L.A. County.
- **The Delta Variant** - The Delta variant now accounts for nearly all the COVID-19 strains seen among samples sequenced in the Los Angeles County area. Delta variants accounts for 99% of all sequenced strains. This variant is more efficiently transmitted between people, likely due to its faster replication, higher viral load, and greater affinity for lower respiratory tract cells compared with earlier COVID-19 strains. While emerging data affirms that fully vaccinated people are well protected from severe infections with Delta variants, it now is clear that fully vaccinated people can become infected, and if infected with Delta, can infect others.
- **Changes to COVID-19 Notifications** – In an effort to find a balanced approach to disseminating COVID-19 updates to the community, staff is reviewing the analytics, email comments and general feedback about the frequency and email lists for news on the Coronavirus. **To continue receiving the weekly Covid-19 Situation Reports, and daily case counts, please update your preferences on the [eNews webpage](#) to included News-Coronavirus. - **L.A. County Daily Briefing Statistics on COVID-19** – The number of new cases reported today is an undercount due to missing test results from one lab. Of the 49 new deaths reported today, 13 people who passed away were over the age of 80, 13 people who died were between the ages of 65 and 79, 15 people who died were between the ages of 50 and 64, and seven people who died were between the ages of 30 and 49. One death was reported by the City of Long Beach. To date, Public Health identified 1,425,806 positive cases of COVID-19 across all areas of L.A. County and a total of 25,563 deaths. There are 1,385 people with COVID-19 currently hospitalized and 30% of these people are in the ICU. This is a decrease of 288 daily

hospitalizations in one week. Testing results are available for nearly 8,300,000 individuals with 16% of people testing positive. Today's test positivity rate is 3.4%. With increased routine screening testing, Public Health anticipates case numbers may increase again. Please note: On Saturday, September 11 and Sunday, September 12, Public Health will make improvements to the data processing systems which will result in no new data being reported on those days. Neither the collection of this data nor outbreak investigations will be affected by this pause in reporting; however, no press releases will be issued during this system's upgrade.
