## COVID-19 CASE COUNT

SEPTEMBER 10, 2021

The City of Manhattan Beach remains committed to providing the community with critical information and updates on the COVID-19 pandemic. The COVID-19 Situation Reports are published twice-a-week on Tuesdays and Thursdays and supplements the Situation Reports with coronavirus case counts (latest numbers) on Mondays, Wednesdays, and Fridays to keep the community informed. In an effort to find a balanced approach to disseminating COVID-19 updates to the community, staff is reviewing the analytics, email comments and general feedback about the frequency and email lists for news on the Coronavirus. **Please note:** Tomorrow, Saturday, September 11 and Sunday, September 12, Public Health will make improvements to the data processing systems which will result in no new data being reported on those days. Neither the collection of this data nor outbreak investigations will be affected by this pause in reporting; however, no press releases will be issued during this system's upgrade.
