CURRENT INITIATIVES AND UPDATES

- **The Delta Variant Continues to Dominate** - The Delta variant emerged in late May, quickly dominated the scene and remains the predominate variant detected among our residents; accounts for 100% of cases sequenced. For more information, please view the [press release](#).
- **Health Guidance as Winter Approaches** - The Los Angeles County Department of Public Health encourages everyone to prepare for the winter. There are strategies everyone can use to reduce transmission as the weather cools. Please help everyone five years and up in your family and your social circle get vaccinated – and, if it is your time, please make sure you and others you know who were previously vaccinated return for a booster dose. - **LA County Requirements on Proof of Vaccination** - In early November, proof of vaccine requirements went into effect for both LA County and LA City businesses. **Manhattan Beach, as part of LA County, only needs to adhere to LA County’s order requiring vaccine proof to work at or drink/eat indoors at bars, breweries, wineries, nightclubs, and lounges.** Other establishments may choose to implement indoor vaccination requirements for their employees or guests to further promote a healthy environment. Remember, masking indoors is still required at all locations unless patrons are actively eating or drinking.

VACCINE PROOF REQUIREMENTS

LA COUNTY (MANHATTAN BEACH)

- Bars, wineries, breweries, nightclubs, & lounges

LA CITY (SAFE PASS LA)

- Food & Beverage Establishments
- Gyms & Fitness Centers
- Entertainment and Recreation Venues
- Personal Care Establishments
- Indoor City Facilities
- Outdoor Event Venues require a negative test within 72 hours of event if not vaccinated

- **L.A. County Daily Briefing Statistics on COVID-19** – Public Health confirms 26 new deaths and 1,088 new cases of COVID-19. Of the 26 new deaths reported today, eight people who passed away were over the age of 80, 11 people who died were between the ages of 65 and 79, four people who died were between the ages of 50 and 64, two people who died were between the ages of 30 and 49, and one person who died was between the ages of 18 and 29. There are 616 people with COVID-19 currently hospitalized, 25% of whom are in the ICU.
