MANHATTAN BEACH CITY HALL AND CITY FACILITIES TEMPORARILY CLOSED TO VISITORS

In response to the recent surge in COVID-19 cases, the City of Manhattan Beach City Hall and the Police and Fire Department lobby will be temporarily closed to visitors through January 15, 2022. At this time, City Hall will be closed to visitors for walk-in services. Significantly, public safety and public works services will not be adversely affected, and in-person recreation programs will continue until further notice.
