# COVID-19 CASE COUNT JANUARY 11, 2022

### **HEALTH OFFICER ORDER UPDATE**

The Los Angeles County Responding Together at Work and in the Community <u>Health Officer Order</u> (HOO) has been updated. Please note that the updated definitions for mega events are effective as of 1/15/22 and the masking requirement is effective no later than 1/17/22. Changes to the HOO are are highlighted below:

Isolation and Quarantine Requirements are revised to mainly align with the State Public Health
Officer's revised <u>Guidance for Local Health Jurisdictions on Isolation and Quarantine for the
General Public</u>, released on January 8, 2022. This guidance does NOT apply to healthcare
personnel in any setting or emergency services personnel. See <u>AFL-21-08.7</u>. This guidance does
NOT apply to TK – 12 Schools. See Appendix T1 & T2. In the workplace, employers are subject to
the <u>Cal/OSHA COVID-19 Prevention Emergency Standards (ETS)</u> or in some workplaces the
<u>Cal/OSHA Aerosol Transmission Diseases (ATD) Standard</u> (PDF), and should consult those
regulations for additional applicable requirements.
