

Overall Sentiment







Please do not allow Suzanne Hadley to hijack the city council for her own political ambitions. Concentrate on Manhattan Beach's real concerns.



While this survey was cheap and fun to read, I hope that little if any of this information is used for any substantive decision-making. While first realizing that a wealthy community will generally provide a higher satisfaction rating, the analysis would benefit from a longitudinal comparison with similarly situated communities, or with earlier surveys. The graphics imply huge disparities in responses where the actual difference is small. There's no drilling down on general responses. And some questions are just inappropriate—do we really think a random survey can provide guidance on how to solve the homeless problem? The racial breakdowns are absurd given our demographics. There are commingling of issues funded by different pots of money (i.e., streets and infrastructure in same question as parks and facilities). At least no one is saying they get their information from street banners.


