Esteemed Council Members-

Last June, I sent a letter to the Council urging you to reconsider issuing a permit for the Juneteenth celebration planned at Bruce's Beach. I thought that event could have used the added legitimacy a permit would have lent it. I was concerned that an event drawing a high percentage of Black attendees might suffer a higher incidence of calls to police, noise complaints, and allegations of illegality due to prejudice. In light of the commentary generated recently in consideration of adding Bruce's Beach Park to the Special Event Permitting Policy, my concerns about resident attitudes toward unpermitted Black cultural events have proven warranted. In fact, they have been exceeded by the fact that that event and others are falling victim to revisionist history.

My friends and I have attended 3 events at Bruce's Beach Park: last year's Juneteenth Celebration, the Culture Club's Sound Bath Meditation, and the Black History Month picnic on the last weekend of February. These were each vibrant and relevant cultural events, held at a beautiful location with specific historical significance. These events by our accounts were peaceful and respectful and we did not witness any of the negative impacts described by those opposed to such events. While I do not discount the practical concerns that residents might have about the effect of such events on park neighbors, I feel it must be acknowledged that many accounts were rife with preconceived notions and fear mongered projections into the future. In general, the events have been deeply and sometimes intentionally mischaracterized.



It warrants mention that predominantly white events held around the city carry many of the same logistical problems, but nowhere near the level of opposition. I urge you to take note when that is the case and lead the community to be honest with ourselves about why that is. Inherent bias can be its own form of misinformation. The Annual 6 man and AVP Beach Volleyball Tournaments, the Hometown Fair, weekly Concerts in the Park throughout the summer, the Holiday Pier Lighting, and Fireworks Show are all great litmus tests for this conversation. Extending the same logic to today's decision, Special Event Permitting, specific limitations and capacities of our parks, and enforcement of these limitations and capacities should be proportionally consistent across all parks and across all events.

As I mentioned in my letter last week about the plaque language, (again, nice job on that, by the way), there appears to be a continued effort to whitewash the park's history and strip the coveted green space of it's

cultural significance by placing cultural events on county land at the strand level. Please reject these efforts. They will backfire anyway. Those seeking to remove the park's symbolism will only amplify that symbolism by echoing in the present what has already happened in the past. The public does have the right to use the park, to peaceably assemble, and to freely speak on the matter, of course, regardless of permit status.

I haven't seen any practical objection to special events at Bruce's Beach that cannot be positively influenced or safeguarded against by adding the park to the Special Events Permitting Policy. Any disagreement over whether events like these should be allowed is evidence that Bruce's Beach *should be included* in the policy. This would allow the City to place limits on such events if they are deemed disruptive to the neighborhood, or make the necessary preparations and safety assessments to support such events and mitigate neighborhood impact. This includes staffing, street closures, portable restroom requirements, trash collection and public notice.

Please support the recommendations of the Manhattan Beach Parks & Recreation Commission by including all parks in the Special Event Permitting Policy. And help the community understand that the policy itself is the very tool for mitigating the negative impacts they seek to avoid.

Our reasons for retaining the current regs and excluding those venues from such permits include their relatively small size, their location in heavily residential neighborhoods and the harm that would ensue to those nearby homeowners as well as anyone trying to use the parks due to the noise (particularly if there's amplified sound), the traffic, possible street closures and the shortage of nearby parking and restroom facilities.

Former MB Mayor, Mark Burton, writes a passionate letter to City Council, advocating for the residents.

Dear City Council:

In my career in city government, I handled tens of thousands of claims for damages, lawsuits, and hearings. For such matters of importance, I always went to the "scene" to observe, observe what was there and what wasn't there. Last week for my MB morning walk, I parked at City Hall and walked to Bruce's Beach Park ("BB Park") to do such an observation. Here is what I observed and what I didn't observe at this city park.



What I Observed in BB Park:

• BB Park has the best observation area of the blue Pacific Ocean in the entire city. It is unrivaled. It inspires. It takes your breath away. There is something so peaceful and tranquil when observing the blue Pacific Ocean from BB Park.

- *BB Park is a tiered park, with a series of steeply graded, grassy slopes. Several of these steeply graded, grassy slopes have staircases to traverse from one slope to the other.*
- *BB* Park has two sets of two cement benches, facing west toward the blue Pacific Ocean, on two of the park's tiers. All four benches are the primary park "facility" and serve as a great observation point.
- BB Park has a basketball court on one of the park's lower tiers. As a former basketball junky, I always laugh when I see this basketball court. It's always empty because no one wants to play on a narrow court on a hill with such a steep grade. You would be chasing your basketball down the hill all day long.

What I Didn't Observe in BB Park:

- 1. BB Park doesn't have any picnic tables for families or gatherings. Most of our city parks have picnic tables, including our two pocket parks, 8th Street Park and Larsson Street Park.
- 2. BB Park doesn't have children's playground equipment. Most of our city parks have children's playground equipment for families or gatherings.
- 3. BB Park doesn't have a water fountain. Most of our city parks have a water fountain.
- 4. *BB* Park doesn't have a barbecue to cook for families and gatherings. Many of our city parks have a barbecue to cook for families or gatherings.
- 5. *BB Park doesn't have restroom facilities.* Most of our city parks have restroom facilities.

When is a park, not a park? When it's BB Park.

BB Park's primary function is to serve as a scenic view observation area. At some point in time, I'm sure many of you have stopped at a scenic view observation area, got out of your car, walked around, and looked at the incredible view. Many of these scenic view observation areas are at the top of grade, a vista.

From what I observed, and from what I didn't observe, BB Park is not an appropriate venue for any special event. As previously stated, BB Park was previously excluded by Staff and Council since it is one of three, distinctively neighborhood parks, intimately nestled adjacent to our residents.

Finally, there is a risk management aspect that supports excluding BB Park from special events. As you can readily discern, BB Park may be a dangerous condition of

public property, the disclaimer on your BB Park sign aside. This is especially so if you permit special events for which BB Park is not designed to accommodate. With its steep topography, BB Park may not be safe for large gatherings of people or families.

Please do the right thing for our residents and continue to exclude Bruce's Beach Park, 8th Street Park, and Larsson Street Park from your Special Events Policy.



Councilmembers:

I cannot be more opposed to this item, for many reasons. The way this is presented is short on details or financial impact analysis, in a seeming intentional way for your highly-comps to engineer themselves a 10.76% raise effective 1/11/2025. This is almost a kleptocracy, without Council performing any effective oversight. Your cost analysis seems to be more "can we afford it" than "should we be paying for this." For those that profess to be "fiscal conservatives," this is more akin to reviewing whether you still have checks in the checkbook.

Were any of these individuals to have performed to their current level of compensation I would not have so much of a complaint. But the underperforming evidenced over the last several years makes this all the more intolerable. And this is cross-the-board when it comes to your directors. The lack of performance of your Public Works and Park and Rec Directors are obvious. That Community Development could not write a Housing Element to prevent HighRose before it was even in the ideation stage is another example. That the HR and Finance Director allow such an report such as this one to be issued is again emplematic of an intent more to deceive and not engage the public.

Here's a number of other considerations:

1) This should not be in the Consent Agenda. It is not "routine and customary." Or shouldn't be.

2) It should have a dollar value of impact. That is generally expected when making a finance decision.

3) As per the email below to Charelian of Feb 1, I suggested that since this high comp approval has become pro forma, then perhaps that factor should be presented along with the COLA request for the mid-managers in February. That would be honest and transparent. But, no, Charelian would rather rest on a technicality and obscurity instead of better financial impact information. Disclosing that linkage in tonight report is closing the barn door. And that linkage is viewed as pro forma approval because this is put on Consent.

4) Also, by having the same employees negotiating the COLA increase with the represented groups, knowing full well that Council isn't going to bother to scrutinize the negotiator's own linked COLA request, is the same thing as having the highly comps negotiate their own raise with themselves.

5) There is a sizable difference between the cost of living impacts on a mid-manager's salary than a highly comp. Both fill up their cars with the same amount of gas, eat the same amount of food, and I would expect by now there are few APR mortgages. Bottom line: there is no need for a COLA raise of 3% per year for three years (compounded) for your non-performing highly comps, who are already comp'd higher than their position warrants.

6) Of course, any raise in base salary increases costs in other pools, significantly vacation, deferred comp, retiree health, and pension. I would expect that given the number of holidays provided by the City (many more than private industry) and an easy work schedule (particularly during the 9/80 years), that any employee with over 10 years of service has maxed out their vacation accrual. This 10.76% raise in effect provides those employees the equivalent of 90 additional vacation days (840 x 10.76%). I can tell you from experience that no one in private industry has close to these accrual hours nor the totality of your highly comp's benefit packages. Nor does a highly comp get assurance of a raise more than one year at a time in private industry.

7) The base pay for these individuals as provided by the Council back when Mark Burton gave away the store was too high. Yet you keep adding to that inflated amount, also never taking into account the huge amount of benefits received.

8) There is no way a "Communication and Civic Engagement Manager" is worth \$170,000 in today's dollars--on top of a "Marketing and Communications Coordinator" with a salary of \$103,860, and an "Assistant to the City Manager" of

\$138,936. A few of you were elected because of the CM padding his assistants. This position sounds like a Deputy CM without that title. Of course, the way the City works, I can see that becoming next year's request "since there will be no impact on overall salary costs." City Staff know how to play the long game around you, as well as the "boiling the frog" technique.

9) Your Finance Department is overly compensated. From someone in the finance field, I can tell you that no one in private industry with this group's responsibilities and abilities is making that much. And this is a group that has been operating the same budget format for 20 years or more, when more efficient, robotic software products have become available. Public engagement is minimal to nil.

10) There is no way that the plethora of salary ranges represented by the paragraph at the bottom of page 2 of the report should be on Consent.

11) Your annual May budget process is a joke. If 70% of your budget is compensation-related, then the game is over before it starts. Remove the remaining fixed costs or variable costs that have been negotiated via long-term contracts, and then remove the proprietary programs, and there's basically nothing left. Look back over the last year and see how many times there has been an adjustment of a position, position title, or position funding. No one in the public can provide good feedback or oversight, or you provide good transparency and accountability, when the ball continually moves.

12) The salaries for your highly comps also do not take into consideration the intangible benefits of working for a City with the financial resources of M.B. so the director gets a good budget and doesn't need to strain to meet the demands of a weak social safety net one sees in other cities (as well as no forest fires, floods, snow removal, etc.). The county even is responsible for beach maintenance. Plus, I can think of a lot of worse things than having to come to work in M.B. every day.

13) The salary schedule does not reflect the Performance Bonus as identified on page 3. This used to read that a bonus of \$10K could be granted if funding was available in the respective department's budget. I would expect that this \$10K bonus was also granted pro forma (no transparency, so I don't know). That means that if a department head did not spend all their budget, presumably on items of benefit to the residents of the City of MB, then the CM would be able to bonus them. Similar language is in d) iii) of this section. I often hear how much Bruce Moe is liked by his employees. No wonder. I would suggest that there be some Council oversight into the granting of Performance Bonuses. Although I don't see the need for the bonuses in the first place.

14) You need a fully functioning, resident-driven Finance Committee. I recently saw the City of Benicia has a standing Open Government Commission. You might establish that as well.

Folks, please set up. Do better. At the very least show you pretend to give the highly comp's salaries, as well as all city expenditures, some real oversight.

Dear Mayor Stern and Councilmembers,

I am writing to ask you to please approve and adopt the recommendation unanimously passed by the Parks and Recreation Commission to extend the Special Events Policy to include Bruce's Beach and the 2 parkettes.

It makes the most sense to manage these properties through the city, rather than have individuals or groups assume they can have events as they choose, without having to follow any rules or guidelines. What makes the parks work so well for private events - and I have had many of my kids' birthday parties at the parks - is that there is this system in place for reserving space, and each park comes with its own regulations and limitations. Certainly, Bruce' Beach would have special regulations and limitations so that its neighbors wouldn't be subjected to overly-amplified noise, and the parkettes would likely have a limit to the numbers permitted per event.

There is no reason to exclude these 3 parks from the Special Events Policy; that policy would be adjusted to accommodate the specific needs and boundaries of each of these parks, just as it does for every other park.

I hope you can see the logic here, and agree with the Parks and Recreation Commission's recommendation. It makes the most sense: it's consistent with existing policy for other parks, and gives the city, not the individual, the ability to regulate and manage private events in our city parks. It also provides for punitive measures for those who don't follow the policy's guidelines, or for those who circumvent the park reservations process.

By the way, Coucilmember Hadley's suggestion that a Juneteenth celebration be relegated to the grass outside the lifeguard station and the nearby sand is not viable. Please reject the Parks & Rec recommendation of opening up the two parkettes and Bruce's Beach park to special permits. None of these three venues is appropriate for large events that would be disruptive to their neighborhoods and hard to control (witness the recent event at BB park). What is needed is enforcement of our ordinances and enforcement needs to be initiated as soon as the illegal event begins. A permitting process will not alter those dynamics and, indeed, could make enforcement even harder once an event that might have initially been in compliance gets out of control.

Dear Council Members:

On Tues, March 15, you will consider updating the Special Events Policy, removing the exclusion of Bruce's Beach, and 8th Street and Larsson Street Parkettes as possible locations. At the direction of City Council, this issue was considered during the Parks & Rec Commission meeting on February 28. I encourage you to read Jeanne Fratello's <u>article/post</u> on <u>thembnews.com</u> for a thorough and accurate account of the Commission's discussion, deliberations, and recommendations.

As described in the article, the Parks and Recreation Commission unanimously agreed to a five-part recommendation to City Council. However, it appears that Staff is only bringing forward one of the Commission's five recommendations to City Council.

I believe it would be a mistake for City Council to adopt the one change (i.e., update the current special events policy to include Bruce's Beach and the two parkettes) without also adopting the other 4 recommendations. The complete set of recommendations collectively balance the public's desire to organize permitted events with local residents' desire to mitigate the impact of such events. The recommendations also contemplate increasing penalties for related violations and direct staff to develop a plan for proactively addressing "rogue" events.

P&R Commission Recommendation #2: City Council to direct staff to update its special events policy to specify distinct parameters for special events at each park within park system - such as specifying the frequency of events that would be allowed at each park, the maximum size of events that would be allowed at each park, types of events, whether amplified sound is allowed at each park, and more.

If CC were to adopt Recommendation #1 and not adopt Recommendation #2, then the special event permitting process would remain largely at the discretion of staff and provide no parameters to event organizers, residents living near parks, or families considering living near parks regarding potential frequency of events, size of events, and impact of events. It would be reasonable for residents who live near Bruce's Beach Park to accept a few permitted events each year in the park with appropriate mitigation measures in place for parking, traffic, restrooms, trash, etc. If CC adopts changes to the Special Events Policy, the changes should incorporate both Recommendations #1 and #2 of the P&R Commission.

P&R Commission Recommendation #3. City Council should review its municipal code with regard to appropriate penalties for violators of the code, creating stiffer penalties for those who hold unpermitted events or who exceed the parameters of their event permit. Currently the municipal code has no teeth with respect to penalties for such violations. Hence, there is minimal deterrent effect. Currently, the municipal code sees no difference between violations such as skateboarding in a park or organizing a huge event without a permit. If the municipal code contemplated stiffer penalties for egregious violations of park rules and City policies, and believed that such park rules would be enforced and violations prosecuted, then it would deter event organizers from running rogue events.

P&R Commission Recommendation #4: City Council should direct staff, including the Manhattan Beach Police Department, to create a "playbook" (i.e., plan) for how it will proactively address unpermitted events and those that exceed parameters of permits when it learns about such events ahead of time.

Such events will continue to be organized until the City takes a proactive stance to prevent them from occurring. Rather than being reactive, City staff (perhaps led by the MBPD) should create a proactive plan for addressing rogue events.

P&R Commission Recommendation #5: City Council and staff should take social media postings into account when investigating and addressing potentially unpermitted events.

On a personal note...those of your who attended the Feb 28 meeting of the P&R Commission heard me describe that my family & I live next to Live Oak Park and, thus, I can sympathize (based on personal experience) with the frustrations expressed by the numerous residents near Bruce's Beach Park who wrote to us or spoke during the Commission meeting. Living near a park can be wonderful most of the year, providing access to open space, natural areas, basketball courts, and sports fields. As residents who live near parks, sometimes we feel that it's an extension of our personal space. But we have to recognize that our parks are a community resource for the benefit of the entire community. Every year, for the Hometown Fair, a bank of unsightly port-a-potties and 2 large dumpsters are positioned directly in front of my home. Fair sit on our patio while eating funnel cakes from the Fair, often leaving their trash behind. I've never complained about it...and I never will. It's all part of the good-and-bad that comes with living next to a wonderful park.

Dear Mayor Stern, Mayor Pro Term Napolitano and Council Members Franklin, Hadley and Montgomery,

I commend the work done by the Parks and Recreation Commission and I agree with all the points of their recommendation except for one, the recommendation to include Bruce's Beach Park in the City regulation for Special Events.

The transcripts of their hearing suggest that the reasoning for such a recommendation was based on two considerations:

1) That the problems of unauthorized events could be avoided if there were a policy allowing and regulating special events at Bruce's Beach Park;

2) That *parks are parks* and special events are a natural activity for all parks even if they cause some inconvenience for the residents.

I beg to disagree with such reasoning:

1) The first rationale directly contradicts two other instances where the City used this argument to arrive at precisely the opposite outcome. The first occasion was when the city council was discussing banning smoking in our town. At that time, it was contended that enforcing a general ban was impossible and the City had to authorize the activity in order to regulate it. The second occasion was when the city council was considering short term rentals, and once again, the contention was that the City had to allow short term rentals because that was the only way to regulate it. I am very sorry that I could not find the exact transcripts and cannot quote him exactly, but my recollection is that Council Member Napolitano said something to the effect that this suggested reasoning was fallacious because *prohibition is in fact a regulation* – specifically the regulation was you cannot smoke and you cannot have short term rentals. That was a smart observation; he was right, and the City Council agreed with that logic, and subsequently prohibited both activities.

The real issues are prevention and enforcement. For both things, the proposals of the Parks and Recreation Commission are insightful: we need a protocol to prevent violations – which should include monitoring social media; we need enforcement and we need penalty for unauthorized special events, both in case they happen in a park where such events are not admissible at all or in case they happen in a park where such events are not admissible at all or in case they happen in a park where they admissible but a permit was not obtained or its limits were not respected. The problems are not caused by the prohibition of special events and cannot be solved by including Bruce's Beach Park in the policy and regulation for special events.

The real issue is does this City Council wants to allow Special Events at Bruce's Beach Park? Is this decision a decision respectful of the landscaping, the architecture, and the physical location of that park? And this question brings me to the second argument that supported the recommendation of the Parks and Recreation Commission .

2) Treating all parks the same way goes against the very nature and purpose of park design and designation. As any landscape architect would tell you, the design determines the intended purpose of the park, and the purpose of the park informs the design. Parks have many purposes and different parks have different purposes – they are not just or always a space, for example with playgrounds for active recreation. Also, sustainable parks do not ignore their physical context – especially when that context is urban, residential and densely developed like in this case.

Bruce's Beach Park's specific land and architectural features clearly connote it as a *passive recreation park* which can sustain only what a park architect would call "low intensity recreation": it does not have a playground, it does not have bathrooms, it is an open space with natural habitats and lacks any level of development – not even picnic tables. It is clearly conceived as part of the dense urban infrastructure of the neighborhood to provide a simple respite and refuge to the community and passive activities such as observing nature - maybe the sunset, the ocean, watching birds or picnicking. Passive recreation typically means less management and lower costs to maintain the park - something that surely was considered when the park was created.

Thus, as much as I admire and respect all the Parks and Recreation Commissioners, when they have compared Bruce's Beach Park to Live Oak Park and observed there are special events in the latter, so there can also be in the first, they are mistaken in that they are not taking into account the different landscaping and architecture of the two parks, and therefore the different intended purposes of the two parks.

Nobody denies the history of the Bruce family and no matter what has been said – viciously – on social media, it is not about that. Expressive events commemorating that history could always be allowed. If anything, this attempt comes to question the necessity for the city to define what constitutes and what does not constitute an expressive event protected by the First Amendment. Many other cities have done it and maybe it is time for Manhattan Beach to do the same.

I am very aware that when it comes to Bruce's Beach Park, emotions are triggered. People concerned about special events at Bruce's Beach have been called bigot, racist, hateful, horrible, disgusting, despicable, embarrassing, "gross" and the like on Nextdoor and Facebook.

I know who I am, and I am not defined nor deterred by the labels who emotionally triggered individuals are using. When we are emotional, we all risk to say or do the wrong thing. Please do not fall victim to these attacks. Base your decision on what is best for the park, the neighbors, the residents, and the city. Do not base your decisions on your emotions or emotions of others. Do not allow Special Events at Bruce's Beach Park.

I sent the e-mail below prior to the February 27th event at Bruce's Beach. I am mystified at the number of my neighbors telling me they sent similar communications to Parks & Rec and yet it still recommended that the exemption from special event permitting for Bruce's beach and the parkettes be removed. What justification could there possibly be for changing the status of these neighborhood parks within four years of a 5-0 vote for exemption? Resident supported that move then and continue to support that now.

So what changed?

If we can't control unpermitted events as was clearly demonstrated on the 27th, why would we look to remove the exemption? If we cannot control noise, size and mitigation for unpermitted events why are we entertaining permits? If the vast majority of residents want neither, how did this issue come up for consideration? Who put this issue before the council? Who decided to send it to Parks & Rec for a vote? Why is it before us again since it was resoundingly defeated in 2018? Why aren't the votes and voices of citizens being considered?

February 27th was disastrous for our neighborhood. By noon, many of us chose to leave for the day. It was loud, unruly and parking was entirely disrupted. It was so loud and crowded by 11:30 a.m. we opted to visit friends out of the area. A neighbor's teenage daughter was cursed and yelled at when she unfortunately caught sight of a couple partially nude and compromised. She was berated through no fault of her own and it left her very shaken. Event go-ers were still walking through our neighborhood past sundown. I would not want to be home alone or have a child home alone during an event of this nature. The event go-ers brought so much stuff to the park. Chairs, food, music. It was like a campground. This is ridiculous. Now Bruce Greenberg says we should trust Parks & Rec to change the status so that the can control the frequency of these events???

Currently the events are disallowed and still Chief Abell, despite ample notice, did nothing. How would the permitting process help a situation that we cannot manage (or avoid) when it is expressly forbidden?

There should be NO CHANGE to the exempt status of Bruce's Beach or the parkettes. Since 2018, these areas remain residential, lack bathrooms and have poor public parking. Our beaches, sidewalks, downtown and city parks are public areas. Residential grassy spots should not be.

Dear Park and Rec Commissioners and Liaisons,

Bruce's Beach and our town's parkettes are already difficult to use and enjoy. Bruce's Beach is crowded on weekends, the basketball hoop is in high demand and parking is impossible. Still, we enjoy the park and walk through it regularly as it is precious open space for sunshine and solitude. We pay property taxes to enjoy that open space and we purchased a home with no backyard very much planning to use Bruce's Beach at our leisure.

I am very glad to share all of these spaces with tourists, visitors from other towns and my neighbors, but I see no reason to make these spaces available to special events, large gatherings, concert promoters, reservation systems and the like.

These spaces are very much open to and enjoyed by the public. Persons are free to visit and enjoy the park. There is no basis to expand the public's access to allow special gatherings. There are plenty of public spaces in our town available by reservation for special events. Each of those locations has ample parking and dedicated restrooms. Bruce's Beach and the parkettes have neither. These locations disrupt residential parking already. To expand the use and modify the policy in place will be to voluntarily wade into the mess that followed when physical fitness trainers began using Sand Dune Park for classes. That use was considerably smaller in scope that what a special event modification would permit, but the neighborhoods were overrun with parking problems, trash and early morning/late evening noise and loitering. Note: Sand dune park has restrooms. There is a reason these spaces have the deisgnation they carry and were located in pockets of residential areas. Those designations had strong bases in logic for limiting special events. It makes no sense to open these areas up to large gatherings; the uses are already loud and crowded. Amplified sound would be untenable.

I see no reason to modify the policy.

To whom it may concern. I wanted to add my voice to the upcoming city meeting so that an accurate accounting of events are documented.

I live in the 2600 block of Highland Ave., which, overlooks the park and all the activity that happens there. I recently moved back to the Sbay from inner city Los Angeles (Hancock Park) as a result of the city of LA not managing their city properly as it pertains to street violence, thefts and general unenforcement of already placed laws and regulations. I felt moving back home to a small managed community would be the right answer for me, since I'm a native SoCal person who grew up in SBay.

Prior to the large un-permitted event at Bruce's Beach Park on Sunday, February 27th, I was 100 percent in favor of having events here at the park and thought permitting was a viable way to do that. I thought it would be great to have something to go to across the street that was fun, safe and regulated.

After living through that Sunday, I now have a complete change of heart for any events taking place or having a permit process that allows events to occur.

Initially, the day started out well with many families coming to enjoy the park. It was peaceful and enjoyable as people were respectful of the park and our residents. Kids were playing and families enjoying the beautiful vistas. We even went down and partook in the festivities, spoke to many people and enjoyed some really great food.

Later that afternoon, somewhere around 1:30 or 2pm, the energy of the park changed dramatically and rapidly. There was incredibly loud music (concert and festival style loud) whereas, I couldn't even hear my TV which was turned up loud to compensate for the unusually loud music and cluster of what seemed to be around 400 to 450 people. We had to close our doors and windows because it was so loud. This music came from the park and passerby vehicles that were looking for parking. Some circling the park as many as 5 times.

People started parking in my private and deeded parking spaces which I was planning on using that day for my family to come over and enjoy the day. I respectfully and kindly went down to the curb several times asking people not to park in my private parking spots as we were expecting company. I was ignored. I was also feeling threatened for going down and politely asking people not to park in my spaces. I was instantly taken for an anti-supporter of their cause, as I heard people talking about me both from across the street and as the parking violators walked away from me, as they called me unsavory names.

As the day progressed, parking was completely unavailable. To that end, people looking for parking would block traffic on Highland and streets surrounding the park, often times double parked on Highland talking to other attendees waiting for a spot, all while knowing they were blocking traffic. The violators could care less and continued to double park while screaming out the window "to go around". This behavior resulted in angry and hostile behavior from through traffic drivers with endless honking for people to stop blocking traffic. I can't tell you how much I enjoyed this all taking place in front of my home. Approximately 90% of the through traffic drivers swung out into opposing traffic lane to get by, which nearly resulted in a few people being hit at the crosswalk areas. Again, this went on for a very long time. This I felt was a very dangerous situation that could result in street fighting and escalate further. Many a slur from both double parked cars and through traffic drivers were levied which, was all audible inside my home behind closed doors and windows. My 80 year-old mother was scared.

A little later in the afternoon and during the incredibly loud concert music, double parking, honking and slurs being thrown out, there was Approximately 3 to 4 cars that were parked on Highland with people standing outside their cars and partying. With this particular group of party-goers the words Mother Fucker, Bitch, Fuck You, N word and other loud slurs were heard over and over with ZERO regard for the surrounding homes. This loud and aggressive tossing of words was offensive, disruptive, insensitive and threatening. It also felt "PUT ON" by way of pressing the behavior as if it were a show. It got so bad, I had to cancel my family plans and leave my home because it just became so intolerable and my mother wanted to leave because it felt unsafe.

I called the police station twice. Spoke to the Watch Commander, lodged my complaints only to find that the police had tied-hands, so-to-speak. Nothing was done about my complaints, no ticketing, no moving people along and no busting up of an un-permitted event and no one asking people to follow the rules that are listed on a sign board that clearly states; NO amplified music, NO alcoholic beverages and NO BBQ's. On top of this all, trash was everywhere and left the park in a very poor state. I saw residents afterwards help organize the trash for the city the next morning but litter was still found throughout the park and on the Highland in the gutters.

In closing, I am now 100% against any permitted and large group activities here at Bruce's Beach Park. After witnessing a complete lack of courtesy and respect for our neighborhood and having hate speech directed at me, I see no point in issuing permits for fees when our city already has failed to regulate the existing laws and code violations. Why is it ok to impose laws and ordinances on our own residents and then turn a blind eye to event attendees that don't live here and, worse yet, don't care about the residences that do?

Events need to take place in commercial places where music can play loud, people can park, throw their trash away, speak loudly, drink responsibly, BBQ if they wish, use restrooms, a place where laws, ordinaces and rules are applied, followed and enforced, like any other event place. Our little park isn't geared to accommodate these types of events or large group activities and shouldn't be forced to do so.

I really hope our city and officials realize that our residents live here for a reason. We enjoy the safety, peaceful and clean living environment that Manhattan Beach has always offered. I don't want to feel threatened in front of my house or that my front yard is a festival / concert ground with people breaking laws left, right and center creating a very unsafe and disruptive living environment with coarse and unsavory talk being tossed about.

Also, please keep in mind that I am a Person Of Color and identify with two other minority groups and have no political agenda. I simply want to report what I witnessed and experienced. My only goal here is to preserve a safe, clean and enjoyable living environment for myself and my family without having to feel threatened or be forced out of my home.

Thank you in advance. I would also like to remain anonymous to the public if that could be respected, I would really appreciate that.

Mayor Stern and Council:

I would like to offer my thoughts about Councilmember Hadley's proposed text for a new plaque at Bruce's Beach Park in anticipation of your meeting on Wednesday.

This email is long and detailed because her proposed language is inaccurate in part and shockingly misleading. The point of replacing the existing plaque with a new plaque was to more forthrightly convey an episode of history that took place there: creation of a thriving resort for Black beach goers in a time of segregation and the unfortunate use of government power that ran that business out of town.

Councilmember Hadley forgoes that purpose and instead paints a misleading portrait of well-paid Black property owners who bought property elsewhere when the City exercised eminent domain to build a park.

Virtually every sentence in Hadley's proposal is calculated to contradict the well-documented fact that acquisition of the properties was an act of racial discrimination. The park was a pretext. Councilmember Hadley has revised history to downplay the racism that drove those events, even cast doubt on whether racial bias was involved at all.

She does our community a great disservice.

Some examples:

1. Hadley states that "Despite opposition to Blacks' owning land elsewhere in California, Willa and her husband purchased two lots..." The implication here is that Manhattan Beach — unlike "elsewhere in California" — welcomed Black property ownership. There is no evidence in the historical record that Manhattan Beach welcomed Black property ownership; the harassment and intimidation suffered by the Bruce's and their Black neighbors, leading to the taking of their property by the City, quite obviously suggests the opposite. Before the recorded racial covenants that would later be placed in property deeds in Manhattan Beach making it very clear that Blacks were not welcome here, the historical record compiled by the History Advisory Committee documents plenty of episodes of hostility toward Black residents and visitors to Manhattan Beach.

I'll add that the odd inclusion of dollar figures distracts from the point of the plaque as well. Readers will marvel at the difference in property values between then and now. Or they will satisfy themselves that the apparent return on investment washes away any concern for motive. But the Bruce's chose to buy that property and create their business there. The Bruces did NOT chose to sell the property. In America, the government should not take a person's property to keep people of color out, no matter how much they are paid.

2. The language perpetuates the red herring that the City's condemnation was not racist because some of the parcels taken were owned by white owners. Hadley neglects to distinguish the absentee owners (who were white) from the Bruces, who had a thriving business that was attracting Black families to the beach. It is well-documented that the City initiated the eminent domain proceeding to shut down the Bruces' resort. The taking of nine (not 25 as Hadley claims) parcels of white absentee-owners' property was merely collateral damage.

3. The only reference in the Hadley language to racism is the suggestion that several sources "at that time" believed the City's action to be racist. Yet, the City's own well-documented history concludes that the City's action was motivated by racial discrimination. At the March 16, 2021 Council meeting, Councilmember Montgomery referred to the "horrifying and painful racist history of what happened to the Bruce family and others . . . It was the lowest point in our city history." At that same meeting, then Mayor Hadley referred to the events as "a stain in our history." Now, a year later, Councilmember Hadley's plaque language insidiously purports to erase all of that in a single stroke by suggesting that the City bought some land for a park and some people at that time believed the City to have racist motivation. The point is that a thriving Black business was run out of town and that action had affected not only the Bruces but all Black families who thereby lost access to Manhattan Beach. That is the impact of history.

4. The language implicitly justifies the eminent domain proceeding because the Bruce's and others were compensated fairly. This suggestion misses the mark. An eminent domain proceeding is lawful only if it has a proper purpose. The take was unlawful whether or not the property owners were paid because its purpose was racially discriminatory, pure and simple.

5. The emphasis in the proposed language on the amount of money received by the Bruces suggests that they had no reason for complaint. However, their business was destroyed and their property taken against their will in order to accomplish racial exclusion. That is the central point; yet, the proposed language submerges that historical fact entirely.

6. The fact that the Bruce's and their Black neighbors bought property elsewhere has no bearing whatsoever on the City's wrongdoing.

7. There is no evidence that the City intended to build a park when it acquired the property. None. Yet, Councilmember Hadley's language implies that the "Great Depression" and World War II interfered with an actual City plan to construct the park. This is an invented, post hoc rationalization to endeavor to explain the delay.

Councilmember Hadley's language directly contradicts the meticulously documented historical facts assembled in the History Advisory Report, which was unanimously accepted by the Council and referenced in the Council's own Statement of Acknowledgement, Condemnation and Empathy. Her efforts are disrespectful to the resident volunteers who at Council direction devoted many hours to preparing an accurate history of the events in question.

Councilmember Hadley's proposed text is actually worse than the plaque presently on the site. It is a misguided attempt to absolve the City of its racist past or at least to cultivate seeds of doubt about what happened here.

As I stated to the Council months' ago, I strongly recommend that you abandon this course and revisit the proposal from the residents that the Council recruited and appointed to perform this task.

Mayor Stern and Council:

I urge you to accept the recommendations of your Park and Recreation Commission and eliminate the exclusion of Bruce's Beach Park from the special permitting process when this item comes before you later this month.

The City's parks are a valuable asset to the community. They are used daily by many for recreational purposes and all but three are available for events through a reservation system. As I see it, residents should have the opportunity to reserve *all* parks for appropriate events, such as birthday parties, neighborhood gatherings, family reunions and cultural celebrations. There is no reason why Bruce's Beach, and the 8th Street and Larson Street parkettes should be excluded from the existing process by which the City can review and approve or deny permits for special events. The process itself assures that the proposed use will be of an appropriate size and scope for the requested park space and will be subjected to conditions to minimize neighborhood impacts.

When this item appeared on the Council agenda last month and when it subsequently came before the Commission, numerous neighbors of Bruce's Beach raised objections based on anticipated impacts. Anyone living adjacent to a park must expect some impacts associated with park use, whether by permit or otherwise. Bruce's Beach was acquired ostensibly for park purposes in 1924 and has existed as a passive park since the 1950s; any person who owns or rents property in the vicinity certainly knew it was a park when they arrived here, and must reasonably expect that the use of the park will occasionally cause impacts. That is a normal consequence of choosing to live near a park, and is balanced out by the advantages and enjoyment of open space and unobstructed ocean views. Those who reside near Pollywog Park and Live Oak Park put up with traffic, parking and noise impacts from summer concerts, the Hometown Fair, sporting activities and other events, some of which are very impactful. The Bruce's Beach neighbors are no more entitled to a ban on use of that park than are the neighbors of the other parks in town.

Bruce's Beach, of course, has special significance insofar as it was acquired by the City for purpose of racial exclusion as documented in the City's official history of the site, the history that you adopted. It is appropriately the site for events that celebrate inclusion and diversity or seek a remembrance of troubling parts of our American and City past. I attended the Juneteenth event in 2021 at Bruce's Beach — which could not receive a permit under the current policy — and observed that the park was an ideal setting for the event. The site amply accommodated the crowd in attendance, the event lasted only a few hours during the midday, traffic on Highland flowed unimpeded and there were no

visible significant off-site impacts. The symbolic import of having the event at Bruce's Beach cannot be overstated.

Further, the park is well suited for this type of event, as well as birthday parties, family reunions and the like. It is adjacent to two parking lots. Public bathrooms are conveniently located in the Lifeguard Headquarters. It is located along a bus route. It is simply not distinguishable from the other parks in which events are permitted, aside from being the only park in town with a beautiful ocean view (yet another reason it should be allowed to host special events).

Some who have commented on this matter decry the symbolism associated with Bruce's Beach. However, that ship has already sailed. Whether these commenters like it or not, the park *has* special significance. The proposition that the park be unavailable for events as a means to erase that significance, to deny our history and bury the unfortunate abuse of authority that led to the creation of the park is misguided.

Bruce's Beach and the two parkettes should be included in the existing special events policy so that they may on occasion be reserved in part or in whole for events. All parks in the City should be treated equally. The existing permitting process assures that the City will be able to apply conditions to assure that the type of event, the number of participants, the hours and whether amplified sound is allowed are all appropriate for the parks in question.

My husband and I are writing to express our disagreement with the recent unanimous vote of the Parks and Rec Commission to permit events at Bruce's Beach and the 8th Street and Larsson Parquettes.

We live just three blocks from the Larsson Parquette and have used it with our daughter and now our granddaughter. It is a small narrow park with the majority of the park space reserved for small basketball court (one hoop), swings and a large play structure. It affords little space for seating. Typically there are three person households of nearby homes using the park as an antidote to the small or not existent backyards without play space.

All three of these parquettes/park in question are situated in neighborhoods where houses are in close contact and there is little street parking. Our other parks (Live Oak, Marine Avenue, Pollywog) have large roadways buffering the noise emanating from events held there and includerestrooms. There is no restroom at Larsson Parkette, hence its users are nearby residents. Bruce's Beach and 8th Street Parquette also lack restrooms.

If events are permitted and residents want to use the park/parquettes on a drop-in basis, there will not be enough room.

Please **override** the decision by the Parks and Rec Commission to allow events at Bruce's Beach Park and 8th Street and Larsson Parquettes.

Re: Proposal to change the policy for the use of the parklettes at Bruce's Beach, 8th Street, and Larsson Street

Dear City Council:

In response to the City's request for feedback regarding a review of its special events policy for the City's three parklettes, please accept the following comments. We oppose any changes to the City's current policy which might allow alcohol consumption or permit special events at the City's three parklettes. The current no alcohol and permitted events policy have served our City and its residents well for years. We especially oppose changing the special events policy as it applies to Bruce's Beach.

<u>Alcohol use</u>. Any change in the policy to allow the consumption of alcohol would be foolish and counterproductive to the public's use of the area. Obviously allowing public alcohol consumption will lead to some persons being intoxicated or under the influence while using the park. Why add a new concern regarding the use of these small public parklettes? They are located in residential family neighborhoods. Alcohol consumption is not permitted at the beach areas adjacent to Bruce's Beach. Consumption of alcohol is illegal on all public beach areas in Manhattan Beach. Why should the park be treated differently from the public beaches? The parklettes are used daily by families, many with small children present. Why expose children visiting a public park to individuals consuming alcohol?

Recently Bruce's Beach has become the focal point of controversial efforts to return (by illegal gift) certain beach front property to the heirs of one family whose property was condemned by a lawful eminent domain proceeding more than a century ago. Needless to say the issue is politically and legally charged. There is currently a lawsuit pending in Superior Court regarding the matter. Considerable local, state and national public media attention has been brought upon Bruce's Beach, often with the reporting at odds with the truth. This has attracted more individuals to the small park. As a result, there have been attempts using on line resources to organize unlawful large gatherings at Bruce's Beach. There is and will remain for some time a conflict over the underlying issues. With the park serving as the center for such attention and controversy, it should not be allowed to serve as a site for alcohol consumption. It is common knowledge that alcohol, depending on the amount, can affect the sound judgment of some individuals. This is reason enough to jettison any proposal to allow alcohol consumption at Bruce's Beach.

<u>Special Events</u>. There are valid reasons to reject outright any proposal that Bruce's Beach should become a designated or permitted site for special events. For decades the park has not been approved for special events of any kind via a city permit or otherwise. There are numerous reasons for this. The park is small. There is insufficient parking in the area. Those who visit the parklette appreciate that the existing parking lot is filled from morning to evening by those using the beach. Numerous surfers use the parking lot on a daily basis. The nearest other available public parking is more than 11 blocks away. The streets adjacent to Bruce's Beach have very few parking spaces. The area surrounding the park is residential. This is not where special events should be held. The City owns and controls Polywog Park and Live Oak, which have appropriate areas for such permitted events. Noise and disruption from large crowds, from foods trucks attracted to the location, from illegal sound amplification and from amplified music would become the norm at the parklettes if permitted concentrated activities were allowed at Bruce's Beach. The residents

of nearby residences should not become the victims of such nuisances. Recent organized activities (illegal with no permit) at the park reflect on just how objectionable such organized activities are – with alcohol use, drug use, loud music, food trucks, supersized tents, and more. Even the police have difficulties enforcing applicable laws.

The City's current policy prohibits special events at the City's three parklettes (Bruce's Beach, 8th Street and Larsson Street). For years there have been few if any problems or serious incidents at these parklettes when their use has been in compliance with the City's current policies. Should alcohol or organized permitted crowd events be allowed, it will lead inevitably to unwanted noise, additional crime, undesirable traffic, excess trash, and more.

When all is considered, Bruce's Beach and the two others parklettes are located in purely residential neighborhoods. These facilities are limited and not well suited for the types of activities that will be promoted by the proposed changes to the policy. Any changes to the current use policy for these parklettes allowing alcohol consumption or large organized public crowd gatherings and concentrated public activities would be inimical to protecting the environment in the adjacent existing neighborhoods.

My family and I live immediately adjacent to Live Oak Park and, thus, I can sympathize with the concerns expressed by many residents who live near Bruce's Beach Park and the parkettes, especially in light of the unpermitted event that was held on Sunday at Bruce's Beach Park.

The recommendations that were unanimously approved by the Commission yesterday will, if adopted by City Council, directly address unpermitted events and mitigate the impact of permitted events on neighbors of parks. Incorporating Bruce Beach Park and the Parkettes into the Special Events Policy does not mean that organizers could conduct events in these parks whenever they choose. Quite to the contrary, it would allow us to establish distinct parameters for each park regarding frequency of events, size of events, types of events, use of amplified music, etc. With appropriate parameters defined, many Special Events Applications will be denied and those that are approved will be conducted with appropriate measures in place to mitigate the adverse impact on neighbors (e.g., traffic, trash, restrooms, alcohol, etc.).

Please be advised that the outcome of yesterday's Commission meeting was a set of recommendations to City Council. Ultimately, City Council (not the Commission) has the authority to make decisions regarding updates to the Special Events Policy, Municipal Code, and enforcement priorities. So, this issue should reappear on the City Council's agenda sometime in the near future.

Thank you, again, for your input into the process.

My name is a Jessica Moffett and I have been a resident of MB for over 15 years.

I wanted to express my disappointment with a series of events that took place on Sunday.

First and foremost I was upset to see that a large party event was allowed at Bruce's Beach on Sunday despite a city ordinance in place that prevents special events at parkettes in MB. I wish our City Officials and Law Enforcement could have directed the organizers to another area in our city that allows for such events (maybe Polliwog? I'm not sure). This was very disrespectful to the residents directly affected and I believe a failure on our City for not implementing our local ordinances.

Secondly, our city was ambushed by a large bicycle group once again. This was the largest group I have seen to date! My neighbor was directly caught in the middle and felt threatened. They are clearly here to disrupt and intimidate our City. I'm sure you have all seen the videos of MB residents being harassed and pictures of a pick up truck full with bikes. That was a first.

Lastly, there was an incident at Vons yesterday where a mob of these bicyclists shoplifted at the store stealing food and alcohol. Vons is currently in the process of filing a police report. I have spoken to the manager and their Corporate Office. A report will be filed with local police. I really want the police to be notified so they know these events with the bicyclists have escalated.

I don't think these were isolated events. I believe this was all coordinated to intimidate and threaten residents. It would be naive to think otherwise.

Given the climate of crime in our county and city, I would ask City Council to not change any laws regarding special event permits at our Parkettes. I'm scared as a resident as to what kind of trouble this could bring to our city. 

I appreciate your quick response. I believe you have certain facts incorrect, and I have some follow-up questions for you. Please see in-line in blue below.

On Mon, Feb 28, 2022 at 1:44 PM Suzanne Hadley <<u>shadley@manhattanbeach.gov</u>> wrote:

Thank you for your email, Diana. I am in favor our keeping our parkettes and Bruce's Beach out of the normal permitting process due to their uniquely small nature and locations deeply embedded within residential communities. These small areas have inadequate parking, bathroom facilities, trash receptacles and areas for noise dissipation to make then suitable for anything but individual or small-group gatherings. I am not in favor of changing this long-standing city policy.

If these parks in questions are not appropriate for special events then wouldn't the City's special events permitting process address this and deny such events? Why not <u>consistently apply the process to all parks</u>. You have not explained how it hurts MB to include such parks in this process, or provided information on why this "long-standing city policy" exists in the first place for these 3 parks but not others.

The event yesterday was estimated at 250-300 people. Crowds of hundreds can and have been accommodated at Polliwog Park on the east side and Live Oak Park on the west.

I did not do a headcount, but I included an image of what I saw on Sunday at 4pm: a number of community members and families gathered for a beautiful picnic day at the park. The number of people at the park didn't look problematic to me, and **you will see that there was lots of open grass space** -- see my photo attached). I didn't see a crowd control problem at the park. Of course traffic and parking was increased in the area. Why would the City not want to include Bruce's Beach (and the 2 parkettes) in the existing process if such an event was deemed appropriate, *so that the City can better control the impact to surrounding neighborhoods*?

It's possible council will change the policy. I am only one vote. The community will have a chance to weigh in on this suggestion. I'm glad the mayor took it off consent (where it was not an item that was "*routine and customary*") and put it on general business for vigorous public discussion. You may know that homeowners around BB have lost hundreds of thousands of dollars in equity value due to the controversy, crowds, disputed ownership, etc. around Bruce's Beach. If your family owned a home on 26th St., HIghland Ave or 27th St. neighboring the park, I would vigorously defend your property rights.

With respect I also disagree that enforcing our laws is "un-welcoming and non-inclusive to people of color." That sounds like the soft bigotry of low expectations. Everyone is equal before the law.

Please do not mischaracterize my statement. I did not say that enforcement of our laws leads to an MB that is "un-welcoming and non-inclusive to people of color."

Let me copy what I initially wrote so you can re-read it carefully:

I'm writing to you today because I was shocked to read some of the e-Comments from the last City Council meeting regarding an agenda item that would <u>include</u> Bruce's Beach (and the 8th Street and Larsson Street parkettes) from the City's <u>existing</u> special events permitting process. The reasons stated for continued exclusion of Bruce's Beach echoed the same divisive rhetoric that led to our beautiful beach town being mischaracterized as un-welcoming and non-inclusive to people of color.

The organizers were told in advance that this event was not allowed for many reasons:

- No permits for gatherings are allowed currently at BB. Nonetheless they moved forward with a large event without a permit. Illegal.
- The event was one that required tickets and an entrance fee. Illegal on both counts.

INCORRECT: Please see attached screenshot that shows that the event was FREE

- Food trucks were invited and at least one did not have the required CMB business license. Illegal.
- Alcohol was advertised and served openly in BB. Illegal in all our parks without a permit.

The event was described as BYOB (which I do not condone), but also I believe you are mischaracterizing (hopefully not intentionally) when you say "Alcohol was advertised and served openly in BB"

- Amplified music was played. Illegal without a permit.
- A personal BBQ was utilized. Illegal in all MB parks.

I don't want any sort of park event to happen illegally ... but I <u>do</u> expect our City to enable residents and community members to go through a special events permitting process so that such events, if they serve a benefit to the community, can take place safely and not be deemed "illegal."

I'm not sure why anyone would be in favor of enforcing the law for some folks and not for others. That seems to me to be the essence of discrimination. "Rules for thee but not for me" is not how I wish our city to be governed. We'll see what happens.

I'm not saying that some laws should be applied to some folks and not to others. Where are you coming to that conclusion? As I stated above: I don't want any sort of park event to happen illegally ... but I <u>do</u> expect our City to enable residents and community members to go through a special events permitting process so that such events, if they serve a benefit to the community, can take place safely and not be deemed "illegal."

However, by your argument, why are some parks included in the City's special events permitting process and others (like Bruce's Beach) are excluded?

Why would the City require permits to host birthday parties in parks and even insurance to host block parties ... but not apply the same due process to Bruce's Beach (and the other 2 parkettes)?

This includes staffing, street closures, trash collection and public notice of events .. which the City seems to manage well (ex. Concerts at Polliwog and the 6-man volleyball tourney)

Why not have Bruce's Beach (and the 8th Street and Larsson Street parkettes) be included in

this *existing* City review process if residents are really concerned and wish to exert some control over potential neighborhood impact?

Other points to consider:

1. Please allow all City parks to be places where families and the community can celebrate special events such as birthday parties, neighborhood gatherings, family reunions and cultural celebrations.

2. Without a permitting process, parks can be the site of unauthorized gatherings where city rules are harder to enforce.

3. Including all parks in the current robust permitting process allows for the City to set tailored limits on the type of event, number of participants, date and time, and amplified sound at each park.

4. A permitting process allows City departments to make the necessary preparations and safety assessments to support the event and mitigate neighborhood impact. This includes staffing, street closures, trash collection and public notice of events.

5. It creates an opportunity for the city to collect additional revenue from application fees and billable city services provided for the event.

Hi MB Parks & Recreation Commission and esteemed City Councilmembers,

First, I want to thank you for your continued efforts to make MB a beautiful community-centric beach town. From Concerts in the Park at Polliwog, Hometown Fair and the summer volleyball tournaments, there is so much to enjoy in MB.

I'm writing to you today because I was shocked to read some of the e-Comments from the last City Council meeting regarding an agenda item that would <u>include</u> Bruce's Beach (and the 8th Street and Larsson Street parkettes) from the City's <u>existing</u> special events permitting process. The reasons stated for continued exclusion of Bruce's Beach echoed the same divisive rhetoric that led to our beautiful beach town being mischaracterized as un-welcoming and non-inclusive to people of color.

I visited Bruce's Beach Park Sunday Feb 27 around 4pm (MB Police was there too) and saw nothing but a friendly gathering of community members and kids enjoying the last Sunday of Black History Month on a beautiful sunny MB day. (see my photo attached)

If people have an issue with gatherings like this ... then I think it's all the more reason why Bruce's Beach should NOT be excluded from the City's special events permitting process so that the City can **either deny** such events if they are deemed disruptive to the neighborhood, **or** can make the necessary preparations and safety assessments to support such events and mitigate neighborhood impact. This includes staffing, street closures, trash collection and public notice of events ... which the City seems to manage well (ex. Concerts at Polliwog and the 6-man volleyball tourney)

Why not have Bruce's Beach (and the 8th Street and Larsson Street parkettes) be included in this *existing* City review process if residents are really concerned and wish to exert some control over potential neighborhood impact?

Other points to consider:

1. Please allow all City parks to be places where families and the community can celebrate special events such as birthday parties, neighborhood gatherings, family reunions and cultural celebrations.

2. Without a permitting process, parks can be the site of unauthorized gatherings where city rules are harder to enforce.

3. Including all parks in the current robust permitting process allows for the City to set tailored limits on the type of event, number of participants, date and time, and amplified sound at each park.

4. A permitting process allows City departments to make the necessary preparations and safety assessments to support the event and mitigate neighborhood impact. This includes staffing, street closures, trash collection and public notice of events.

5. It creates an opportunity for the city to collect additional revenue from application fees and billable city services provided for the event.

By all accounts I understand that the Bruce family had their day in court and lost on the issue of racial discrimination. 


