According to my wife the paramedics arrived a short time later. Initially they could not revive me and the captain told my wife the same and suggested she call someone to come be with her during this difficult time. Again according to my wife one paramedic said lets try one more time and when they did I responded and came to. There was hospitalization and a variety of different therapies over the next several months and thankfully today I seem to have recovered completely. I am not the most religious person in the world but I believe in my healed heart that God put life saving magic in the hands of the paramedics that came to this house. I am an avid supporter of the Manhattan Beach Firefighters and Police as well. The question here among other things during contract negotiation's becomes what is my life worth, and what is the lives of all the others that the paramedics have saved and helped in this city worth? You can't put a dollar amount on it can you? I believe that every penny the Firefighters and police earn in this city they truly earn. I don't in any way manner or form in our world today understand why we pay baseball players, football players, soccer players and other athletes upwards of twenty, thirty, and even forty million dollars a year to play a sport for five to seven months a year and why the people who literally save human lives on a daily basis are required to fight for every nickel and dime they get during negotiations. I honestly believe that our lawmakers need to take a minute and reflect in their own lives what is actually important in life an athlete who helps sell beer and peanuts or a Paramedic or Cop that saves lives. I realize that there are priorities and budgets that need to be adhered to but I also believe lives are worth more than beer and peanuts. Please, please, please take the time to understand what our firefighters actually and award the what they are really worth and more so that that what they really deserve. Remember one more thing for you and your families as well. The world is unpredictable and perhaps while I sincerely hope not the time may actually need the paramedics to come to your home to save a life in your family and if so what would they be worth to you then.

We live at 500 7th St, Manhattan Beach, CA 90266 and if you are familiar with the streets in that area, it is very confusing (infact WAZE even misdirects our doordash orders because of their incorrect positioning of our house). Our house is not on the alley. You would have to know the area to find our home quickly. I believe we got the best and most immediate attention for my newborn baby because these guys knew where we lived and how best to get there and to navigate the truck in the tight alley with impossible turns. They referred us to go to the nearest hospital and we rode in the ambulance to Little Company of Mary and immediately got a room in the ER. It's really important to me to make sure that everyone in Manhattan Beach has access to the same quality of talented Manhattan Beach firefighters and paramedics as we did on that very scary evening. Please keep it local!!!!! They are always there for us!
