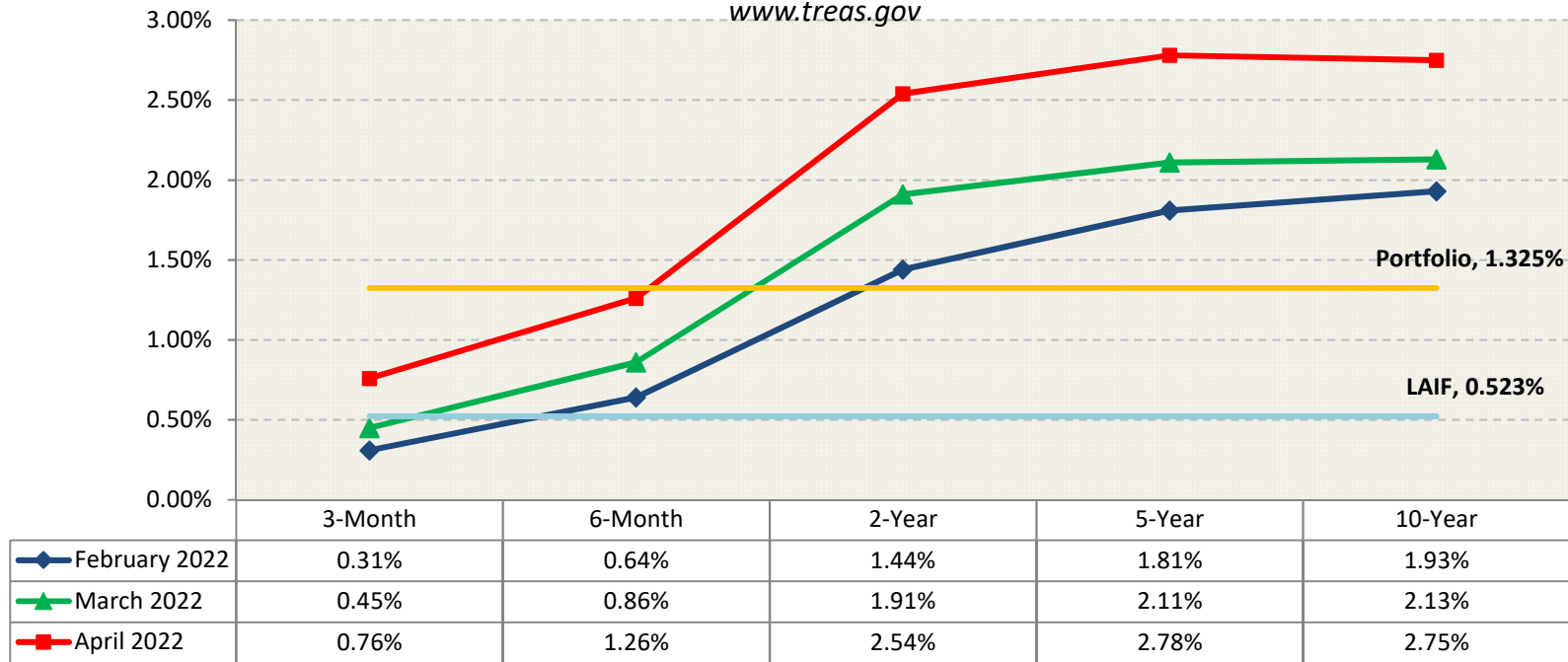

## Pooled Money Investment Account Monthly Portfolio Composition <sup>(1)</sup> 04/30/22 \$225.5 billion

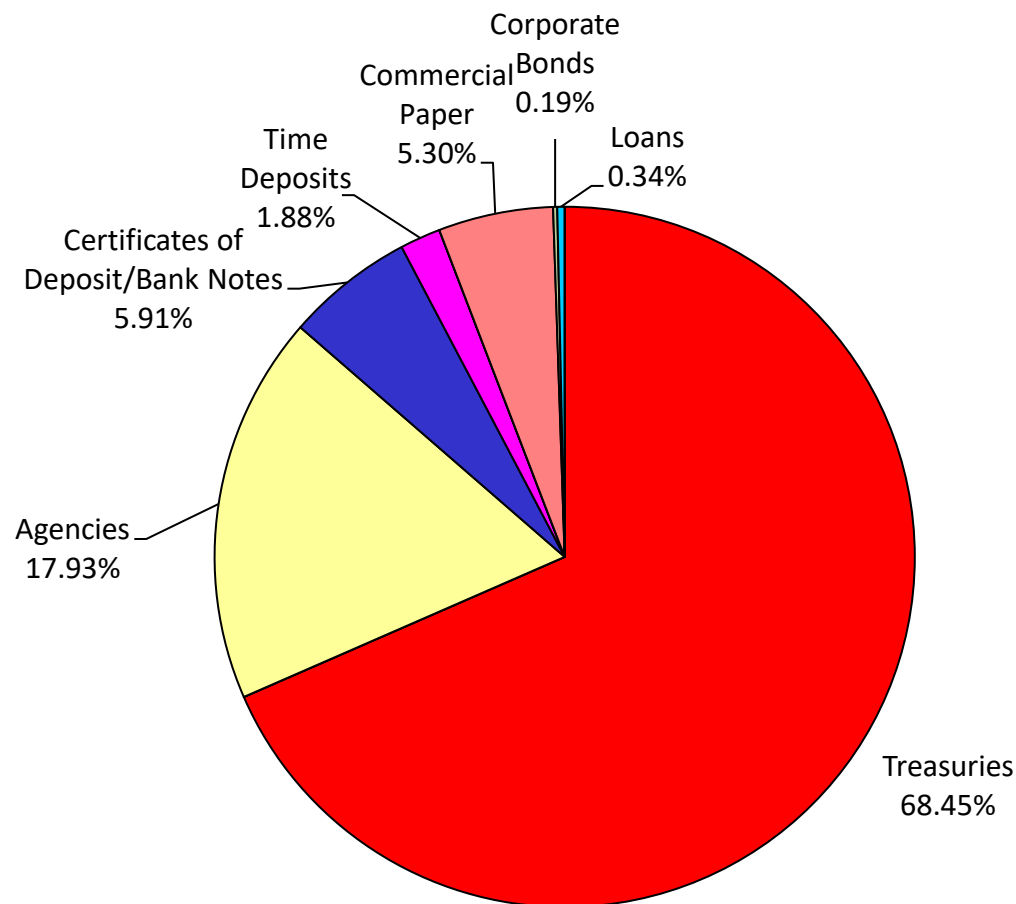
