Dear Mayor Stern, City Council, et al:

I am unable to attend tonight's Budget Study Session, but wish to offer a few thoughts. First, thank you and staff for the time and effort to compile the reporting information. The focus of my comments are on Downtown Manhattan Beach.

I want to thank Erick Lee and the Public Works teams for beginning the process of beautifying downtown. With several objectives achieved or in process, such as the installation of bike racks, additional seating and landscaping, we are seeing results on projects in the works for many years. A continued focus on lighting, both for safety as well as creating a charming village atmosphere in the evenings remains a high objective. General maintenance, including increased cleaning of sidewalks, particularly ones located in the vicinity of "take out" food establishments is needed.. Wayfinding is imperative in guiding our locals and our visitors to all the corridors of our downtown. Manhattan Beach Blvd is heavily traveled and reaching the outer limits of our downtown should be encouraged. Informative but not overly intrusive street signage mentioning, for example, more shops and restaurants with an arrow pointing in that particular direction, will help guide pedestrians north and south on Manhattan Avenue and on Highland.

Enforcement of no-smoking and cycling rules of the road are important. E-bike safety is a top priority, not only for the children but also the safety of pedestrians in crosswalks, etc. The 9th Street crosswalk is of particular concern.

Thank you for your efforts on the homeless. We are seeing a bit of an uptick and when we reach out to continue expediting personnel to assist as best possible to mitigate issues and provide assistance.

Foot patrol and police visibility during the summer is appreciated, especially with increased congestion and population downtown.

Outdoor dining has been very popular with most residents and visitors and we now have 2 years of tangible experience providing facts rather than speculation as to the experience and impact on our downtown infrastructure. I am in favor of supporting an expert to lead the process for evaluating a potential redesign project that will address permanent long term outdoor dining. In doing so, there must be a strong collaboration between all entities involved including residents, business owners, building owners, city staff, etc. as the effect will be far reaching and have great impact for an extended period of time. We have previously spent a lot of time and money on downtown redesign projects. We are also coming off of a pandemic that adversely affected all our business, and some much harder than others. I ask you to be very mindful as we go through this process as we are still in recovery mode and every effort needs to be made to be fair and provide parody to all involved.

I have been a resident of our great City for 30 years and fully support permanent outdoor seating for our restaurants in this city especially in the central core. That said, I'm not sure why it requires \$250k in consulting fees—seems excessive.

Having said that, if hiring a consultant for \$250k is the only way for our to realize this vision, then I'd be in support of that approach.

Outdoor restaurant seating enhances the quality of life for residents in so many similar cities with similar weather patterns in this country and around the world. Advantages are:

- 1) Enhanced safety for pedestrians in the city core—especially at night as everyone is moving around from venue to venue—many with more than a little alcohol in their system
- 2) Reduction of traffic and pollution in the city core
- 3) Enhanced recreational environment for those who use this City—both residents and visitors alike
- 4) More seating avaiability for our restaurants which improve business financials and tax revenue to the City

A common disadvantage often sited is reduced street parking along with the associated meter revenue to the City

Perhaps the solution to the reduced street parking would be partially mitigated by the full use of the already existent parking lots both close to the core and others in and around the City if we were to offer a convenient shuttle service from outer parking lots that are now underutilized in the evenings (various school lots etc.) for residents or key pick up points throughout the City. Residents can use these shuttle services for a small monthly fee—a revenue source for the City that could replace the metered parking. This would also reduce the level of drivers driving in the evenings perhaps under the influence of alcohol back to homes.

I'm sure for \$250k, a consultant can come up with any number of solutions that completely mitigate any negatives associated with permanent outdoor seating that go beyond my suggestions above. I sincerely hope the Council in it's infinite wisdom also decides that the benefits far outwegh the negatives—and create a healthier environment as we move out of this Pandemic.
