2. Approval of Minutes from the May 11, 2022 North MB BID Meeting

4. North MB BID Chairman Peter Kim Update

Power washing of the sidewalks has been sporadic. This is mainly due to residents complaining about the noise of the water, and store owners not wanting their customers exposed when waiting in line. Chairman Kim requested that a representative from Public Works be present at the next meeting for an update.

5. Public Arts Project – Surf Sculpture

The BID chairman was at the artists' workshop during the meeting and the BID Board was able to see the progress of the sculpture live. Due to the delicate nature of the manual stone placement, the artist anticipates completion in approximately 2 months. There are still some matters that need to be cleared between the artist and the City.

6. Update on Website, Social Media Branding and Copyright

Jordan Sands, an acquaintance of one of the Board members expressed interest in maintaining the North MB BID's social media and website. He introduced himself and shared his background and experience with the Advisory Board. The Board voted to hire Jordan Sands for the position for an initial term of six months and unanimously approved a \$1,500 stipend per month. City staff will prepare an agreement.

7. <u>Refurbishment of Entry Monument on Rosecrans</u>

The monument was damaged due to a vehicular accident and will need to be restored, more so than originally planned. Concerns were raised about the location of the monument, possible location change.

8. 2022 Holiday Stroll

The Stroll is confirmed, and the application has been submitted to the City. The BID Board will get a response in approximately 2 weeks.

9. Update on City Attorney's Guidance on Becoming an Association

City staff looked into the history of the formation of the DMBPA and gave the BID Advisory Board a summary of the events that took place in 1998.
