




Overall Sentiment





In Councilmember Hadley's legal opinion, State density bonus law is ambiguous. Because she thinks that, Hadley says she will leave it to the court to order approval of Highrose. That tough talk may be what some residents anxious about the project want to hear. But that is not leadership, it's just pandering. A perfect example is a recent trapping on a Lakewood business property where coyotes were destroying greenhouses. They were also jumping over adjacent residential 6.5 foot walls to kill pets. Children could not play in their yards. The business owner agreed to legally trap. Trail cameras showed FIVE had moved onto the property. One was successfully trapped and the other four are gone. They are smart and sense when a predator is in their midst and will leave. Trapping coupled with education works to provide safety for pets, people. Show that leaders are not afraid to manage dangerous wildlife.
