RE: Rezoning Under Manhattan Beach's 6th Cycle Housing Element

To the City Council:

As you know, our organization is currently engaged in litigation against the City over its failure to adopt a compliant sixth cycle housing element. That litigation remains pending, and we intend to amend our pleadings to account for the City's recent adoption of a new housing element that again fails to meet critical state law requirements.

This letter describes new litigation that we intend to initiate tomorrow, October 19, over the City's failure to complete the rezoning process required by state law. We understand that you have already discussed this new potential lawsuit in closed session and may plan to do so again today, based on our prior communications with the City's litigation counsel. This letter is simply intended to formally express our concern in writing and make a compromise offer.

Under Government Code Sections 65583(c)(1)(A), 65583.2(c), and 65588(e)(4)(C)(i), the City was required to complete all rezoning necessitated by its housing element by October 15, 2022.<sup>1</sup> The City did not meet that deadline. We therefore intend to initiate litigation against the City pursuant to Government Code Section 65587(d)(2) to obtain a judicial declaration that the City is subject to the penalty in Government Code Section 65583(g)(1) and to compel the City to complete the required rezoning.

We will agree not to proceed with the new litigation if the City agrees to enter into a tolling agreement with the following essential terms: (1) the City agrees to immediately withdraw its

housing element from review by HCD to allow for the development of a revised housing element; (2) the City agrees that it is currently prohibited from using the provisions in subdivision (d)(1) or (d)(5) of Government Code Section 65589.5 to disapprove a housing development project that qualifies for approval under subdivision (d) of that section; and (3) the City agrees that it is currently subject to the penalty for failure to rezone in Government Code Section 65583(g)(1). If the City would like to enter into such a tolling agreement, please let us know by 1:00 p.m. tomorrow, October 19, 2022. If we do not hear from you, we will proceed with litigation.
