As articulated in our November 2018 letter & petition submitted to the City of MB Planner, attached, we are strongly against the addition of any telecom or other visible utility equipment on the corner of Highland Avenue and 19th Street (walkstreet). This has been proposed before and forcefully rejected by concerned homeowners in the vicinity.

We received notification on October 3, 2022 that AT&E Mobility has one again submitted an application for visible telecom equipment in this location. This location is <u>most</u> intrusive to the beach view corridor down the 19th walkstreet, not *least* intrusive as AT&T's proposal claims.

We are writing to follow-up on our last letter **protesting the installation of an AT&T Mobility Telecom facility at 19th Street and Highland Avenue** and my visit to meet with you at the City offices Friday November 3, 2017. The proposed installation of an antenna on top of the street light pole would have a severe negative impact to our property aesthetically, spoiling our view of the ocean. It would also reduce our property value significantly. Attached on page 3 is a photo from our living room showing how central this light pole is to our view and the feel of our property at 1900 Highland.

We understand that the proposed equipment cabinet has been relocated from 19th street to the 19th place alley way. Thank you, we agree! The alley ways are far more fitting places to have electrical and mechanical equipment than the walk streets.


