2.1 Proposals to Update signage

CAC decided on a LED programmable sign where announcements could be posted.



Proposal:

- 2.1a) Replace current CAC sign with a new versatile (LED lit) art piece sign that meets requirements for funding from PAIF
- Artistic sign with a programmable (lit) section to advertise events
- Remove existing sign and remove brick wall under sign
- Obtain waiver for height/size

Options considered:

- 2.1b) Replace existing sign with new, identical size sign in same location [general fund]
- New lights (existing lighting no longer working)
- Height waiver grandfathered?
- 2.1b) Replace sign with a new, larger and more versatile **non-art piece** [general fund]
- Include LED lighting programmable to advertise ongoing evemts
- Remove existing sign and brick wall under sign
- Obtain waiver for height/size?

2.1(a) Proposed Sign

UPDATE dimensions on photo



- Monument design similar to other typical signs
- Sign includes Art mural and LED section that can be changed periodically to announce art center events
- Full color High resolution LED
- Double sided with internal LED lighting for both mural
- Aluminum base hand painted by artist
- 6' (72") wide x 10' (120") high x 20" deep
- Allocate \$100-\$200k based on Video display at City Hall
- Setback from sidewalk and building TBD

Timeline: 18-24 Months




