

Overall Sentiment







Not opposed to the project, but opposed to the process. If library money is available, the various alternative uses of that money should be discussed community-wide. Other projects jumping to mind are improvement of the main library's public outdoor space or extended hours to improve access. That this project was presented in whole cloth and architectural design to the district and various commissions without alternatives exploration belies a community effort and is a bit Machiavellian. The survey's a joke--why would only 48% say that library services wouldn't be improve? Contrast to 66% interested in a new aquatics center, and that wasn't sufficient for some councilmembers. For outreach, there is no reason "Friends of Polliwog" get preference--you folks have to stop with granting a few vocal residents with a group name with more leverage than any other. Finally, deferring "loss of space and parking access" to being "discussed later" ignores some rather important issues
