

Overall Sentiment








In August 2021, the City was authorized \$8.4M in ARPA funds. Water and sewer infrastructure projects are primary acceptable ARPA spend. I have not seen this money go to either, yet you are asking us for fee raises (for water in 2022, and now sewer--which could have been addressed simultaneous with the water increase). But this money went to the general fund and fire station (way down the ARPA list), and cost overruns for the Polliwog playground equipment and the community center. So, given the fungibility of money, the water and sewer rate increases go to fund these expenditures in lieu of establishing a decent general fund CIP program. And we sit on untapped reserves, like the Reserve for Economic Uncertainty that's never used for times of economic uncertainty. You folks intentionally disregard honest, comprehensive financial planning, seeming to trickle out items to fool all of the residents all of the time. And note that the PPT presentation has been unavailable for at least 2 days.

Staff report again does not disclose the impact of increase on pension and accumulated vacation. Just one example of how our CM presides over a general disregard for community participation and empowerment. We are not getting the benefit of the myriad supplementary support he is given, such as "community engagement managers", environmental managers, or extra code enforcement. The annual "step and grade" dance yields no

apparent efficiencies. The only tool for most problems is to put up a sign. Everything is marketing and performative governance. Our financial system is aged, opaque and riddled with accounting gimmicks. There is no cohesive, universally understood community goals. Master plans are a placebo. Projects appear out of whole cloth seemingly on a whim. The CM was unable to deal with simple pandemic problems such as landscape maintenance, Ocean Dr, or park access. Continuing his employment is another 3 years of lack of stagnation, resident disengagement and lack of progress.
