### REGISTRATION

- All teams must be registered through the Manhattan Beach Parks & Recreation Department. Registration will take place [online](#) or in person at 1400 Highland Avenue, Manhattan Beach, CA 90266. Once registered, your team must submit a completed roster form. Rosters can be submitted either in person or emailed to [asherman@manhattanbeach.gov](mailto:asherman@manhattanbeach.gov). The deadline for roster submittals and changes is July 28.

### CHECK-IN

- All teams are to check-in with the Tournament Director before 8:30am, Friday regardless of weather.

### CANOPY CHECK-IN/GUIDELINES

- Each team will be limited to one blank 10X10 canopy (no branding of any kind). Teams will be responsible for all items in the canopy. All canopies must be open and accessible on all four sides. Please do not bring valuable personal items to the event.
- Rental equipment and snow fencing prohibited.

### AWARDS

- Ten individual first and second place awards will be given for each division (T-shirts and medals).

### RULES

- The City of Manhattan Beach Parks and Recreation Department reserves the right to make decisions pertaining to entries, rules, and general procedures governing this tournament.
- Masters team players ages are determined by your age on the day of the tournament.
- Additional rules include: no net serves, original court size (long court), players must rotate, no libero, no open hand serve receive, and only the team captain may address the official.
- Teams may register up to 10 persons per team. All persons playing must be on the roster or teams will be subject to forfeit during playoffs. All players must play on Friday, in order to play Saturday.

### GUIDELINES

- Any goods brought into the tournament area are subject to inspection (i.e. coolers, bags, backpacks, etc.). Large coolers are prohibited. ALCOHOL IS PROHIBITED.
- No amplified music. Megaphones must receive approval by the Tournament Director before use.
- Props, generators, and household furniture are prohibited. (i.e. basketball hoops, plywood structures, metal structures, etc.).
- Team themes and costumes should not be graphically offensive to a reasonable person or young juvenile and acceptable to a family standard.
