I started a petition on change.org actually that doesn't have too many signatures but I believe has evidence to support my claims about these lights and their brightness and their potential downsides that they have. And I actually use orange blue light blocking glasses at night because these lights are so bright and I can't even look directly at them. So, wow, I didn't think I'd get past everything I needed to in under a minute.
