THAT WE'LL GO COMPLETELY BACK TO NON-VIRTUAL EVENTS OR MEETINGS. ONE OF THE THINGS THAT WE'RE WORKING ON IS A HYBRID MODEL AND WORK WITHING THE THREE CITIES TO TRY TO BE CONSISTENT IN HOW WE REOPEN. WE'RE PARTNERING WITH THE CHAMBERS AND PROUD OF HOW THAT IS GOING. SHE IS GOING TO TALK ABOUT VACCINES.

THAT'S JUST SOME INFORMATION THERE THAT YOU ARE ALL AWARE OF. >> YES.

AS WE'RE ALL AWARE VACCINE ELIGIBILITY HAVE OPENED TO ALL OF CALIFORNIANS AGE 16 AND UP.

THOSE THAT ARE 16 AND 17 CAN ONLY GET THE PFIZER VACCINE WHICH WE'RE OFFERING HERE.

IF YOU'RE INTERESTED IN GETTING AN APPOINTMENT SHOULD VACCINE LA.COM. IN TERMS OF WHAT WE'RE DOING AS THE DISTRICT, WE'RE EDUCATING THE TEACHERS AND STUDENTS, WE'VE DELIVERED OVER 6500 DOSES THANKS TO OUR RELENTLESS WORK FORCE.

THEY ARE ALL VOLUNTEER BASED VACCINATORS AND LICENSED NURSE PRACTITIONERS AND NURSES.

WE ARE NOW ABLE TO HAVE PUBLIC CLINICS THAT ARE OPEN TO THE PUBLIC. THOSE WILL BE SATURDAY AFTERNOONS.

WE'VE BEEN ABLE TO ACCOMMODATE AT CITY HALL.

THE FRONT DESK RECEPTIONIST AND ABLE TO DIRECT CUSTOMERS TO MAKE THE APPOINTMENT SO THEY CAN COME IN AND SEE THE APPROPRIATE STAFF. JUST A LITTLE BIT ON HOW THINGS WENT.

WE FOUND THAT OTHER THAN PUBLIC RECORDS THAT REQUESTERS NEEDING TO COME IN AND LOOK AT PHYSICAL PLANS THAT WERE NOT AVAILABLE DIGITALLY, ALL OTHER PERSONS WERE ACTUALLY ABLE TO BE HELPED VIA E-MAIL, PHONE,

ALL OF OUR SERVICES ARE AVAILABLE THAT WAY.

IF YOU ARE REQUIRED TO COME TO CITY HALL FOR WHATEVER REASON, THE PUBLIC INFORMATION TEAM DID A GREAT JOB PUTTING TOGETHER A MAIN BANNER FOR THE CITY'S MAIN WEB PAGE.

YOU SEE LIMITED IN PERSON APPOINTMENTS AVAILABLE.

IT TAKES YOU TO A PAGE THAT SHOWS YOU HOW TO GET IN THERE.

WE CAN HELP PEOPLE THAT WAY.

THEY THINK IT'S GOING WELL.

WE'RE GOING TO CONTINUE TO MONITOR THE DEMAND AS WHAT MIGHT COME NEXT DURING THE NEXT PHASE AS WE MIGHT START ALLOWING LIMITED WALK INS AS WELL.

THAT'S THE FIRST PART ON REOPENING.

THE SECOND PORTION OF MY UPDATE HAS TO DO WITH THE NEW COUNTY HEALTH OFFICER ORDER THAT WAS RELEASED LAST THURSDAY IN THE REFLECTION OF IMPROVING NUMBERS FOR VACCINATION AND DECLINING NUMBER OF CASES THE COUNTY NEW HEALTH ORDER DOES ALLOW SOME INDOOR SEATED ACTIVITIES AND PRIVATE EVENTS SUCH AS MEETINGS AND CONFERENCES.

THE COUNTY DID RELEASE SEVERAL ACCOMPANYING PROTOCOLS FOR THESE USES AN SOME OF THEM ARE PRETTY RESTRICTIVE AN PROVIDE A PATH FORWARD FOR THESE EVENTS.

THEIR STRICT CRITERIA INCLUDES PROOF OF VACCINATION OR TESTING NEGATIVE PRIOR TO THE EVENT, ALSO A CAP OF ONE HUNDRED PEOPLE ALONG WITH THE WHOLE HOST OF FACE COVERINGS, DISTANCING AND PROTOCOLS AS TO WHEN YOU CAN EAT AN WHEN YOU CAN'T AN THINGS LIKE THAT.

THE COUNTY ALSO DID RELEASE A NEW GUIDANCE FOR A USE CALLED INFORMAL SOCIAL GATHERINGS UP TO 25 PEOPLE OF VARIOUS HOUSE HOLES, TWO HOURS OR LESS WEARING FACE MASKS, MAINTAINING DISTANCING AN RULES FOR EATING AN DRINKING.

ON NOVEMBER 4, 2020, THE CITY COUNCIL CONSIDERED A REQUEST FOR REGULATIONS REGARDING BEE KEEPING.

ANIMAL REGULATED PROVISIONS SPECIFICALLY RELATING TO BEES AND CHICKENS AN PIGS.

THE CITY HAS RECEIVED FOUR INDEPENDENT ANIMAL RELATED COMPLAINTS SINCE 2018.

ONE REGARDING ROSTERS AND THREE REGARDING BEE KEEPING.

THIS SUMMARIZES CURRENT REGULATION AND ENFORCEMENT.

DOMESTIC AND EXOTIC NOT TO EXCEED THE NUMBER OF FIVE.

DOMESTIC ANIMALS INCLUDE DOGS CATS, RABBITS, HENS, FISH AND THE LIKE. EXOTIC ANIMALS AN FARM ANIMALS ARE EXCLUDED WITH THE EXCEPTION OF POT BELLY BIGS.

THE REGULATIONS DO NOT SPECIFICALLY IDENTIFY BEES OR BEE KEEPING. THERE ARE OTHER PROVISIONS IN TITLE FIVE IN THE CODE.

BEE KEEPING ARE REGULATED BY LOCAL JURISDICTIONS BECAUSE IF NOT DONE PROPERLY BEES CAN BECOME AGGRESSIVE AND THEY CAN BECOME A NUISANCE. WATER, THE AMOUNT OF SPACE IN THE HIVE AND TENDING TO THE HIVE ALL PLAY A ROLE IN SUCCESSFUL BEE KEEPING.

LOCAL JURISDICTION HAVE EXPERIENCED A SURGE IN BEE KEEPING ACTIVITIES PARTIALLY IN RESPONSE TO EVIDENCE THAT SOME BEE SPECIES HAVE BECOME ENDANGERED.

IN ADDITION TO BEING VITAL TO BIODIVERSITY BEES ARE HEALTHY ECOSYSTEMS MOST NOTABLE BEING FOOD SECURITY.

THE AGRICULTURAL COMMISSIONER REGULATES BEE KEEPING ACTIVITIES IN ACCORDANCE WITH VERY SPECIFIC REGULATIONS OF THE STATE OF CALIFORNIA FOOD AND AGRICULTURAL CODE WHICH REGULATES BEES AND HONEY PRODUCTION. ALL BEEKEEPERS MUST REGISTER ANNUALLY WITH THE COUNTY.

THE COUNTY DEPARTMENT IS ALSO RESPONSIBLE FOR INVESTIGATING COMPLAINTS REGARDING BEE KEEPING.

THEY TYPICALLY GET OUT TO THE SITE WITHIN TWO DAYS OF RECEIVING A COMPLAINT.

ISSUE NUISANCE VIOLATIONS AND FOLLOW-UP WITH ENFORCEMENT EFFORTS. ALL COMPLAINTS WITH THE COUNTY OR CITY THE INSPECTOR'S NOTES AND CITATION.

REGULATION OF BEE KEEPING CARRIES.

SOME JURISDICTIONS HAVE NOT ADOPTED REGULATIONS SPECIFICALLY RELATING TO BEE KEEPING AND RELY ON LOS ANGELES COUNTY FOR GUIDANCE. OTHERS PROHIBITED BEE KEEPING ENTIRELY.

A FEW EXAMPLES OF CITIES IS REDONDO BEACH, TORRANCE, LONG BEACH, CITY OF LOS ANGELES.

THESE CITIES REQUIRE PERMITTING.

HIGH QUANTITY, PLACEMENT AND MANAGEMENT.

SWITCHING GEARS TO CHICKENS AND PIGS.

BASED ON THE CODES DOMESTIC ANIMAL PROVISIONS HENS ARE ALLOWED ON RESIDENTIAL PROPERTIES WHEREAS ROOSTERS STRICTLY PROHIBITED.

THEY CURRENTLY PERMIT POT BELLY PIGS BUT PROHIBIT HOGS AND OTHER SPECIES OF PIGS.

ENFORCEMENT PROVISIONS FOR ANIMAL RELATED VIOLATIONS IN EVENT WHERE ANIMAL ACTIVITY IS CREATING A PUBLIC NUISANCE.

IN ACCORDANCE WITH OUR NUISANCE ABATEMENT CODE.

I'LL WALK YOU THROUGH SOME PROVISIONS IDENTIFIED IN THE CODE.

ACCORDING TO TITLE NINE ANY ADDITION TO A PROPERTY WHICH ADVERSELY EFFECTS THE HEALTH, WELFARE, OR SAFETY.

ANY ANIMALS THAT ATTACK OTHER ANIMALS ARE CONSIDERED A PUBLIC NUISANCE.

ADDITIONAL PROVISIONS ENTITLE FIVE INCLUDE FIVE POINT ZERO ONE POINT THREE ONE ZERO WHICH STATES IT'S UNLAWFUL FOR THE OWNER OR PERSON HAVING CUSTODY OF ANY ANIMAL FOR FAILURE OF CONTROL FOR ANIMAL TO COMMIT ANY NUISANCE.

OWNERS OF ANY ANIMAL ARE REQUIRED TO SUPPLY ANIMALS WITH SUFFICIENT FOOD AND WATER AS OFTEN AS THE HABITS OF THE SPECIFIC ANIMAL REQUIRE. MAINTAIN HOUSING OF ANIMALS.

ELIMINATE EXCESSIVE NIGHTTIME NOISE.

REASONABLE PRECAUTION IT PROTECT THE ANIMALS FROM THE PUBLIC AND CORRECT ANY VIOLATIONS WITHIN A REASONABLE TIME.

IF ANY OF THESE PROVISIONS ARE VIOLATED, WRITTEN NOTIFICATION TO THE OWNER.

IF A NUISANCE IS NOT PROPERLY ABATED WITHIN A PERIOD ESTABLISHED WITHIN THE PROVISIONS OF THE CODE, THE COUNCIL MAY HOLD A HEARING TO DETERMINE IF A NUISANCE EXISTS AND WHETHER OR NOT IT SHOULD BE ABATED.

IN CONCLUSION THE CITY'S MUNICIPAL CODE INCLUDES AVENUES TO PERMIT KEEPING OF THESE ANIMALS SUCH AS PIGS AN CHICKENS.

CODE ENFORCEMENT CASES.

I WANTED TO HAVE STAFF LOOK AT THIS AND MAKE SURE THE HISTORY WAS

CLEAR NOT ONLY TO MY COLLEAGUES AND COUNCIL BUT THE RESIDENTS THAT CALLED AND REPORTED THE BEE ACTIVITY AND STINGING ACTIVITY.

ACCORDING TO STAFF, THAT'S NOT TRUE.

THAT'S GOOD TO KNOW.

WE DON'T KNOW, JOE, HOW MANY HIVES ARE OUT THERE IN PEOPLE'S YARDS. WE HAVE NO IDEA YET.

I FEEL ALSO FOR BEE SWARMS AROUND OUR NEIGHBORHOOD.

BY WAY OF BACKGROUND AT THE LAST COUNCIL MEETING WE WERE DISCUSSING ENFORCEMENT OF THE FACE COVERING EMERGENCY ORDER WHICH LED ME TO PROMPT A REPORT TO THE COUNCIL THIS EVENING TO FILL YOU IN ON WHAT THE OTHER DETAILS ARE ON WHAT CDC PROVIDES BY WAY OF SERVICES ALONG THE STRAND AND THE GREEN BELT WHICH IS FOCUSED ON PUBLIC EDUCATION AND DISTRIBUTION OF MASKS IN WHICH TO HELP KEEP THE PUBLIC SAFE.

SO TO PROVIDE THE PRESENTATION.

>> YES, THANK YOU CITY MANAGER.

HONORABLE MAYOR AND MEMBERS OF THE CITY COUNCIL.

SENIOR MANAGEMENT ANALYST.

AS CITY MANAGER INDICATED THE CITY'S RESPONSE TO THE COVID 19 PANDEMIC BEGAN BY CITY MANAGER ON CITY COUNCIL'S BEHALF THE CITY HAS UTILIZED TWO DIFFERENT PROGRAMS TO LIMIT COVID 19 TO EDUCATE AND ENFORCE THE EVER-CHANGING REGULATION.

THESE AREAS INCLUDES BUT WERE NOT LIMITED TO DOWNTOWN MANHATTAN BEACH.

PARKING LOTS AND THE BEACH.

LET'S GO INTO FIRST THE PROGRAM THAT CITY MANAGER IS REFERENCING, THE AMBASSADOR'S PROGRAM.

SPRING OF 2020 THE CITY DEPLOYS FIRE CONTRACT OFFICERS ALSO KNOWN AS CSC THE CITY HAS ALWAYS HAD A LONGSTANDING RELATIONSHIP WITH CSC AS THEY HAVE ASSISTED THE CITY WITH SECURITY FOR ANNUAL EVENTS SUCH AS HOMETOWN FAIRS AND MANY MORE.

A VARIETY OF RESPONSIBILITIES THAT INCLUDED CROWD CONTROL, FACE COVERING HANDOUTS AN VISITOR ASSISTANCE.

THE CITY HAS EXTENDED TWO TO \$12,000 PER WEEK LARGELY DEPENDING ON WEATHER AND IF THERE'S A HOLIDAY WEEKEND.

WHILE THE PROGRAM DOES COME AT A SIGNIFICANT COST, THE CITY HAS RECEIVED GENERALLY POSITIVE REVIEWS OF THE TYPE OF EDUCATION AND PROGRAM PUBLICATION.

A VARIETY OF COVID 19 PUBLIC HEALTH CONCERNS, PROTESTS, CIVIL UNREST, VIOLENT PHENOMENON, TRAFFIC PATTERNS.

GREATER STAFFING RESOURCES TO ASSIST THE POLICE DEPARTMENT'S RESPONSE AND REASSURE THE COMMUNITY THAT PUBLIC SAFETY WAS SAFEGUARDED.

ADDITIONALLY, THESE ARE THE SIDE NOTE THAT'S WE SOMETIMES HEAR ABOUT BUT IT'S GOOD FOR US TO KNOW A QUICK RESOURCE TO REPORT CRIMES OR OFFER BUSINESS EMPLOYEE ASSISTANCE TRANSPORT TO THEIR VEHICLES LATE AT NIGHT IF THEY FEEL UNSAFE FOR ANY REASON.

THAT'S THE FIRST ELEMENT OF THE CITY'S PUBLIC SAFETY INITIATIVE. THE OTHER ELEMENT IS THE FACE COVERING ENFORCEMENT TEAM.

I'LL TRY TO QUICKLY SUMMARIZE IT.

ON JULY 15, 2020 THERE WAS AN CITY ORDER REITERATING THE FACE COVERING REQUIREMENT THAT THE COUNTY HAD AND AUTHORIZING THE ADDITIONAL PERSONNEL TO ENFORCE THE REQUIREMENT.

ON JULY 17, 2020, THE CITY EXECUTED THAT AGREEMENT PROVIDING STAFFING WITH THE NECESSARY CITATION AUTHORITY TO ENFORCE THESE REQUIREMENTS. JUST TO REPORT ON THE PROGRESS OF THAT FROM JULY 2020 TO 2021 HAD 17,000 INTERACTIONS TO THE COMMUNITY TO INFORM VARIOUS INDIVIDUALS OF THE FACE COVERINGS REQUIREMENTS.

THE ENFORCEMENT PROGRAM NOTED 99.9% COMPLIANCE AND POSITIVE IMPLEMENTATION TO THOSE NOT COMPLYING WITH THE FACE COVERING REQUIREMENTS.

IN THE TIME PERIOD THE CITY DEPLOYED THE FACE COVERING REQUIREMENTS. THE CITY SPEND ABOUT \$15,000 PER MONTH TO ENFORCE THE REQUIREMENT. THE CITY DOES EXPECT TO BE REIMBURSED BY FEDERAL GOVERNMENT FOR MOST IF NOT ALL COSTS.

THIS SERVES AS A COMPREHENSIVE STAFF REPORT.

THE FACE REQUIREMENT PROGRAM HAS SHIFTED THEIR PRIORITIES AN GEARED TOWARDS THE PUBLIC ENGAGEMENT PROGRAM.

THERE'S NO NEED TO EXTEND THE ENFORCEMENT PART OF THAT.

THE PUBLIC EDUCATION COMPONENT.

STAFF RECOMMEND THAT'S THE CITY COUNCIL DISCUSS AND PROVIDE DIRECTION REGARDING THE PUBLIC SAFETY DIRECTION AND THE POLICY OF THE CSC AND THAT CONCLUDES MY REPORT.

WE ARE ANXIOUSLY AWAITING TO GET SOME MORE INFORMATION FROM THEM.

SUBMIT A FIRST APPLICATION FROM MARCH 15 TO THE BEGINNING OF THE EMERGENCY UNTIL SEPTEMBER 15TH.

THAT IS UNDER ADVISEMENT WITH OUR FEMA REPRESENTATIVE.

THEY CHANGED THE MYTHOLOGY IN ACCEPTING SPECIFIC REIMBURSEMENT ITEMS AND LIMITED TO SPECIFIC ITEMS.

THAT APPLICATION WAS RIGHT AROUND 850,000.

WE SUBMITTED ONE IN JANUARY FROM SEPTEMBER 15TH TO JANUARY FIRST. THAT WAS RIGHT AROUND 140,000 REIMBURSEMENT OF WHAT WE CONSIDER QUALIFYING REIMBURSE MS.

GOING FORWARD, THAT'S A DOUBLE EXPENSE IF THEY ARE BEING PAID 18 TO \$20 AN HOUR.

THAT'S \$40 AN HOUR TO HAVE THEM WALKING SIDE BY SIDE.

CAN THEY GO INDIVIDUALLY AS OPPOSED TO SIDE BY SIDE?

THE ADDITIONAL THOUSAND A WEEK, ABSOLUTELY NOT.

I THINK IT'S TOO EXPENSIVE.

WE'RE PROBABLY GOING TO HAVE TO DO SOMETHING DIFFERENT GOING FURTHER.

I'M SORRY IF I CONDITION RECALL WHAT WE CALL THEM.

THEY ACTUALLY HAVE A UNIFORM.

THEY WERE USED FOR CROWD CONTROL.

THEY WERE USED FOR THINGS LIKE THAT.

I THINK THERE WAS ABOUT 15 MEMBERS OF THAT.

I UNDERSTAND MOST OF THEM ARE RETIRED.

IN TERMS OF AMBASSADORS TELLING PEOPLE, POINTING PEOPLE IN THE RIGHT DIRECTION.

THEY HAVE A GREAT KNOWLEDGE OF THE CITY BECAUSE THEY LIVE HERE.

THEY RECOMMEND RESTAURANTS AND WHERE TO PARK, THINGS LIKE THAT.

WHAT'S THE FEASIBILITY REACTIVATING THEM PRESUMING THEY FEEL SAFE AN THE INFECTION RATE IS DOWN.

>> DO YOU WANT TO ADDRESS THOSE.

>> ACTUALLY I'M GOING TO ASK CHIEF ABLE TO JUMP ON HERE.

IN TERMS OF PEOPLE TRAVELING TWO BY TWO.

YOU MAY RECALL AT THE BEGINNING OF THE PROGRAM; THEY WERE DOING THAT

BECAUSE CSC DIDN'T HAVE CITATION AUTHORITY.

THE CHIEF CAN TALK ABOUT THE FACT THERE WAS SAFETY IN NUMBERS FOR THE PERSON IN CSC AT THE TIME.

PEOPLE WOULD OFTEN CHALLENGE THE PERSON WRITING THE CITATION.

IF WAS A WAY OF KEEPING CONTROL OF THE SITUATION.

AND THOSE PEOPLE WOULD HAVE THE OPPORTUNITY TO ATTACK THE POLICE DEPARTMENT.

>> THERE'S ALWAYS SAFETY IN NUMBERS.

WORKING WITH OUR CITY WHETHER IT'S SPECIAL EVENTS OR LEADING UP TO THIS POINT RIGHT NOW.

I UNDERSTAND THE COST COMPONENT BUT SAFETY IN NUMBERS AND ALSO WITNESSING ISSUES THAT COME ABOUT AS WELL.

THERE'S A REASON FOR IT.

WE ACTUALLY DO THAT WITH OUR OFFICERS BOOTS ON THE GROUND FOOT BEAT AS WELL.

WITH REGARD TO THE OTHER PORTION.

I THINK YOU WERE ASKING THE QUESTION ABOUT VOLUNTEERS ON PATROL.

WE HAVE NATURALLY INTRODUCED THEM BACK INTO THE WORKPLACE.

THEIR NUMBERS ARE LIMITED.

WHEN THEY DO COME BACK, KEEP IN MIND THEY ARE VOLUNTEERING.

MUCH OF WHAT THEY DO IS NOT WHAT WE WOULD CONSIDER WITH THE CSC STAFF.

CAN THEY DO SOME OF IT, YES.

BUT NOT TO THE EXTENT WE USE CSC FOR.

THEY ARE RETIRED, NO DISRESPECT TO THEM.

I HAVE LIEUTENANT AARON AVAILABLE TO ANSWER ANY QUESTIONS AS WELL. >> THANK YOU.

COLLEAGUES WHAT DO WE WANT TO DO?

>> IF THE CIVILIAN PATROL WAS ELIGIBLE AND NOT AT THEIR AGE, THAT WOULD BE GREAT.

BUT WE CAN'T.

THE ENFORCEMENT PART OF IT IS GONE.

THAT PART OF IT IS GONE.

DO YOU WANT TO USE CSC AND COVID EDUCATION?

MAYBE PUT A CERTAIN TIME LIMIT.

PUT IT FOR 90 DAYS AND SEE WHAT HAPPENS.

WE'LL BE OUT OF THE YELLOW TIER I HOPE.

SEE WHERE WE ARE, I'M LOATHE TO CUT IT BECAUSE WE'RE NOT GETTING REIMBURSED 100% FOR SOMETHING THAT'S WORKED FOR MONTHS, SECURITY GOING TWO BY TWO WALKING AROUND THE CITY.

I THINK IT'S CIVILIANS RIGHT WE TRY IT THE WAY FEMA SAYS, EVEN IF WE DON'T GET DOLLAR FOR DOLLAR THAT WE HAVE THEM OUT DURING THE BUSIEST PART OF THE YEAR.

NOW IS NOT THE RIGHT TIME TO PULL BACK.

>> JOE HOLD ON ONE SECOND.

CHIEF ABLE ARE YOU TILL THERE.

- >> YES, I'M STILL AVAILABLE.
- >> OR LIEUTENANT, WHAT DOES CSC DO ABOUT TRAFFIC.
- DO THEY ASSIST FROM THEM?

I DID HEAR SOME POSITIVE COMMENTS ABOUT LAST WEEKEND IT WAS SO CROWDED DOWNTOWN.

HOW HELPFUL ARE THEY WITH TRAFFIC DIRECTIONALLY, PARKING ADVICE, THAT KIND OF THING?

WE HAVEN'T USED THEM IN OUR PARKING LOT'S GORGE END TO HELP REDUCE SOME OF THE STAFFING NEEDS THAT WE HAVE WITH REGARDS TO PARKING ENFORCEMENT AS WELL.

THE SUMMER MONTHS INCREASE AS COUNCIL MEMBER MONTGOMERY WAS ALLUDING TO.

THEY DO HELP WITH THAT ESPECIALLY IN THE PARKING LOTS AND DIRECTING TRAFFIC.

THEY CAN BE VERY USEFUL IN THOSE AREAS TO REDUCE THE TRAFFIC FLOW. YES, THAT CAN BE DONE.

>> IF CSC DOES NOT DO IT DOES IT NOT GET DONE OR DO WE USE A UNIFORMED OFFICER.

>> COMMUNITY SERVICE OFFICER.

THEY ARE TRAINED IN THAT RESPECT.

WHETHER IT'S IN THE PARKING LOT OR OUT IN THE STREET, THEY ARE TRAINED TO DO THAT.

MUCH OF THEIR WORK ACTUALLY HAPPENS ON THE STREET.

THEY CAN DO PARKING LOTS BUT IN THEIR ABSENCE THE CSC WOULD BE HELPING IN THAT RESPECT.

- >> CSC WOULD BE CHEAPER IN THAT RESPECT IS WHAT I'M GUESSING.
- >> FULLY BURDENED YES.
- >> JOE, LET ME WRAP UP MY COMMENTS AND I'LL GO TO YOU.

I'M WITH STEVE THAT I DON'T WANT TO DO THIS INDEFINITELY.

I DO WANT TO GET TO JUNE 15TH.

I'M CONCERNED ABOUT PAYING FOR A WHOLE SECOND FORCE.

ESPECIALLY AS I HOPE FEMA WHEN WE STOP NEEDING TO WEAR MASKS OUTDOORS THERE'S NO EDUCATIONAL COMPONENT.

I WOULD HOPE WE WOULD BE ON TOP OF THAT AND BE RESPONSIBLE NOT TO REIMBURSE FOR THINGS NOT COVID RELATED.

UNTIL THEN I REALLY DO LIKE, I'M WITH RICHARD, I LIKE THE EXTRA BOOTS ON THE GROUND AND EXTRA EYES AND EARS OUT THERE FOR PARKING AND SKATE BOARDING.

WE HAVE WITHIN THE LOTS.

JUST THAT AMBASSADOR FUNCTION.

I THINK IT IS GOOD THEY HAVE MASKS WITH THEM.

MASKS ARE STILL REQUIRED INDOORS.

THEY ARE ABLE TO HELP LOCAL BUSINESS, THEY ARE CHEAPER THAN OUR COMMUNITY SERVICE OFFICERS HOURLY RATES.

THAT COULD BE A GOOD SAVINGS.

I'M SOMEWHERE IN BETWEEN STEVE AND RICHARD.

I DON'T WANT TO SIGN OFF ON IT INDEFINITELY BUT I DO SEE REAL VALUE.

I DIDN'T ASK THE DBPA ABOUT THIS SPECIFICALLY.

IF I WERE A BUSINESS OWNER, I WOULD BE HAPPY DOWNTOWN TO SEE SOME OF THESE FOLKS WALKING AROUND TOWN GIVING MASKS TO HELP PEOPLE COME IN MY STORE OR BEING EXTRA EYES AN EARS FOR POLICE.

I LIKE RICHARD'S SUGGESTION OF NINETY DAYS OR GETTING US PASSED JUNE 15TH.

I'M GOOD STAYING THE COURSE FOR NOW.

STEVE, AND THEN WE'LL GO TO JOE.

>> I JUST, I WOULD QUESTION THE EDUCATION FUNCTION.

I WOULD REALLY LIKE TO KNOW HOW OUT IN THIS WORLD RIGHT NOW DOESN'T KNOW THE MASK RULES AND THAT THEY SHOULD HAVE THEM WITH THEM.

IF ANYONE IS -- FORGETS THEIR MASK, IT'S ON THEM AT THIS POINT. THAT'S FINE.

WHAT WE ALL WANT, IT'S NICE TO HAVE THEM.

IT'S GREAT TO HAVE MORE BOOTS ON THE GROUND.

ARE WE GOING TO HAVE THEM LONG TERM FOR EDUCATION?

IT REALLY GETS DOWN TO WE WANT THE RIGHT BOOTS ON GROUND TO ENFORCE THE RIGHT RULES.

WE'RE TALKING ABOUT SKATE BOARDING AND BIKES.

DOGS ON THE BEACH.

WE NEED MORE BOOTS ON THE GROUND IN THAT RESPECT.

THAT SHOULD BE OUR LONG-TERM GOAL.

MORE QUALITY-OF-LIFE COMMUNITY SERVICE OFFICERS CAN MAKE PEOPLE FEEL BETTER ABOUT DOWNTOWN AND THE MALL.

WE HAVE TO TRANSITION AT SOME POINT FROM CSC.

I'M FINE WITH IT FOR NOW BUT IT'S NOT SUSTAINABLE.

WE DON'T HAVE THE REAL AUTHORITY THAT NEEDED TO ENFORCE THE RULES THAT WE REALLY WANT TO ENFORCE AT THIS POINT.

THEY ARE ADDED SEMI UNIFORM, THEY HAVE THE DAY GLOW VESTS, GREAT. THEY ARE STILL IGNORED IF PEOPLE WANT TO.

THEY ARE A NICE TRANSITION BUT WE HAVE TO START PLANNING FOR THAT NEXT STEP FOR THE FUTURE AND DECIDE WHETHER WE WANT MORE COMMUNITY SERVICE OFFICERS AND WHERE WE'RE GOING TO STATION THEM AND WHAT THEIR DUTIES ARE.

>> THAT'S A GOOD POINT AN THE CODE ENFORCEMENT OFFICERS AS WELL. JOE, DID YOU HAVE COMMENTS.

>> LET'S HAVE MAYOR PRO TEM GO FIRST, PLEASE.

>> I DO THINK WE'RE TALKING ABOUT TWO DIFFERENT THINGS.

WHETHER WE WANT TO CONTINUE TO UTILIZE THEM FOR COVID RELATED THINGS AND IN THIS AREA THAT WE'RE CALLING EDUCATION, THEY CAN STILL BE THAT PERSON THAT HANDS SOMEBODY A MASK TO INDICATE THAT MASKS ARE STILL REQUIRE OUTSIDE AS WELL, WE'RE NOT OUT OF THIS, RIGHT? THERE'S STILL THAT OPPORTUNITY NOW TO CONTINUE THAT.

WE ARE GETTING POTENTIALLY INCREASED RESISTANCE AS PEOPLE ARE FEELING MORE COMFORTABLE BUT WE STILL HAVE TO MAINTAIN VIGILANCE AS WE SAW WITH OUR BEACH CITY HEALTH DISTRICT STAFF AS WE RECOGNIZE WE HAVE TO BE VIGILANT.

WE'RE NOT NECESSARILY OUT OF THE WOODS WITH THAT.

WE HAVE THE CSC TO HELP US WITH THAT PIECE OF IT.

WITH RESPECT TO ALL OF THOSE OTHER CONCERNS, ALL OF THOSE WAYS WE HAVE BEEN IDENTIFYING AND HEARING ABOUT LAPSES IN SOME OF OUR CODE ENFORCEMENT LIKE DOGS ON THE BEACH AND E-BIKES AND THINGS LIKE THAT. PERHAPS THAT'S SOMETHING THAT WE REALLY WANT TO COME TO ASK OUR POLICE DEPARTMENT OR CODE ENFORCEMENT TO COME BACK TO US AN GIVE US RECOMMENDATIONS ON A PLAN FOR THAT.

DO THEY NEED ASSISTANCE WITH OTHER TYPE SES OF ENFORCEMENT OF ALL THAT OTHER BUCKET OF THING THAT'S WE HEARD COMPLAINTS AND KNOW THERE'S ABSENCE WITH RESPECT TO THAT BUCKET?

I'M IN THE CAMP WITH RICHARD, WE ARE STILL IN THAT PLACE WHERE WE'RE CONCERNED ABOUT COMPLIANCE WITH COVID REQUIREMENTS THAT WE'RE STILL CONCERNED ABOUT OUR CHANGES, WE'VE GOT SUCH REDUCED PARKING THAT HAVING SOMEBODY OUT ON THE STREETS HELPING DIRECT PEOPLE TO THE PARKING THAT IS AVAILABLE, THE CROWDING THAT IS GOING TO CONTINUE TO INCREASE AS WEATHER GETS NICER AN PEOPLE ARE STILL TRY TO GO GET TO THE BEACH.

IT'S PROBABLY STILL TIME TO KEEP THEM FOR SOME PERIOD OF TIME. AGREE THAT WE SHOULD PUT SOME LIMIT ON THAT, MAYBE IT'S THE JUNE 15TH DATE THAT WE ARE TRYING TO WORK TOWARDS WHEN WE THINK EVERYTHING WILL BE OPENING UP.

IT'S THE MIDDLE OF APRIL, THAT'S IN THE TOO FAR AWAY.

>> THANK YOU.

>> ONE OF THE PARAGRAPHS SAID GENERALLY POSITIVE REVIEWS.

I THINK IT SAID SOMETHING ABOUT POSITIVE RESPONSES.

IS THAT SCIENTIFIC OR A COUPLE OF PEOPLE SAID THAT IT WAS WORKING WELL?

THIS A BIG EXPENDITURE.

THIS CAN BE AS MUCH AS 12,000 A WEEK IS 28,000 A MONTH.

THAT'S A PRETTY BIG EXPENDITURE.

WE ALREADY TALKED IN PREVIOUS COUNCIL MEETINGS ABOUT CUTTING BACK ON CITATIONS I WOULD LOVE TO HEAR HOW MANY SCUFFLES DID THEY GET INTO BY HAVING TWO OF THEM.

I SEE IT AS HIGHLY INEFFICIENT.

I'M DOWNTOWN A LOT OTHER PARTS OF THE CITY WHERE IT'S CROWDED A LOT. AS SOON AS THEY TALK TO SOMEBODY, THEY PASS BY THEM THEY TAKE THE MASK DOWN.

I DON'T BELIEVE THE 95% COMPLIANCE.

I THINK PEOPLE MORE SO ARE GOING TO BE -- WE'RE GETTING MORE AND

MORE INOCULATED AN MORE AND MORE IMMUNITY.

I SEE A HUGE EXPENSE THAT'S INEFFECTIVE.

I WOULD LIKE TO SEE IT LIMITED.

MAYBE GO AHEAD FOR ANOTHER THIRTY DAYS AND REEVALUATE IT.

>> WE'RE STILL IN COVID.

WE'RE STILL UNDER CALIFORNIA LAW THAT SAYS HAVE YOU TO WEAR A MASK.

THE LAST REPORT -- LOOK AT THE NUMBER OF ENFORCEMENT CITATIONS

WHICH WE WIRED OUT NOW VERSUS EDUCATION IT!S IN IT THE 400 BANCE

WHICH WE WIPED OUT NOW VERSUS EDUCATION IT'S IN IT THE 400 RANGE.

EITHER DENY IT OR PAY ATTENTION TO IT.

THE EDUCATION PART IS STILL PART OF IT.

CALIFORNIA LAW, WE'RE UNDER COVID.

MAKE IT SIMPLE.

NINETY DAYS GET PASSED THE JULY FOURTH WEEKEND.

WHETHER IT'S THE SPEEDERS THAT GO BY OR SKATE BORDERS.

DOWNTOWN ENFORCEMENT VISITOR ASSISTANCE, WE GET PASSED THE WEEKEND WE SHOULD BE SITTING PRETTY WE'RE IN THE YELLOW BY THEN.

MAYBE WE WON'T BE WEARING MASKS BY END OF JUNE.

FINGERS CROSSES.

UNTIL THEN THIS IS A MINOR COST THAT WE GO THROUGH THE CITY.

I CAN'T IMAGINE FEMA IS NOT GOING TO GIVE US DOLLAR FOR DOLLAR.

THIS IS COVID RELATE.

GIVE IT NINETY DAYS AND THEN STOP.

IT GIVES A TIMEFRAME AND THEY KNOW EXACTLY WHAT THEY ARE GOING TO DO.

DAVE, IS THAT A SECOND?

>> NO

POTENTIALLY THAT'S \$144,000 FOR NINETY DAYS.

EVERYONE KNOWS IT'S THE LAW TO WEAR A MASK.

WE'RE PAYING PEOPLE THAT KNOW IT'S THE LAW.

>> RICHARD HOW ABOUT A FRIENDLY AMENDMENT.

HOW ABOUT JUNE 15TH.

THAT'S AS LONG AS I'M WILLING TO DO --

>> WHAT ARE THE SPECIFIC DUTIES GOING TO BE.

>> I'VE HEARD REPORTS FROM -- WE HEARD IT IN THE BUSINESS

PROFESSIONAL ASSOCIATION KIM AND KELLY AT THE FRAME SHOP.

SHE CALLED THE POLICE BECAUSE THE KIDS WERE THERE WITH THEIR E-BIKES TAKING UP THE WHOLE SIDEWALK AND EVERYTHING LIKE THAT.

THE KIDS DON'T EVEN LISTEN TO THE POLICE.

THEY'RE NOT GOING TO LISTEN TO CSC.

I DON'T THINK THEY WEIGH INTO THAT.

>> THAT'S WHY I ASKED WHAT ARE THEY GOING TO DO?

>> TO JUST HAVE THEM GO AROUND AND TELL PEOPLE TO PUT ON A MASK IT'S NONSENSICAL.

IT'S THE LAW.

THEY SHOULD KNOW IT.

EVERY TIME YOU WATCH TELEVISION THERE'S 14 ADS STILL.

>> I THINK RICHARD IS SAYING BECAUSE WE'RE GOING TO BE REIMBURSED WHAT'S THE HARM.

I'M SAYING I'M OKAY WITH THAT.

I THINK DOWNTOWN LIKE THE EXTRA PRESENCE RADIOING INTO PLACE.

- I'M OKAY UNTIL JUNE 15TH.
- >> ARE ALL THOSE REIMBURSABLE BY FEMA.
- >> WE HAVEN'T SEEN A DIME FROM FEMA.
- >> DIRECTOR, ARE WE BILLING FEMA BY THE HOUR OR SUBMITTING THE 100% OF THE CSC FUNCTION AS AN EDUCATIONAL FUNCTION, HOW DOES THAT WORK?
- >> THE EDUCATION PART IS A LITTLE BIT CHALLENGING IN THE SENSE THAT COMMUNICATION IS MORE WHAT FEMA IS LOOKING FOR.

MAYBE IT'S THE WAY THAT YOU'RE DOCUMENTING IT AS REIMBURSEMENT. WE CREATED A CODE THAT ALL EXPENDITURES THAT ARE COVID RELATED THAT IT GOES TO SUBCOMMITTEE THAT REVIEWS THOSE EXPENDITURES AND FORMALIZE THEM AND MAKE SURE THEY FALL UNDER THE GUIDANCE THAT WE UNDERSTAND. THERE'S SOME TECHNICALITIES THAT WE SEE EDUCATION IS NOT SOMETHING THAT'S REIMBURSABLE BUT COMMUNICATION WOULD BE REIMBURSABLE.

IT'S THE TINY HAIR THINGS HAVE YOU TO SEPARATE IN ORDER TO GET A REIMBURSEMENT.

- >> TRAFFIC CONTROL REIMBURSEMENT.
- >> I DON'T THINK SO.
- >> FOR AN HOUR OF A CSC BOOTS ON GROUND OR A PAIR OF OURS, ARE THEY SELF REPORTING WHAT THEY DO AND FINANCE IS SAYING OKAY IN ONE HOUR THEY DID TEN MINUTES OF EDUCATION.

FIFTY MINUTES OF TRAFFIC TALKING TO KIDS ABOUT E-BIKES AND WANDERING AROUND HELPING PEOPLE FIGURE OUT WHERE TO PARK.

>> I DON'T THINK THE DETAIL IS THAT GRANULAR.

WE GET A REPORT ABOUT A MONTH AFTER THE WORK WAS DONE.

IT'S JUST THE BILLS LAG AND THE DOCUMENTATION ON THE INVOICING IS NOT THAT GRANULAR.

IT WILL TALK ABOUT COVID ENFORCEMENT OR COVID, WHATEVER IT MIGHT BE.

>> MY OUESTION IS A FINANCE OUESTION NOT A CSC OUESTION.

YOU'RE TAKING 100% OF THAT INVOICE AND SAYING BECAUSE IT'S CSC WE'RE SUBMITTING IT FOR REIMBURSEMENT OR A PERCENTAGE OF THAT INVOICE.

>> IT WOULD BE A COMBINATION.

SOMETIMES IT'S THE ENTIRE INVOICE AND SOMETIMES IT'S A PORTION OF THE INVOICE.

>> I WONDER IF WE CAN GET AN ANSWER ABOUT THIS RANGE OF COST F. IT'S \$2,000 A WEEK, A LOT DIFFERENT THAN \$12,000 A WEEK.

CAN WE BE CONTROLLING THAT PIECE?

>> IT LARGELY DEPENDS ON HOLIDAYS, TRAFFIC PATTERNS AND WEATHER THAT THE POLICE DEPARTMENT IS OBSERVING OR CAN PREPARE FOR AN EVENT. LIEUTENANT AARON TRIES TO BE AS EXPEDITIOUS AS POSSIBLE AND MINDFUL OF CITY EXPENDITURES.

HE DOESN'T JUST AUTOMATICALLY PLACE CSC OFFICERS IF HE SEES NOT A LOT OF FOOT TRAFFIC DOWNTOWN.

I APOLOGIZE FOR THE RANGE I KNOW TWO TO 12 IS A LARGE RANGE BUT IT DOES MATTER.

IF IT'S A WEEKEND WHERE IT RAINS THERE MAY NOT BE A CSC OFFICER DOWN THERE

BUT IF IT'S A SUNNY DAY THERE MAY BE CROWDING OPPORTUNITIES THERE. >> THANK YOU FOR THAT, GEORGE.

LOOKING FORWARD TO THE NEXT SIXTY DAYS.

THAT MIGHT BE A REASONABLE PERIOD OF TIME.

WE HAVE NICE WEATHER AND OUT OF THE RAIN POTENTIALLY.

WE DON'T KNOW IF THERE'S GOING TO BE ANOTHER ENVIRONMENTAL IMPACT THAT BRINGS PEOPLE IN.

IN GENERAL NICE WEATHER, THERE'S ONLY ONE HOLIDAY, MEMORIAL WEEKEND BETWEEN NOW AND THEN.

DO YOU THINK WE'RE LOOKING AT THE \$2,000 OR THE \$12,000?

I DON'T KNOW WHAT REALLY CAUSE THE 12 IS THAT REALLY NICE WEATHER AND THE HOLIDAY OR IS THAT REALLY NICE WEATHER AND BIO ILLUMINATE LENSES AND ALL OF THAT.

- >> I WOULD SAY IN ALL LIKELIHOOD, GOOD WEATHER AND A HOLIDAY IS GOING TO INCREASE THOSE COULD HAVES TOWARDS THE 12-DOLLAR A RANGE.
- >> LET ME RESPOND A MOMENT TO THAT.

I JUST WANTED TO SAY THANK YOU FOR EVERYONE THAT PROVIDED INPUT AND ASSISTED WITH THIS OVER THE LAST 18 MONTHS.

OUR PENSION OBLIGATION TIMELINE.

WE STARTED WITH CITY COUNCIL APPROVAL OF THE RESOLUTION IN THE INDENTURE AND BOND PURCHASE AGREEMENT BACK ON DECEMBER 15th. PRIOR TO THAT WE HAD ABOUT SEVEN PUBLIC MEETINGS.

APRIL 13th, STAFF ALONGSIDE WITH OUR MUNICIPAL ADVISOR AND THE BOND COUNSEL HAD AN SNP RATING CALL.

OVER 60 SLIDES, ABOUT AN HOUR AND A HALF.

WE FOUND OUT TODAY THAT WE HAVE, THEY HAVE REAFFIRMED OUR A.A.A. RATING.

SO WE OBTAINED THAT CREDIT RATING THIS MORNING.

HAPPY TO REPORT THAT.

TONIGHT, WITH YOUR CONSIDERATION TO APPROVE THE P.O.S., BOND PRICING WILL TAKE PLACE ON THE 27th AND 28th.

IT'S A TWO-DAY PROCESS, BECAUSE THEY ARE TAXABLE BONDS.

AND CLOSING ON MAY 12th.

A JUNE DATE, NOT KNOWING IF THERE WOULD BE ANY DEALS FROM THE JUDICIAL ACTIVITY.

AND THE T.I.C. IS OUR TRUE INTEREST RATE AT 3.05.

CHIEF WAS ALSO A SURFBOARD SCHAPER AND KNOWN FOR HIS PLASTIC FANTASTIC BOARDS.

CHIEF HACKAMACK IS HONORED WITH A PLAQUE IN OCEANSIDE.
