City Council Adjourned Regular Meeting – Closed Session

Mayor Hadley: Good evening everyone and welcome to our Special Closed Session meeting on Monday, June 14th at 6:30 PM on Zoom. So welcome to those of you who've joined us. I'm going to call this meeting to order and we will begin with the pledge to the flag. I'm going to mute my camera, rise, place my hand over my heart and please recite the Pledge with me. Thank you. I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all. Thank you everyone.
