**City Council Adjourned Regular Meeting**  
**Monday, September 13, 2021 3:00 PM**

Mayor Stern: Welcome everyone to our Monday, September 13 Regular Meeting. I will call the meeting to order and ask everyone to rise to your highest level as we say the Pledge of Allegiance to the flag.
