Mayor Stern: Thank you and welcome everyone to the City Council Adjourned Regular Meeting of Tuesday, November 9, 2021 at 4:30 PM. I will call this meeting to order and first on our line of business is a Pledge to the flag. So if everyone could rise to your highest level, we will stop our video and all rise to recite the Pledge together.
