Mayor Stern: Thank you. Well welcome everyone to our City Council Adjourned Regular Meeting of Tuesday, March 22, 2022. We will begin tonight with our Closed Session at 4:30 PM. So I will call this meeting to order and our first line of business is to join together in saying the Pledge of Allegiance.
