CITY MANAGER, ONE-ON-ONE MEETINGS, WHAT HAPPENED AND HOW DO WE

MAKE IT BETTER GOING FORWARD.

WE GET TO LOOK AT OTHER DEPARTMENTS, BEVERLY HILLS, HOW THEY HANDLE THE REPORTINGS, THROUGH THE CITY MANAGER AND OUR RESIDENTS.

WHEN THE CHIEF SAYS SHE'S ALSO EMBARRASSED ABOUT IT AND IT WON'T HAPPEN AGAIN, I TAKE HER WORD FOR IT.

WITH THAT THE CITY MANAGER HAS COMMENTS.

AND I UNDERSTAND THAT PART OF THAT FEELING OF SAFETY IS FEELING INFORMED AND FEELING YOU'RE AN EQUAL PARTNER IN THE INFORMATION THAT WE HAVE REGARDING THE CRIMES THAT OCCUR IN OUR COMMUNITY.

IT'S NOT ENOUGH FOR ME TO TELL YOU THAT CRIME IS DOWN.

YOU NEED TO FEEL THAT.

AND IT CAN FEEL THAT THERE'S NOT TRANSPARENCY WHEN YOU DON'T KNOW EVERYTHING YOU SHOULD KNOW AND THAT IS ULTIMATELY MAY RESPONSIBILITY.

THROUGH MAY CRIME IS DOWN ABOUT 15% IN MANHATTAN BEACH.

SO WHILE WE HAVE HAD A MISSTEP IN OUR COMMUNICATION, THE THINGS
WE'RE DOING INTERNALLY AND EXTERNALLY WORKING WITH THE COMMUNITY

HAVE RESULTED IN A DROP IN CRIME YEAR OVER YEAR TO 22 TO 2023.

I'LL WORK WITH THE CITY MANAGER TO SEE HOW WE CAN BE MORE UP

FRONT IN THE INFORMATION WE'RE PUTTING OUT AND BETTER WAY TO

COMMUNICATE WITH THE COMMUNITY IN A QUICKER MANNER.

ANYBODY ELSE IN OUR RESIDENTS DOWNTOWN ESPECIALLY DON'T WANT TO

SEE IT.

THEY'RE OVERWHELMED AS IT IS.

WE OPT FOR FIREWORKS IN DECEMBER.

OUR TRADITION HERE.

SALUTE TO THE TROOPS.

WE'RE GOING TO CONTINUE WITH THAT.

WE TALKED ABOUT THE FACT THAT WE HAD THE SALUTE TO THE TROOPS

AND THANK YOU TO MAYOR PRO TEM FRANKLIN FOR STEPPING UP HERE.

HE'S THE ONLY ONE OF US WITH AN ACTIVE SON IN THE MILITARY.

BUT THAT'S BEEN 46 YEARS, DIRECTOR LEYMAN, A CONCERT IN THE PARK

WE DO IT JULY $4^{\rm th}$ TO RECOGNIZE ALL OF OUR VETERANS, ACTING MILITARY PERSONNEL, ANYBODY THAT HELP US, THAT'S WHY WE DO IT RIGHT BEFORE JULY $4^{\rm th}$.

AND THE FACT THAT WE HAD THE SATIN DOLLS, THIS IS OUR WAY OF SHOWING APPRECIATION FOR OUR VETERANS.

NO, I DID NOT TAKE ONE BUT I SAW THEM BEING HANDED OUT.

WE PROGRAM THINGS LIKE A COFFEE MAKER TO START ON TIME.

>> GOOD EVENING, HONORABLE MAYOR MONTGOMERY, MAYOR PRO TEM FRANKLIN AND HONORABLE COUNCILMEMBERS.

MY NAME IS ENZO AMES AND I'M HERE TO EXPRESS MY HEARTFELT THANKS
TO THE CITY AND MARK LEYMAN, THE HEAD OF PARKS AND REC AND
MR. SEAN ROBERTS FOR PUBLIC WORKS MANAGER FOR THEIR SUPPORT AND
ENCOURAGEMENT IN THE COMPLETION OF MY EAGLE SCOUT PROJECTS, THE
REVITALIZATION OF SAND DUNE PARK BACK TO ITS NATURAL FORM
WITHOUT ALL OF THE INVASIVE SPECIES.

WHEN I EMBARKED ON THIS VISION I HAD A VISION OF CREATING A SPACE TO BRING JOY TO OUR COMMUNITY.

MY PROJECT INCLUDES REMOVAL OF OVER 1500 INVASIVE NONNATIVE

SHRUBS WHICH WERE DESTROYING THE NATURAL HABITAT WHICH WU

REPLACED WITH 600 DROUGHT-TOLERANT CALIFORNIA PLANTS INCLUDING

BUT NOT LIMITED TO MEXICAN SAGE, CALIFORNIA POPPY AND

HUMMINGBIRD SAGE.

THESE PLANTS PROVIDED A TRUE, NATURAL SUSTAINABLE HABITAT FOR THE BEES AND BIRDS.

THIS WORK TOOK SIX MONTHS TO PLAN AND AFTER ANOTHER THREE MONTHS

TO EXECUTE, IT TOTALED 219 VOLUNTEERS.

LUCKILY THE CITY AND THE COMMUNITY WAS ABLE TO DONATE A TOTAL OF \$5,000 FOR THIS PROJECT AND AT THE CONCLUSION OF THIS PROJECT WE ARE ROUGHLY SLIGHTLY OVER \$600 EXTRA SO I WOULD LIKE TO DONATE THIS MONEY TO THE CITY TO THE CONTINUED MAINTENANCE OF THIS PROJECT.

WHAT A GREAT START TO THE SEASON WHEN YOU GET A REFUND.

NEXT SPEAKER.

>> HI, COUNCIL.

MIKE McCALSKI, 32-YEAR RESIDENT.

I WANTED TO TALK TO YOU ABOUT THE PUBLIC SAFETY IN LIGHT OF THE RECENT ARMED ROBBERIES IN TOWN.

A COUPLE OF OTHER THINGS I WANT TO WEIGH IN ON.

I'M NOT A FAN OF THE POLICE CRUISER LOGO.

I BELIEVE IT'S ITEM 16 ON THE AGENDA.

IT'S HARD TO SEE IN BAD WEATHER OR BAD LIGHTING.

THE OLDER LOGO WAS LARGER AND MORE VISIBLE.

I'M NOT SURE THE NEW MUTED LOGO HAS THE SAME EFFECT.

THE REVISED NEIGHBORHOOD WATCH REPORT.

IT USED TO BE WE GET SPECIFIC LOCATION FOR THE SPECIFIC CRIMES EACH WEEK BUT NOW IT ARRIVES ONCE A MONTH.

SO I DON'T KNOW THAT THAT'S NECESSARILY AN IMPROVEMENT.

I USED TO LIKE THE DASHBOARD FOR THE CRIME STATS.

THAT'S BEEN ELIMINATED AS WELL.

CERTAINLY THE OLD REPORT WAS IN NEED OF AN OVERHAUL AND THE NEW REPORT IS A STEP IN THE RIGHT DIRECTION BUT THE THEME SHOULD BE MORE TIMELY INFORMATION BETTER THAN LESS.

WHICH BRINGS US TO THE CRIMES ITSELF, LIKE THE ARMED STRAND ROBBERIES.

WE'VE HAD CRIMES IN THE PAST.

SOMEWHERE ALONG THE WAY WE STOPPED GETTING ALERTS EXCEPT WHEN THE POLICE WERE SEARCHING FOR A SUSPECT.

CHIEF JOHNSON INFORMED ME THEY STARTED LOOKING FOR THE SUSPECTS

AND THEY HAD A CLEAR IDENTIFICATION, YET HE INFORMED ME THAT

THERE WAS NOT ENOUGH ACTUAL INFORMATION FOR THE GENERAL PUBLIC.

I DON'T UNDERSTAND THAT.

HER OFFICERS HAD INFORMATION WHAT TO LOOK FOR FEW THE DECISION WAS MADE NOT TO GIVE THAT INFORMATION TO THE PUBLIC.

HOW CAN WE HAVE MORE EYEBALLS ON LOOKOUT FOR THESE THUGS A BAD THING.

I BELIEVE ACCURATE INFORMATION ABOUT SERE EYES CRIMES SHOULD BE SHARED EFFECTIVELY WITH THE ENTIRE COMMUNITY AND BY NOT DOING SO IN A TIMELY AND PROACTIVE MANNER THAT DOES A DISSERVICE TO THE RESIDENTS.

IN MY VIEW, FOR A SITUATION LIKE THE STANDS ROBBERIES, THERE
SHOULD HAVE BEEN AN ALERT AFTER THE FIRST ROBBERY SO THERE WOULD
BE MORE EYES ON SO THE SECOND COUPLE WOULD HAVE BEEN MORE
FORWARNED.

HI, MY NAME IS HEATHER KIM AND I GUESS I'LL JUST START WITH I'M

WHAT HAPPENED WITH THOSE TWO ARMED ROBBERIES AT THE STRAND.

OF COURSE PROPERTY CAN BE REPLACED BUT THESE PEOPLE'S SENSE OF
SECURITY AND SAFETY, THAT WILL NEVER BE REPLACED.

IT DOESN'T HAPPEN TO ME PERSONALLY OR MY CHILDREN BUT I FEEL FOR

THEM AND I DON'T FEEL SAFE ANYMORE EITHER.

HOW ARE YOU GUYS -- YOU KNOW WHAT, THE CHIEF MADE HER APOLOGIES AND STUFF BUT THE BUCK STOPS WITH YOU GUYS ULTIMATELY.

THE COMMUNICATION LOST.

THERE HAVE BEEN OTHER INCIDENTS AND I DON'T CARE IF SHE SAYS CRIME IS DOWN.

CRIME IS DOWN BECAUSE PEOPLE LIKE ME DIDN'T REPORT CRIME FOR A WHILE TOO.

I'M CHANGING MY HABITS NOW.

I'M REPORTING EVERYTHING.

BUT I'M GOING TO TELL YOU THOSE STATISTICS ARE NOT SOMETHING TO
BE PROUD OF JUST BECAUSE SOMETHING IS DOWN THIS MONTH COMPARED
TO LAST YEAR.

ITEM 4 IS A REQUEST FOR COUNCIL TO ADOPT A RESOLUTION APPROVING A PILOT AGREEMENT WITH THE CHAMBER OF COMMERCE IN THE AMOUNT OF \$67,000 FOR NORTH MANHATTAN BEACH BUSINESS IMPROVEMENT DISTRICT MANAGEMENT EXECUTIVE CORONATION SERVICES AND ADJUST

CORRESPONDING REVENUES.

THE QUESTION GOES TO THE LAST PART, ADJUST CORRESPONDING

REVENUES.

WHAT DOES THAT MEAN IF THEY COLLECT 25,000 A YEAR.

THIS GOES BEYOND THE PILOT PROJECT OF 67,000 A YEAR, THEY'VE GOT BALANCE IN THE PARKING FUND IT'S NOT GOING TO BE SUSTAINABLE IF IT CONTINUES ON AT THAT COST WHICH I ASSUME WILL INCREASE WITH THE COST OF LIVING IN THE FUTURE.

HOW IS THAT GOING TO BE ADDRESSED BEYOND THIS?

I KNOW IT'S A PILOT PROJECT BUT I ALSO KNOW HOW PILOT PROJECTS

>> HONORABLE COUNCILMEMBER NAPOLITANO, GEORGE GABRIEL, ASSISTANT TO THE CITY MANAGER.

SO THIS RESOLUTION, THIS AGREEMENT COMES BEFORE YOU TONIGHT BY
WAY OF DIRECTION FROM THE NORTH MANHATTAN BEACH ADVISORY BID.
YOU ARE CERTAINLY CORRECT THAT THERE IS A STRUCTURAL DEFICIT
TERMS OF A FISCAL DEFICIT.

THERE IS A BALANCE OF \$423,000 OR SO IN THE NORTH MANHATTAN BEACH RESERVE BALANCE.

THAT BEING SAID, THE NORTH MANHATTAN BEACH ADVISORY BOARD IS AWARE THAT THIS IS NOT SUSTAINABLE.

WE ACTUALLY DID A PRELIMINARY FIVE-YEAR FORECAST OF EXPENDITURE WITH COST-OF-LIVING INCREASES.

WITHIN THE FIRST FIVE YEARS OF SO IF COSTS REMAIN THE SAME WITH C.O.L.A. ADJUSTMENTS AS WELL, THEY WILL PROBABLY EAT ABOUT HALF OF THEIR RESERVE BALANCE WITH THE REVENUES THAT ARE COMING IN AS

IT IS RIGHT NOW.

THEY'RE CERTAINLY AWARE THAT IT IS NOT SOMETHING THAT CAN BE MAINTAINED.

- >> THAT'S PART OF THE CONTRACT IN ORDER TO EXPLORE OTHER REVENUE OPPORTUNITIES.
- >> AND THEY HAVE THE ABILITY TO CHANGE THE ASSESSMENTS IF
 EVERYBODY VOTES TO INCREASE THOSE AND PERHAPS THEY WOULD IF THEY
 GET RESULTS IN THE CONTRACTUAL AGREEMENT.

- >> Mayor Pro Tem Franklin: IF NO ONE IS INTERESTED OR ONE PERSON
 IS INTERESTED, DO WE HAVE A CHANCE TO COME BACK AND REVISIT?
 >> WE CAN PUT THAT IN THE STAFF REPORT AND GIVE COUNCIL THE
 OPTION TO DO OUTREACH, ADVERTISE AND COME BACK.
- >> Mayor Pro Tem Franklin: OKAY.

THANK YOU.

>> Mayor Montgomery: ANYTHING ELSE?

A MOTION BY COUNCILMEMBER HOWORTH, A SECOND BY MAYOR PRO TEM FRANKLIN.

VOTING SCREEN, PLEASE.

- >> Councilmember Howorth: DO YOU NEED KNOW STATE ANYTHING?

 I MOVE TO ACCEPT THE RESIGNATION AND DIRECT THE CITY CLERK TO

 RETURN WITH A LIST OF APPLICANTS.
- >> Mayor Montgomery: TERRIFIC.

DONE THIS BEFORE.

- >> Mayor Montgomery: MOTION PASSES 5-0.
- >> Mayor Montgomery: NEXT IS ITEM 9.
- >> Councilmember Napolitano: THESE ARE FOR SOME TRAFFIC

 IMPROVEMENTS AT MANHATTAN BEACH BOULEVARD AND PACIFIC AVENUE.
- I WILL NEVER UNDERSTAND WHY WE DID A RIGHT-TURN ONLY AND A THROUGH AND LEFT THERE SINCE EVERYONE WANTS TO TAKE A LEFT AND IT HOLDS EVERYONE UP WHO WANTS TO GO ACROSS.

THIS WILL FIX THAT WITH A NUMBER OF OTHER FIXES BUT IT RAISES
QUESTIONS TO ME REGARDING A COUPLE OF THE ITEMS.

ONE IS TO ADD A BIKE LANE WHILE MAINTAINING STREET PARKING FOR MOST LOCATIONS.

YOU KNOW, IT'S HARD TO TELL FROM THE DIAGRAM EXACTLY WHAT WE'RE TALKING ABOUT BEING A COUNCIL THAT IS NOT IN FAVOR OF ROAD DIETS.

I'M CONCERNED WITH WHAT'S HAPPENED ON 15th STREET AND WHAT HAPPENED ON MORNINGSIDE WHEN WE MADE TRAFFIC IMPROVEMENTS.

AND I'M NOT IN FAVOR OF ISOLATED BIKE LANES WHERE THERE'S NOTHING FOR MILES AND THERE'S A HALF BLOCK OF A BIKE LANE AND THEN THERE'S NOTHING AGAIN BECAUSE OF PARKING.

I DON'T THINK THAT'S WELL THOUGHT OUT.

IF WE'RE GOING TO ENCOURAGE PEOPLE TO USE A BIKE LANE, WE NEED TO HAVE AN EXTENDED LENGTH OF BIKE LANE TO MAKE THAT WORK.

THE ADDITION OF PEDESTRIAN CROSSWALK AND PEDESTRIAN CONVENIENCE,

I KIND OF TAG ALONG WITH OUR OTHER ITEM FURTHER IN THE AGENDA

HERE REGARDING VALLEY DRIVE AND THE IDEA THAT WHAT IS BEING

ASKED FOR IS NOT JUST CROSSWALKS THERE BUT AT SOME POINT MAKING

THOSE RAISED CROSSWALKS WHICH IS BASICALLY A SPEED HUMP AND YOU

KNOW, WHY IS THAT BEING PROPOSED THERE AND NOT HERE GIVEN THE

DESIGNATION THE STREETS ARE STILL LOCAL COLLECTORS.

WE'RE DOING SOME THINGS IN SOME PLACES AND OTHERS IN OTHERS.

I'M LOOKING FOR SOME CONSISTENCY IN OUR TRAFFIC APPROACH IN

THESE CHANGES THAT WE HAVE HERE.

EITHER WE'RE GOING TO DO -- THE SECOND WE GET A REQUEST FOR

RAISED CROSSWALKS IN ONE PLACE, WE'RE GOING TO HAVE THEM EVERYWHERE.

ARE WE READY FOR THAT?

DO WE WANT THAT?

WHY IS IT THAT WE DON'T HAVE THOSE HERE THOUGH.

AND AGAIN I WANT TO SEE BEFORE APPROVING THIS WHAT THAT CLASS 2 BIKE LANE MEANS, WHERE IT'S GOING TO GO AND WHY -- BECAUSE I'VE ASKED BEFORE.

LET'S EXPLAIN A BIKE LANE FROM AVIATION DOWN TO PIER.

AND I KNOW THAT'S GOING TO RAISE HACKLES BECAUSE IT'S GOING TO IMPACT PEOPLE'S PARKING.

- >> HELEN SHI HAS BEEN WORKING EXTENSIVELY ON THIS PROJECT AND WILL ANSWER YOUR QUESTIONS.
- >> Mayor Montgomery: DO YOU HAVE THE SCREEN SHOT OF THE IMPROVED ROADWAY PROJECTS SO WE CAN ALL SEE WHAT WE'RE TALKING ABOUT.
- I ALSO APPRECIATE NOT SHRINKING DOWN TO NUMBER 2 FONT.

THANK YOU FOR MAKING IT LARGER.

>> GOOD EVENING, MAYOR MONTGOMERY AND THE CITY COUNCIL MEMBERS.

MY NAME IS HELEN SHI, SENIOR CIVIL ENGINEER FROM PUBLIC WORKS.

SO I'M TRYING TO GET ALL OF THE QUESTIONS.

IF I MISS ANYTHING, PLEASE LET ME KNOW.

SO THE FIRST YOU ASKED IS FOR THE BIKE LANE CLASS 2 BIKE LANE.

THAT IS IN OUR MOBILITY PLAN.

WE'RE TRYING TO HAVE BIKE LANES ON BOTH SIDES OF MANHATTAN BEACH BOULEVARD ALL ALONG FROM PIER TO AVIATION BOULEVARD, THE CITY BORDER.

SEW NOW I BELIEVE WE DON'T HAVE THE WHOLE STRETCH BUT WE'RE

TRYING TO -- THAT'S WHY THIS CONCEPTUAL PLAN HAS THE RANGE FROM

ARDMORE UP TO EAST AVENUE.

THIS IS FOR THE PURPOSE OF THE WHOLE SYSTEMIC BIKE.

>> Councilmember Napolitano: IS THAT GOING TO CHANGE WESTBOUND MANHATTAN BEACH BOULEVARD FROM, YOU SAID, PINE DOWN TO ARDMORE INTO A SINGLE LANE?

>> YES.

THAT'S THE PURPOSE.

THE REASON WHY IS --

>> Councilmember Napolitano: I WANT TO BE CLEAR.

YOU'RE TAKING TWO LANES OF TRAFFIC PUTTING THEM DOWN TO ONE LANE.

- >> FOR EASTBOUND DIRECTION.
- >> Councilmember Napolitano: NO.
- I WAS TALKING WESTBOUND.
- >> WESTBOUND DIRECTION ORIGINALLY IS TWO LANES.

WE'RE CHANGING IT TO ONE LANE BECAUSE OF MERGING.

>> Councilmember Napolitano: THANK YOU, YOUR HONOR.

THE PROSECUTION RESTS.

[LAUGHTER]

>> Mayor Montgomery: HELEN, IF YOU WANT TO ADDRESS THE REST OF THE QUESTIONS AND WE'LL COME BACK TO YOU.

>> OKAY.

AND THEN THE QUESTION YOU HAVE IS FOR THE CROSSWALK.

THE ADDED NEW CROSSWALK ON THE WEST LEG IS JUST A REGULAR CROSSWALK AS WE DO CONTINENTAL CROSSWALK FOR ALL OF THE SIGNALIZED --

>> Councilmember Napolitano: I READ THAT.

BUT MY QUESTION WAS WHY IF WE'RE PROPOSING A RAISED CROSSWALK AT VALLEY DRIVE WE'RE NOT PROPOSING A RAISED ONE AT PACIFIC.

- >> ON PACIFIC AVENUE --
- >> Councilmember Napolitano: EITHER OR BOTH.
- >> WE USUALLY DON'T DO A RAISE CROSSWALK.

THAT'S NOT A STANDARD OR A STATE REGULATION.

THE STATE DOESN'T ALLOW IT.

UNLESS IT'S LOCAL OR LOW-VOLUME STREETS, THEN THAT COULD BE CONSIDERED.

BUT THE CURRENT STANDARD IS BICYCLISTS OR SCOOTERS, THEY DON'T PREFER ANYTHING RAISED CROSSWALK UNLESS THAT VOLUME IS REALLY LOW AND THE NEIGHBORHOOD DOESN'T HAVE ANY OPPONENT TO IT,

OTHERWISE WE DON'T PURPOSELY PROPOSE RAISED CROSSWALK.

>> Mayor Montgomery: AND YOUR NEXT -- ANY OTHER QUESTIONS YOU HAD PAST THAT ONE?

HOLD ON, JOE.

>> Councilmember Napolitano: THIS IS -- I'LL DEFER IN A SECOND.

THIS IS A MAJOR THING THAT IS ON CONSENT CALENDAR BEFORE WE JUST

ASKED ABOUT BRING BACK ANY ROAD DIETS OR BIKE LANES THAT ARE

GOING TO IMPACT TRAFFIC IN MANHATTAN BEACH.

I KNOW WE WANT TOO ENCOURAGE, IT'S A PIECE OF THE MASTER PLAN BUT ON A CASE-BY-CASE BASIS WE NEED TO REVIEW THIS.

THIS IS GOING TO TAKE AWAY PARKING EAST OR WESTBOUND.

IT'S GOING NARROW FROM TWO LANES TO ONE LANE OF TRAFFIC GOING WESTBOUND.

THAT'S A BIG DEAL AND I THINK WE NEED TO HAVE A REAL HEARING ON THAT AND NOT BURY IT ON THE CONSENT CALENDAR.

- >> Mayor Montgomery: COUNCILMEMBER LESSER FIRST.
- >> Councilmember Napolitano: IT WASN'T A QUESTION.
- >> ON THE STREET PARKING, WE'RE TAKING OUT SEVEN SPACES AND ADDING FOUR.
- SO TOTAL LOSS IS THREE PARKING FOR THE WHOLE STRETCH.
- >> Councilmember Napolitano: PARK ALL UP AND DOWN -- SO YOU'RE GOING TO HAVE THE BIKE LANE GO AROUND THE PARKING SPACES FROM ARDMORE --
- >> THE PARKING ON THE SIDE AND THE BIKE LANE AND THE TRAVEL

LANE.

ON THE CURB IS PARKING AND OUTSIDE THE PARKING IS BIKE LANE AND THEN THE TRAVEL FOR --

>> Councilmember Napolitano: MOST CITIES ARE GOING THE OPPOSITE
OF THAT AND PUTTING THE CARS FARTHER INTO THE TRAFFIC AND
PROTECTING THE BIKES.

>> THIS IS ACTUALLY MORE OF THE -- JUST TO BE, YOU KNOW, BECAUSE
WE DON'T HAVE ENOUGH -- THIS IS A MORE COMPATIBLE TO OUR
RIGHT-OF-WAY.

IF YOU WANT TO HAVE THE BIKE LANE AND THEN THE PARKING IT WILL CAUSE POTENTIAL SAFETY HAZARD FOR THE PEOPLE PARKING THE CAR,

>> Councilmember Napolitano: I'M JUST SAYING THAT'S WHAT OTHER COMMUNITIES ARE DOING.

I'M SURE THERE'S SOME STUDY THAT SHOWS ONE IS BETTER THAN OTHER.

BUT THE BOTTOM LINE IS I'M REALLY ADDRESSING THE LOSS OF A LANE

OF DRIVING FROM PINE TO ARDMORE AGAIN BURIED IN A CONSENT

CALENDAR ITEM.

>> SORRY TO INTERRUPT.

WE DID AN ANALYSIS.

THE REASON WHY WE WANT TO REDUCE THE LANE IS BECAUSE THE PEAK
HOUR OF TRAFFIC ACCOUNTS FOR WESTBOUND DIRECTION OR EASTBOUND
DIRECTION, DEMAND IS 500 CARS, WHICH PER THE INDUSTRIAL STANDARD
THE STATE STANDARDS, THE CAPACITY OF PER LANE PER HOUR IS 1500.

SO WE'RE ONLY 500, WAY BELOW THE THRESHOLD TO BE CAUSING ANY ALARM.

>> Councilmember Napolitano: I DON'T KNOW HOW OFTEN YOU'VE DRIVEN THAT.

>> Councilmember Howorth: THAT'S ON A SATURDAY.

>> Councilmember Napolitano: I WASN'T ASKING FOR THAT INFORMATION.

I APPRECIATE IT.

BUT I DON'T NEED THAT INFORMATION.

>> Mayor Montgomery: COUNCILMEMBER LESSER AND THEN COUNCILMEMBER FRANKLIN AND THEN COUNCILMEMBER HOWORTH.

DON'T GO ANYWHERE.

>> Councilmember Lesser: I MISSED THAT WE WERE GOING TO TAKE OUT
A WHOLE LANE OF TRAFFIC AS PART OF THE MOBILITY LANE COMPLIANCE.
CAN YOU REPEAT ONE MORE TIME WHAT YOU RESPONDED TO COUNCILMEMBER
NAPOLITANO.

THIS CONFIGURATION WOULD GO HOW FAR EAST IN ALL THE WAY TO SEPULVEDA BOULEVARD?

- >> WESTBOUND DIRECTION?
- >> Councilmember Lesser: FOR NOW I AM.
- >> WESTBOUND DIRECTION WE'RE GOING FROM THE -- A LITTLE BIT EAST OF JOHN STREET TO WEST PACIFIC AVENUE.

IT'S BASICALLY ONE BLOCK.

CURRENTLY BECAUSE THERE'S ONLY ONE LANE WEST OF PACIFIC AVENUE.

- >> Councilmember Lesser: COULD THAT NOT MEAN THAT TRAFFIC HEADED WESTBOUND WILL BEGIN TO FUNNEL AND BACK UP HEADING EASTBOUND IN RUSH HOUR TRAFFIC.
- >> CURRENTLY YOU HAVE TO MERGE TO ONE LANE.
- >> Councilmember Lesser: FURTHER TO THE WEST.
- >> AND THE REASON WE WANT TO MAKE IT TO THE EAST IS CURRENT MERGING AREA IS ONLY 60 FEET.
- IT CAUSES UNSAFE BEHAVIOR FOR THE DRIVERS WHO'S TRYING TO SPEED, GET AHEAD OF EACH OTHER.
- THAT'S WHY NEIGHBORS HEAR THE NOISE OF SPEEDING AND THE VERY LOUD NOISE OF BREAKING.
- I MEAN THERE'S NEAR MISSES OR RECORDED ACCIDENTS DUE TO THE REALLY SHORT MERGING AREA.
- IT'S ACTUALLY, ACCORDING TO THE STANDARDS, CITY STATE STANDARDS,

 A MERGING LANE -- MERGING LANES OF 60 FEET IS REALLY NOT UP TO

 THE STANDARDS.
- SO WE NEED TO MAKE IT LONGER.
- SO TO MAKE IT LONGER, BECAUSE WEST OF PACIFIC AVENUE WE REALLY DON'T HAVE ANY ROOM.
- SO WE HAVE TO DRAG IT TO EAST.
- >> Councilmember Lesser: I THINK FOR MY PART IT MIGHT BE HELPFUL
 TO BRING THIS BACK ALONG WITH THE MOBILITY PLAN AS AN ATTACHMENT
 TO BETTER UNDERSTAND WHAT THE OVERALL VISION IS, JUST AS
 COUNCILMEMBER NAPOLITANO IS SUGGESTING.

THANK YOU, MR. MAYOR.

>> Mayor Montgomery: YOU'RE WELCOME.

MAYOR PRO TEM FRANKLIN.

>> Mayor Pro Tem Franklin: THANK YOU.

SO COUNCILMEMBER NAPOLITANO ADDRESSED WESTBOUND -- I JUST WANT
TO TALK A LITTLE BIT ABOUT EASTBOUND ON THIS BECAUSE I TRAVEL
THAT A LOT.

I'VE BEEN TRYING TO IMAGINE THIS FOR THE LAST WEEK OR SO WHAT IT WOULD LOOK LIKE AND HOW THE TRAFFIC WOULD GO.

SO I BELIEVE THIS NEEDS QUITE A BIT FOR STUDY.

EVEN TAKING EASTBOUND TRAFFIC EAST OF ARDMORE THROUGH THE SPECIFIC INTERSECTION, THIS LOOKS LIKE IT'S GOING TO START SQUEEZING THE TRAFFIC INTO ONE LANE STARTING FROM ARDMORE BECAUSE YOU'RE GOING TO HAVE PARKING AND THE BIKE LANE AND THEN IT WOULD ONLY BE ONE LANE.

IS THAT CORRECT, DO YOU THINK?

>> CURRENTLY THE TWO LANES START -- WEST OF ARDMORE IS ONLY ONE LANE.

SO EAST OF ARDMORE IT OPENS UP LIKE A POCKET SO WE HAVE TWO LANES.

SO ACCORDING TO THE TRAFFIC ANALYSIS, THE VOLUME IS REALLY LOW.

WE REALLY DON'T NEED TWO LANES FOR THIS STRETCH PER THE VOLUME

ANALYSIS.

AND THEN YOU'RE ONLY PICKING UP TRAFFIC FROM DOWNTOWN AREA AND

FROM THE SITE STREET ALONG THIS STRETCH TO GET MORE INTO MORE TRAFFIC.

SO THE POINT YOU RAISE PROBABLY WEST OF SEPULVEDA BOULEVARD,
THEN YOU ACCUMULATE ENOUGH TRAFFIC TO GUARANTEE FOR TWO LANES.
OTHERWISE WE DON'T NEED TWO LANES.

- >> Mayor Pro Tem Franklin: JUST FROM PERSONAL OBSERVATION, IT'S GOING TO BE A LOT.
- >> Councilmember Napolitano: COUNCIL WILL DECIDE WHETHER WE NEED TWO LANES OR NOT.
- >> PER THE ANALYSIS.
- >> Mayor Pro Tem Franklin: THERE'S GOING TO BE A LONG LINE OF CARS COMING DOWN THERE.

THERE MIGHT BE AN INCREASE IN ROAD RAGE HERE WITH THAT.

AND I UNDERSTAND THE DEDICATED LEFT TURN LANES AT PACIFIC.

BUT ALSO TOO -- I'M NOT EXPECTING YOU TO ANSWER THIS, I DON'T

ANY IF IT'S BEEN STUDIED, BUT HOW MANY CARS ARE TURNING LEFT ON

EASTBOUND MANHATTAN BEACH BOULEVARD AT PACIFIC.

- >> Councilmember Howorth: TURNING ON TO PACIFIC.
- >> Mayor Pro Tem Franklin: NOT TO SAY THEY DON'T DESERVE TO TURN LEFT BUT THEY'RE TURNING LEFT NOW AND IT SEEMS TO BE FINE.

BUT YOU'RE -- BECAUSE WITHOUT THE DEDICATED LANE THERE'S TWO LANES THAT CAN KEEP GOING EAST AND IT REALLY DOES BUILD UP.

WE'RE GETTING A LOT OF VISITORS AND A LOT OF LOCAL TRAFFIC AS WELL GOING THAT WAY.

MY OTHER QUESTION WAS --

- >> Councilmember Napolitano: RUSH HOURS BACKS UP TO --
- >> Mayor Pro Tem Franklin: YEAH, I KNOW.
- >> THE BOTTLENECK IS DOWN TO SEPULVEDA BOULEVARD.
- >> Councilmember Napolitano: THIS IS GOING TO COME BACK.

OKAY.

ACCEPT THAT.

>> Mayor Pro Tem Franklin: RIGHT.

YOU SAID THERE WAS SOME OUTREACH TO RESIDENTS?

UNLESS I'M MISSING IT, I DIDN'T SEE THE RESULT OF THAT OUTREACH IN THE REPORT.

>> THE COMMUNITY MEETING WAS APRIL 20th, THIS YEAR.

WE DID THE ADS IN BEACH REPORTER AND THE CITY WEBSITE AND SOCIAL MEDIA AND ALSO I SEND OUT MAILERS WITHIN 500 FEET OF THE INTERSECTION.

SO THE ATTENDEES TO THE MEETING IS 5 TO 8 RESIDENTS SHOWED UP.
YOU KNOW, SOMETIMES MORE, SOMETIMES LESS.

- >> Mayor Pro Tem Franklin: OKAY.
- >> AND THEN WE COLLECT THEIR OPINION.

MOST OF THEM ARE REALLY CLOSE TO THIS INTERSECTION AND THEN THIS CONCEPTUAL PLAN HERE SHOWN ON THE SCREEN IS AFTER THE DISCUSSION.

WE COLLECTED ALL OF THEIR OPINION.

THIS IS THE FINAL OR PRELIMINARY DESIGN BASED ON THEIR COMMENTS.

>> Mayor Pro Tem Franklin: HOW MANY COMMENTS WERE RETURNED BY
MAIL OR -- I MEAN, DID PEOPLE RETURN BY MAIL OR WERE THEY GIVEN
AN OPPORTUNITY TO E-MAIL?

>> NO.

THEY JUST SHOWED UP TO THE PUBLIC MEETING.

- >> Mayor Pro Tem Franklin: SO FIVE TO EIGHT RESIDENTS?
- >> AND THEN WE HAVE PHONE CALLS FROM THE RESIDENTS AND E-MAILS.

 THERE'S OTHER TWO TO THREE PHONE CALLS AND THE E-MAILS.
- >> Mayor Pro Tem Franklin: OKAY.
- >> AND ALSO BEFORE THIS -- THIS HAS BEEN A LONG TIME ISSUE SO WE HAD IN LAST TWO OR THREE YEARS WE'VE BEEN TALKING ABOUT THIS.

 CITY ENGINEER HAS BEEN DISCUSSING THE WHOLE ISSUE.
- SO IT HAS BEEN VERY THREE -- AT LEAST A THREE YEARS' PLAN TO HAVE THIS PRELIMINARY DESIGN.

WE DIDN'T REALLY COME UP SUDDENLY.

IT IS BASED ON COMMUNITY CONCERN.

- >> Mayor Pro Tem Franklin: THANK YOU.
- >> Mayor Montgomery: COUNCILMEMBER HOWORTH.
- >> Councilmember Howorth: YEAH, MR. MAYOR.
- I THINK HAD MORE OF A COMMENT STATION DIRECTION THAN QUESTION,

 IF YOU NEED TO OPEN THIS UP FOR PUBLIC AND THEN I CAN SPEAK

 AFTER THAT.
- >> Mayor Montgomery: THANK YOU, HELEN.

CAN YOU GIVE US AN OVERVIEW FROM THE TRAFFIC QUESTION, TRAFFIC

ENGINEER POINT OF VIEW, KNOWING THAT THREE OF US, FOUR OF US HAVE GONE THROUGH THIS ROAD DIET FIASCO BEFORE.

WE WERE ALL THROWING BRICKS AT L.A. UNTIL THEY OPENED IT UP AGAIN.

WE'RE NOT FAN OF ROAD DIETS.

BUT TELL US -- WE'VE BEEN IN THAT WAGON TRAIN OF CARS GOING WESTBOUND AND COMING OUT EASTBOUND.

WHEN I'M CAR 799, THERE'S ALWAYS TRAFFIC GOING BOTH DIRECTIONS, NOT JUST HOMETOWN FAIR FIREWORKS, IT'S JAMMED.

CAN YOU GIVE US YOUR POINT OF VIEW.

NOT THE ENGINEER SIDE BUT THE TRAFFIC POINT OF VIEW.

>> SURE.

THANK YOU, MAYOR MONTGOMERY, MEMBERS OF THE CITY COUNCIL.

YES, I DO REMEMBER VERY CLEARLY VISTA DELMAR FIASCO AND WRITING LETTERS AS WELL.

I THINK THE CITY COUNCIL DESERVES A FULL REPORT, A REVIEW OF WHAT THE PROS AND CONS ARE OF THE DIFFERENT OPTIONS AVAILABLE HERE.

HAVING IT ON CONSENT PROBABLY DIDN'T GIVE YOU THE OPPORTUNITY TO DO THAT.

THERE'S SOME ADVANTAGES TO MOVING BACK THE MERGE LANE IN THE WESTBOUND DIRECTION FOR SAFETY REASONS.

THERE ARE ADVANTAGES TO HAVING A BIKE LANE IN BOTH DIRECTIONS
THROUGH THIS ONE NARROW CORRIDOR WHERE WE DON'T HAVE A LOT OF

OPPORTUNITIES TO PROVIDES A BIKE LANE ANYWHERE ELSE TO GET TO THE DOWNTOWN.

THROUGH THE OTHER -- THERE ARE ADVANTAGES FOR THIS

CONFIGURATION, INCLUDING EXTRA CROSSWALK LOCATIONS, LEFT-TURN

POCKETS WHERE WE DIDN'T HAVE THEM BEFORE THAT BACKS UP TRAFFIC

AND SOME OF THE OTHER THINGS.

THIS WAS AN OPPORTUNITY THAT WE HAD.

WE HAD A PROJECT FOR MANHATTAN BEACH BOULEVARD AND PACIFIC AVENUE AND WE'RE LOOKING TO TRY TO MAKE IT SAFER, MAKE IT FLOW BETTER.

OKAY.

THERE ARE SOME OTHER ALTERNATIVES THAT YOU CAN CONSIDER AND TAKE A LOOK AT.

NOT HAVING BIKE LANES, HAVING TWO LANES IN THE EASTBOUND DIRECTION, LIKE WE HAVE NOW, THERE ARE SOME TRADE-OFFS.

YOU MAY OR MAY NOT BE ABLE TO HAVE A LEFT TURN POCKET OR MAY NOT BE ABLE TO HAVE BIKE LANES AND TWO LANES IN ONE DIRECTION.

RATHER THAN GO THROUGH THE MICROCOSM OF THAT, I THINK YOU PROBABLY WOULD BENEFIT FROM HAVING THIS COME BACK TO YOU.

SO WE DO HAVE FLEXIBILITY.

WE'RE NOT LOCKED INTO ONE OPTION OR THE OTHER.

WE HAVE MORE THAN ONE OPTION OF WHAT TO DO?

>> YES, OF COURSE YOU DO.

AND TONIGHT TO MAKE SURE TO BRING BACK ANY RECONFIGURATION BACK
TO YOU FOR YOUR REVIEW AND APPROVAL.

- >> Mayor Montgomery: MAYOR PRO TEM FRANKLIN.
- >> Mayor Pro Tem Franklin: YES.
- IS THERE ANY JEOPARDY?

ARE ANY OF THE FUNDS JEOPARDIZED BY NOT PUTTING IN A BIKE LANE THERE?

- >> NO, NOT FOR NOT PUTTING IN A BIKE LANE.
- >> Mayor Pro Tem Franklin: YOU ALL KNOW I RIDE MY BICYCLE A LOT.

 I'VE NEVER RIDDEN ON MANHATTAN BEACH BOULEVARD.

YOU CAN GO THROUGH THE NEIGHBORHOOD, PACIFIC I DON'T KNOW WHAT STREET IT IS, AMERICAN MARTYRS, IT'S NICE AND CALM, STOP SIGNS, STREETS WITHOUT MANY PARKS CARS, GO DOWN 15th AND THAT LEADS YOU RIGHT INTO -- THERE'S STOPLIGHT AND IT LEADS YOU RIGHT INTO DOWNTOWN.

IT SEEMS LIKE THERE ARE SOME ALTERNATIVES.

- >> Mayor Montgomery: WHAT'S WHAT WOULD COME BACK TO US.
 OPEN UP PUBLIC COMMENT NOW.
- >> HONORABLE MAYOR, MEMBERS OF COUNCIL, I'LL JUST STATE THE OBVIOUS HERE A LITTLE BIT.

THIS IS A MASSIVE CHANGE TO MANHATTAN BEACH BOULEVARD AND PACIFIC AND IN REGARDLESS OF WHAT THE TRAFFIC ANALYSIS SAYS, THE NUMBERS AND WHAT WE CAN DO AND CAN'T DO, I AM ENCOURAGED THAT THIS IS NOT BEING PASSED ON CONSENT.

AND THANK YOU TO COUNCILMEMBER NAPOLITANO FOR PULL IT AND HAVING SOME DISCUSSION.

I HAD NO INTENTION OF SPEAKING TO NIGHT.

I DID NOT SEE ANYTHING ABOUT MANHATTAN BEACH GOING DOWN TO ONE LANE.

AND WE MAY HAVE NOTICED THE RESIDENTS WITHIN 500 FEET OR 250.

THIS WILL IMPACT ALL OF US IN MANHATTAN BEACH.

AND IF WE'RE GOING TO CHANGE MANHATTAN BEACH BOULEVARD DOWN TO ONE LANE OR REDUCE LANES IN ANY DIRECTION WESTBOUND OR -- I AGREE WITH MAYOR MONTGOMERY.

I MUST BE CAR 501 EVERY SINGLE TIME.

I AM BACKED UP GOING WESTBOUND AND THEN EASTBOUND IN THE MORNING, GETTING OUT OF TOWN.

ANYWAY, I AM ENCOURAGED BUT HOW THIS GOT ON CONSENT IS BOTHERSOME AND WHATEVER NEEDS TO HAPPEN.

SUCH A MASSIVE CHANGE FOR US, ALL RESIDENTS IN MANHATTAN BEACH.

AND COUNCILMEMBER NAPOLITANO, THANK YOU FOR PULLING IT.

WE REALLY NEED TO LOOK AT THIS IN A LITTLE MORE DETAIL.

I HAD NO IDEA THAT THIS IS WHAT WAS IN THERE AND IT CERTAINLY WAS NOT CLEAR IN THE COUNCIL AGENDA THAT WAS POSTED.

- I WANTED TO PIGGYBACK ON THAT ONE.
- I TRAVERSE MANHATTAN BEACH BOULEVARD TO GET TOWN TO THE PIER ALL OF THE TIME AND IT'S -- WE COULD USE ANOTHER LANE FOR TRAFFIC.
- IT SEEMS -- I'M SURE PUBLIC WORKS OR WHATEVER OFFICE IT IS JUST LOOK FOR DIFFERENT OPPORTUNITIES TO MAKE LIFE BETTER.
- GOSH, I WOULD LOVE TO SEE MORE BIKE LANES BUT I DON'T THINK THAT'S THE RIGHT PLACE FOR IT.

AND I APPRECIATE THE SPEAKER WHO SAID STAFF WANTS TO MAKE OUR

LIVES BETTER.

YOU KNOW, SO NO ONE IS DOUBTING THAT.

NO ONE IS DOUBTING THAT THERE'S SOME TECHNICAL SPECS AND THEY PENCIL OUT.

HOWEVER, IF YOU'VE EVER DRIVEN KIDS TO MIDDLE SCHOOL IN THE MORNING HEADED FROM, YOU KNOW, I GUESS THE WEST PART, YOU KNOW, WEST OF VALLEY AND YOU'RE COMING UP THAT HILL HEADED EAST, DO NOT TAKE AWAY ANY LANES.

THIS IS SOMETHING THAT AFFECTS US.

THOSE ARE MY COMMENTS.

COUNCILMEMBER LESSER.

>> Councilmember Lesser: I LOOK FORWARD TO VIEWING THE POLICY

WHEN IT COMES BACK AND I SECOND COUNCILMEMBER HOWORTH'S IDEA THAT SOMEHOW WE ADVERTISE THIS.

I WANT TO THANK COUNCILMEMBER NAPOLITANO FOR RAISING THIS ISSUE AS A CONSENT CALENDAR ITEM.

LIKE EVERY MEMBER UP HERE ON THIS DAIS, I PRIDE MYSELF ON VIEWING THE STAFF REPORTS, IT'S NOT CLEAR FROM THE STAFF REPORT THE MAGNITUDE OF THE CHANGE AFFECTED BY THIS PROPOSAL.

I LOOK FORWARD TO A MORE IN-DEPTH CONVERSATION AND THAT'S IT FOR ME.

>> Mayor Montgomery: I'LL WRAP IT UP HERE.

NOTHING ERIC OR HELEN OR DIRECTOR LEE SHOULD BE OFF TO HAVE CREATIVITY LIST HERE.

I WOULD BE UP TO DO WHATEVER TO LIMIT THE FRUSTRATION GOING WEST FROM PCH OR COMING UP EAST TOWARD PCH.

ANYTHING YOU DO THAT WOULD SHORTEN OR SQUEEZE TRAFFIC INTO ONE LANE TO ME WOULD AFFECT ALL THE WAY TO VALLEY ARDMORE GOING OUT OF DOWNTOWN AND COMING INTO IT FROM THE EAST SIDE GOING WEST FROM PCH.

CONSIDERATION OF A RESOLUTION FOR STOP SIGNS IN ALL DIRECTIONS

AT THE INTERSECTION OF VALLEY DRIVE AND PINE AVENUE AND ADOPTION

OF DETERMINATION OF EXEMPTION PURSUANT TO -- I'LL STOP THERE.

WHO IS GOING TO DO IT?

TALYN?

TRAFFIC ENGINEER IS NOT GOING TO GO ANYWHERE.

>> HONORABLE MAYOR AND COUNCILMEMBERS, TALYN MIRZAKHANIAN HERE.

I WOULD LIKE TO INTRODUCE OUR CITY TRAFFIC ENGINEER TO PRESENT

THIS ITEM.

>> Mayor Montgomery: WELCOME BACK, ERIK.

>> THANK YOU VERY MUCH.

THANK YOU, DIRECTOR TALYN.

MY NAME IS ERIK.

I'LL KEEP THE PRESENTATION FAIRLY SHORT.

WE DON'T HAVE A POWER POINT PRESENTATION FOR YOU.

BUT BY MEANS OF BACKGROUND I WOULD LIKE TO SAY THAT THIS ITEM CAME TO US THROUGH A PUBLIC ITEM AT THE CITY COUNCIL BACK IN MARCH OF THIS YEAR.

THE RESIDENTS OF THE VALLEY DRIVE AREA BETWEEN 27th STREET AND OAK HAD ASKED FOR SOME TYPE OF TRAFFIC CALMING AFTER A COUPLE OF SIGNIFICANT ACCIDENTS.

THE CITY -- THEY ALSO PROVIDED A FOLLOW-UP PETITION FOR THAT.

APRIL 27th WE BROUGHT THE ITEM TO THE PPIC, THE PARKING AND

PUBLIC IMPROVEMENTS COMMISSION WITH A LIST OF POSSIBLE TRAFFIC CALMING MEASURES AND BACKGROUND FOR THAT.

THE COMMISSION REVIEWED ALL OF THE STAFF'S RECOMMENDATIONS AT THAT TIME AND UNANIMOUSLY APPROVED THOSE.

IN ADDITION TO THOSE STAFF RECOMMENDATIONS, THEY ALSO RECOMMENDED PAINTING A SOLID DOUBLE YELLOW CENTER LANE ON VALLEY DRIVE BETWEEN THOSE TWO STREETS, 27th AND OAK, AS WELL AS RECOMMENDED A STOP SIGN AT THE CORNER OF VALLEY DRIVE AND PINE. WE ARE BRINGING THE PPIC REPORT TO YOU TONIGHT ALONG WITH A RECOMMENDATION FOR ALL OF THE STAFF -- ALL OF THE PPIC'S RECOMMENDATIONS.

SO THE STAFF RECOMMENDATION IS THE PPIC'S RECOMMENDATION AND THAT INCLUDES INSTALLATION OF THE DOUBLE YELLOW LINE, A SPEED ACTIVATED FLASHING SIGN ON VALLEY DRIVE WEST OF OAK FACING THE TRAFFIC COMING IN FROM SEPULVEDA, A TEMPORARY LANDSCAPED CENTER MEDIAN AND EASTBOUND CURB POCKET AND CURB EXTENSION.

IT'S NARROWING THE LANES ON VALLEY DRIVE BETWEEN SO PULL VA THE BOULEVARD AND OAK IN AN EFFORT TO REDUCE THE INBOUND TRAFFIC IN THAT DIRECTION.

IT PROVIDES EXTRA VISIBILITY FOR THE DRIVEWAY FOR THE SENIOR APARTMENTS TO GET THEM A LITTLE FARTHER OUT SO THEY CAN SEE AROUND THE CORNER.

SO THAT WOULD BE A RECOMMENDATION FOR THAT.

PROVIDING FOR A LEFT TURN POCKET FROM VALLEY DRIVE ON TO OAK

DRIVE WHICH REDUCES THE BACKUP THAT WOULD HAPPEN BACK THERE.

ALSO TO INSTALL TWO PAINTED CROSSWALKS AT VALLEY DRIVE AND

WALNUT AND VALLEY DRIVE AND ELM AVENUE.

THAT WOULD BE PAINTED AT FIRST AND THEN RECONSTRUCTED,

CONSIDERED FOR A CAPITAL PROJECT TO INSTALL RAISED CROSSWALKS

ALONG WITH THE CORNER TO RESTRICT THE CROSSWALK LANE AS WELL AS

TO REDUCE THE TRAFFIC SPEEDS ON VALLEY DRIVE.

IT HAS A TRAFFIC CALMING EFFECT FOR THAT.

AND TO THE POINT FROM COUNCILMEMBER NAPOLITANO, THIS IS A LOCAL ROAD WITH A POSTED SPEED LIMIT OF 30 MILES AN HOUR.

THOSE ARE MORE APPROPRIATE FOR OUR RAISED CROSSWALK IN THE FUTURE.

RAISED CROSSWALK AS OUR COUNCILMEMBER DUALLY NOTED IS KIND OF LIKE A SPEED HUMP.

IT GIVES YOU A VERTICAL DIFFERENCE OF 4 INCHES OR SO AND DISCOURAGES SPEEDING.

IT ALSO -- THE OTHER RECOMMENDATION WOULD ALSO BE TO ADOPT
RESOLUTION NO. 2391 APPROVING STOP SIGNS IN ALL DIRECTIONS AT
THE INTERSECTION OF VALLEY DRIVE AND PINE AVENUE.

THE LAST ITEM ON THE RECOMMENDATION LIST IS TO ADOPT A DETERMINATION OF EXEMPTION PURSUANT TO 15301C OF THE CALIFORNIA CEQA.

THAT CONCLUDES THE REPORT.

THE ITEMS AND THE LOCATIONS ARE DISPLAYED ON THE SCREEN FOR YOU.

- IF YOU HAVE ANY OUESTIONS I WOULD BE HAPPY TO ANSWER THOSE.
- >> Mayor Montgomery: THANK YOU, ERIK.

STAND BY.

COUNCILMEMBER NAPOLITANO YOU'RE UP FIRST AND THEN COUNCILMEMBER LESSER.

>> Councilmember Napolitano: A COUPLE OF QUESTIONS.

CONCERN OVER THE EVERYONE MENTATION, FUTURE EVERYONE MENTATION

OF ANY RAISED CROSSWALKS, ESPECIALLY THIS STRETCH RATHER THAN

BEING A MORE STRICTLY RESIDENTIAL STREET SINCE YOU'RE TURNING

OFF OF SEPULVEDA.

YOU'RE GOING TO GET A LOT OF PEOPLE TAKING THIS ROAD THAT DON'T LIVE IN MANHATTAN BEACH THAT ARE VISITORS.

I CAN ONLY IMAGINE WE'RE GOING TO HAVE LOTS OF SIGNAGE AND ROAD PAINT TELLING PEOPLE THERE'S A RAISED CURB HERE.

I'VE EXPERIENCED THIS IN OTHER COMMUNITIES AND IT DOESN'T NECESSARILY SLOW THEM DOWN.

IT SENDS THEM FLYING SOMETIMES, ESPECIALLY COMING FROM THAT STRETCH.

I GUESS IF THE IDEA IS FOR STAFFER CROSSWALKS WHERE WE'VE PUT IN OTHER PLACES THE FLASHING CROSSWALKS WHERE PEOPLE HAVE TO STOP AND THE LIGHTS ARE FLASHING IN THE GROUND AS WELL AS UP ABOVE, WHY AREN'T THOSE BEING CONSIDERED HERE?

WE PUT THEM ON HIGH LAND, WE PUT THEM ON MORNINGSIDE, WE PUT THEM ON DIFFERENT AREAS OF TOWN.

>> CORRECT.

SO TO ANSWER THAT QUESTION, COUNCILMEMBER NAPOLITANO, AS WE DO
IN OUR NEIGHBORHOOD TRAFFIC CALMING PROGRAM WE TAKE ANYTIME A
STEP-WISE APPROACH.

WE WOULD BE RECOMMENDING PUTTING IN PAINTED CROSSWALKS AT THE TIME, STUDYING, TAKING A LOOK AT IT, SEE HOW IT WORKS.

IF WE'RE NOT GETTING A SPEED REDUCTION, WE COULD TAKE IT TO THE NEXT STEP.

THEN IT WOULD COME BACK TO THE CITY COUNCIL SO YOU COULD CONSIDER THE RAISED CROSSWALKS OR FLASHING BEACONS.

>> Councilmember Napolitano: FLASHING CROSSWALKS.

OKAY.

ALL RIGHT.

THANK YOU, YOUR HONOR.

- >> Mayor Montgomery: COUNCILMEMBER LESSER.
- >> Councilmember Lesser: I WANTED TO FOLLOW UP ON YOUR RESPONSE
 TO COUNCILMEMBER NAPOLITANO WITH REGARD TO TIMING.
- IS THE STAFF RECOMMENDATION TO AUTHORIZE ALL OF THESE CALMING
 MEASURES AT ONCE OR IS THERE A SUGGESTION WITH INPUT BY COUNCIL
 ON PRIORITIZATION TO DO CERTAIN OF THESE CALM MEASURES
 IMMEDIATELY, AND THEN STAGGER SOME OF THE OTHERS AFTER AN
 INITIAL REVIEW.

IT'S UNCLEAR FROM THE STAFF REPORT.

>> THAT'S A VERY GOOD QUESTION, COUNCILMEMBER LESSER.

THE INTENT IS FOR THE INITIAL TRAFFIC MEASURE TO GO IN AT ALL ONCE.

THESE A PAINTED MEDIAN AT SEPULVEDA.

POINTED CROSSWALKS AT ELM AND WALNUT.

A STOP SIGN AT PINE AND THEN TO COME BACK -- OH, AND THE FLASHING SPEED SIGN.

WHEN YOU EXCEED THE SPEED LIMIT, THE SIGN HAS A WHITE -- LITTLE LIGHTS AROUND THE OUTSIDE TO WARN YOU EAR GOING OVER THE SPEED LIMIT.

IT'S NOT A SPEED AWARENESS SIGN THAT'S FARTHER DOWN THE STREET.

WE WANT THERE TO BE CONSISTENT SPEED REDUCTION THROUGHOUT THE

ENTIRE LENGTH OF THE STRETCH.

IT'S A LONG STRETCH AND PEOPLE WOULD SPEED UP -- IF YOU ONLY HAD CROSSWALKS AT ELM AND WALNUT, THEY MAY SPEED UP BETWEEN THAT SECTION.

THAT'S THE INTENT.

>> Councilmember Lesser: WE'VE HAD E-MAIL DISCUSSION.

THIS IS A STREET I'VE BEEN FAMILIAR WITH AND I THINK IT GOES
BACK 19 YEARS AGO WHEN I WAS SERVING ON THE PARKING AND PUBLIC
IMPROVEMENTS COMMISSION.

WE WERE FORCED TO INCREASE THE SPEED LIMIT TO 30 AND I WELCOME YOU DESCRIBING WHY WE WERE FORCED TO INCREASE IT AND DESCRIBE WHY WE MIGHT HAVE AN OPPORTUNITY TO REDUCE IT AND IT INVOLVES THE SENIOR VILLAS ON THE STREET.

I'LL LET YOU DESCRIBE THAT.

I'M WONDERING WHY THAT'S NOT INCLUDED IN THE STAFF REPORT AND
WHY THAT SHOULD NOT BE ONE OF THE DIRECTIONS HERE TO REDUCE THAT
SPEED LIMIT.

>> SURE.

THANK YOU FOR THE QUESTION.

AND FOR EVERYONE'S BENEFIT, AB43 WAS A LEGISLATION PASSED BY THE STATE OF CALIFORNIA TO ALLOW FOR AN ADDITIONAL FIVE MILE AN HOUR SPEED REDUCTION IN SPECIAL AREAS, SUCH AS SENIOR ACTIVITY

CENTERS, SCHOOL AREAS AND HIGH PEDESTRIAN AREAS THAT HAVE BEEN DESIGNATED AS A SAFETY ZONE.

THAT LEGISLATION WAS PASSED LAST YEAR AND DOESN'T GO INTO EFFECT UNTIL JULY 1st OF 2024.

ONE YEAR FROM NOW.

THE STATE HASN'T COME UP WITH THE PROCESS AND PROCEDURES TO ALLOW FOR THAT MONITORING AND THAT CHECKLIST AT THIS POINT.

THE SENIOR APARTMENTS WOULD QUALIFY, WE THINK, FOR THAT DESIGNATION AND THEN WE COULD REDUCE THE SPEED LIMIT TO 25 MILES AN HOUR.

>> Councilmember Lesser: FINAL QUESTION IS, YOU AND I ALSO EXCHANGE THERE HAD IS A SPEED MONITORING SIGN AT THE INTERSECTION OF PINE WHICH IS NOT WORKING AND YOU WERE GOING TO FOLLOW UP WITH THE PUBLIC WORKS.

I WAS THERE AND I COULDN'T BELIEVE HOW FAST MANY VEHICLES WERE

GOING.

>> THAT'S VERY TRUE.

IF YOU WATCH THE FEEDBACK SIGN WHEN IT IS WORKING YOU CAN SEE HOW FAST THEY'RE GOING AND YOU CAN SEE THAT THEY SOMETIMES SLOW DOWN AS THEY SEE THE SIGN.

THE BATTERIES IN THE SIGN HAVE BASICALLY DIED.

THEY CAN'T BE RECHARGED AGAIN.

THEY'RE FIVE YEARS OLD AND THAT'S HOW OLD THE SIGN IS.

WE'VE ASKED PUBLIC WORKS GO IN AND REPLACE THE BATTERIES ON THE SIGNS.

IT WAS WORKING A WEEK BEFORE THAT BECAUSE I GO PAST THAT STRETCH OF ROAD ABOUT ONCE A DAY.

- >> Councilmember Lesser: THANK YOU.
- >> Mayor Montgomery: MAYOR PRO TEM FRANKLIN AND THEN COUNCILMEMBER HOWORTH.
- >> Mayor Pro Tem Franklin: THANK YOU.
- I WALK THE AREA ACTUALLY TWO TIMES EVEN BEFORE THIS CAME TO THE COUNCIL TODAY BECAUSE THE RESIDENTS, YOU KNOW, REACHED OUT TO US AND WANTED SOME HELP HERE.
- SO YOU'VE GOT A RECOMMENDATION HERE FOR A DEDICATED LEFT-HAND

 TURN LANE FROM EASTBOUND NORTH ARDMORE TO NORTH BOUND SEPULVEDA.

 BUT YOU HAVE TWO LANES THERE NOW, RIGHT.
- SO THERE'S TWO LANES NOW THAT ARE ABUTTING SEPULVEDA, EASTBOUND FROM NORTH VALLEY.

- SO I WAS JUST WONDERING WHAT IS THE CORRECTION GOING TO BE IN.
- >> THE LEFT TURN POCKET WOULD BE JUST WEST OF OAK AVENUE.
- >> Mayor Pro Tem Franklin: RIGHT.
- >> AND SO THAT'S NOT AN AREA AFFECTED BY THE SEPULVEDA INTERSECTION.
- >> Mayor Pro Tem Franklin: OKAY.
- >> WE'RE BASICALLY TAKING THAT WIDE INTERSECTION THAT HAS LOTS
 OF PAVEMENT AND REDUCING THE AMOUNT OF PAVEMENT.
- BY DOING THAT WE HAVE A LEFT-TURN POCKET WE CAN PROVIDE IN THE MIDDLE.

THERE WAS AN ACCIDENT LAST YEAR WHERE A LEFT-TURNING DRIVER HIT AND COLLIDED WITH AN EASTBOUND DRIVER COMING OFF OF SEPULVEDA BOULEVARD AT A HIGH SPEED.

>> Mayor Pro Tem Franklin: OKAY.

AND I WAS JUST A LITTLE DISAPPOINTED THAT THERE WASN'T MORE

DETAIL ON THE PROPOSED -- DID YOU CALL IT A TEMPORARY LANDSCAPE

MEDIAN?

- >> WE BROUGHT THIS CONCEPT TO --
- >> Mayor Pro Tem Franklin: I SEE ALL OF THE PAVEMENT THERE AND I DON'T KNOW HOW IT'S GOING TO --
- >> SURE.

THE ROADWAY IS ABOUT 40 FEET WIDE BETWEEN THE HOTEL AND THE APARTMENTS.

WE WOULD STILL HAVE ONE LANE IN EACH DIRECTION AS WE DO NOW.

THE CENTER PORTION OF THE STREET WOULD BE IN A TEMPORARY BASIS

IT WOULD BE PAINTED GREEN WITH EDGE LINES ON EITHER SIDE USING

UP SOME OF THAT PAVEMENT WIDTH.

IT ALSO MAKES PEOPLE COMING OFF OF SEPULVEDA BOULEVARD SLOW DOWN MUCH MORE AND SLOW DOWN BEFORE THEY GET TO OAK AVENUE.

WITHIN THAT CENTER MEDIAN AREA ONCE YOU GET BEYOND THE

INTERSECTION AT OAK, THAT'S WHERE THE LEFT-TURN POCKET WOULD BE

IN THE OPPOSITE DIRECTION.

SO IT WOULD BE PAINTED AND STRIPED TO BEGIN WITH IT.

IF IT WORKS OUT THEN WE WOULD COME BACK WITH A PERMANENT SOLUTION FOR RAISED CURBS AND SOME TYPE OF LANDSCAPE IN THE MIDDLE OF THE ROAD.

>> Mayor Pro Tem Franklin: OKAY.

>> THIS ITEM WAS BROUGHT TO THE CITY COUNCIL ABOUT FOUR YEARS AGO, 2018.

AND AT THAT TIME THE CITY COUNCIL HAD DEFERRED THE ISSUE TO SOME OTHER FUTURE DATE.

>> Mayor Pro Tem Franklin: OKAY.

AND GOING BACK TO THE RECOMMENDED STOP SIGN AT PINE AND VALLEY THERE, SOME RESIDENTS WERE CONCERNED ABOUT THE NOISE.

YOU KNOW, PEOPLE STOPPING AND THEN STARTING UP AGAIN AND THINGS LIKE THAT.

I MEAN IS THERE ANY DATA AROUND THAT?

IS IT JUST ANECDOTAL?

>> SURE.

WHEN YOU INSTALL A STOP SIGN THERE'S ALWAYS PROS AND CONS.

THE PROS ARE THAT IT COULD MAKE TURNING MOVEMENTS AT THE

INTERSECTION SAFER.

ON THE CON SIDE IT COULD, AS YOU SAY, INCREASE THE NOISE LEVEL AT THE INTERSECTION ITSELF FOR PEOPLE THAT ARE DECELERATING OR ACCELERATING WHERE YOU WOULDN'T HAVE THAT NOW.

THERE'S AN INCREASED POTENTIAL FOR REAR-END COLLISIONS BECAUSE YOU DON'T HAVE TO STOP THERE NOW.

AND THERE IS THE POTENTIAL FOR DRIVERS, ONCE THEY COME TO THE STOP SIGN AT VALLEY DRIVE, THEY MIGHT CHOOSE TO GO UP PINE AVENUE TO ROSECRANS.

SO THERE'S PROS AND CONS TO IT AND WE LAID THAT OUT IN THE PPIC REPORT.

>> Mayor Pro Tem Franklin: SO SOUTHBOUND PINE WHEN YOU'RE COMING
UP TO VALLEY, IF YOU'RE GOING TO GO WESTBOUND ON VALLEY, ASSUME
YOU HAVE, LIKE THE WAY IT IS NOW, YOU CREEP OUT THERE AND THERE
ARE PARKED CARS ON VALLEY, CORRECT, THAT OBSCURE --

THERE'S ALSO A RED CURB AT THE INTERSECTION TO TRY TO KEEP THE CARS --

>> Mayor Pro Tem Franklin: TO KEEP THEM BACK A LITTLE BIT. OKAY.

GREAT.

>> YES.

THANK YOU.

>> Mayor Montgomery: COUNCILMEMBER HOWORTH.

>> Councilmember Howorth: JUST BASICALLY A QUICK QUESTION ABOUT THE CURB-OUT AT WALNUT AND VALLEY AND I THINK ELM AT VALLEY.

WOULD THOSE TAKE OUT PARKING IN --

>> NO.

THEY'RE IN EXISTING RED CURB ZONES.

>> Councilmember Howorth: FABULOUS.

THANK YOU.

>> Mayor Montgomery: COUNCILMEMBER NAPOLITANO.

>> Councilmember Napolitano: THANK YOU.

ONE THING I FORGOT TO BRING UP.

IT GOES TO ANOTHER SAFETY ISSUE.

WAS THERE CONSIDERATION TO ELIMINATE.

GROSSLY SUBSTANDARD BIKE LANE THERE WHICH WAS ONE OF THE REASONS WHY THIS -- I THINK WIT AS YOUNG CHILD SIDESWIPED RIDING A BIKE THERE.

I DON'T KNOW IF IT'S TWO-FEET WIDE.

BUT WE HAVE CARS OBVIOUSLY ON ONE SIDE.

AGAIN, MESSING WITH PEOPLE'S PARKING, TRAFFIC OR THEIR HOMES, THEY GO OUT OF THEIR MINDS WHICH I UNDERSTAND.

I WOULD TOO.

BUT IT'S NOT REALLY -- I THINK WE HAVE A SIGN THERE MAYBE SAYING BIKE LANE.

BUT IT'S NOT -- IT DOESN'T MEET THE STANDARDS FOR A BIKE LANE.

>> YOU ARE CORRECT.

IT'S A BIKE ROUTE, NOT A BIKE LANE.

IT'S AN EDGE LINE TO NARROW DOWN THE TRAFFIC.

YOU DON'T SEE A 14th-FOOT LINE YOU SEE A 11-FOOT LINE.

>> Councilmember Napolitano: YOU'RE GIVING A FALSE SENSE OF SECURITY.

>> WE DO NOT DO THIS IN THIS SEGMENT BECAUSE IT'S ACTUALLY PREDATED ALL OF OUR [INDISCERNIBLE].

I STILL THINK THAT THE EDGE LINE HELPS REDUCE TRAFFIC SPEEDS.

THEY WOULD BE HIGHER IF WE DIDN'T HAVE AN EDGE LINE ON THE

STREET AND NARROWED DOWN THE LANES.

THE OTHER ALTERNATIVE IS TO PUT THE EDGE LINE ON THE OTHER SIDE OF THE STREET ALONG THE PARKED CAR SIDE AND THEN MOVE THE LANES OVER TOWARDS THE PARKWAY.

>> Councilmember Napolitano: ONE OBSERVATION.

I KNOW IT'S NOT NECESSARILY A QUESTION.

AT SOME POINT WE REALLY NEED TO EVALUATE -- IT GOES TO THE IDEA OF AN EAST-WEST BIKE LANE TO GET FROM AVIATION TO THE PIER BUT ALSO NORTH-SOUTH, ESPECIALLY ALONG THE PARKWAY WHERE, YOU KNOW -- I KNOW THERE WILL BE SCREAMING, BUT INCORPORATING SOME OF THE PATHWAY.

BUT THAT'S FOR ANOTHER DAY.

THANK YOU, YOUR HONOR.

- >> I WOULD LOVE TO BRING BACK A VETERANS PARKWAY BIKE LANE BIKE PROJECT FOR YOU.
- >> Mayor Montgomery: ONE MORE QUESTION AND THEN PUBLIC COMMENT.
- >> Mayor Pro Tem Franklin: I NOTICED ALSO, AND I HADN'T NOTICED IT BEFORE, WHEN YOU COME OFF OF SEPULVEDA AND HEAD WEST ON VALLEY RIGHT THERE AT THE HOTEL IT'S DOWNHILL AND I REMEMBER THINKING THAT'S KIND OF LIKE ACCELERATING.

ARE THERE ANY TRAFFIC MITIGATION WAYS OF STRIPING OR THINGS LIKE THAT THAT TELL PEOPLE HEY, IT'S A HILL, SLOW DOWN.

>> RIGHT.

THAT'S THE INTENT OF THE MEDIAN THAT WE'RE PROPOSING.

THAT WOULD HAVE THAT TYPE OF NARROWING EFFECT TO COUNTER ACT THAT DOWNGRADE.

PEOPLE ARE COMING OFF OF SEPULVEDA BOULEVARD FROM A SEGMENT THAT'S 45 MILES AN HOUR OR MORE.

AND THAT'S HARD TO GET THEM TO CHANGE THEIR BEHAVIOR.

>> Mayor Pro Tem Franklin: SO IS THERE ANY KIND OF MESSAGING WE CAN PUT ON THE PAVEMENT, GO SLOW, HILL.

HILL, SLOW DOWN.

>> THAT'S WHAT THE FLASHING SPEED SIGN IS INTENDED TO DO.
YOU CAN SEE THAT COMING AROUND THE CORNER FROM SEPULVEDA
BOULEVARD.

YOU'LL SEE YOUR SPEED AS YOU'RE GOING DOWN THAT STRETCH.

>> Mayor Pro Tem Franklin: I'M TRYING TO REMEMBER IF I'VE SEEN

IT ELSEWHERE, MAYBE NOT IN THE CITY, BUT SOMETHING THAT, HEY, YOU'RE ON A GRADE GOING DOWN TO SLOW DOWN.

>> RIGHT.

WE'LL TRY TO DESIGN SOMETHING INTO OUR TEMPORARY MEASURE.

>> Mayor Montgomery: I HAVE TWO QUESTIONS AND I WAITED TO SEE IF ANYBODY ASKED IT.

I KNOW ONE HALF OF THE ISSUE, WHATEVER YOU CAN DESIGN THE BEST PROGRAM IN THE WORLD BUT PART OF IT IS ENFORCEMENT TOO WITH POLICE.

NEW STOP SIGNS, PEOPLE ARE NOT GOING TO PAY ATTENTION OFF OF THE BAT.

WON'T EVEN SEE THEM FOR A WHILE.

HAVE TO GET USED TO SEEING THE STOP SIGN.

YOUR PROGRAM IS TO PUT THINGS IN PLACE, WATCH IT FOR SIX MONTHS

AND IF IT DOESN'T SLOW DOWN THAT YOU FEEL THAT MILEAGE IS

SLOWING DOWN ENOUGH AND THEN YOU COME BACK WITH THE SECOND

MEASURE.

IS THAT YOU OR THE STATE SAYING YOU CAN'T MAKE ALL OF THESE CORRECTION AT ONE TIME.

THERE MUST BE A GAP IN TIME THAT SAYS WE NEED A RAISED CROSSWALK, YES NEED MORE BEACONS TWO FEET AWAY.

WHICH ONE IS IT?

>> THE STATE DOESN'T MANDATE THE ORDER AND MANNER IN WHICH YOU CAN PUT IN TRAFFIC CALMING MEASURES.

IT'S SMART PRACTICE TO PUT IN ONLY THE AMOUNT OF TRAFFIC CALMING THAT OS.

OVERKILL, YOU WOULD PUT IN MORE THINGS THAN ARE NECESSARY.

AND IT ACTUALLY WOULD IMPEDE TRAFFIC IN THAT SENSE.

>> Mayor Montgomery: SO THE CAUTIOUS ROUTE, WAITING TO SEE IF THE FIRST ROUND MAKES EVERYTHING BETTER, DROP THE SPEED LIMIT DOWN, EVEN.

THE NEW RULE COMES INTO EFFECT NEXT YEAR, FIVE MILE AN HOUR LESS, WE'RE GOING TO SEE IF IT MAKES A DIFFERENCE IN SIX MONTHS AND IF IT DOESN'T WE'RE GOING TO GO TO ROUND TWO AND ADD IN THE KITCHEN SINK AND EVERYTHING THAT WE'RE GOING TO DO.

>> CORRECT.

IT'S IMPORTANT THAT THE RESIDENTS 0 OWNERS OF THESE MEASURES.

IF WE PUT IN THINGS THEY DON'T WANT IT'S NOT GOING TO BE

RECEIVED WELL.

>> Mayor Montgomery: THAT'S TRUE.

WE'RE RIGHT BACK TO ADDING MORE THINGS TO IT.

THE ONLY THING WE LOSE IS TIME.

AND THE POSSIBILITIES EXIST THAT WE HERE NOT DOING ENOUGH SOON ENOUGH THAT'S A DIFFERENT QUESTION.

OPENING UP PUBLIC COMMENT.

CITIZENS DETAILING AUTO ACCIDENTS, COLLISIONS, ROLLOVER

ACCIDENTS, PARKED CARS THAT WERE TOTALED, PETS KILLED, CONSTANT

SPEEDING VEHICLES EVEN UP TO 50 AND 60 MILES AN HOUR THAT WE SEE

AND OUR YOUNG NEIGHBOR CYCLIST GETTING HIT BY A CAR.

THANK YOU TO THOSE WHO CAME TO NORTH VALLEY TO TAKE A LOOK AT

LITTLE BOY UP THERE MAKING ALL OF THE NOISE, I'M URGING YOU TO

TAKE THIS SERIOUSLY AND INSTALL SOME TRAFFIC CALMING MEASURES IN

THIS AREA.

EVERYBODY LOVES VALLEY AND ARDMORE AND THE GREEN BELT.

IN MANY WAYS, IT'S THE GATEWAY TO OUR CITY.

BUT THERE HAVE BEEN ISSUES FOR A LONG TIME.

I WOULD LIKE TO THANK OUR TRAFFIC ENGINEER FOR THE WORK HE'S DONE TO HELP OUR COMMUNITY.

BUT THE ISSUES DO PERSIST.

BUT JUST TO CLOSE, I DON'T THINK THE TRAFFIC CALMING IS JUST SOMETHING THAT'S TRENDY IN COMMUNITY PLANNING.

MY WORK TAKES ME ALL OVER LOS ANGELES AND IT'S AMAZING,

COMMUNITY AFTER COMMUNITY YOU SEE THESE TRAFFIC CALMING MEASURES

GETTING INTO ROAD RAGE, IT'S JUST A REACTION TO OUR SOCIETY.

WE SEE THIS ON NORTH VALLEY DRIVE TOO.

IT'S IMPORTANT AND NEEDED.

I APPRECIATE ALL OF YOUR WORK ON OUR NEIGHBORHOOD'S BEHALF AND FOR THE CITY.

WHO IS OUR CLOSER?

THERE HE IS.

>> I LIKE THAT.

>> Mayor Montgomery: TWO MORE.

YOU WANT TO MOVE OVER HERE SO WE CAN SEE YOU.

>> IT'S A PLEASURE TO BE HERE WITH YOU.

MY NAME IS DALE.

MY WIFE AND I HAVE LIVED AT 3007 NORTH VALLEY DRIVE FOR GOING ON HALF CENTURY NOW.

SO PROBABLY BEFORE MANY OF YOU WERE BORN.

BUT IN ANY EVENT, AS LONG-TIME RESIDENTS OF MANHATTAN BEACH AND THE VALLEY DRIVE, THERE'S ALWAYS BEEN TRAFFIC ON VALLEY DRIVE.

AND WE MOVED IN WITH OUR GUYS WIDE OPEN AS DID OTHER PEOPLE.

I THINK OUR PURPOSE HERE IS NOT TO REDUCE THE AMOUNT OF TRAFFIC BECAUSE IT'S A MAJOR CORRIDOR, AN ARTERY INTO THE HEART OF THE RESIDENTIAL PART OF MANHATTAN BEACH.

SEEING NONE, WE'LL CLOSE PUBLIC COMMENT.

COUNCIL.

COUNCILMEMBER HOWORTH, YOU'RE UP FIRST.

>> Councilmember Howorth: ERIN, PLEASE TELL RANDY AFTER TEN
YEARS, HE'S MY DOCTOR I'VE BEEN HEARING ABOUT THIS AT THE VISITS
FOR A LONG TIME.

BY THE WAY, IT KIND OF FIRST CAME TO US IN MARCH OF 2015 AND WE WERE ON THE COUNCIL THEN AND AT THAT TIME THERE WAS A DIFFERENT SCENARIO PROPOSED AND WE SENT IT BACK AND I THINK WHAT WE HAVE HERE IS A REALLY ROBUST YET COMMON SENSE APPROACH.

YOU KNOW, I DO THINK IT'S REALLY INTERESTING PSYCHOLOGICALLY SPEAKING WHAT A DIFFERENCE THE PAINTED MEDIAN.

- >> Councilmember Howorth: THE MOTION IS TO APPROVE THE PARKING AND PUBLIC IMPROVEMENTS COMMISSION FOR STOP SIGNS IN ALL DIRECTION AS WELL AS ADOPT RESOLUTION NUMBER 23-0091.
- >> Councilmember Napolitano: WOULD THAT BE BRINGING FACT-FINDING THE FUTURE ITEMS IF IT COSTS MORE.
- >> Councilmember Howorth: I THINK WE WAIT SIX MONTHS.
- >> Councilmember Napolitano: YOUR MOTION DOES NOT INCLUDE APPROVAL OF THOSE.
- >> Councilmember Howorth: IT DOES NOT.
- >> Councilmember Napolitano: THAT'S ALL I WANT TO KNOW.
- YES, I SUPPORT THESE FIRST ROUND OF CHANGES.
- I'M GOING TO RESERVE ON THE SECOND ROUND UNTIL WE GET MORE DATA BACK.

THERE ARE A COUPLE OF THINGS -- I WANT TO SAY FOR ALL OF THE TRAFFIC CALMING MEASURES ESPECIALLY AROUND THE CITY OF L.A.,

THEIR WHOLE VISION ZERO EVERYTHING IS DONE THE OPPOSITE.

THERE ARE MORE INJURIES AND DEATHS NOW BECAUSE OF THE THINGS

THEY'VE DONE BECAUSE PEOPLE TRY TO GET AROUND THESE THINGS.

I'VE GOT FAMILY THAT LIVES UP THAT BLOCK OF PINE RIGHT THERE.

I KNOW WHAT THE SITUATION IS HERE.

I SUPPORT THESE MEASURES AND WILL VOTE FOR THOSE.

I DON'T KNOW WHY WE HAVEN'T DONE IT BEFORE THAT.

2015, I WASN'T HERE.

DON'T BLAME ME.

JUST KIDDING.

IT'S A JOKE.

IT'S A JOKE.

[LAUGHTER]

>> Councilmember Howorth: WERE YOU HERE BEFORE THAT.

>> Councilmember Napolitano: NOBODY CAME TO US.

NOW IS THE TIME TO FIX THINGS.

I'M FINE WITH THE STOP SIGN.

BUT AGAIN, I DON'T WANT ANYONE TO GET THAT FALSE SENSE OF

SECURITY.

MAKE EYE CONTACT WITH THOSE DRIVERS WHEN YOU CROSS THAT STREET,

CROSSWALK OR NOT.

SOME TRAFFIC ENGINEERS WILL TELL YOU IT'S SAFER TO NOT HAVE A CROSSWALK BECAUSE IT FORCES YOU TO BE EXTRA SAFE YOURSELF AND THEM AS WELL.

PLEASE BE SAFE REGARDLESS OF WHAT WE PUT OUT THERE.

AND THEN AS WE CHECK THE DATA AND SEE HOW THINGS COME

BACK -- AGAIN, THERE'S A BOOMERANG EFFECT THAT IF YOU PUT TOO

- >> Councilmember Napolitano: NO.
- >> Councilmember Howorth: REMARKABLE.
- >> Councilmember Napolitano: THERE ARE PAINTINGS ON THE SIDEWALKS AT CROSSWALKS IN MANY OTHER CITIES SAYING LOOK UP.
- >> Mayor Montgomery: COUNCILMEMBER FRANKLIN, YOU'RE UP.
- >> Mayor Pro Tem Franklin: IN LONDON IT SAYS LOOK LEFT LOOKING

FOR THE TRAFFIC.

SO, YOU KNOW, I CAN'T OVERSTATE THE IMPORTANCE OF PUTTING THESE TRAFFIC CALMING MEASURES IN.

IT'S LONG OVERDUE.

THE GREEN BELT ACTS AS ANOTHER NATURAL CORRIDOR, YOU KNOW, OF KIDS, BICYCLISTS, PUSHING, YOU KNOW, BABY CARTS, BABY CARRIAGES, EVERYTHING.

>> Councilmember Lesser: THERE MIGHT BE SOME REASONS FOR EXPLORING THAT.

I DID WANT TO ENCOURAGE THE POLICE TO CONSIDER PUTTING SOME SELECTIVE ENFORCEMENT.

THEY'RE LIMITED ON THE NUMBER OF MOTORS THEY HAVE BUT THIS MIGHT BE AN AREA WHAT CAN WE DO SOON, WHAT CAN WE DO QUICKLY.

PERHAPS THERE IS MORE SELECTED ENFORCEMENT THERE BUT I DEFER THAT THE POLICE DEPARTMENT DO THAT.

I WOULD WELCOME SOME INFORMATION ON WHETHER IT WOULD BE FEASIBLE.

I RECOGNIZE THERE BEING AN ALIGNMENT AND CUTTING BACK SOME OF THE VEGETATION ON THE VETERANS PARKWAY RIGHT AT 27th BUT THAT MIGHT BE A GOOD SPOT FOR SOME FORM OF CROSSWALK AS PART OF THE

MEASURES.

WITH THAT I'M SUPPORTING THE MEASURE AND SECOND.

>> Mayor Montgomery: WELL DONE.

THE MAYOR, ONE OF THE THINGS HE DOES OR SHE DOES IS NOT SPEAK AS MUCH AS EVERYONE ELSE.

YOU LISTEN TO WHAT YOUR COLLEAGUES SAY.

I DON'T WANT TO REPEAT WHAT SOMEONE ELSE HAS SAID.

I THINK A LOT OF PEOPLE WHEN THEY'RE SPEEDING THROUGH ARE VISITORS.

WHETHER YOU WANT TO CALL IT ON A POST-COVID NEED TO SPEED OR THEY WANT TO GET SOMEWHERE FASTER, WHATEVER SIT GOING TO BE, THERE'S AN INCREASE ALL OVER THE COUNTRY, NOT JUST MANHATTAN BEACH.

WE'VE ALL SEEN IT.

I DON'T THINK L.A.'S TRAFFIC IS SAFE.

NOTHING THEY TALK ABOUT WORK IN SWEDEN WORKS IN MANHATTAN BEACH OR THE SOUTH BAY OR L.A. AT ALL.

AS STEVE MENTIONED, THE DEATHS INCREASED.

THIS IS NOT WHAT WE LOOK TO TO SAVE US.

THEY'VE ALL BEEN A COMPLETE FAILURE.

TAKING THAT AWAY FROM IT, WE CONTROL OUR OWN DESTINY HERE AND WE LOOK AT THINGS DO.

OUR PARTNERSHIP IS NOT JUST BETWEEN YOU AND ME AND ALL OF US AND YOU.

IT'S THE POLICE DEPARTMENT, THE ENFORCEMENT OF THE STOP SIGNS.

I'LL TAKE THE LONGER VIEW AND SAY WE'RE GOING TO SEE ERIK AGAIN SAYING THERE HASN'T BEEN ENOUGH.

EVEN IF WE ORDER, TO ALAN'S POINT, WE DON'T ORDER THE RAISED CURB AND IT SHOWS UP THE NEXT DAY.

YOU HAVE TO ORDER THAT.

SIX MONTHS BECOMES A YEAR.

DON'T THINK SIX MONTHS IN A DAY THEY'RE GOING TO INCREASE THESE ITEMS, IT DOESN'T WORK THAT WAY.

I WOULD RATHER HAVE THEM ON HAND SO WHEN WE REALIZE THAT IT'S NOT WORKING THE WAY WE WANT IT TO BE, THEY'RE READY TO GO.

BUT THAT BEING SAID, I CAN TELL YOU THE NUMBER OF TIMES THEY NIECE RIDES OVER THERE.

THEY BELIEVE IN THE FORCE FIELD BY WATCHING STORES WARS AND THE MANDALORIAN.

THIS IS REALITY AND THE CAR NEXT TO THEM.

IF I HAD A CHOICE I WOULD WIPE ALL OF THAT OUT AND PUSH THOSE TO THE INSIDE LANE.

NOW THE RESIDENTS WON'T LIKE THE CAR PARKING.

BUT IF SAFETY IS A GOAL YOU SHOULD NOT HAVE A CAR THIS CLOSE TO SOMEBODY RIDING A BIKE.

I WOULD WIPE IT ALL OUT AND PUSH TIGHT TIN SIDE CORNER, INSIDE STREET.

THIS IS A GOOD FIRST STEP.

I AGREE WITH ALL OF MY COLLEAGUES HERE.

THIS IS A GOOD FIRST STEP.

YOU'LL START SEEING THINGS CHANGE.

PEOPLE WILL LEARN WHERE THE STOP SIGNS ARE AND CHIEF WILL HAVE OFFICERS OUT THERE.

BUT HERE WE GO, IT'S A GOOD FIRST STEP.

LET'S GET IT STARTED AND WE'LL BE BACK SIX MONTHS AGAIN.

WITH THAT WE'LL DO A ROLL CALL VOTE.

>> JUST TO BE CLEAR, IT'S SIX MONTHS AFTER THE INSTALLATION, NOT FROM TODAY.

>> Mayor Montgomery: YES, NO.

CORRECT.

SIX MONTHS FROM WHEN THEY ACTUALLY GO IN THE GROUND WE'RE GOING TO SEE ERIK AGAIN AND MOST OF YOU ALL AGAIN.

STEP SOMEONE IS SIX MONTHS FROM WHEN THEY GO IN THE GROUND, NOT TODAY.

DID WE TALK ABOUT -- EVERYONE STOP FOR A SECOND.

WHEN DID WE SAY WHEN INSTALLATION IS GOING IN?

DO WE KNOW YET?

DO WE HAVE AN IDEA OF A PROJECTED DATE OF WHEN IT'S GOING THE GROUND?

>> STOP SIGN IS A FAIRLY EASY REQUEST AND WE CAN GET A STOP SIGN IN AFTER THE RESOLUTION IS PASSED.

WE HAVE THE SIGNS IN STOCK, IT PROBABLY WOULDN'T TAKE MORE THAN

A MONTH.

>> Mayor Montgomery: FANTASTIC THAT'S GREAT NEWS.

SO NO SHIPPING DELAYS ON THE STOP SIGN.

WE'RE ALL DONE.

WE ALL VOTED.

WE ALL PUSHED OUR SCREENS.

THERE WE GO.

>> MOTION PASSES 5-0.

>> Mayor Montgomery: THANK YOU ALL FOR BEING HERE.

APPRECIATE IT.

HAVE A GOOD NIGHT.

THANK AMBER FOR US.

>> Councilmember Howorth: DON'T DO IT RIGHT NOW.

TELL MY DOCTOR.

>> Mayor Montgomery: CAN WE TAKE A FIVE-MINUTE BREAK AND COME

BACK FOR THE LAST ITEM?

WE'RE GOING TO BREAK FIVE MINUTES AND COME BACK.

[BRIEF RECESS]

>> Mayor Montgomery: EVERYBODY, WELCOME BACK.

RECONVENE OPEN SESSION.

ITEM 14, UPDATE THE CITY COYOTE MANAGEMENT PLAN.

CITY MANAGER BRUCE MOE.

>> GEORGE GABRIEL WILL HANDLE THE PRESENTATION.

>> GEORGE GABRIEL, ASSISTANT TO THE CITY MANAGER.

THIS REPORT IS AN UPDATE ON THE CITY'S COYOTE MANAGEMENT REPORT
AS WELL AS A RESOLUTION WITH MICHAEL BAKER INTERNATIONAL TO
PROVIDE ENVIRONMENTAL CONSULTING SERVICES FOR THE COYOTE
MANAGEMENT AND RESPONSE PLAN WITH A NOT TO EXCEED AMOUNT OF
\$35,000.

THIS ITEM IS RETURNING TO YOU FOLLOWING THE APRIL 2023 COUNCIL DIRECTION WHICH THEY ASKED FOR STAFF TO RETURN WITH THE ENVIRONMENTAL CONTRACT FOR THE COYOTE RESPONSE PLAN CONSIDERED BY THE COUNCIL.

CONSISTENT WITH PRIOR UPDATES I WANT TO GO OVER THE CITY'S

OBSERVATION DAY TO THE FRAME IT FOR THE CITY COUNCIL AS WELL AS

THE MAPPING THAT I TYPICALLY PROVIDE TO THE CITY COUNCIL FOR

THEIR AWARENESS.

AND SO IF YOU CAN SHOW THE ATTACHMENT, PLEASE.

SO FIRST, THE COYOTE OBSERVATION DATA IS BROKEN DOWN INTO PERIODS.

ONE IS AN ANNUAL BREAKDOWN FROM 2016 TO 2023 AND SLIGHT MODIFICATION TO THE 2023 COLUMN.

THAT'S ACTUALLY JANUARY THROUGH MAY.

AND SO AS YOU CAN SEE, THE DATA SUGGESTS THERE'S AN INCREASE FROM 2016 TO 2020 BUT WE'RE SLIGHTLY IN LINE WITH 2022, MAYBE A SLIGHT INCREASE FROM 2022 IN TERMS OF INTERACTIONS OR OBSERVATIONS.

DO WANT TO CAUTION THE CITY COUNCIL IN LOOKING AT THAT DATA AS

TO REPORTED SIGHTINGS.

THE CITY HAS ASKED RESIDENTS TO REPORT SIGHTING AS WELL AS

ASKING RESIDENTS TO REPORT THEM ON THE CITY'S GO REACH

APPLICATION AND A LOT OF PROMOTION VIA HANG TAGS, POST CARDS,

ALL OF THAT.

AND SO THAT OBSERVATION DATA CAN BE SLIGHTLY MISLEADING BECAUSE IT DOESN'T ACCOUNT FOR DUPLICATIONS.

THAT BEING SAID, THE NUMBER DOES LOOK LIKE IT'S GOING TO BE INCREASING FROM THE PRIOR YEAR AND TRENDING ABOVE.

IN TERMS OF UNCONFIRMED AND CONFIRMED PREDATION, THAT NUMBER IS PRETTY MUCH MANY LINE.

MARTHA, IF YOU COULD SCROLL DOWN, PLEASE.

AND SO THAT DATA FOCUSES ON THE LAST TWO YEARS WHEN THE CITY

COUNCIL HAS BEEN ADDRESSING COYOTE OBSERVATIONS PRETTY STARKLY.

AND SO YOU CAN SEE IN 2022 THAT DATA BROKEN DOWN THE SAME WAY ON

A MONTHLY BASIS.

2023 WE HAVE DATA FROM JANUARY TO MAY, RECORDED SIGHTING IS SOMEWHERE IN LINE, UNCONFIRMED PREDATIONS IN LINE WITH A SLIGHT UPTICK IN MAY.

AS OF RIGHT NOW THE DATA SUGGESTS THAT WHY THERE IS AN INCREASE,
THERE COULD BE AN INCREASED PRESENCE, THERE'S NO STARK
TRAJECTORY THAT INDICATES THERE'S A LARGE INCREASE FROM THE
PRIOR YEAR.

MARTHA, IF YOU CAN SHOW THE MAP AS WELL, PLEASE.

SO ADDITIONALLY WHAT THE CITY DOES IN TERMS OF LOOKING AT THEIR DATA, WE HAVE AN OBSERVATION DATA MAP SO IT BREAKS IT DOWN INTO WHAT PLACE OF THE CITY THESE REPORTED SIGHTS ON CONFIRM PREDATIONS ARE OCCURRING.

THERE SEEMS TO BE A SLIGHT CONCENTRATION IN THE NORTHEAST

QUADRANT OF THE CITY NEAR THE MANHATTAN VILLAGE AREA AND THE

SOUTHEAST AS WELL.

THAT'S SOMEWHAT IN LINE WITH WHAT OUR CONSULTANT INDICATED.

THERE COULD BE COYOTE PACKS COMING INTO THE CITY IN THOSE AREAS.

ANIMAL CONTROL OFFICERS WITH THE MANHATTAN BEACH POLICE OFFICER

CONTINUED TO MONITOR, INVESTIGATE AND EDUCATE THE COMMUNITY ON

COYOTE ACTIVITY.

AND SO I'LL SWITCH GEARS FROM HERE AND KIND OF GO INTO THE CONTRACT THAT IS UP FOR CITY COUNCIL CONSIDERATION.

SO CONSISTENT WITH WHAT STAFF INDICATED IN THE PRIOR REPORT, AN ENVIRONMENTAL ANALYSIS WOULD NEED TO OCCUR PRIOR TO A FORMAL APPROVAL OF THE COYOTE MANAGEMENT RESPONSE PLAN.

STAFF SOLICITED PROPOSALS FROM 19 QUALIFIED FIRMS IN ACCORDANCE WITH CEQA, STAFF PROVIDED ONE MONTH FOR CONSULTANTS AND GOT A RESPONSE FROM ONE FIRM, MICHAEL BAKER INTERNATIONAL TO PROVIDE THE ENVIRONMENTAL CONSULTANT SERVICES.

MICHAEL BAKER DEMONSTRATED A CLEAR UNDERSTANDING OF THE SCOPE OF WORK AND PROVIDED THE DETAILED METHODOLOGY FOR COMPLETING THE REQUISITE STUDIES.

CURRENTLY THEY'RE WORKING ON THE SCOUT HOUSE PROJECT ADDS WELL.

THAT BEING SAID, PURSUANT TO THE COYOTE MANAGEMENT PLAN, MICHAEL

BAKER HAS WORKED WITH OTHER JURISDICTIONS, INCLUDING THE CITY OF

PASADENA.

THAT WOULD CONCLUDE MY PRESENTATION TONIGHT AND IF YOU HAVE ANY QUESTIONS I'M AVAILABLE AS WELL AS TALYN MIRZAKHANIAN ON THE CEQA FRONT.

STAFF RECOMMENDS THAT THE CITY COUNCIL RECEIVE THE UPDATE, ADOPT THE RESOLUTION APPROVING THE AGREEMENT AS WELL AS APPROPRIATE THE NECESSARY FUNDS FROM THE RESERVE BALANCE.

>> Mayor Montgomery: COUNCILMEMBER HOWORTH.

>> Councilmember Howorth: JUST SO EVERYBODY UNDERSTANDS IN THE PUBLIC, THE \$35,970 FOR THE CONSULTANT IS ONLY FOR THE ENVIRONMENTAL REVIEW THAT IS REQUIRED IN ORDER FOR US TO PROCEED WITH THE INTERSECTION THAT COUNCIL GAVE.

MAKING SURE THAT PEOPLE UNDERSTAND THIS IS NOT GOING TO IMPLEMENT ANY NEW METHODS OF CONTROL.

THAT IS THE NEXT STEP THAT WE HAVE TO TAKE.

SO THAT'S NUMBER ONE.

OKAY.

SO I HAVE A QUESTION, I KNOW THAT OBVIOUSLY WE SHARE BORDERS WITH EVERY OTHER COMMUNITY.

DO PEOPLE FROM OTHER CITIES SPEAK TO EACH OTHER AND SAY HERE IS WHERE OUR COYOTES ARE?

YOU ALL SHARE THAT INFORMATION.

>> OUR ANIMAL CONTROL DIVISION FREQUENTLY INTERACTS WITH -- I
DON'T KNOW IF THEY HAVE ONE IN HERMOSA.

BUT WE'VE HAD INFORMATION SHARING SESSIONS AND IN FACT HOSTED

EVENTS SO THAT REDONDO AND HERMOSA BEACH COULD ATTEND -- NOT

ONLY THE CONSULTANT WAS HERE FOR AN ANALYSIS ON HOW TO ADDRESS

COYOTES BUT THE CONSULTANT AS WELL AS THE CALIFORNIA DEPARTMENT

OF FISH AND WILDLIFE WERE HERE.

THERE WAS TWO SESSIONS WHERE THERE WAS INFORMATION SHARING GOING ON.

THERE IS FREQUENT INTERACTION.

EACH CITY IS DIFFERENT IN HOW THEY GO ABOUT ADDRESSING THEIR COYOTE MANAGEMENT RESPONSE AND HOW THEIR PRIORITIZE IT.

>> Councilmember Howorth: ONE REASON I ASK AND OBVIOUSLY IT'S A
LITTLE FURTHER EAST ON ROSECRANS BUT THIS PAST WEEKEND I DID A
TEST DRIVE OF A VEHICLE AND THEY SAID GO OVER TO THE HOBBY LOBBY
PARKING LOT.

THAT'S WHERE WE'RE GOING TO TEST IT BUT WATCH OUT FOR THE KITTIES.

WHAT?

WE STARTED SEEING ALL OF THESE CATS.

SOME PEOPLE DECIDED THAT'S A REALLY GREAT PLACE -- THERE'S A HEDGE AND THERE'S LITTLE CAT CRATES IN THERE AND LITTLE DISHES AND THERE'S ALL OF THESE CATS.

PEOPLE ARE FEEDING THEM.

AND I KNOW THAT -- IT WAS SORT OF THE PROOF THAT YOU HAD SAID LIKE IN THE VILLAGE OR IN OTHER PLACES, YOU KNOW, THEY MAKE LITTLE HOMES FOR THEM OR FEED THE FERAL CATS.

WE'RE STILL GOING TO CONTINUE THAT EDUCATION NO MATTER WHAT HAPPENS, CORRECT?

>> CORRECT.

WE WILL TAKE NOTE OF THAT FERAL CAT HABITAT.

- >> Councilmember Howorth: I WAS REALLY -- AND THEN I STARTED
 GOING OFF AND THE GUY WAS LIKE, I SHOULDN'T HAVE SAID ANYTHING.
 THANK YOU.
- >> Mayor Montgomery: COUNCILMEMBER LESSER.
- >> Councilmember Lesser: CAN YOU JUST SUMMARIZE WHAT STEPS MUST
 BE UNDERTAKEN BEFORE TRAPS WOULD BE CONSIDERED UPON COMPLETION
 OF THE ENVIRONMENTAL REPORT ASSUMING THERE'S NO FURTHER
 AMENDMENT TO THE COYOTE MATH PLAN.
- >> WHAT WOULD ELICIT IT A TRAPPING SITUATION?

THE COYOTE MANAGEMENT PLAN HAS -- SO THE COYOTE MANAGEMENT PLAN INDICATES WHETHER THE FACTORS INCLUDE WHETHER THE COYOTE IS ACTING IN AN AGGRESSIVE WAY, WHETHER THERE IS AN ATTRACTANT PRESENCE THAT ELICITS THAT BEHAVIOR, IF THERE'S HUMAN BEHAVIOR AFFECTING THAT COYOTE'S BEHAVIOR AS WELL.

DEPENDING ON A VARIETY OF CIRCUMSTANCES, A SIMPLE CITING DOES NOT INDICATE NECESSARILY A TRAPPING ACTION.

WHAT WOULD ELICIT A TRAPPING CONSIDERATION AT THE VERY LEAST IS

AN AGGRESSIVE COYOTE IN A YARD AND THERE CANNOT BE AN ATTRACTANT

THAT IS PRESENCE.

WHAT WE'RE TRYING TO DISTINGUISH IS BETWEEN COYOTE BEHAVIOR ACTING NORMAL VERSUS ABNORMAL.

WHAT WE'RE HOPING WITH THE COYOTE MANAGEMENT RESPONSE PLAN DRAFT
THAT COUNCIL HAS CONSIDERED IS THAT COYOTE BEHAVIOR THAT IS
AGGRESSIVE AND THAT IS ABNORMAL, THAT IS WHERE A TRAPPING
CONSIDERATION WILL BE CONSIDERED.

>> Councilmember Lesser: CONSISTENT WITH WHAT COUNCILMEMBER
HOWORTH JUST DESCRIBED, IN TERMS OF INDIVIDUALS NOT REALIZING
THAT THEY'RE CREATING A FOOD SOURCE AND NOT TRIMMING BACK HEDGES
AND SUCH WHICH MAKES FOR NESTING SITES OR DEN SITES, EXCUSE ME,
FOR COYOTE.

WHAT IS NEXT PLAN FOR CITY STAFF OR THE ONGOING EFFORTS BY CITY STAFF TO UP ITS GAME IN TERMS OF OUTREACH TO THE COMMUNITY AND FOLLOW UP ON THESE SITES WHERE PEOPLE ARE IN FACT NOT WITHSTANDING THE OUTREACH, STILL ENGAGING IN OFFERING FOOD AND SAFE HARBOR.

>> STAFF IN THE PAST HAS TAKEN SOMEWHAT OF A REACTIVE RESPONSE

IN TERMS OF WHEN THERE IS A COYOTE SIGHTING OR THERE IS A REPORT

OF A COYOTE, THEY'LL DO INVESTIGATIVE WORK AS TO WHAT CAN BE

DONE TO MITIGATE THOSE COYOTE OBSERVATIONS.

OBVIOUSLY SINCE 2022, JULY 2022, I THINK STAFF HAS TAKEN A MORE

AGGRESSIVE ROLE IN TERMS OF BEING A LITTLE MORE PROACTIVE ON ADDRESSING OUR COYOTE RESPONSE.

ON AN ONGOING BASIS IT'S GOING TO CONTINUE TO OCCUR AND THAT
PROACTIVE RESPONSE IS OBVIOUSLY WHENEVER THERE IS COYOTE
SIGHTINGS, TALKING TO THE NEIGHBORHOOD WHERE THAT COYOTE
OBSERVATION OCCURRED, PLACING A DOOR TAG OR A DOOR HANG TAG
SAYING THAT THERE WAS A RECENT COYOTE OBSERVATION AND ESPECIALLY
WHEN THERE'S UNCONFIRMED PREDATIONS, OR ANIMAL CONTROL OFFICER
IS DOING AN ADMIRABLE JOB OF WHAT WAS THE CAUSE OF IT.
SO THERE IS, YOU KNOW, DOWN TO THE DETAIL OF, YOU KNOW,
CONTACTING A LOCAL VETERINARIAN AND GETTING AN ANALYSIS ON, YOU
KNOW, HOW COULD THIS HAVE OCCURRED.

COULD IT HAVE OCCURRED BLUNT TRAUMA VIA A VEHICLE, COULD THIS HAVE OCCURRED VIA A COYOTE BITING INTO IT.

OUR ANIMAL CONTROL OFFICERS DO A DETAIL JOB.

- >> Mayor Montgomery: GEORGE, TWO QUESTIONS.
- IS THE COMMUNITY MANAGEMENT PLAN ON OUR WEBSITE?
- >> IT IS.
- >> Mayor Montgomery: NOTHING CHANGED THERE.

CAN YOU GO BACK TO THE SLIDE WHERE THE YEAR OVER YEAR COMPARISON, COYOTE SIGHTINGS '22 VERSUS '23, PLEASE. THE KEY NUMBERS JUMP OUT AT ME.

LOOK AT THE DIFFERENCE.

SHOULD BE ONE MORE SLIDE.

THERE WE GO.

THE NUMBERS HAVE DROPPED ALMOST IN HALF, A LITTLE OVER HALF.

WE HAVEN'T GONE TO THE MIDDLE OF -- WE'RE IN JULY, THE DRIEST PART.

MAYBE AUGUST.

IT'S GOOD.

WHETHER THAT'S BECAUSE WE'RE NOT REPEATING DUAL SIGHTINGS OR,
TWO, THE COYOTES HAVE MOVED ON TO BETTER GROUNDS.

WE'VE GONE AWAY FROM FEEDING THE FERAL CATS.

MAYBE THE COMBINATION OF THEM.

BUT I'M LEERY OF PUSHING OUT THERE THAT WE CONSTANTLY HAVE A COYOTE PROBLEM.

LOOKING AT THE DATA, IT'S NOT TRUE, COMPARED TO WHAT IT WAS LAST YEAR OR A YEAR-TO-YEAR COMPARISON.

EDUCATION IS GREAT BUT IF PEOPLE TAKE THEIR FOOD AWAY, DON'T PUT IT OUT THERE, FEEDING EVERY STRAY CAT THAT GOES BY AND THERE'S A HEDGE NUMBER IN THERE FOR DUAL REPORTING.

WE CAN REPORT IT TO THE NEWSPAPER AND THE MEDIA.

HERE ARE THE NUMBERS.

YOU'RE ASSUMING EVERYBODY REPORTS BUT THERE IS DUAL REPORTING.

- I LIKE THE EDUCATION PART OF IT.
- I THINK IT'S KEY.
- I'M OBVIOUSLY IN FAVOR OF THE PLAN.

THE WAY THE NUMBERS ARE GOING, THAT'S NOT OUR ISSUE YET.

I'M KNOCKING ON WOOD WHEN I SAY THAT AND I HOPE IT STAYS THAT WAY.

>> Councilmember Napolitano: DOES [INDISCERNIBLE] DO THE COYOTE REPORTS AS WELL?

>> Mayor Montgomery: I'M NOT GOING TO GO THAT WAY.

I'M GOING TO OPEN UP TO PUBLIC COMMENT.

HOW ABOUT ON ZOOM.

PLEASE.

WHY NOT.

YOU HAVE THE WHOLE PLACE TO YOURSELF.

PERFECT.

>> SO MY NAME IS SHANNA AND I'M A LONG-TERM RESIDENT HERE.

KNOW STEVE FROM HIGH SCHOOL.

WELCOME, EVERYBODY.

NICE TO MEET ALL OF YOU MANY PERSON.

JUST IN MY NEIGHBORHOOD LAST WEEK WE HAD TWO CATS KILLED BY A COYOTE.

AND I THINK THERE'S SOME HESITANCY FOR PEOPLE REPORTING BECAUSE
THEY THINK THERE'S SOME PEOPLE WHO FEEL THAT IT WILL LEAD TO
CALLING OF THE COYOTE AND THEY'RE ANIMAL LOVERS.

WE NEED TO MAYBE THINK ABOUT THAT.

AND I THINK IF YOU READ NEXT DOOR, SOME OF THE COMMENTS OF THE PEOPLE WHO HAVE LOST THEIR PETS IS HEARTBREAKING.

I AM NOT SURE WHAT WE'RE SAYING ABOUT NOT -- WELL, WHEN I READ

SOME OF THE INFORMATION OUT THERE, THE COYOTE BEHAVIOR BECOMES MORE AGGRESSIVE, MORE AGGRESSIVE AND THAT'S FROM CAL STATE PEST CONTROL.

AND SO MY CONCERN -- SORRY.

I'M NERVOUS TO TALK.

MY CONCERN IS THAT WE'RE SEEING SO MANY CATS KILLED, WHETHER THEY'RE BEING REPORTED OR NOT, IT'S COMMON KNOWLEDGE IN THE NEIGHBORHOODS.

PEOPLE ARE TALKING ABOUT IT.

THE REPORTING IS -- THE NEW REPORTING HAS JUST COME UP.

I THINK THAT'S NEW FOR THE ANIMAL CONTROL REPORTING.

I THINK WE NEED TO BE MORE AGGRESSIVE IN WHAT WE'RE DOING,
WHETHER IT'S CULLING THEM, WHETHER IT'S EDUCATING, TAKING A LOOK
AT WHAT LAND ARE WE TAKING AWAY FROM THE COYOTE.

WE'VE NEVER HAD THIS PROBLEM BEFORE.

THIS IS A NEW PROBLEM.

SOMETHING HAS CHANGED IN OUR NEIGHBORHOODS.

I DON'T KNOW THAT IT'S NECESSARILY FEEDING FERAL CATS.

THAT'S BEEN GOING ON FOREVER.

WE HAVE A LOT OF CAT LOVERS.

THE FACT THAT WE'VE SEEN THEM ON PACIFIC PLAYGROUND, THE NEXT THING IS, ACCORDING TO CAL STATE, IS THAT THE COYOTE BEHAVIOR BECOMES MORE AGGRESSIVE AND IT NEXT COULD BE A SMALL CHILD.

WE HAVE A LOT MORE SMALL CHILDREN OUR NEIGHBORHOODS THAN WE HAVE

HAD IN THE LAST 20 YEARS AND I THINK IT'S IMPORTANT THAT WE GET AGGRESSIVE.

>> Mayor Montgomery: BEFORE YOU GO, ONE QUESTION.

THE CATS YOU MENTION, THEY DON'T REPORT THEM.

ARE THEY FERAL CATS OR HOUSE CATS?

>> HOUSE CATS.

ONE WAS DEXTER.

I HAVE THREE CATS.

I BRING THEM INSIDE AT NIGHT ALWAYS.

BUT DURING THE DAY I'M WORRIED ABOUT THEM BEING IN MY BACK YARD DURING THE DAY.

>> Mayor Montgomery: PLEASE TELL ALL OF YOUR NEIGHBORS TO TALK TO US.

I DON'T READ NEXT DOOR.

WE NEED TO FIND OUT.

WE NEED TO KNOW.

THIS PUTS A PLAN IN PLACE.

>> THESE NUMBERS ARE FOR HALF A YEAR.

WE'RE GOING INTO THE SUMMER WHERE WE HAVE YOUNG ADOLESCENT PUPS.

SO THEY'RE LOW RIGHT NOW BY IT'S NOT EVEN HALF A YEAR.

OR IT'S JUST A HALF A YEAR AT THIS POINT.

>> Mayor Montgomery: THANK YOU VERY MUCH.

APPRECIATE IT.

>> SORRY TO BE NERVOUS TO TALK.

- >> Mayor Montgomery: YOU DID A GREAT JOB.
- WE CAN ASK YOU STORIES ABOUT STEVE LATER.
