WALK STREET TARGETED OUTREACH

Outreach Scope

- Expanded from 6 to 15 commercial corners:
 - Provide equitable opportunities to other parcels that may change uses
 - If supported by public, planned to maintain baseline of max. 6; first-come, first-serve
- Outreach targeted to parcels along same block as the 15 commercial corners
 - Survey and Focus Group meetings



WALK STREET COMMERCIAL CORNERS

Outreach Results

Majority strongly opposed to the idea on all corners despite proposed mitigation measures

Concerned with:

Noise, vermin, parking, traffic, pedestrian congestion, quality of life, privacy, property value, change in character, proximity to residences

Public Realm Development Standards & Design Guidelines

Enhance public spaces that activate the environment on select corners adjacent to commercial uses

Community Input (Concerns)

- Sidewalks are narrow and congested
- On-street decks cause numerous issues:
 visual blight, maintenance, drainage flow,
 vermin, visibility and access, eliminate parking
- Parking/Traffic get worse with increased occupancy
- Trash/Noise



Community Input (Concerns)

- Sidewalks are narrow and congested
- On-street decks cause numerous issues (e.g., visual blight, maintenance, drainage flow, vermin, visibility and access, eliminate parking)
- Parking/Traffic issues with increased occupancy
 - Trash/Noise

Potential Solution and Long-Term Vision

Permanent Sidewalk Widening




Sidewalk Widening

- Addresses community input on narrow sidewalks
- Allow sidewalk dining adjacent to establishments
 - >> No utility connection concerns, less congested sidewalks, clear path of travel for pedestrians, unified layout
- Reduces various issues related to on-street decks
- Creates more opportunities to serve the public with flexible uses when sidewalk dining is not occurring
- o Provides curbside passenger access for parked cars
- Reduces need for access ramps to/from dining area




Sidewalk Widening





Before After





















Sidewalk widening example on slope









Reconfigure On-Street Parking

 Remove, add, and reconfigure spaces from angled to parallel or vice versa

Identify Potential Dining/Seating Areas

- Based on establishments that participated in temp.
 program and available space in the vicinity
- Identify new public seating areas for other uses



Two-Phased Approach on Right-of-Way

- Long-Term: Mostly sidewalk dining with few on-street decks where sidewalk cannot be widened
- Short-Term??

Long-Term Vision Implementation

 As a major public improvement, requires City Council approval to allocate funds and plan build out over a period of time

Outdoor Dining Defined

Open air "al fresco" dining on sidewalks, dining decks, rooftops, and in public parklets in which the experience:

- Allows for opportunities to enjoy the pleasant weather and scenic ocean views
- Promotes a sense of community and interaction with others
- Enhances the ambiance of the small town character of Manhattan Beach
- Balances community vibrancy with residential quality of life



TASK FORCE DISCUSSIONS

Public Right-of-Way Improvements

1. What menu of options should be included as part of the public realm development?

Example: Benches, chairs, tables, public art, bike racks, trees, lighting, etc

2. Should there be any special considerations?

Example: Limited number of street furniture, porter service, distance from adjacent parcel, etc
