MEETING MINUTES

February 27th Task Force Meeting Consensus


- Refer to existing permits without creating new applications
- Hours: 9am to 10pm
- Set noise level standards
- Live outdoor entertainment shall be limited to special events only with permit
- Allow ambient music in public right-of-way (i.e., sidewalk dining area) with permits where speakers are located on private property

- Allowed in certain areas with a Use Permit
- Outdoor dining area shall not face residential uses
- Must provide a sound attenuation plan
- No balconies allowed over public right-of-way
- Outdoor dining defined as dining area with more than one wall open to the outside



Hermosa Beach Case Study



Municipal Code Section (17.26.050b): Commercial Zone - Standards and Limitations

- Allowed with permit approval from the community development department
- Outdoor seating not be arranged to create food courts





Hermosa Beach Case Study



- No entertainment, music, speakers, televisions, or audio or visual media allowed
- Noise shall not create a nuisance to surrounding residential neighborhoods, and/or commercial establishments


The Tower Bar Restaurant

Municipal Code Section (19.36.235) Outdoor Commercial Uses Above the Ground Floor

 New or expanded (including expanded hours of operation) for an outdoor dining or seating area for commercial uses shall require approval of an administrative permit



West Hollywood Case Study



- Lighting must prevent glare or direct illumination
- Acoustical wall is required around the perimeter of the outdoor use
- Planters and similar structures shall be provided
- Physical elements that are visible shall be compatible with overall design of main structure

Laguna Beach Case Study

- Rooftop Dining Standards proposed at City Council Meeting – (July 2022)
 - Rooftop furniture setback and screening
 - Dining area 8ft back from edge of building
- Outdoor heaters
 incorporated in rooftop
 furniture such as
 umbrellas or a fixed
 overhead shade
 structure
- Moveable heaters and propane tanks are not permitted








Where are public flex spaces possible in Downtown?













2nd FLOOR OUTDOOR DINING



- Outdoor permitted in certain areas with a Use Permit
- Outdoor dining area shall not face residential uses
- Must provide a sound attenuation plan
- No balconies allowed over public right-of-way
- Outdoor dining defined as dining area with more than one wall open to the outside


