Your decision to have the approximate cost estimate done by city employees was so beneficial as we did not have to approve \$91k initially for another consultant.

The official estimates given were Anywhere from \$7.6 to \$12.5 MILLION

Dear Mayor Franklin and Council Members:

I would like to offer a few thoughts regarding this evening's Public Hearing Related to EV Charging Cost Recovery.

Disclosure: I have owned an EV for the past 10 years and I have occasionally used the City's EV charging infrastructure. I used the City's EV chargers more frequently in the earlier years (when the chargers were readily available) and much less frequently in recent years (they seem to be always in use).

Yes, the City should charge to recover the cost of electricity and infrastructure. Perhaps free EV charging made sense 10 years ago as an incentive for drivers to acquire and operate EV to benefit the environment. However, EV adoption is clearly well past the tipping point in MB that we need to offer such incentives.

Observation and Analysis: I believe the staff report and Matrix Consulting recommendations are flawed in assuming that the City will recover \$182,000 per year by instituting a fee of 51 cents / kWh. A basic premise of economics teaches that as price increases, demand/utilization decreases. Thus, as you increase the price from zero to 51 cents / kWh, utilization will almost certainly decrease. EV owners have many alternatives for charging their cars in the immediate area including home chargers and commercial chargers (e.g., EVGo, ChargePoint, ElectrifyAmerica, and Tesla Superchargers), with prices ranging from ~ 19 cents / kWh during off-peak hours to ~54 cents / kWh during peak times. Tesla has 24 Supercharger stalls at Manhattan Village Mall and another 20 Supercharger stalls in Hermosa Beach underneath Vons. See attached map for additional commercial charging locations.

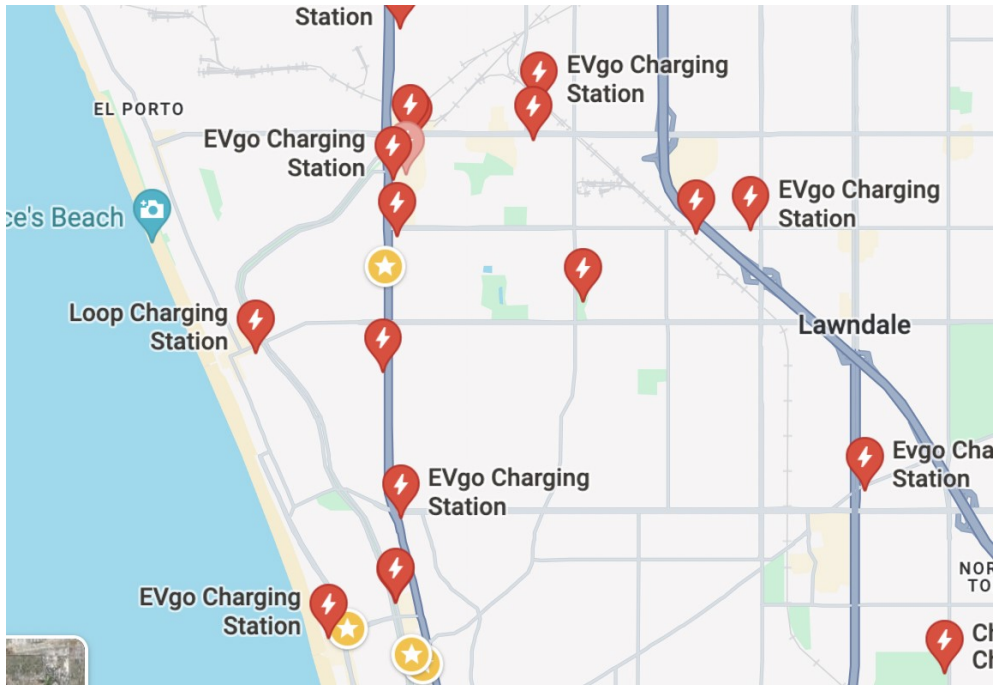
So, the revenue projections are almost certainly high if, in fact, utilization declines as you increase the price of usage. Of course, the variable cost of the program (i.e., electricity cost) will also decline with decreased usage. However, your fixed costs will generally remain constant.

Questions:

1. Has the City considered variable pricing based on time-of-use, as the commercial charging networks use?
2. Has the City considered de-risking this program by partnering with a commercial charging network operator on a revenue sharing basis? This would take workload off of our Public Works staff, eliminate any financial risk to the City, eliminate the burden of fee collections, maintenance, etc.?

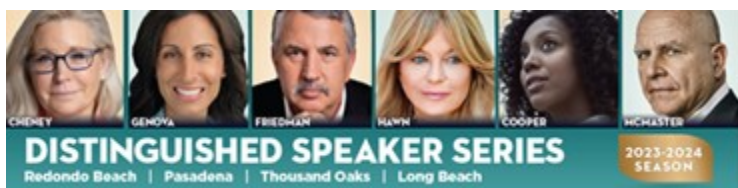
