Mayor Franklin: Thank you. Welcome to the City Council Adjourned Regular Meeting of Monday, April 8th, at 5:00 PM. We need someone to lead the Pledge. City Attorney Quinn Barrow can lead that for us.

City Attorney Barrow: Put your hand over your heart, begin.

Mayor Franklin: Okay.

Councilmember Napolitano: Slowed it down.

Mayor Franklin: May we have a roll call please?

City Clerk Alvarez: Councilmember Lesser?

Councilmember Lesser: Here

City Clerk Alvarez: Councilmember Napolitano?

Councilmember Napolitano: Here

City Clerk Alvarez: Councilmember Montgomery?

Councilmember Montgomery: Here

City Clerk Alvarez: Mayor Pro Tem Howorth?

Mayor Pro Tem Howorth: Present.

City Clerk Alvarez: Mayor Franklin?

Mayor Franklin: Here. Could I call for a motion to approve the agenda?

Councilmember Lesser: So moved.

Mayor Franklin: Moved by Councilmember David Lesser and seconded by Councilmember Richard Montgomery.

Councilmember Napolitano: Is this the Al version of Councilmember Montgomery?

Mayor Pro Tem Howorth: What's that?

Councilmember Napolitano: No teleconference?

City Clerk Alvarez: For the two participants via Zoom, if you would like to provide Public Comments, please raise your hand. We have Asiye.

Mayor Franklin: Okay.

Asiye: Yes. I'm sorry. I'm just learning how to use this Zoom. Okay, my name is Asiye and I am attending from Orange County because my business is in LA. So that's why I follow all the cities, City Council meetings and I would like to add the comment on public privacy and safety in terms of schools and some of the city public locations like parks or recreation centers. Where I have 4 kids and safety and privacy always comes first, even when we're in public. We have been working with a different school district around Southern California, Northern California. For us safety and privacy, mostly for privacy and for the product will cover school's play yards, where there's been a lot of issues with different school districts. The intruders are contacting with children while they're playing on the play yard. Especially elementary level and middle school. Younger generations. Because many schools don't have a lot of teachers to watch children while they're playing on the yard. Due to that reason, intruders are contacting kids through the fence because they are visible. We have schools come up to with a lot of problems, the drug issues. We've been servicing schools with chain link fence, artificial grass combined together to protect our children for their privacy so nobody can contact from outside while they're on the yard. We've been servicing with the

schools with this product where, it's, I can't show you because my camera is not visible. My company is named grasstik.com. We are an artificial chain link fence company, where chain link and artificial grass combined together. It gives you privacy and safety in your environment and it also changes your environment because the color is green.
