There are wonderful things about e-bikes. But like any new technology, the problems emerge only after they are adopted and begin to be abused. (Think about cell phones for a minute.)

Kids on e-bikes have become a menace in the South Bay, especially around the Strand. This is our greatest shared resource, and it can't be allowed to be turned into a zone of lawlessness and danger for anyone. Unfortunately, the various police departments have not approached this problem with the seriousness it deserves or the tactics that will actually improve the situation. I don't know who thought it was a good idea to offer five dollar Starbucks gift certificates in exchange for the restraint of middle school boys, but that was frankly ridiculous.

The solution seems self-evident. These are motorized vehicles. And they should be treated like every other motorized vehicle. They should be required to be registered and plated. There should be a prominent license plate in the front and the back that the police and citizens can easily photograph to identify perps. If a vehicle is stopped without plates or the registration, it should be impounded. Serial violations should result in the permanent impoundment of the vehicle.

The problem is that there is too much speed and anonymity in the hands of young boys. They will abuse it. And for the police department to treat these crime sprees as though they are primarily a traffic issue is not helpful. But if the perpetrators can be identified by their license plate, their parents can be confronted and fined. And then the kids will get the message. And they will stop. Deterrence is the best police tactic ever invented.

For the last 36 years,; I have resided at 2104 Elm Ave,, 1/2 block north of the Elm/19th intersection. I have seen the traffic safety risk situation at this intersection dramatically and progressively deteriorate over the last decade; as more and more cars try to hurry as rapidly as possible west from Sepulveda/PCH, into the heart of our formerly peaceful, child and pedestrian friendly Tree Section neighborhood.

In addition, with the major increase in construction, maintenance, and resident owned vehicles parking on the streets adjacent to, and often extremely close to the actual Elm/19th intersection - On many occasions we are now experiencing the harrowing danger of a truly "Blind Intersection".

As a physician, it seems almost a miracle to me that a very serious, potentially fatal traffic collision involving vehicle passengers and/or bikes and pedestrians hasn't yet occurred at Elm and 19th.

Thank you for taking up the above-referenced issue and reviewing the recommendations of the Parking and Public Improvements Commission for potential traffic calming measures pertaining to the above-referenced matter. Please approve these recommendations and specifically the installation of four-way stop signs at the intersections of 19th Street and Oak Avenue; 19th Street and Elm Avenue; and 17th Street and Oak Avenue.

My address is 2101 Oak Avenue and I have lived very near the 19th Street and Oak Avenue intersection since 1984. Although my own children are adults and have moved from Manhattan Beach, we now have on our block, as well as the blocks to the north and south, more young children than I have seen during my forty-year residency. Young children and teens are riding bikes (ever increasingly e-bikes), motorized scooters and skateboards up and down Oak. I observe them in the morning going to school and then in the afternoon as they return home. They do the same on weekends.

As you may know, Oak Avenue between Marine Avenue and 19th Street slopes significantly to the south. Even those riding conventional bikes pick up considerable speed as they approach 19th Street from the north. I nearly always cringe when a bicyclist goes by, hoping that a vehicle turning right /north onto Oak does not collide with the rider. Should a bicyclist ride south along the east side of Oak (against traffic), a vehicle turning right /north from 19th would never see the rider. A head-on-collision would be catastrophic.

The visibility and line of sight from Oak Avenue just north of 19th is very poor – looking both east and west. There were vehicle accidents at this intersection on May 31, 2023, and again on June 30, 2023. There have been others. A 4-way stop would force drivers to decrease their speed, stop, look, and then proceed. Such a 4-way stop now exists on Oak Avenue at 14th Street. The installation of such a 4-way stop at Oak and 19th would increase safety and could ultimately prevent injury or death.

A contributing problem at the Oak and 19th intersection may also be the low hanging landscaping and utility pole at the northeast corner property and the newer fence (2023) at the northwest corner property. Both interfere with the line of sight and obscure approaching vehicles. It might prudent for the City of Manhattan Beach to adopt a requirement that corner lot fences have a diagonal rather than a 90 degree outside corner. This would inherently improve visibility and line of sight.

In closing, the addition of a 4-way stop on 19th Street at Oak Avenue and the other referenced locations is a commonsense solution to the dangers existing at these intersection -- a solution that residents of Oak Avenue and Elm Avenue wholeheartedly endorse. Our children deserve to be safe and protected.

Thank you for considering the safety of our children and these much needed improvements to our neighborhood.

Tomorrow in Agenda Item 13 at the Council meeting you will be asked to review the traffic calming measures as recommended by the Parking and Public Improvements Commission (PPIC) and vote on Resolution 24-0045.

As a 20+ year resident of Manhattan Beach my wife and I (and others) had the opportunity to be involved with the effort to bring much needed 4-way stop signs at the intersections of 17th & Oak, 19th & Oak, 19th & Elm. **Over the course of the past year discussions with dozens of neighbors on the various impacted blocks, there**

over the course of the past year discussions with dozens of heighbors on the various impacted blocks, there is a unanimous agreement from all neighbors that these 4-way stop signs are required.

In my walking up and down our streets I was surprised to hear the strong level of support for these additional stop signs, at the first mention of the city's study.

While we appreciate the city's research on this matter, *the information provided to you that no accidents have occurred at these intersections over the past 5 years is highly inaccurate.*

As neighbors we have seen a great many accidents over this period, and can attest that near misses are a near daily occurrence.

As a case in point the last near miss was this evening at 6:22PM. (My wife and I live 100 feet from one of the intersection, and the sound of screeching tires is unmistakable).

The city has received testimony in support of the additional stop signs from dozens of residents in letters and emails over the past year, only a portion of which are addressed in the report before you today.

That said, we are very appreciative of the efforts of the City Engineer and City staff this past year. His willingness to listen to the residents, hear the often passionate testimony from many, and his ultimate support for the 4-way stop signs are sincerely appreciated.

His conclusions, are entirely correct, that high car speeds coming off Sepulveda and restrained visibility at these intersections are a major problem needing addressing.

The PPIC likewise concluded in its March 18th vote in support of these stop signs, that they should be a high priority of the City and should be implemented promptly.

I would urge the City Council to hear the matter tomorrow and approve the City Engineer's recommendation in Resolution 24-0045.
