Mayor Franklin: Great. Thank you. Well, good evening. Welcome to the City Council Adjourned Regular Meeting for Tuesday, May 21st, at 5PM. May we do the Pledge to the Flag? So let's see. I think Mayor Pro Tem, Amy?

Mayor Pro Tem Howorth: Yes. Thank you. Please rise, face the flag. Put your right hand over your heart. Begin.

Mayor Franklin: I'm your honor.

Councilmember Napolitano: Vector, Victor.

Mayor Franklin: Can we have a roll call please?

City Clerk Tamura: Councilmember Lesser?

Councilmember Lesser: Here.

City Clerk Tamura: Councilmember Napolitano?

Councilmember Napolitano: Here.

City Clerk Tamura: Councilmember Montgomery?

Councilmember Montgomery: Here.

City Clerk Tamura: Mayor Pro Tem Howorth?

Mayor Pro Tem Howorth: Present.

City Clerk Tamura: Mayor Franklin?

Mayor Franklin: Here. And how about a motion to approve the agenda? So moved by Councilmember Montgomery and seconded by Councilmember Lesser.

Mayor Pro Tem Howorth: Wait.

City Clerk Tamura: Motion - -

Mayor Franklin: Got it?

Mayor Pro Tem Howorth: It didn't count my vote.

City Clerk Tamura: No, it didn't count.

Mayor Pro Tem Howorth: Oh sorry.

City Clerk Tamura: That's okay.

Mayor Franklin: Passes 4-1.

Mayor Pro Tem Howorth: Oh, there she goes again.

Councilmember Montgomery: Can we do it again?

Mayor Pro Tem Howorth: Yes, somebody second it. My apologies gentlemen.

Councilmember Napolitano: What happened?

Mayor Franklin: Okay.

Mayor Pro Tem Howorth: When I pressed it.

Councilmember Lesser: - - logged in.

Mayor Pro Tem Howorth: I pressed it twice by mistake which didn't count.

Mayor Franklin: Nah, it's fine.

City Clerk Tamura: Motion passes. 5 - 0.

Mayor Franklin: All is well. Public Comments? Seeing none here. On Zoom?

Mayor Franklin: Okay. We're gonna close Public Comments.
