Mayor Franklin: Thank you very much. Welcome to the City Council Adjourned Regular Meeting for 5 o'clock on July 2nd. Let's do a Pledge to the Flag. Any new victims here? Well Bruce Moe, you might not have a chance to do it for awhile.

City Manager Moe: You know something I don't? Please place your right hand over your heart.

Mayor Franklin: Great. Thank you. Can we have a roll call please?

City Clerk Tamura: Councilmember Montgomery?

Councilmember Montgomery: Here

City Clerk Tamura: Mayor Pro Tem Howorth?

Mayor Pro Tem Howorth: Here.

City Clerk Tamura: Mayor Franklin?

Mayor Franklin: Here. And do we have a motion to approve the agenda?

Councilmember Lesser: So moved.

Mayor Franklin: So we have a motion by Councilmember David Lesser and seconded by Councilmember Steve Napolitano.

City Clerk Tamura: Motion passes. 5-0.

Mayor Franklin: Okay. So now we move to Public Comments. There anybody here in Chambers? No? How about online?

Assistant City Clerk Alvarez: There are no request on Zoom.

Mayor Franklin: Okay. So we close Public Comments. And so now we move into Closed Session. Any announcements?
