In the past, officers have been selected on a seniority basis. Mr. Gill reported that Commissioner Gill would be next in line to serve as Chair, followed by Commissioners Murray and Nicholson Although this has been the practice in the past, it is not the rule. The Commission has the right to choose any member of the Commission they feel is most qualified.

A motion was made to name Commissioner Ned Gill as the 2008/2009 Parks and Recreation Commission Chair. Mr. Gill reported that staff contacted Commissioner Gill prior to the

meeting, due to the fact that he was not able to attend, and he indicated that it would be an honor to serve as chair if selected. (MSC: Nicholson/Murray – Unanimous)

During a discussion among the Commission, both Commissioner Murray and Nicholson indicated a desire to serve as vice-chair. The Commissioners used a lottery system to determine the vice-chair and Commissioner Nicholson was chosen. A motion was made to name Commissioner Steven Nicholson as Commission Vice-Chair. ## 08/0623-2 Tour of Live Oak Park Facilities

Mr. Gill and Mr. Al-Oboudi conducted a tour of the Live Oak Park facilities and pointed out the following conditions:

Joslyn Center (renovated four years ago)

- Auditorium floor large cracks
- Shortcomings no dressing room or back stage
- Lack of storage space neighbors complain about outdoor storage containers
- Buildings structurally out of compliance with major codes
- Senior Citizen OASIS would like to expand, leaving no room for recreation classes (Commissioner Harris suggested that the City partner with the Manhattan Beach Middle School and Manhattan Beach Christian Church, using their facilities for classes and activities.)
- Restrooms in the southwest room are the only A.D.A. restrooms in the Live Oak facilities

## Scout House

- Cracks run from Joslyn Center through the Scout House (Joslyn/Scout House built on fill)
- Restrooms not A.D.A.
- Structurally out of compliance with major codes

# **Tennis Courts**

• Constructed with 100% asphalt, resulting in settling of courts

# Live Oak Park Hall

- Restrooms not A.D.A.
- Poor air circulation
- Structurally out of compliance with major codes
